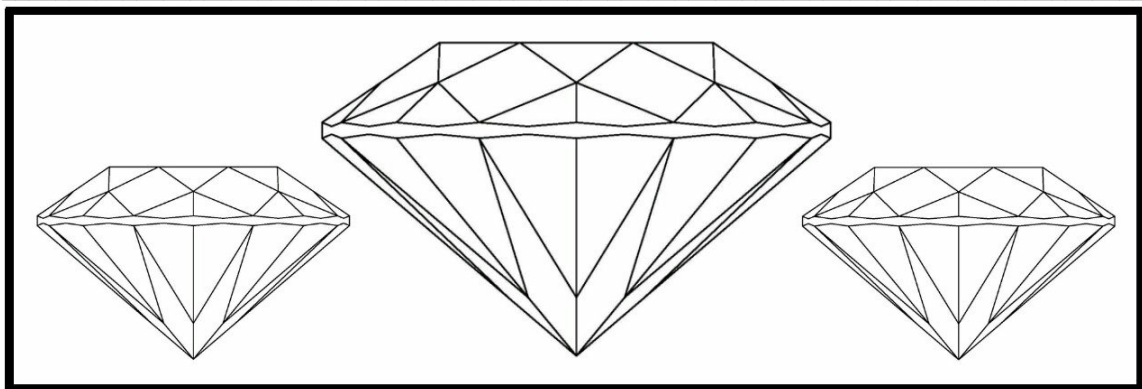

The Federation have right for democratical recognition about own membership in the organization, in accordance of true facts on function of Organization, or another in opinion of no existence of the Organization because own active difference in legal basess of organization be the law of establishment and such purpose.

Opinion 1.

The United Nations is based on being formed in response to the Second World War, and for the purpose of fully preventing repetition of the same crimes.

Today, the United Nations is by no means active for the purpose of preventing warfare at the level of **Global Wars**, and the fact that the United Nations has steadily co-operated with a terrorist group at state level for the purpose of standard membership of the organization and allowing direct and often undemocratic and counterfeiting the main interests of the organization, for the sole benefit of a terrorist group, be the internal bureaucratic monopoly of member parties and mafie in their organized structure of organization.

Membership in the organization is only a risk of allowing a foreign group to use the organization's legal model for the sole purpose of enslaving the federation and abusing the position for its own interests of silence, criminal manipulation, and monopolies.

Opinion 2.

The United Nations is legally founded to support the stabilization of states and emerging states, and to enable them to protect themselves by the legal principles of international law, to maintain their independence and security. Such legal functions are entirely free from legal participation in practical matters, and the organization ultimately only maintains the objectives of the Member States without distinction as to their legal legality and terrorist status, and for the direct purpose of allowing persecution to legitimate states and peoples, damaging democracy and justice to the peoples.

Opinion 3.

UN Security Council is active in interests only for the purposes of its own state strategy and monopoly, and without being responsible for the importance of international law, justice and interests based on accountability and the existence of the UN. The UNSC is not active under the legal obligation and the actual obligation of States, in which case it is publicly acknowledged that the UNSC has the courage to block the justice of states and to allow their rape and enslavement even after a period longer than sixty years, meaning the ultimate sum of allowed crimes for such a period, as well as the overcoming of the World War II crimes,

and therefore the United Nations gains positions in a much worse criminal position than the Fascist German Third Empire during the regime of Adolf Hitler.

Opinion 4.

The UNSC does not have enough sobriety and activity to stop a terrorist movement that is at a much lower level than today's UN military and security force. The federation's development strategies mean achieving the level of capability of much greater security of its own security, as well as its open capabilities, are much better stabilized by its own security sources, and the goal of increasing security for the world beyond UNSC. Therefore, according to the security strategy, it is much more important not to depend on the UNSC.

Opinion 5.

The UN guarantees the legal claims of human rights, justice and unity of nations, but in no case does such an organization with the ability to sufficiently guarantee the function of the legal form of this exercise to enforce these claims, and the significance, organization is not active for this purpose, when for such purposes the organization gets high funding from the sponsors, and then the organization just does not follow the catastrophes of crimes for damaging human rights. The organization continues to use attitudes of full discrimination, fails to respect the rights of joint communication, along with the fact of active cover of criminal activities.

States that want to use the International Law of the United Nations will only lose to their own defense capabilities, and the result will be greater government and civilian bankruptcy risks.

Opinion 6.

The resulting active UN function, contrary to its own legal principles, is only a step towards silent coercion by States to launch their own weapons of mass destruction and spreading their own subsistence strategies over the basic steps of civilian destruction of other states where mutual protection of criminal states allows development in the victory of justice only if weapons of mass destruction against terrorism are used. The organization does not sufficiently allow for peace talks, and at the same time favors the stable functioning of terrorist regimes, rather than states that demand their own claim of legal justice, and therefore such states are blocked on the rights of their development.

Opinion 7.

The legal form of the United Nations is an entity based on democracy according to the standard of justice and the legal significance which is so defined by justice for the purpose of security protection. The UN is not an organization that is actively able to establish normal communication in accordance with responsible practices and at the same time the United Nations is not capable of achieving the direct function of democracy according to the standards of justice where it is possible to ensure fairness and the enforcement of legal claims. The UN is not capable of activating for the purpose of responsible growth of legality and applying its own legal principles.

Opinion 8.

The organization establishes its own growth of legal development in force with a

world level, limiting civilization growth and development, the future of all nations and generations of states, although the blocked possibilities of civilization development have not been sufficiently tested and developed to achieve a responsible experience position, a legal decision on the function and significance of the validity of international rules. That is why international law is developed without a universal view of a political nature, but only with the basis of ideological origins according to cultures and religions of foreign states that are not in the federal capability of controllability of their development and independent modification according to current trends and ideas of society.

Opinion 9.

The United Nations recognizes the practice of economic stability of peoples' equality, securing the capability to prevent dominance and abuse of the inferior status of nations, and is therefore an irresponsibly active organization goal, blocking the development of technologies and the modern growth of states that may be at risk of a dominant position. In fact, such a rule is applied only in a position

As someone is motivated to make more progress in humanity, the United Nations states will allow him to be discriminated against and robbed of development rights and the demands of his development, as well as being at risk of bankruptcy.

Opinion 10.

Falsification of facts, media censorship and influence of society by fascinating reports, as well as support for organizing the actions of the social terrorist movement that are led to implement strategies based on criminal monopoly.

Opinion 11.

Some legal functions of international rights are intended only for the purpose of slowing down the development of foreign civilizations, allowing the complete confidentiality of new and revolutionary technologies for the purpose of their own use by only some states, and thus ensuring their values of silent global dominance and the risks of their neocolonial control of the world movement, to ensure their independent protection, while abusing common membership in the United Nations, for the purpose of espionage, and identifying major international advances in technological development between states, to prevent their ability to decline in domination.

Opinion 12.

The organization can activate its own core strategy of its development on the basis of the interest of only a few member states of the minimum power of democracy and their ability to generate an emotional effect, thus creating an active group trend that is not based on verified facts and informations, but only opinion of some corrupted agencies and officials. As a result, this trend is decisive for the purpose of violating all international rules, the activation of crimes is much worse than the Second World War, and only for the purpose of profit, only the states that have established this trend.

The organization is not sufficiently stable for membership in the Organization to guarantee the right to use the responsible form of legal function.

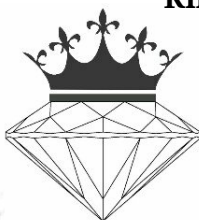

Until time when Federation is not member of The UN organization, We are have a Right for;
