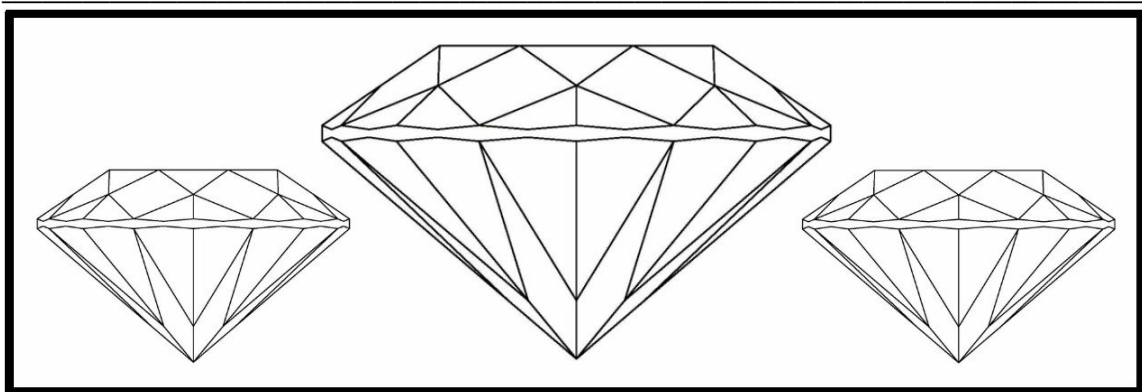



Development of Secret Science Office

1. Each member state of the Federation will create an Administration list of his scientific people.
2. Scientists will be silent in their protection, and their names and personal information will be protected from the public.
3. Scientific personalities will be supported in their field, enabling their collaboration with business firms and corporations in the category of their science and interest or development project.
4. Scientists acquire federal law, their right to recognition of their status as research interests, for the purpose of their recognition as Legal Persons, with the right to exercise the status of an institution and business activities in the field of science, thereby expanding their own resources, capital, laboratories and important assets.
5. The Science Institutions work with the federation's education centers, the councils of the cities and ministries, and other public bodies of the company and the federation. Institution is a public body of an open society.
6. The Federation has the right, in the logistics of its own offices, to ensure the development of collaborative development cooperation and the management of common resources among scientific institutions, and to create a management plan for their joint functions, as well as to develop development contracts and projects for building and research.
7. Each institution employs at least one official member who will be a representative of federal secret projects, with the legal entitlement of the federations to perform a silent and covered administration of Institutional Collaboration on Secret Private Registry Projects according to Navigation from the Secret Science Office.
8. The institution has the duty to allow representatives of the Secret Sciences Offices, its ability to gain information and data of the institution, development steps and investigations that will be intended for secret cooperation and under cover of the institution's behalf. The Federation will pay all financial costs for a particular operation of a part of the institution.
9. Each Federation movement will allow a unified centralization of all Scientific Institutions for the purpose of establishing the Federal Association of Science, which centralizes all intelligence of science and development throughout the federation.
10. The Federation thus establishes a common Federal Intelligence Center that can be used by each Federation member for the purpose of federal growth in enabling information science resources and enabling a common equal development across the entire federal scale of civilization.
11. The Federal Association of Sciences develops research in the fields of science according to the budget of interests of the Scientific Institutions of the Federation, as well as fields which are determined by the federation's common development strategy, and development in the profesion of chemistry, particles and energetics, electronics, mechanics, quantum mathematics, biology and genetics, farmaceutics and health, material

science, the space industry, the arms industry, the transport industry, and other elements of the advanced form of civilization and intelligence.

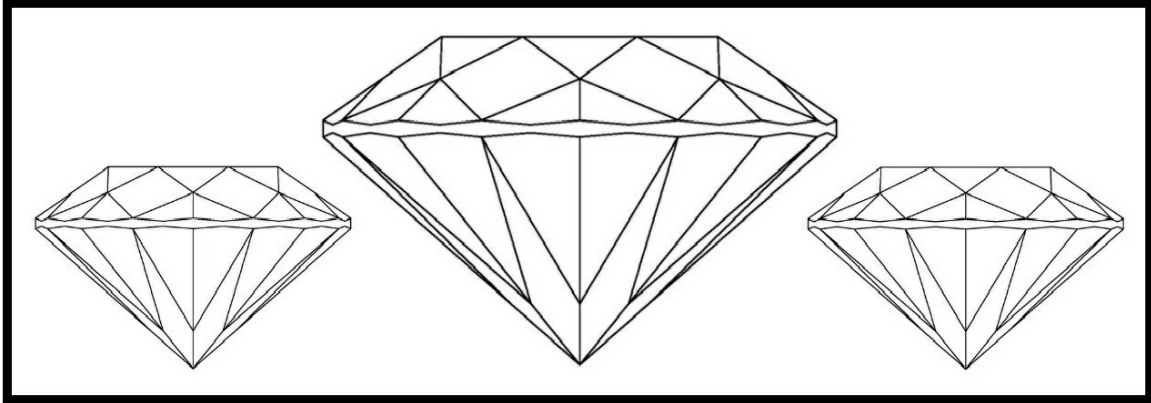
12. The Federal Association of Sciences will use its own information commercially or organizationally for the purpose of its own development, and at the same time to strategically support the growth of the maturity of the Federation's active business ventures for the purpose of advanced civilization building. The Federation has the right to purchase information for its own management purposes.
13. The Federal Association of Sciences will continue to exercise the basic distinction of its management system, such as the Central Council for Development and Research Planning, the Office for the approval of the publicity of association projects, the development of the economic strategy of the functions, the establishment and control of own resources, the patent register and the authorization of copyrights, the categorization of scientific projects, publicity department, personnel register of all active researchers and scholars of science, library and centers of professional science and literature education, other departments to be established by the Association Council or the Federation.
14. The Federal Association of Sciences will extend cooperation with international groups, organizations and associations for the purpose of a joint scientific and information partnership, joint project management, and coordinating verification of data and information on the results of scientific research and confirmation of their appropriate use and safety.
15. The Federation will establish a conference in which volunteer candidates from amongst the scientists will be selected and for the purpose of their use in the interest of being a member of the Secret Science Development Group serving only to develop secret federal projects.
16. The Federation has the right to determine the minimum or maximum budget of the working period and the category of research area of the scientists who have been admitted, and to decide to block the right to terminate their employment if justified by the obligation of the security information strategy.
17. The Federation has the right to determine the health and fitness regime of the participating scientists in order to maintain the best quality of their regime and the results of the profession.
18. The work of Secret Scientific Research must not be based on the function of crime, damaging human rights and freedoms, or coercion and damage to human values.
19. The Secret Science Group establishes an Office that will create its own administration and development administration, project register, staff management, property budgets, proprietary cadastre management, development of strategies and covered communications and organizing.
20. Each part of the Secret Science Group is kept in anonymous protection among all groups, with the basis of its own function governed by the code of autonomy, and only direct top-level persons may be entitled to direct administrative oversight, specially elected members of the Royal Council, selected members of the Federal Senate and representatives of the highest constitutional services as members of the Federation. The selection of responsible persons can be determined by the results of long-term psychological observations and tests.

21. The Secret Science Group is activated only in the silent proximity of the Federal regime and the so-called silent development of technology, substances, information, methods and products for the purpose of developing the Federation and secret affairs, or collaborating on secret missions and research.
22. The Secret Science Office establishes its own industrial centers, raw material sources, official houses that are under anonymous administration and with full isolation from the public and against espionage. All centers must be strictly guarded on their safety and function.
23. The Secret Science Authority also uses a logistics organization to establish a strategic partnership with public enterprises, using the independent name of commercial counterparts of companies that use their name and the development of parts of technology and projects among professional professionals to counter organizational collaboration.
24. Researchers in the performance of research work will, on condition of their duties, never disclose any information about their employment, participation in projects or the development of secret projects, and their life may be isolated in public society.
25. Each scientist will get a private apartment and living space in secret research area zones and a responsible financial salary for research work and the circumstances of a secret lifestyle.
26. Every active scientist has paid health checks, health costs and healthy living needs, as well as special family allowances, from federation sources.
27. Each scientist will be taken to the secret contact point on arrival at the flexible contact area and will then receive a protective suit to cover his or her identity, face, fingerprints, voice tones, sample bottoms, and other biometric identification data. Each suit is created so that an alarm can be recorded from its changeover and damage to the anonymity guarantees. The suit owns only an identification number that replaces the name of the scientist. The scientist must not share his name and public data in a secret society, his work performance is fully anonymous.
28. Family and friends of a scientist must not know his real profession. Therefore, a replacement identity will be created for each scientist. The scientist has the right to contact his family and the free movement in society.
29. The Federation has the right to establish civilization science centers for the life of researchers' families.
30. If a scientist leaves a secret zone for the development of federal scientific projects for the purpose of visiting a public civil society, the federation has the duty to ensure its security screening by interrogation tactics and to verify its security. The Federation has the right to control private telephones, Internet messages, postal communications, satellite imagery and contacts, as well as information checks of people who have been in contact with him or at a glance, and in the light of his friends and family.
31. If a scientist with high level rank of importance leaves a secret zone for the development of federal scientific projects for the purpose of visiting a public civil society, the federation has the duty to ensure its security protection be the armed guard.
32. If a scientist terminates his employment on a permanent basis, the federation has the right to periodically inspect and contact former

scientists for the purpose of their interrogation by secret agents, and to check their continued confidentiality and to maintain secret information on all secret mission projects. Every scientist has the right to request regular financial compensation from the federation for review after questioning.

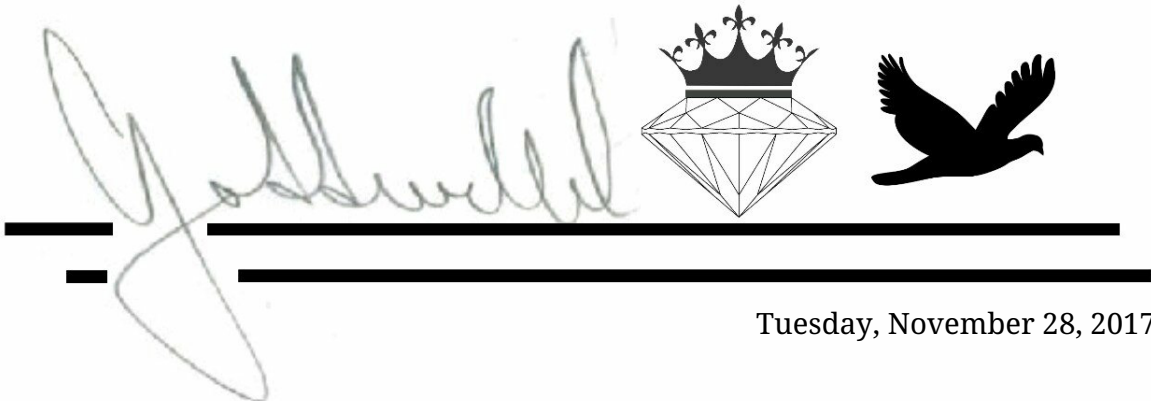
33. A scientist who has terminated his professions will be granted by the federal authorities to confirm his working experience as a corporate corporation as a covert of his past, following a covert profession before family and friends.
 34. Every scientist who has completed his professions receives a subsidy from the Federation for the establishment of his commercial property and investment in development.
 35. If the Scientist terminates his professions, the Federation has full rights for its permanent control over its health reports, issuing special immunity to police investigating authorities, special rights to federal authorities, granting special retirement benefits and financial contributions, and enrichment.
 36. The Federation provides special health care rights for all scientists who have terminated their employment relationship with the Secret Science Agency, as well as screening all police records, with the Federation's right to inspect all foreign travel, or to ban visits to risky countries, as well as to control business and other social activities.
 37. If the Federation enters a state of war and other special mode, the federation has the right to issue a decision on the duty service, meaning scientists immediate return to his profession without the possibility of another decision or appeal, unless otherwise permitted a special responsibility reasons.
 38. The Federation has the right to decide to block the right to refuse federal citizenship by a scientist who has terminated his employment relationship with the Secret Science Office, in order to ensure the safe keeping of all secrets.
 39. No one shall any record or publish any facts about the research conducted in the scientific section of the Secret Office, the disclosure of data from a secret research mission as an act of crime.
 40. Workers in secret zones may only be persons legally sentenced to death, or persons sentenced to life imprisonment, so that the information can not be conveyed to the public. The goal of the Secret Science Institute's development is to create fully automated laboratories and ensure their robotic function. The Secret Research Unit may be run by Android Computer Intelligence.
