STATES:

- 1. This statement made by me accurately sets out the evidence that I would be prepared, if necessary, to give in court as a witness. The statement is true to the best of my knowledge and belief and I make it knowing that, if it is tendered in evidence, I will be liable to prosecution if I have wilfully stated in it anything that I know to be false, or do not believe to be true.
- 2. I am 62 years of age.
- 3. I am a British Citizen and I have resided in Australia on and off for 62 years. I am a Priest of the Russian Orthodox Church Outside of Australia. I have been a Priest for 6 years, almost 7 years. I am a roving priest where I cover all the parishes throughout New South Wales. I am also a registered Migration Agent (registration number 9251054). I am a Justice of the Peace, a member of the Migration Institute of Australia, a founding member of the Refugee Council of Australia, part of the Russian Relief Association and a member of the New South Wales Commission for Children. Up until last year I was also the director for the Migration Bureau.
- 4. I initially became aware of Father Chris, who I also know as Stanislav VAKHABOV, when he was referred to Australia by Metropolitan Hillarion (who is also the Archbishop of Australia and New Zealand) around 2011. It was originally intended that Father Chris become the Parish Priest in Dublin, Ireland. However, this did not go ahead due to, I believe, the economic crisis at the time and the Church did not think they had enough funds to support father Chris. Therefore it was suggested he come the Croydon Church All Saints of Russia in Australia. I completed all the relevant documentation to facilitate Father Chris coming to Australia. His two year Religious Working Visa was granted in 2012 and Father Chris arrived in Australia in

December 2012. He commenced working as the Rector (first priest who is in charge) at Croydon Church All Saints of Russia on his arrival. Father Michael LI is the second priest and I am the third priest. The three of us normally serve together. I would see Father Chris on a weekly basis, at least two services a week, sometimes more.


- 5. Father Chris did not speak about himself much to me, however I knew a bit about his history due to my work as the Migration Agent. I knew he came to us from Tiraspol in Moldova. He was born in Moldova but held Ukrainian citizenship. He had also been to Ireland and Russia. He had been involved in youth projects and church committees. We were told Father Chris spoke fluent English, however he only spoke very little broken English. I speak very little Russian and that made it difficult for us to communicate at length. Father Chris resided in the priest's accommodation attached to the church at 18 Chelmsford Avenue, Croydon. He resided there by himself. Father Chris is a Monk, so he has to be by himself.
- 6. The residence where Father Chris resided is a small, three bedroom granny flat. One room is the toilet and bathroom, another room is a small bedroom with one bed and a small 2 seater lounge and a desk, and the third room is a small kitchen/dining room. It is very small and suitable for one person.
- 7. I was personally not impressed with Father Chris from the beginning. I did not find him to be a competent priest. He did not take direction and he was not punctual. He would leave during services and come back during services and take phone calls during services. Things that priests don't do. However, I tried to be supportive of him but he didn't seem to bond with anyone particularly well. Father Chris divided the church in the short time he was there. Most of the parishioners didn't like him, however a small group of elderly women loved him. They would cook for him regularly and mothered him.
- 8. Father Chris provided church services that would vary week to week. He taught bible studies on Tuesday nights and this is where the elderly women got to know and like him. He also made appearances at youth activities over the Christmas holidays. The youth activities included conventions in Sydney and Melbourne. He also travelled to South Australia, Victoria and New Zealand and conducted services at church there. He taught at the Russian school in Strathfield on Saturday mornings St Alexander Nevsky.

- 9. On Saturday the 5th of July 2014 I was at the church in Croydon and I saw a young boy appear from nowhere during the service. I had not seen this boy before. The boy looked like he was in his early teens. I didn't see the boy with anyone and I was not introduced to him. He was performing altar duties on this day. On Sunday the 6th of July 2014 I saw the same boy at church again during service. He was performing altar duties. Father Chris introduced him briefly from Belarus and then he was whisked away by Father Chris. At this time I did not think it was too out of the ordinary to have a new altar boy as it was school holidays and quite often the regular altar boys would have their cousins participate during services. However did not seem to be with any particular family. He was always kept very close to Father Chris.
- 10. On Monday the 7th of July 2014 I saw at the Croydon church again. I spoke briefly to him and he told me he was 14 years old. He did not speak English at all so I spoke with him using my broken Russian. I did not find out anything else about him on this day.
- 11. There was no church for the rest of that week until Saturday the 12th of July 2014. This was the feast of St Peter and St Paul. We had a service at the cathedral in Strathfield and there was a feast afterwards. Father Chris left straight after the service which was very unusual. I did not see that this service.
- 12. After the feast my family and I attended the church at Croydon about 2pm where I conducted a Baptism for a family member. When I was in the church I saw that Father Chris' Monk's hat and his case were in the robbing room, so I knew he had been back after the service at Strathfield, however I did not see him. I remained on the church grounds having a picnic with my family during the afternoon. About 5.45pm Father Chris came out of the church and advised me that we had no Deacon for the service at 6pm. This was the first time I has seen Father Chris since the end of the service at Strathfield. I did not see him arrive at the church at any stage while I was there all afternoon. He has direct internal access to the church from his residence. I believe he was in his residence all afternoon.
- 13. About 6pm when the service started appeared out of nowhere again and performed altar duties. Once again he was not with a family. At the end of the service I asked Father Chris how was getting home. Father Chris said, "It's none of your business." Father Chris and disappeared again.

- lim parents had given him permission to travel to Australia. 16. Around this time I also learnt that however it was not approved by the church and the church did not know anything about it. I had noticed that Father Chris constantly kept all his blinds drawn which had never been the case before.
- stayed with my family he seemed happy to be with us. I 17. On the 16th of July 2014, when didn't find him overly happy before that, He was withdrawn and isolated. When he came to us he settled in and said prayers, we chatted and he seemed happy and comfortable to be there. I about himself. He told me about his Facebook page. He told me he saw skyscrapers on his Facebook page and the skyscrapers were in Melbourne. He told me that he wanted to be an architect and he wanted to come to Australia. He told me a bit about his family, that he had two sisters. He liked our pet cat and he settled in quite well. I didn't question him talk. I wanted him to feel comfortable and welcome.

18. The next morning, the 17th of July 2014, my wife drove o the church in Croydon to spend left his back pack and all his belongings at our house because the day with Father Chris he was due to return that afternoon. There was mention that Father Chris and were going to go to Manly for the day, but it was raining so I don't know if they went or not. It was arranged back to our house that night between 6pm - 7pm. Chris does not have a car and does not drive, so the head Sister, Lena INGLISS, was going to drive pack to our place.

- 19. By 7pm on the 17th July 2014 had still not been returned to my home. About 7.30pm I received a call from Lena INGLISS. Lena told me that Father Chris was not allowing him to be returned. I called Father Michael PROTOPOPOV and informed him that father Chris was refusing to return at left it with the church hierarchy to pursue the matter and report it to that police, which they did. I also tried to contact Father Chris on his mobile (I don't remember the number at this time). He didn't answer any of my calls or messages. During Friday the 18th and Saturday the 19th of July 2014 I continued to try to contact Father Chris on his mobile number. I also sent him emails. I don't have copies of the emails with me now but I can get them and I will provide them to Detective Senior Constable Melissa HORVAT.
- 20. Late on Saturday night, 19th July 2014, Father Chris finally answered one of my calls.

He said, "Father David you're stressing me."

I said, "Well I'm still your Migration Agent and I need to see you and speak to you."

He said, "Well send me an email with the details."

Father Chris refused to speak to me further. I sent Father Chris and email.

21. On Sunday the 20th July 2014 I attended church at 8am. Father Chris arrived a few minutes later. I was surprised to see him so early, as he usually turned about 8.45am.

I said, "You're here early. Where's

He said, "not here and you're not going to know where he is."

I said, "The agreement was that would be with me."

He said, "That agreements finished, which you should know by now."

Dear Father David,

I would like to thank you from the bottom of my heart for the assistance that you gave to my son and would like to pay homage to you and your Matushka. Father David, I can honestly say, and am happy to swear before an icon of Our Lord, that I am telling the truth in that my son, is a normal boy whom I trust. He did not say anything untoward about Vakhabov even though Vakhabov was maligning people who only wanted to do the right thing by him. Vakhabov enticed my child and courted him, touching him in intimately, my son did not know what to do in this situation. It's difficult enough for adults to know how to react let alone a child who has not been confronted with this two-faced behaviour particularly especially as he was in in a foreign country where he did not know the laws in this regard.

Vakbanov constantly told that you and Father Protopopov belonged to a sect and that he had photographic evidence to prove this, however he never actually showed the photo to

He also told me via Skype all sorts of nonsense and said I should write to Metropolitan Illarion but send the letter to him to pass on. He also stated that if went to Lloyd then anything could happen to him and one would never know where he might end up. I asked him why he had not reported this situation to the parish leaders and he replied that the Metropolitan was absent and all the rest belonged to the sect and had turned against him.

The social networks are not proof of defamation about a child - one can enter his page and write a lot of nonsense about him quite easily.
