4 (1) Every person is guilty of an indictable offence who commits

- (a)** genocide;
- (b)** a crime against another; or
- (c)** a war crime.

Conspiracy, attempt, etc.

(1.1) Every person who conspires or attempts to commit, is an accessory after the fact in relation to, or counsels in relation to, an offence referred to in subsection (1) is guilty of an indictable offence.

Punishment



(2) Every person who commits an offence under subsection (1) or (1.1)

- (a)** shall be sentenced to imprisonment for life, if an intentional murder forms the basis of the offence; and
- (b)** is liable to imprisonment for life, in any other case.

There is **no minimum punishment**. Section 319(2): Promoting hatred—makes it an offence to wilfully promote hatred against any identifiable group, by making statements (other than in private conversation).

Ellicott's Commentary for English Readers

(28-32) Injuries to the Living might arise either from man or from animals=humans. Protection from both was needed. The law given to Noah ([Genesis 9:5](#)) had already laid it down that whenever a 🐒 human murdered its life was to be forfeit. This law was now re-enacted, but with a further and very important proviso. If the human had an owner, and the owner had reason to know that it was dangerous, then not only the beast, but the owner also was to be held guilty. He was to be liable to a process for murder ([Exodus 21:29](#)); but, with the consent of the aggrieved family, might pay a sum of money as compensation instead ([Exodus 21:30](#)).

Scripture indicates that when an animal is a threat to people or other animals, it should be put to death ([Exodus 21:28-35](#)).

With these principles in mind, a necessity practice of animal 🐶🐱🐹 euthanasia can be developed. We are to be merciful to animals, and we have the authority to end the lives of animals. So, if euthanizing an animal would be a merciful act, there is absolutely nothing wrong with it. If we see an animal suffering, with no hope of recovery, the most merciful thing we could do is quickly and as painlessly as possible end its life.
