**Sherri Kane and Leonard G. Horowitz's Comprehensive Report on the Child Sex Trafficking Network Responsible for Disappearing an Estimated 500,000 American Children Annually.**



Los Angeles—[Shocking proof](#) has surfaced to indict a former FBI Division 5 director for lying about his marriage to Church of Satan heiress, Diana Rively, Anton LaVey's ex-wife, to keep a secret child-trafficking sex-slavery network hidden.



The revealing document threatens to shake-up the Justice Department with many questions as to why the FBI, working with the CIA, has been unable to stop a network of child traffickers from kidnapping, raping, and sexually enslaving hundreds, possibly thousands, of American children annually.

[In the handwritten letter](#), recovered from 1998, Ted Gunderson, a retired FBI/CIA official and informant on matters of a satanic network of pedophiles and child traffickers wrote, "The marriage [to Diana Rively] . . . didn't work out. It only lasted 2 and one half weeks and I left. It would have been a catastrophe to stay there. Nothing against Diana."

The letter, signed with kisses and hugs, was sent to Gunderson's professional associate, [Barbara Hartwell](#), who was programmed to serve in the CIA's psychological operations unit. She trained in psychological profiling and in debriefing military and intelligence personnel, and later toured with Gunderson to "disseminate intelligence on government corruption," according to Hartwell. Their assignments included a child-trafficking operation linked to officials of the CIA, U.S. military, Church of Satan, and Justice Department.

The stunning admission and letter raises several scandalous questions, including why mind-control inductees are assigned to operate as enemies of State, even embracing satanism, to disseminate indicting intelligence on U.S. government corruption on behalf of the CIA?



One reason involves undermining “dissident activism” by generating “controlled opposition.” Fake dissidents provide cover for criminal operations, and deter real grassroots activism from sparking revolutions.

Another explanation involves globalization, and propaganda intended to undermine nationalism to embrace governance through the United Nations.

Hartwell and Gunderson toured with alleged CIA mind control victim sex slave, [Brice Taylor](#), who’s celebrity is widely known among American patriot and Christian fundamentalist groups. One researcher among them, [Robert Sterling](#), discerned “a deeper conspiracy” operating here.



Photo shows murdered child, Jon Benet Ramsey, resembling MKULTRA sex slave, Brice Taylor. Experts say pedophile satanists prefer their victims to appear innocent and doll-like due to their “dominant/submissive perversion complex” generated, likewise, from early sexual abuse.

Sterling concluded, “The most effective form of disinformation is that which blurs the truth with fiction so effectively that they become impossible to differentiate.” He noted that at the time Taylor, and other alleged victims of the CIA’s Project Monarch MKULTRA sex slavery operation, such as Cathy O’Brien, hit the lecture circuit, “some powerful research was starting to circulate in alternative circles involving Satanic pedophilia operations.”\*

## Letter Links Gunderson to the Church of Satan

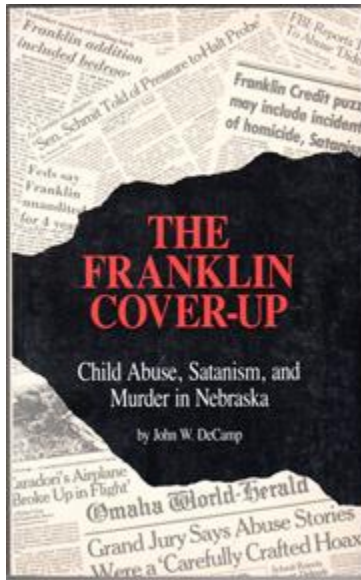
Gunderson's [letter](#), citing his marriage to Rively, helps clarify a criminal conspiracy responsible for censoring the actual number of abductions that experts put annually in the tens of thousands.



The letter compels investigations of two satanic churches and the FBI and CIA, the agencies supposedly gathering intelligence on kidnappings to arrest villains. In addition, officials in Congress, the White House, and even the Vatican, concerned about criminal exposures and embarrassing publicity over matters of pedophilia, are susceptible to additional investigations compelled by the letter.

The [letter](#) proves Gunderson lied about his marriage to “Diana,” and confirms what many independent investigators determined—Gunderson secreted his relationships with satanic church officials, evidencing a double agent assignment.

## More CIA/FBI Officials Linked by Letter



Over the years, Gunderson, a high profile CIA/FBI official, had been harshly criticized for lamely addressing pedophilia, sex slavery, and “The Franklin Cover-up” involving Nebraska Senator John DeCamp, politicians, and Catholic priests. As FBI, Division 5, Director, Gunderson gathered intelligence on the satanic network that involved members of the Church of Satan, Temple of Set, the CIA, FBI, judges, prosecutors, politicians, and other clients acquiring sex slaves he failed to disclose publicly, or pursue through internal affairs.

Many conscientious objectors, including Hartwell, charged Gunderson with protecting his superiors and the network.

Gunderson, however, had repeatedly denied allegations of his marriage to the Church of Satan heiress, sorceress, and high priestess, Diana Rively (a.k.a., Diana Hegarty). The revelation would have devastated his career, generated domestic outrage, and possibly risked national security. Imagine the public learning their presidents acquired kidnapped satanically-trained sex slaves through the FBI and CIA.

Two years after the letter was written, Gunderson, and a half dozen agents, began to harass, libel, and threaten Hartwell for speaking out about Gunderson’s “anonymous sources,” including relationships with officials linked to satanic churches and international pedophilia and child trafficking networks.

## **A Marriage Too Hot to Handle**

Gunderson’s marriage to Rively was taboo, since she edited *The Satanic Bible*, *Satanic Rituals*, *The Complete Witch* and *The Devil’s Notebook* while married to Anton LeVay.



Since the Rively-Gunderson annulment, Gunderson has had a team of agents working to discredit anyone who dared mention his relationship with Rively, or Temple of Set founder, Michael Aquino—a most incriminating fact evidenced widely over the Internet.

The CIA agents involved with Gunderson, covering-up his marriage, filtering government corruption stories, and harassing, threatening, and discrediting journalists investigating his links to the satanic network, include: convicted felon [Timothy Patrick White](#), “[Dr. True Ott](#),” Greg Szymanski, Eric John Phelps / Craig Oxley, Doug Millar, Don Nicoloff, [Ken Adachi](#), Todd Fahey, and Anthony Hilder.

Hilder allegedly retired from the CIA to produce low-budget poor-quality films that have discredited several conspiracy stories and their analysts, as per the agency’s intent.

Doug Millar, claimed by Gunderson to be “[the nation’s expert on Aquino](#),” and his Temple of Set, likewise discredits himself, and Gunderson too, by writing aimlessly about Gunderson’s targets. A good example is his “review of Michael Aquino’s letter to Ted Gunderson,” that Ott posted on his “[LabVirus.com](#)” website, including White’s limp rebuke of Hartwell. The confusing dribble captiulates suckers only, as intended.





Millar defamed Dr. Leonard Horowitz, the co-author of this report, at a Conspiracy Conference in 2010, falsely accusing him of being knighted by the Pope, even though Millar knew that his collaborators, Szymanski and Ott, had sourced the false claim, and a fraudulent Knights of Malta list upon which the allegation was based.

If, according to Gunderson and his agents, Aquino and his satanic church is public enemy number one, then Aquino's history, actions, and connections are keys to determining what is happening to America's abducted children, and even the dysfunction within the Department of Justice (DoJ). But Aquino's indictment has remained grossly neglected by Gunderson, several prosecutors and courts, and Gunderson's band of secret agents.

This is why double-agency propaganda is the only way to reconcile the weak, conflicting, and confusing exposures Aquino has received from Gunderson's group, DoJ officials, and the mainstream media.

## **Geraldo Rivera Interviews Gunderson and Aquino**





Michael Aquino appeared with Gunderson on [NBC's Geraldo in 1989](#), when Gunderson contradicted himself, lamely excused police and FBI officials for doing nothing about the satanic child trafficking network, and made extremely nervous eye movements that experts say evidences lying.

Viewed in retrospect as a propaganda piece, Gunderson and Aquino play “good cop/bad cop” to muddle the horrifying facts, and cover-up the organized crime network.

Rivera asked Gunderson, “Is there a network of satanic murderers in this country?”

Gunderson replied, “I cannot say that there is a network of satanic murderers.”

Then he contradicted himself:

“I can say that based on information furnished to me by confidential sources and informants, based on interviews with dozens of survivors from the satanic operations through the years, satanic beliefs, etc., I can say that there is a network of these people across the country who are very active. They have their own rest and relaxation farm, they are in contact with each other. It ties in loosely with the drug operation, it ties into motorcycle gangs, and it goes on and on. They have their own people who specialize in surveillances, photography, and assassinations.”



Later in the show, Geraldo questioned Gunderson, “Do you believe sir, that these dreadful allegations of babies being sacrificed are true?”

Gunderson returned, “I absolutely believe it, without any doubt, based on the information that’s been given to me across the country by numerous survivors and by confidential sources and informants.”

## The “Good Cop/Bad Cop” Scam



Aquino then discredited Gunderson by playing the “bad cop.” In the CIA, the Temple of Set founder is actually Gunderson’s MKULTRA boss.

Aquino berated Gunderson, “Then why don’t you name these people and arrest them. Never a name. Never an arrest. These woman come out of a group, and they insist that they know the people in the group, and yet they do not identify these large mysterious cults. Name them, and arrest them, and get them off the street.”

Aquino was costumed to look like a cartoon character in devil’s attire. He was immediately and subliminally discredited, even though he asked crucial common sense questions.

The staged broadcast was a mind-trip for public deception. Geraldo, allegedly neutral, turned to Gunderson and asked, “Does he [Aquino] not make a valid point?”

Gunderson responded with a bunch of silly excuses. “He makes a valid point. The problem with that is number one, police officers don’t believe it, I may believe it. You may believe it, and some people in your audience may believe it. They don’t believe it.”

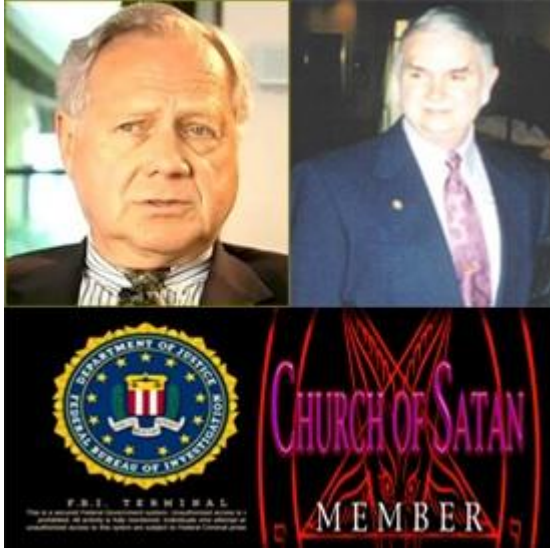


Gunderson's statement was ridiculous, given his FBI director's job required oversight of nearly 700 personnel, each of whom required professional training to follow his orders.

Gunderson continued, “. . . If you decide to investigate these people, you have to number one, handle it from an undercover operation. If you put an undercover operation into effect, then you have in a sense your own police officers becoming involved in these heinous crimes, and they of course become murderers. And in addition to that, if you decide to investigate these people, that's a lot of work, and many law enforcement officers are apathetic and don't want to get involved.”

This, too, violates common sense, television, film, and law enforcement, wherein federal agents and spooks go undercover routinely to safely and effectively investigate, indict, and jail criminals.

**New Evidence the “Franklin Cover-up” Was A CIA Black-op**



Gunderson's letter sparks new interest in his reported links to Church of Satan/Temple of Set official Aquino, who is widely feared as America's Joseph Goebbels—the leading propagandist for the U.S. Army, and a psychological warfare expert working for the CIA.

Aquino broke from Church of Satan founder Anton LaVey in 1975 to establish the Temple of Set, linked by solid evidence to The Church of Scientology and the U.S. Army. At the time, Aquino was a Lt. Colonel in the Army, stationed at San Francisco's Presidio. He was identified by several children among more than sixty victims of pedophilia, vaginal sex, sodomy, and oral copulation, but was inexplicably acquitted.

In advancing the Temple of Set, Aquino attracted nearly thirty Church of Satan members and officials including Diana Rively's daughter, briefly Gunderson's daughter-in-law, Zeena LaVey.



On April 30, 1990, Zeena formally denounced her ties to father Anton, after the Church of Satan leader set her up to be sexually molested by a recognized stalker. Zeena then pledged her allegiance to Aquino and his Temple of Set.

Freelance writer Jeffrey Steinberg [covered the story](#) about satanism and pedophilia in the U.S. military during the infamous "Franklin Cover-up" case heard by the U.S. District Court in

Lincoln, Nebraska. During its February 5, 1999, hearing, “Paul Bonacci claimed that he had been ritualistically abused by Lawrence E. King, as part of a nationwide pedophile ring linked to powerful political figures in Washington, and to elements of the U.S. military and intelligence establishment.”

“On February 27, Judge Warren K. Urbom ordered King to pay \$1 million in damages to Bonacci, in what Bonacci’s attorney, John DeCamp, said was a clear signal that ‘the evidence presented was credible,’” Steinberg reported.

### **John DeCamp’s CIA Service in the Army**



John DeCamp, author of the Franklin Cover-up, is a Gunderson ally, former Henry Kissinger/William Colby subordinate, and a retired Nebraska Senator. Like Aquino and Gunderson, DeCamp worked for the CIA. The U.S. Army assigned DeCamp to serve Colby, the Director of Central Intelligence, during the Nixon era. Colby, with DeCamp, ran the Phoenix Program that involved assassinations and torture.

As the Vietnam War was winding down, with dissidents on the rise, and the media devastating public confidence in government and the military, Aquino and Colby, assisted by DeCamp, refined psychological warfare black ops for “The Company,” especially leveraging the media for controlling opposition.

Their new form of media manipulation for mass mind control advanced the top secret MKULTRA program. The Vietnam War brought horrific bloodshed into people’s living rooms for the first time. Aquino and Company realized that to sedate public opinion and win

propaganda wars, the media had to be leveraged to “spin” stories, minimizing horrors and discrediting opposition.

Given this new information, it is obvious the 1999 case in the “Boys Town” State was a “Franklin Double Cover-up”—a black-op, or side show, directed by The Company to camouflage or minimize more widespread crimes against children, but leave the impression that the Justice Department operates effectively.

The proceedings and story was controlled nearly as well as Aquino’s conduct and bad press throughout his long criminal career as the CIA/MKULTRA/Church of Satan/Temple of Set director.



“This is a lesson in how the CIA/FBI’s counter-intelligence program (i.e., COINTELPRO) operates to control opposition, and is the only way to reconcile Gunderson’s and his group’s behavior—lamey protesting government corruption, while limply indicting the Illuminati, the CIA, and Aquino’s satanic child-trafficking network,” said Dr. Horowitz, a Harvard trained behavioral science expert, libeled by Gunderson’s agents across the Internet. “This illustrates how modern propagandists serve to confuse people, discrediting all sources of intelligence, to generate general apathy. This is precisely how Gunderson—a professional mind-controlled disinformation agent, hypnotized to feign activism and spread government hate—infiltrated the grassroots with his team of agents to generate fear, controversy, and apathy, thus securing the CIA’s entire rogue operation that is kidnapping and killing children,” Dr. Horowitz concluded

## Controlled Opposition: The Primary Propaganda Ploy

It can now be seen that the utility of the Franklin Double Cover-up was to create and control opposition to pedophilia, sex slavery, and child-trafficking. The case served to localize and minimize the widespread child trafficking operation. It was a decoy that purposely fell short of exposing the widespread network of pedophiles, its criminal administrators, and the CIA/FBI's black-op scheme providing propaganda cover for the entire operation.

A more recent example came from a West Hawaii Today (April 21, 2011) feature story. It read, "Two W. Hawaii farms named in human trafficking suit." The article concerned two farms that were named in a lawsuit by the U.S. Equal Employment Opportunity Commission for abusing 200 Thai men.



"What about the thousands of abducted children disappearing every year?" co-author Kane asked. "The CIA-controlled mainstream media generates its own controlled opposition. 200 men get attention in Hawaii. DeCamp's cover-up in Nebraska gets attention. But not Aquino's involvements in the national child-trafficking network that is abducting thousands of children annually."

## The Gang Behind Johnny Gosch's Kidnapping

Noreen Gosch, mother of famous abductee [Johnny Gosch](#), gave sworn testimony linking the CIA's Aquino to the national network of pedophiles neglected by the FBI.





The Justice Department touts its collection of data on missing children, and the FBI's forensic lab reports administered by, believe it or not, Target stores.



Incredibly, besides serving FBI forensics, Target co-owns the "LifeTouch" Company that publishes all public school yearbooks, providing a virtual menu of children for pedophiles, CIA/FBI agents included, and the sex slavery ring targeting youngsters.



This FBI/Target/LifeTouch operation additionally evidences the Justice Department's gross neglect of conflicting interests, abductee data analysis, and reasonable intervention by internal affairs, all of which strongly suggests higher level CIA involvement in extremely well organized crimes against America's families and children.



The Court learned that Johnny Gosch disappeared in 1982 while delivering newspapers. Kept from the Court, however, was a photograph of Johnny, allegedly standing near George H.W. Bush.

The photo's source was Gunderson's crony, Timothy Patrick White. Gunderson's team circulated the photo claiming Bush was the network's sex slave client. The trouble is, White is a convicted felon, and the web's leading rogue CIA agent provocateur. So no one believes him, or by association, the legitimacy of the photo. The story is generally dismissed as a conspiracy theory. Mission accomplished.



Noreen Gosch testified in DeCamp's case that the satanic pedophile network, "was an offshoot of . . . [t]he MKULTRA program . . . developed in the 1950s by the CIA. . . . There was a man by the name of Michael Aquino. He was in the military. He had top Pentagon clearances. He was a pedophile. . . . He was a close friend of Anton LaVey. The two of them were very active in ritualistic sexual abuse. And they deferred funding from this government program to use [in] this experimentation on children."

Where is the American "free press" when you need it? Censored by the CIA and payoffs from organized crime.

### **Johnny Gosch or Jeffrey Gannon: The CIA's Plame Scandal**



Evidence issued by the mainstream media, including the [New York Times](#) and MSNBC, indicates Jeff Gannon (a.k.a., Jeff Guckert, James Guckert, and "Bull Dog")—identifying [a gay porn "military stud" in the White House](#)—served George H.W. Bush and Republican officials by [administering a fake](#) story and news agency that leaked the identity of CIA-agent Valerie Plame. The CIA scandal that compromised her career began when Plame's husband, U.S. Diplomat Joseph C. Wilson, embarrassed Bush by discrediting his claims Iraq had developed nuclear weapons. The leak appears to have been a payback.

A [glaring hypocrisy](#) in this story grossly neglected by the media is that Republicans opposing gay marriage, and homosexuals serving in the military, delegated their dirty tricks to the gay porn site entrepreneur supposedly named Gannon, that could be Johnny Gosch.

“The unqualified [Gannon] was so much a part of the White House Press Corps,” wrote [Wayne Besen](#), author of the book,



Anything But Straight: Unmasking the Scandals and Lies Behind the Ex-Gay Myth, “he reportedly was given a classified CIA memo that outed Plame.”

“You’ve got to hand it to this [Bush] White House,” Besen concluded. “When they couldn’t get the media to buy their spin, they bought the media. Now, when they couldn’t get the media hook they desired, they simply got a hooker.”

Hooker Gannon, however, as reported by [MSNBC](#), may be Johnny Gosch, although a DNA test, unlikely forthcoming, is required to prove it.

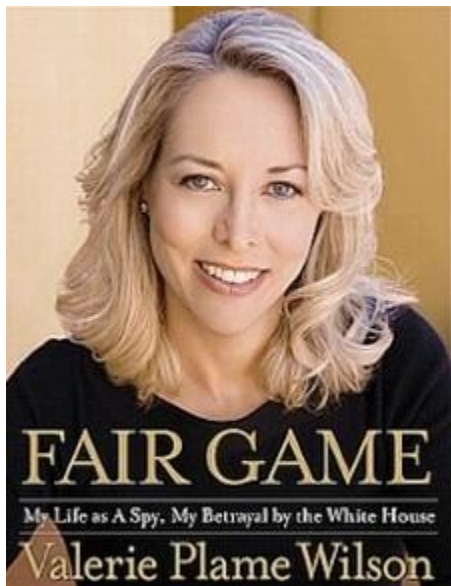
[Sherman Skolnick](#), who exposed bribery within the Illinois court system in the late 1960s, in a corruption scandal that led to the indictment of former Gov. Otto Kerner, posted intelligence provided by his reputable group of investigators who had been tracking “the operation of the male prostitution ring in Omaha (Boys Town), Chicago, and the District of Columbia.” (See: [Rense.com](#), Feb. 28, 2005.) He wrote that Gannon/Gosch was an “expert penetration agent” compiling scandalous sex data on U.S. and foreign governmental officials.



For example, Skolnick reported, fourteen members of the House and Senate used the Gannon/Gosch “warehouse service” with at least two members of the Federal Reserve Board. Congressional members, mostly Republicans, and George Bush, Sr., administered these affairs to secure loyalties, according to Skulnick’s sources.

#### Evidence Linking Johnny Gosch to Jeffrey Gannon is Muddled by the CIA for Bush and Satanic Network Protection

Despite confusion over the identities and activities of Gosch and Gannon, both stories feature CIA sex trafficking scandals with stories that were certifiably “planted” by Gunderson’s group of MKULTRA propagandists, implicating Aquino, DeCamp, and the Bush family and others.



Despite being the world’s leading experts on Gosch and the child trafficking network that disappeared him, Gunderson neglected using the mainstream

media attention the Valerie Plame Affair brought, as an opportunity to expose these horrific satanic pedophilia crimes. Gunderson and his agents instead avoided Plame's compromise by Gannon like a plague. Their rantings exclusively focused on confirming and heralding, as though celebrating, the supposed Gosch/Gannon single identity without DNA testing or definite confirmation. More muddling of the scandal resulted.

Gunderson in a rare mention of Plame, nearly slipped, but caught himself, in stating that the leaked document came from Bush. Gunderson said, ". . . her husband made an uncomplimentary remark about George Bush and that Bush gave, —exposed these people through Jeff Gannon, . . ." The broken statement was made to talk show host, [Alex Merklinger](#) (March 8, 2005).

## **Rense.com Provides Platform for Propagandists**



Two other Gunderson aides, Szymanski and White, contributed to the speculation, falsely claiming confirmation, of the single Gosch/Gannon identity. Szymanski, the CIA/FBI forger cited earlier, issued through Rense.com a [lengthy ridiculous tale](#) of David Johnson-Holm's abuse by his kidnappers. David, Gosch's fellow abductee, is shown below in the photo next to Johnny.

Jeff Rense published Szymanski's embarrassingly poor writing, presented to discredit its author and content, while Rense has consistently rejected Kane and Horowitz's reports exposing these operatives and their COINTELPRO operations. (All other previous reports by Horowitz and Kane were posted immediately by Rense, whose limited censorship he attributed to his fear of retaliation by Gunderson's group of agents.)



Rense also published a [coherent and well-edited statement by White](#) (allegedly), authorized by Gunderson, claiming “100% Confirmation” that Gannon is Gosch. The trouble is, White has never written well, or coherently, anywhere on the Internet in dozens of postings. Add to this uncertainty of authorship, White’s felony conviction, his participation in trafficking drugs and arms, his sourcing the Bush/Gosch photograph, his harassment and libel of these authors and others, plus Gunderson’s “100% Confirmation” of the single Gosch/Gannon identity that was sourced anonymously, and the only certainty is this crime network’s intention to sell fear, confusion, and discrediting information, to the public.

It appears certain that these FBI/CIA agents leaked these photos of their abductees as an intended form of terrorism

## **Filmmaker Thompson Kills Himself After Bonacci Claim**

[Besen](#) also reported that the famous American journalist and rumored snuff filmmaker, [Hunter S. Thompson](#), shot himself hours after Bonacci revealed that Gannon was Johnny Gosch. Thompson is credited for creating “Gonzo Journalism”—a style of reporting where reporters involve themselves in the action to such a degree that they become central figures of their stories.





**John Kerry and High Priest of the Church of Satan Anton Le Vey - S. F. Chron. - 1983**

[Bonacci](#) was forced by the satanic child traffickers to rape Gosch, and participate in murder, homosexual pedophilia, and a necrophilic orgy. He testified in the Nebraska court that these actions were videotaped by “Hunter Thompson,” at a location later identified as the Bohemian Grove. Hours after the Gosch/Gannon single identity announcement, Thompson typed the single word “[COUNSELOR](#)” on his typewriter, then shot himself in the head, according to police. The message conceivably references Counselor DeCamp, or even Massachusetts Senator, John Kerry, who attended Thompson’s funeral.

John Kerry participated in Thompson’s “Fear and Loathing, Campaign 2004,” Thompson’s account of the road trip he took with Kerry during his presidential campaign. This was Thompson’s final magazine feature.

The fraudulent doctored photo of Kerry with Church of Satan founder, Anton LaVey, shown above, is another example of how COINTELPRO creates and disseminates falsehoods to confuse everyone about everything. The fact that this forged photograph is a fraud does not encourage faith in Kerry. Quite the opposite. The action smacks of an intelligence operation to muddle matters implicating Kerry’s probable knowledge of, and/or involvement in, the satanic child trafficking network.

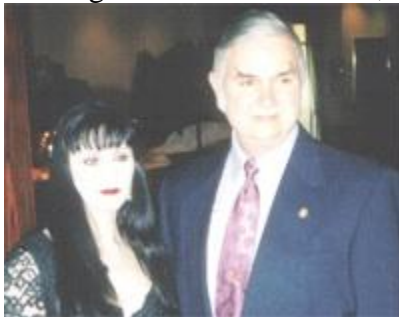


Reporter Steinberg also noted that, “The U.S. Attorney in San Francisco handling the [Presidio’s pedophilia] case was Joseph Russoniello. Russoniello would later be identified by reporter Gary Webb (of the San Jose Mercury News) as a player in the Contra cocaine smuggling operation led by Lt. Col. Oliver North and company.”

According to Hartwell and others, Aquino, Gunderson, and White were, likewise, involved in the Iran Contra affair under Ronald Reagan, trading arms for drugs.



“In May 1989, Aquino was again questioned in connection with child abuse investigations,” Steinberg continued. “[T]his time, at least five children in three cities were making the accusations. The children had seen Aquino in newspaper and television coverage of the Presidio case, and immediately recognized him as one of their abusers...”



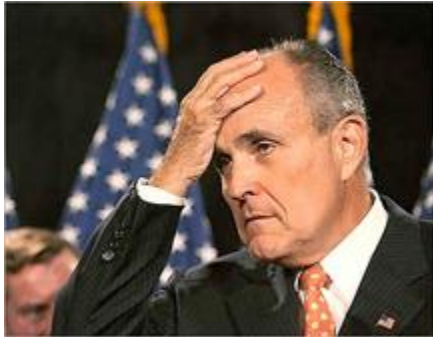
“Aquino was also identified by children in Santa Rosa and Fort Bragg, California. In the Fort Bragg case, ‘allegations of ritual abuse erupted... in 1985 when several children at the Jubilation Day Care Center said they were sexually abused by a number of people at the day care center and at several locations away from the center, including at least two churches.’ Aquino was identified as having been present at one of those churches...”

“The Mercury News reported, ‘by November, 1987 the Army had received allegations of child abuse at 15 of its day care centers and several elementary schools. There were also at least two cases in Air Force day care centers,’ and another in a center run by the U.S. Navy.

“In addition, ‘a special team of experts was sent to Panama [in June 1988] to help determine if as many as 10 children at a Department of Defense elementary school had been molested and possibly infected with AIDS.’

“Yet another case emerged in a U.S.-run facility in West Germany.

“These cases erupted at some of the country’s most esteemed military bases, including Fort Dix, Fort Leavenworth, Fort Jackson, and West Point. Many of those making the accusations were career military officers who had devoted their lives to unquestioned allegiance to the U.S. armed forces. Many would resign their posts in outraged protest...



“The Mercury News [continued], ‘by the end of the year, 50 children had been interviewed by investigators. Children at West Point told stories that would become horrifyingly familiar. They said they had been ritually abused. They said they had had excrement smeared on their bodies and been forced to eat feces and drink urine. They said they were taken away from the day care center and photographed.’

“Despite abundant medical and psychological evidence and literally dozens of child witnesses, and despite ‘950 interviews by 60 FBI agents assigned to the investigation,’ the investigation, ‘led by former U.S. Attorney [and future mayor] Rudolph Giuliani’ (of 9/11 infamy) produced ‘no federal grand jury indictments,’ according to the Herald Record...” (See Steinberg’s full report [HERE](#).)

## **Alex Jones Also Involved in the Franklin Double Coverup**

In a [personal letter](#) to Kane, Hartwell explained how Gunderson's reach extended to Alex Jones and Genesis Communications Network (GCN) officials. She learned this the hard way during an interview with Jeremy Floyd. While Floyd and Hartwell were broadcasting revelations about Gunderson and DeCamp, Jones called repeatedly to stop them.



The Floyd Report host complained, “This Ted Gunderson issue is so hot that Alex Jones called me 3 times in a 40 min period to get me to stop [interviewing Hartwell].”

Besides indicting Jones, Floyd wrote that Michael Trudeau, the Vice President of GCN, supported the censorship.



The day after the show, Hartwell wrote, “I exposed for the first time on radio . . . that John DeCamp was in fact involved in the pedophilia, child sex abuse, and blackmailing of politicians in the Franklin case. I confronted Ted Gunderson with what I knew in November, 1999 . . . and at that time Gunderson admitted to me that he knew of DeCamp’s involvement. That was the beginning of the end of my association with Ted Gunderson, as I could not in good conscience continue to endorse him, or work with him.”



In protesting her censors, Hartwell wrote that “Alex Jones has proven himself to be a liar, a bully, a false patriot, a scamster and a shill; not just to me, but to many others who have been targeted for Jones’s censorship and intimidation tactics.”

After Hartwell told listeners on the GCN broadcast with Floyd about Gunderson’s marriage to Rively, Floyd claimed that Jones forbid him from ever communicating with Hartwell again. The next day Floyd quit working for Genesis.

Critics complain that Alex Jones continues to endorse Gunderson and DeCamp, despite knowing the larger truth about them pertaining to child trafficking, sex crimes, and ritual murders.



Other broadcasters have openly protested Gunderson's and Jones's power to suspend them on networks besides Genesis. These include Jeff Rense, broadcasting now on American Freedom Radio Network (AFRN), and Art Bell, previously with Premier Radio Network.

## **More Gunderson and Jones Dirty Dealings**

Gunderson is widely known for having libeled Coast to Coast[AM] celebrity host, Art Bell, forcing his early retirement from broadcasting. Bell disclosed that on May 16, 1997, his son was kidnapped and raped. The assailant was HIV positive. The pedophile was tried, convicted, and is now serving a life sentence.



But Gunderson, along with David Hinkson, the developer of WaterOz, who threatened to ruin Bell over an advertising fracas, then aired a broadcast that twisted Bell's kidnapping, falsely claiming Art Bell had committed the molestation. Gunderson's hit squad further libeled Bell, claiming he had paid to cover up a criminal indictment, and urged listeners to call Bell "on air" to ask if he had been indicted. Bell retired shortly thereafter.



Hickson was later [sentenced to 43 years in prison for numerous crimes](#), including a “murder-for-hire plot,” and false labeling and advertising of WaterOz, his mineral product containing colloidal silver.



A related fraud occurred in 2009 with Gunderson’s agents increasing their attacks on Dr. Horowitz and his [528](#) resonating silver hydrosol—[OxySilver](#). The doctor had been advertising OxySilver with Alex Jones, with Jones promising a program explaining 528Hz frequency and its revolutionary use in the hydrosol as an alternative to toxic antibiotics and deadly vaccines. Suddenly, at the height of the Swine Flu fright, the show was nixed, and 528 advertising for OxySilver was suspiciously delayed for 5 weeks, during which time Jones’s staff provided a series of [unreasonable excuses](#).



Then Horowitz [learned](#) that Jones, famous for bashing government officials for genocide, had contracted to advertise [Silver Sol](#), a competitor to [OxySilver](#), produced by American Biotech Labs and Clifton Mining Company, on whose Board of Directors sat top medical officials in the Dept. of Homeland Security and FEMA.

Additional inquiries proved Jones’s sponsors had committed consumer fraud, and even scientific fraud, by altering an electron micrograph for advertising to simulate Dr. Horowitz’s research on [528Hz](#) healing technology.

## Gunderson's Infamy in the McMartin Crime Investigation



Gunderson showed up at a crime scene where pre-schoolers had been sexually abused by teachers at the McMartin Pre-School in Manhattan Beach, CA. He then befriended one of the mothers, Jackie McGauley, whose child had been molested.

McGauley claimed that Gunderson poisoned her. She got sick shortly after his arrival, and remained ill the entire time he was living with her.

In an [open letter](#) to Barbara Hartwell, McGauley wrote, "I was ill the entire time Gunderson was in my house. The first week I contracted a rare form of influenza called Psytocosis, then severe fatigue and pain. I once found a substance (like motor oil) in my wall heater and caught Ted putting eyedroppers full of an unknown substance in my coffee."

Jackie McGauley is not the only one who reported life-threatening experiences with Gunderson. Others, mostly woman, came forward over the years to charge Gunderson with various offenses, including an attempted murder, reported by investigative journalist, Janet Phelan.

According to Phelan, "Gunderson deployed chemical assassination weapons against [her]."

“This pattern is seen over and over again,” [Sherri Kane](#) concluded after reviewing hundreds of pages of complaints against Gunderson by dozens of authors online. She noted a pattern: “Women journalists report black-ops involving the CIA, and then Gunderson, White, and their allied agents, each using several aliases, attack them on the Internet for damage control. They demonize, harass, and attempt to discredit the messengers, rather than refuting the messages.”

# Prosecutor: Private eye was tortured in Mexico

SAN DIEGO — A private investigator who vanished two years ago was kidnapped in Mexico, tortured with pleas for five days and murdered on orders from his former girlfriend and boss at an alternative cancer therapy business, a prosecutor said Friday.

But the woman's attorney said the private investigator had died, and is holding the ransom more than \$1 million from the alternative therapy business.

Kimberly Bailey, 33, who was deported from Mexico City and arrested last month, is charged with the federal crime of conspiracy to murder a person in a foreign country. The private investigator, Rick Post, vanished in August 1996.

Bailey also attempted to hire a federal agent posing as a hitman to kill three other people in December, Assistant U.S. Attorney Barbara Major said during a bond hearing in federal court.

"The defendant is someone who believes she can resolve matters that bother her in some way by having people killed," Major said.

U.S. District Judge Cynthia Aaron ordered that Bailey be held without bond while the guilty trial. She faces life in prison if convicted.

Bailey's attorney, James Warner, said that she be released on bond and offered her \$500,000

investigation firm named IntelliSource and was well known in the San Diego legal community, also was a manager for Hishonkara and dated Bailey.

Another employee told Bailey that Post was stealing from the company and was seeing another woman, so she arranged to have him kidnapped Aug. 30, 1996, in Tijuana, Major said.

For five days, Post was held captive, bound and gagged, and tortured with alerts that were applied to his fingers, before he was killed, she said.

His body has never been found. "We don't believe Post is dead," Warner said. "We believe he absconded with a great deal of money and for his own personal reason to chose to stay undercover

for a while."

Authorities charged two other men with helping to kidnap and murder Post. One man, John Krueger, 33, is also being held without bond while the other, Humberto Ibane, 33, remains at large and is believed to be in Mexico.

Bailey made a \$20,000 down payment for the contract killing, Major said.

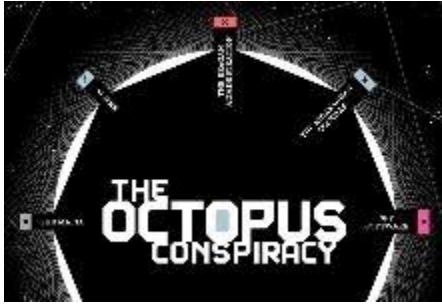

Gunderson wrote the note to Jackie McCauley, complaining about Rick Post. Thus, the side-note should have cited "Jackie," not "Rick."

Did Post or Clark support you and your children for the past year and a half? Come on, how about working with me instead of against me? This was the idea when you quit your job - we were going to work together & both take credit - as a Team".

## Gunderson's Extended Network of the Rich and Infamous



Mounting evidence indicates Gunderson is an extremely dangerous man. In several thorough reports, including an [article](#) by James Orlin Grabbe (deceased), Gunderson worked with a CIA “high-tech genius” named Michael Riconosciuto. This “friend” of Richard Nixon was alleged to be the “developer of the main bomb that blew up the Oklahoma City Murrah Federal Building,” and was a “key CIA figure in the INSLAW scandal that mainly caused the Ruby Ridge Siege,” according to [exhibits in a federal suit](#) filed in Dallas, Texas at the breakout of the Waco Siege. These court records claimed to elucidate “important truths regarding Ruby Ridge and Waco, as well as the ties between them even to the point of showing the ties between the Ruby Ridge, Waco, and Oklahoma City scandals.” Gunderson and Riconosciuto also worked with Robert Booth Nichols (allegedly deceased), the son of John Lear, founder of the Lear Jet Corporation. Nichols, according to [Grabbe](#), and other credible authors, worked for the FBI and collaborated with Gunderson in criminal affairs, including money laundering and narcotics trafficking involving the Yakuza and Gambino crime family.



Gunderson, according to [Hartwell](#) and others, was nefariously involved in exposing Riconosciuto’s connection the “Prosecutor’s Management Information System (PROMIS)” software, designed to help organize the large amounts of paperwork generated by law enforcement and the courts. It was developed by Bill Hamilton, the founder of INSLAW. Hamilton alleged that the Justice Dept. had stolen PROMIS and illegally distributed it, robbing his company of millions of dollars.

Riconosciuto claimed to have modified the software at the Justice Department’s request, so that it could be sold to dozens of foreign governments, with a secret backdoor feature that allowed outsiders to access computer systems using PROMIS. The scam involved Riconosciuto and Gunderson in theft and banking fraud, and was claimed by Hamilton to increase the risk of terrorism and illegal money transfers, including possibly enriching Osama Bin Laden.



Riconosciuto was then set up with 900 pounds of methamphetamine, framed, he claimed, to keep him from exposing the Justice Department's theft. Gunderson testified in his defense, with Riconosciuto ending up in jail.

Gunderson was also aware that Riconosciuto introduced murdered journalist, Danny Casolara, to Nichols. According the book written by Cheri Seymour, [The Last Circle](#), Casolara was in his final stages of investigating an "association of mobsters, government officials, and rogue intelligence figures grown out of a dirty CIA "Old Boy" network that he had dubbed "The Octopus." Casolara told friends that he had in hand significant hard evidence pointing to the connections between INSLAW, Iran-Contra, and the BCCI scandal.

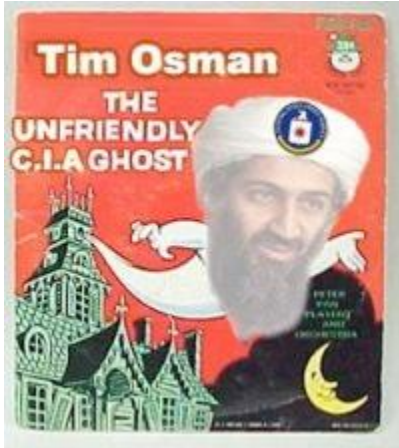
Gunderson was [reportedly scheduled](#) to have met with Casolara the day he died.

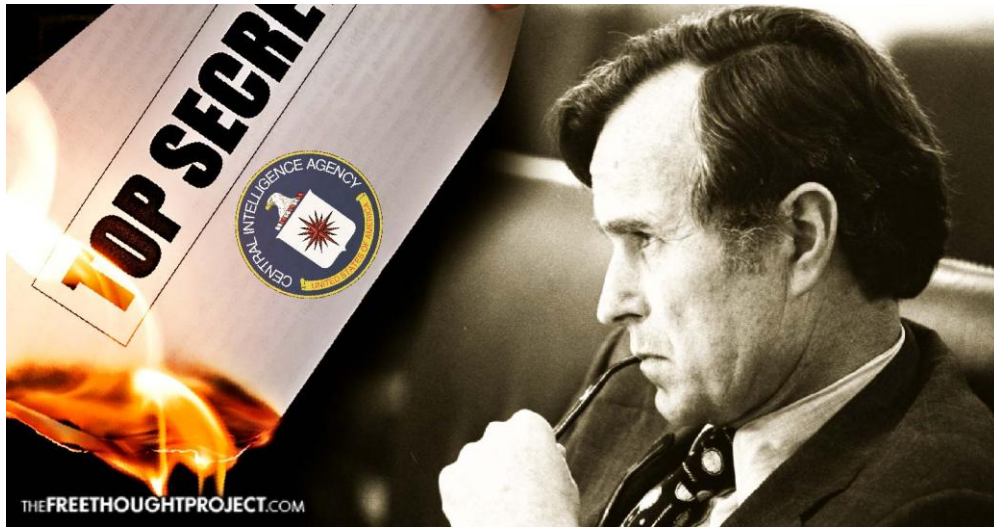

## New Docs Expose Bush Sr. Illegally Destroying Evidence of US Crimes While Head of CIA



Documents recently dredged from the CIA’s massive database expose an effort by the former director to destroy documents evincing the agency’s illegal activities and operations.

That director — George H.W. Bush, who served in the role from January 1976 until January 1977 — went on to become the 41st President of the United States.

As *MuckRock* [reports](#),

*“In 1976, Congresswoman Bella Abzug wrote to CIA Director George H.W. Bush about the existing moratorium on the destruction of CIA files. As the Chairwoman of the Subcommittee on Government Information and Individual Rights, which had jurisdiction over government information policy including FOIA and the Privacy Act, she wanted the moratorium extended — specifically, she wanted to ensure that Congress had time to enact legislation in response to the Church, Pike, and Rockefeller hearings and the resulting reports.”*

Preservation of records — the subject of acrimonious debate during the presidential election, thanks to Hillary Clinton’s use of a private server and disappearing documents — is pivotal to government transparency and accountability. And for preventing alterations and staving off lies.

In a draft response to the congresswoman, the agency originally stated, *“Destruction of Agency material will be in accordance with the recommendations of the President’s Commission on CIA Activities within the United States, Presidential directives and as permitted by law.”*

But edits scribbled on this draft indicate transparency in procedural record-keeping not only didn’t matter to the Central Intelligence Agency, it directly countered Director Bush’s and the agency’s interests.

***“Recommend deletion of bracketed paragraph,”*** “B” penned at the bottom — with brackets specifying the entire aforementioned sentence vowing to remain true to legal strictures.

A strikingly divergent message emerges in the next draft.

*“A decision as to the disposition of those files concerning activities which the President’s Commission considered illegal and improper has not been finalized and the moratorium [sic] on destruction is still in effect.”*

***“You can be assured that whatever action is taken regarding these files will be in the best interests of the individuals involved and the U.S. Government.”***

Ultimately, the agency again flip-flopped for the final draft by including the necessary, *“Destruction of Agency material will be in accordance with Presidential directives and as permitted by law.”*

Bush signed it — but the fact the agency at his behest considered protectionism for itself in writing cannot be discounted.

It could be definitively argued that conspicuous detail marked a brief moment of naked honesty for the CIA — as if the truth of what happens to records of nastier operations momentarily spilled onto the page.

It isn’t as if the CIA — whether headed by Bush or another — never [guiltily](#) concealed its [wrongdoing](#).

Remember the CIA’s abhorrently sadistic torture program? You might — but obtaining the original copy of the report on its nefarious practice won’t be possible. As *The Free Thought Project* [reported](#) on May 17, 2016,

*“[T]he CIA inspector general’s office recently admitted to ‘mistakenly’ destroying their only copy of the classified report. Although CIA Director John Brennan possesses another copy of the torture report, he refuses to send a replacement to the internal watchdog’s office.”*

*“Last summer, the Senate Intelligence Committee and the Justice Department were privately informed that CIA employees at the inspector general’s office had both destroyed the disk and*



*deleted the file containing the full Senate Torture Report. Despite the fact that the Justice Department ordered all copies of the classified document to be preserved, acting CIA Inspector General Christopher Sharpley was unable to locate another copy and eventually informed the Senate Intelligence Committee that his officers has mistakenly ruined their only copies.”*

Award-winning investigative journalist and current editor of *Consortiumnews*, Robert Parry, penned an [article](#) in 2000 concerning a 1976 car bombing in Washington, D.C.’s highbrow Embassy Row — about which the agency created a fake report to throw off the feds and further its own agenda.

*“In early fall of 1976,” Parry wrote, “after a Chilean government assassin had killed a Chilean dissident and an American woman with a car bomb in Washington, D.C., George H.W. Bush’s CIA leaked a false report clearing Chile’s military dictatorship and pointing the FBI in the wrong direction.*

*“The bogus CIA assessment, spread through Newsweek magazine and other U.S. media outlets, was planted despite CIA’s now admitted awareness at the time that Chile was participating in Operation Condor, a cross-border campaign targeting political dissidents, and the CIA’s own suspicions that the Chilean junta was behind the terrorist bombing in Washington.*

*“In a 21-page report to Congress on Sept. 18, 2000, the CIA officially acknowledged for the first time that the mastermind of the terrorist attack, Chilean intelligence chief Manuel Contreras, was a paid asset of the CIA.”*

Parry’s in-depth [investigation](#) skips too far from the topic-at-hand to recount here, but those opening paragraphs sufficiently summarize the agency’s attitude toward covering up illegal and worse activities — not to mention how it attests Bush’s character and ethics.

It seems reasonable for certain government agencies to maintain a degree of secrecy with information sensitive to national security — however, citing national security has written the permission slip for innumerable State wrongs and inexcusable encroachment on individual freedoms and liberties.

### **Jack Crichton, Stage Manager**

If Poppy Bush was busy on November 22, 1963, so was his friend Jack Crichton. Bush's fellow GOP candidate was a key figure in a web of military intelligence figures with deep connections to the Dallas Police Department – and as previously noted, to the pilot car of JFK's motorcade.

Crichton came back into the picture within hours of Kennedy's death and the subsequent arrest of Lee Harvey Oswald, when a peculiar cordon sanitaire went up around Marina Oswald. The

first to her side was Republican activist and precinct chairman Ilya Mamantov, a vociferous anti-Communist who frequently lectured in Dallas on the dangers of the Red menace.

When investigators arrived, Mamantov stepped up as interpreter and embellished Marina's comments to establish in no uncertain terms that the "leftist" Lee Harvey Oswald had been the gunman – the lone gunman – who killed the president.

It is interesting of course that the Dallas police would let an outsider – in particular, a right-wing Russian émigré – handle the delicate interpreting task. Asked by the Warren Commission how this happened, Mamantov said that he had received a phone call from Deputy Police Chief George Lumpkin. After a moment's thought, Mamantov then remembered that just preceding Lumpkin's call he had heard from Jack Crichton.

It was Crichton who had put the Dallas Police Department together with Mamantov and ensured his place at Marina Oswald's side at this crucial moment.

Despite this revelation, Crichton almost completely escaped scrutiny. The Warren Commission never interviewed him. Yet, as much as anyone, Crichton embodied a confluence of interests within the oil-intelligence-military nexus. And he was closely connected to Poppy in their mutual efforts to advance the then-small Texas Republican Party, culminating in their acceptance of the two top positions on the state's Republican ticket in 1964.

During World War II, Crichton had served in the Office of Strategic Services, the predecessor of the CIA. Postwar, he began working for the company of petroleum czar Everette DeGolyer and was soon connected in petromilitary circles at the highest levels. A review of hundreds of corporate documents and newspaper articles shows that when Crichton left DeGolyer's firm in the early fifties he became involved in an almost incomprehensible web of companies with overlapping boards and ties to DeGolyer. Many of them were backed by some of North America's most powerful families, including the Du Ponts of Delaware and the Bronfmans, owners of the liquor giant Seagram.

Crichton was so plugged into the Dallas power structure that one of his company directors was Clint Murchison Sr., king of the oil depletion allowance, and another was D. Harold Byrd, owner of the Texas School Book Depository building.

A typical example of this corporate cronyism came in 1952, when Crichton was part of a syndicate – including Murchison, DeGolyer, and the Du Ponts – that used connections in the fascist Franco regime to acquire rare drilling rights in Spain. The operation was handled by Delta Drilling, which was owned by Joe Zeppa of Tyler, Texas – the man who transported Poppy Bush from Tyler to Dallas on November 22, 1963.

It was in 1956 that the bayou-bred Crichton started up his own spy unit, the 488<sup>th</sup> Military Intelligence Detachment. He would serve as the intelligence unit's only commander through November 22, 1963, continuing until he retired from the 488<sup>th</sup> in 1967, at which time he was awarded the Legion of Merit and cited for “exceptionally outstanding service.”

## **Gimme Shelter**





Besides his oil work and his spy work, the disarmingly folksy Crichton wore a third hat. He was an early and central figure in an important Dallas institution that is virtually forgotten today: the city's Civil Defense organization. Launched in the early 1950s as cold war hysteria grew, it was a centerpiece of a kind of officially sanctioned panic response that, like the response to September 11, 2001, had a potential to serve other agendas.

So avid and extensive was the Dallas civil defense effort that the conservative radio commentator Paul Harvey singled it out for special praise in his syndicated column in September 1960: "The Communists, since 1917, have sold Communism to more people than have been told about Christ after 2,000 years," Harvey wrote, a sentiment common in rightist circles of the era.

But they got their converts one at a time. You and I can 'convert' two others to become militant Americans this week . . . That's precisely the nature of the counterattack that has been mounted in Dallas.

Early in 1961, Crichton was the moving force behind a cold war readiness program called "Know Your Enemy," which focused on the Communist intention to destroy the American way of life. In October 1961, Dallas mayor Earle Cabell introduced a short documentary *Communist Encirclement - 1961*. Afterward, the *Dallas Morning News* wrote that the Channel 8 switchboard was "flooded . . . with calls from viewers lauding the program, which deals frankly with Communist infiltration."

So great was the sense of alarm that at the 1961 Texas State Fair in Dallas, 350 people per hour made their way through an exhibitor's bomb shelter.





In April 1, 1962, Dallas Civil Defense, with Crichton heading its intelligence component, opened an elaborate underground command post under the patio of the Dallas Health and Science Museum. Because it was intended for “continuity-of-government” operations during an attack, it was fully equipped with communications equipment.

With this shelter in operation on November 22, 1963, it was possible for someone based there to communicate with police and other emergency services. There is no indication that the Warren Commission or any other investigative body or even JFK assassination researchers looked into this facility or the police and Army Intelligence figures associated with it.

On November 22, Crichton suggested Mamantov to the police department as the ideal person to interpret for Marina. His basis for knowing this was that in his role in military intelligence he maintained surveillance of Russians in Dallas, working closely in this regard with the police department.

Marina’s statements through Mamantov would play a crucial role in starting a chain of events that could have led to a U.S. missile strike on Cuba. In the hours following Kennedy’s assassination, the Dallas Police Department passed along information purportedly gleaned from Marina Oswald that suggested possible ties between her husband and the government of Cuba.

Though the information would turn out to be wrong, it was quickly passed to Army Intelligence, which then passed it along to the U.S. Strike Command at MacDill Air Force Base in Florida, the unit that would have directed an attack on the island had someone ordered it in those chaotic first hours after Kennedy’s death. That this sequence of events took place is confirmed by the original Army cable from military intelligence in Texas, declassified a decade later. What is not clear is how close matters ever got to zero hour.

A key element in this tangled tale is the little-appreciated overlap between the Dallas Police Department and Army Intelligence. As Crichton, who has since died, would reveal in a little-noted oral history in 2001, there were “about a hundred men in that unit and about forty or fifty of them were from the Dallas Police Department.”

Thus Crichton was a crucial figure linking many seemingly disparate elements: military intelligence, local police, the GOP, the White Russians, the oil community, George de Mohrenschildt, and Poppy Bush.

### **The Poppy and Jack Show**

In the fall of 1963, about two months before JFK's assassination, the two political neophytes Jack Crichton and George H.W. Bush both decided to mount GOP races for statewide office. The following year, they would head the Texas GOP's ticket, with Crichton the nominee for governor and Bush for U.S. Senate. Both used the same lawyer, Pat Holloway, who worked out of the Republic National Bank Building.

The man who recruited them as candidates, state GOP chairman Peter O'Donnell, would several years later be forced by newspaper revelations to admit that his family foundation was a conduit for CIA funds.

Thus in November 1963, Bush and Crichton were essentially working in tandem. Given that alliance, Poppy would need to explain not only where he was on November 22 and why he tried so hard to hide that, but also what he knew about Crichton's activities that day and about Crichton's Army Intelligence colleagues in the pilot car of the motorcade.

In his oral history, Crichton couches his relationship with Bush in benign and casual terms. He says that he and Poppy "spoke from the same podiums and got to be fairly good acquaintances." Their appearances on behalf of the Texas Republican Party evolved into a private friendship that continued over the years. "When he was head of the CIA, I called him one day and I said, 'George, I'm coming to Washington, would you have time to play tennis?' And he said 'Yeah.'

He said, 'How would you like to play at The White House?' And I said 'Man, that'd be a real deal.' So he said, 'Well, I'll have you a partner.'

## **A Crime of Commission**

The Warren Commission's official mandate had been to conduct "a thorough and independent investigation" of the assassination. However, along with subsequent investigative bodies, it failed to assemble, much less connect, even the most obvious of dots. Virtually everybody on the commission was a friend of Nixon's or LBJ's – or both.

The members shared another characteristic: they were, almost without exception, from the conservative establishment and definitely not Kennedy admirers who would have gone to any length to find the truth about JFK's death. Along with Allen Dulles, members included Republican congressman Gerald Ford and John J. McCloy, a top operative for the Rockefeller family.

No doubt coincidentally, McCloy had been best man at the wedding of Henry Brunie, head of Empire Trust, which employed Jack Crichton and invested in de Mohrenschildt's Cuban oil project.

Transcripts of the panel discussions produce a sense that the commission members and investigators were either incredibly naïve or else walking on eggshells. At an early executive session, Earl Warren told his colleagues, "We can rely upon the reports of the various agencies . . . the FBI, the Secret Service, and others."

But commission member Senator Richard Russell, a conservative Georgia Democrat who headed the Armed Services Committee on which his friend Prescott Bush had served, made at least a brief stand.

"I hope," he said, "that you'll get someone with a most skeptical nature, sort of a devil's advocate, who would take this FBI report and this CIA report and go through it and analyze every soft spot and contradiction in it, just as if he were prosecuting them."

Many were already wondering whether CIA personnel might themselves know something about the assassination and how helpful they would be to the investigation. In one executive session, Russell turned to Dulles and expressed his doubts about Dulles's compatriots:

I think you've got more faith in them [the CIA] than I have. I think they'll doctor anything they hand to us.

During the commission's investigation, Dulles and his colleagues sometimes traveled to Dallas, especially to hear witnesses who could not come to Washington. When they did, they set up their temporary conference room in the boardroom of the Republic National Bank. The decision to do so is revealing, if nothing else than of a striking lack of concern for appearances.

The Republic National Bank board was wired into the heart of the anti-Kennedy elite. The bank building itself stood out from other Dallas towers as an important symbol: the headquarters of Dresser Industries and of a number of corporations, law firms, and trusts connected with the Central Intelligence Agency, as well as being the building in which de Mohrenschildt himself had had offices.

### **A Fascinating Tan**

Members of the commission were often absent during testimony. But George de Mohrenschildt's appearance caused a stir. Among those present were Dulles, Ford, McCloy, and two commission attorneys. As de Mohrenschildt would recall in an early draft of his un-published memoirs:

The late Allen W. Dulles, former head of CIA, and a scholarly looking man, was there. He was, by the way, a friend of Mrs. Hugh Auchincloss [Jackie Kennedy's mother] and he came over to talk to us amicably . . . What amazed me, looking backward at my testimony, was that whatever good I said about Lee Harvey Oswald seemed to be taken with a grain of salt as if the decision regarding his guilt had already been formed.

Commission assistant counsel Albert E. Jenner Jr. was the staffer who conducted the interrogations of George and Jeanne de Mohrenschildt, which lasted two and a half days.

As he did with several other key witnesses, Jenner had private conversations with George de Mohrenschildt both inside and outside the hearing room. Perhaps to ensure that he would not be accused of something underhanded, he went out of his way to state the fact of those outside consultations for the record. Aside from asking de Mohrenschildt, on the record, to verify that everything they had discussed privately was reiterated in the public session, Jenner never made clear what the subject matter of those private conversations was.

The transcript of the de Mohrenschildts' testimony runs 165 pages. It reveals George to be a remarkably interesting, dynamic character, whose life resembled that of a fictional adventurer. But numerous points of his testimony, especially relating to his background and connections, cried out for further scrutiny. Instead, Jenner consistently demonstrated that he was either incompetent or deliberately incurious when it came to learning anything useful about de Mohrenschildt.

To wit, here is an exchange between Jenner and de Mohrenschildt, in Washington, on April 22, 1964, with a historian, Dr. Alfred Goldberg, present. Jenner, who had already read extensive FBI reports on de Mohrenschildt, could be forceful when he wanted answers. But most of his moves were away from substance. He seemed determined to reach the commission's conclusion that de Mohrenschildt was a "highly individualistic person of varied interests," and nothing more. In fact, Jenner stonewalled so assiduously that even de Mohrenschildt registered amazement:

MR. JENNER: You are 6'1", are you not?

MR. DE MOHRENSCHILDT: Yes.

MR. JENNER: And now you weigh, I would say, about 195?

MR. DE MOHRENSCHILDT: That is right.

MR. JENNER: Back in those days you weighed around 180.

MR. DE MOHRENSCHILDT: That is right.

MR. JENNINGS: You are athletically inclined?

MR. DE MOHRENSCHILDT: That is right.

MR. JENNINGS: And you have dark hair.

MR. DE MOHRENSCHILDT: No gray hairs yet.

MR. JENNER: And you have a tanned – you are quite tanned, are you not?

*MR. DE MOHRENSCHILDT: Yes, sir.*

*MR. JENNER: And you are an outdoorsman?*

*MR. DE MOHRENSCHILDT: Yes. I have to tell you – I never expected you to ask me such questions.*

Why was Jenner even on the commission staff? Chairman Warren offered an oblique justification for his hiring that perhaps was more revealing than the chief justice intended. He was a "lawyer's lawyer," Warren said, and a "businessman's lawyer" who had gotten good marks from a couple of unnamed individuals.

Commission member John McCloy timidly inquired whether they shouldn't hire people with deep experience in criminal investigations. "I have a feeling that maybe somebody who is dealing with government or federal criminal matters would be useful in this thing."

Warren then implied that this was unnecessary because the attorney general (Robert Kennedy) and FBI director (J. Edgar Hoover) would be involved, totally ignoring the strong personal stakes of both officials in the outcome – and the strong animosity between them. Allen Dulles said little during this discussion of Jenner.

## **Albert Jenner, Company Man**

Albert Jenner was truly a curious choice for the commission staff. He was fundamentally a creature of the anti-Kennedy milieu – a corporate lawyer whose principal work was defending large companies against government trust-busting (which came under the aegis of the slain president’s brother Robert). His partner specialized in trust accounts on behalf of the super-rich.

Jenner’s most important client was Chicago financier Henry Crown, who was the principal shareholder in General Dynamics, then the nation’s largest defense contractor and a major employer in the Fort Worth area. The bottom line is that the Warren commission did not assign a seasoned criminal investigator to figure out de Mohrenschildt’s relationship with Oswald and his larger circle of connections. Instead, they turned the job over to a man whose principal experience and loyalties were firmly planted in the very circles most antagonistic to Kennedy.

The Warren Commission had been pressed to wrap up its inquiries quickly and neatly. But George de Mohrenschildt, whose wife described him as a man who didn’t know how to shut up, was not always a compliant witness.

Commission transcripts contain some tantalizing admissions, which, in the hands of a determined truth-seeker, would have led to important revelations. But whenever de Mohrenschildt let something slip, Jenner would quickly push it aside. He’d even mix up dates, thus creating a hopelessly jumbled chronology of the de Mohrenschildts’ lives.

Among the leads Jenner did not pursue was one from George Bouhe, the Russian community leader who had served as Oswald’s first handler before passing him on to de Mohrenschildt. In his own testimony, Boehe told Jenner that he had been wary of Oswald at first. He said he had even worried about attending an initial welcome dinner for the Oswalds thrown by Peter Paul Gregory, Oswald’s first White Russian contact on returning from the USSR. So Bouhe called a lawyer friend, Max Clark, who happened to be married to a Russian princess, to ask his advice.

“And after a couple of days, I don’t remember exactly Mr. Clark’s answer, but there were words to the effect that since he was processed through the proper channels, apparently there is nothing wrong, but you have to be careful. I think these were the words. Then I accepted the invitation for dinner.”

Jenner did not pursue what this reference to “proper channels” meant. And he did not then ask for more information on Max Clark. Not that he was likely to have needed the answer. Max Clark had previously been head of security for General Dynamics, Jenner’s top client, and was aware of the Kennedy administration’s ongoing investigation of the company.

## **De Mohrenschildt: Jackie’s “Uncle George”**

When the Warren commission released transcripts of its interviews with George de Mohrenschildt, the Associated Press remarked on the “strange coincidence,” particularly that de

Mohrenschildt was a friend of both Lee Harvey Oswald and the “family of President Kennedy.” The latter assertion was not quite accurate. In fact, he was a friend of the family of President Kennedy’s *wife*.

De Mohrenschildt had known Jackie’s family since the late 1930s. During the summer following his arrival in the United States, he, his brother, and his sister-in-law, along with Poppy’s Andover roommate Edward Hooker, headed for the Hooker summer cottage in Bellport, Long Island.

In Bellport they had some houseguests: Janet Bouvier and her daughter, the future Jacqueline Kennedy. A long-lasting friendship ensued. Jackie grew up calling de Mohrenschildt “Uncle George” and would sit on his knee. According to some accounts, de Mohrenschildt was at one point engaged to Jackie’s aunt Michelle.

“We were very close friends,” de Mohrenschildt explained to Jenner. “We saw each other every day. I met Jackie then, when she was a little girl. Her sister, who was still in the cradle practically. We were also very close friends of Jack Bouvier’s sister, and his father.”

This revelation seemed not to interest Jenner, who snapped, “Well, bring yourself along.”

Though Jenner did not find the Jackie Kennedy coincidences even remotely interesting, her own mother did. After the assassination, when de Mohrenschildt wrote Mrs. Auchincloss, offering his condolences, she wrote back:

It seems extraordinary to me, that you knew Oswald and that you knew Jackie as a child. It is certainly a very strange world.

So close were de Mohrenschildt and Jackie’s family that even after the assassination, Oswald’s friend was still welcome in the Auchincloss home. Indeed, immediately after their Warren Commission depositions concluded, George and Jeanne de Mohrenschildt had dinner with Mrs. Auchincloss and her current husband, Hugh. There, de Mohrenschildt would later recall, “The overwhelming opinion was that Lee was the sole assassin . . . I tried to reason – to no avail.”

Jeanne de Mohrenschildt added her recollections of that evening;

Well, the one thing struck me [was that] Mrs. Auchincloss . . . didn’t want any investigation, she didn’t want to know who killed Jack, why and what for. All she kept telling me was that Jack is dead and nothing will bring him back . . . I couldn’t possibly understand how the person, a woman, being so close to the man that was so . . . killed so horribly, having no interest whatsoever to continue the investigation and finding a person who did it.

This story should be taken with a grain of salt. The de Mohrenschildts might have been self-serving in casting themselves as more interested than Jackie’s mother in getting at the truth. Still, if they accurately characterized her preferences, Mrs. Auchincloss’s lack of interest in getting to the bottom of things is striking.



In any case, at the end of the dinner, according to the de Mohrenschildts, Janet Auchincloss informed the couple that, because of the awkward circumstances, Jackie never wanted to see them again. No reason was given.

Did Jackie believe that the de Mohrenschildts knew something, or were even in some way involved? Or was she just concerned for appearances?

Regardless, the simple fact that de Mohrenschildt knew Jackie and was the central figure in the life of the man believed to have assassinated Jackie's husband surely deserved more attention. That the Kennedy marriage had never been as happy as the public was given to believe, that it had deteriorated badly in the last few years, and that Jackie had gone off, over White House objections, to spend time on the yacht of Greek shipping magnate Aristotle Onassis – these did not necessarily add up to anything meaningful.

That Onassis, who was seriously at odds with Bobby Kennedy, had nearly entered into a Haitian investment venture with George de Mohrenschildt may have been no more than coincidence.

Nor does the Bush-Hooker-Bouvier-de Mohrenschildt interweave mean anything in and of itself. But a credible investigation into the assassination of a president would necessarily have probed more deeply into all these matters. Yet a credible investigation is precisely what the Warren Commission wasn't.

There is yet another piece still to this maddening puzzle. It turns out that at least one other guest joined the Auchincloss-de Mohrenschildt dinner that night following the commission depositions: Allen Dulles.

### **Poppy's Moment**

Although the mysteries behind the Kennedy assassination were not resolved by the Warren Commission, the rest of the world began to move on. Certainly, Poppy did. Though he lost the 1964 Senate election – as did his friend Jack Crichton the governor’s race – Poppy had helped set in motion events that would get him to Washington in two short years.

Bush wanted to carve out a new congressional district from that of Representative Albert Thomas, a new Deal Democrat who had played a key role in bringing NASA’s Space Center to Houston. By the time of Kennedy’s assassination, Thomas was showing signs of early senility. A key reason for President Kennedy’s visit to Texas that fateful week was to attend an event honoring Thomas, and generally to boost Democratic prospects for 1964.

In a watershed moment, Poppy and the GOP won a lawsuit they had filed in the fall of 1963 to force the state of Texas to redraw its gerrymandered congressional districts. This victory would play an important role in the state’s gradual shift from the Democratic to the Republican column, which would affect the balance of power in American politics for decades to come. Moreover, it would pave the way for Poppy’s election to the House of Representatives, and later his son’s political rise.

One specific result of Poppy Bush’s suit was the drawing of a “super-Republican” district tailor-made for him. Many of the people who lived there were East Coast trans-plants like Poppy himself, Ivy League graduates for whom tennis and martinis were a more natural choice than horseshoes and tequila. Poppy had done especially well in that area in his Senate race. So in 1966, Poppy sold his shares in Zapata Offshore, left the company in the hands of trusted associates, ran hard, won, and headed for Washington.

### **The Phoenix Program: “Pacification” of 20,000 People**

Congress was a great place for a spy – even better, in some ways, than the CIA. Congressmen were expected to travel the world, looking into matters of interest to the United States. In December 1967, less than a year after Bush was sworn in, he was off to Indochina, with his CIA partner Thomas Devine in tow.

It was Christmas break, a time when congressmen often make overseas trips, but Bush and Devine did not have a typical agenda. Correspondence indicates that having arrived in Vietnam, Bush and Devine hastily canceled an appointment with the U.S. ambassador in favor of other, unstated activities.

For the CIA, the hot item at the time was the so-called Phoenix Program, a secret plan to imprison and “neutralize” suspected Vietcong. This was being rolled out at precisely the moment that Poppy and Devine arrived “in country.”

By the time CIA director William Colby admitted to the program in July 1971, more than twenty thousand people had been killed – many of them possibly innocent, officials later concluded. One person involved in Phoenix’s early stages was Felix Rodriguez, a Cuban exile and CIA operative. Rodriguez would go on to become a great friend of Poppy Bush’s, even visiting him in the White House.

If J. Edgar Hoover's 1963 memo was correct in mentioning "George Bush of the CIA" as an intermediary with Cuban exiles, the coincidence of Rodriguez's activities in Vietnam with that of Bush's visit raises questions as to how the two were connected.

In 1970 Rodriguez joined the CIA front company Air America, which allegedly played a role in trafficking heroin from Laos to the United States. The Laotian operation was led by Donald Gregg, who would later serve as national security adviser during Poppy Bush's presidency.

When Bush and Devine traveled to Vietnam the day after Christmas 1967, Devine was in his new CIA capacity, operating under commercial cover. Handwritten notes from the trip show that Poppy was especially interested in the Phoenix program, which he referred to by the euphemism "pacification."

The two remained in Vietnam until January 11, 1968. Whatever information they were seeking, they left just in time. Only three weeks after the freshman congressman from Texas and his CIA sidekick departed Saigon, the North Vietnamese and Vietcong launched the massive Tet Offensive.

### **A Disturbing Incident**

Meanwhile, the Kennedy assassination had put into the White House Lyndon Baines Johnson, who had a long-standing but little-known relationship with the Bush family.

This dates back at least to 1953, when Prescott Bush joined Johnson in the U.S. Senate. Johnson was the powerful majority leader and Prescott had his own pipeline to the highest levels at the Eisenhower White House. That same year, Poppy Bush started Zapata Petroleum with Hugh and William Liedtke, who as law students at the University of Texas several years earlier had rented LBJ's guesthouse. Later, Bush became close with LBJ's chief financiers, George and Herman Brown, the founders of the construction giant Brown and Root (which later became part of Halliburton).

Pat Holloway, former attorney to both Poppy Bush and Jack Crichton, recounted to me an incident involving LBJ that had greatly disturbed him. This was around one p.m. on November

22, 1963, just as Kennedy was being pronounced dead. Holloway was heading home from the office and was passing through the reception area. The switchboard operator excitedly noted that she was patching the vice president through from Parkland Hospital to Holloway's boss, firm senior partner Waddy Bullion, who was LBJ's personal tax lawyer. The operator invited Holloway to listen in. LBJ was talking "not about a conspiracy or about the tragedy," Holloway recalled.

I heard him say,"Oh, I gotta get rid of my goddamn Halliburton stock." Lyndon Johnson was talking about the consequences of his political problems with his Halliburton stock at a time when the president had been officially declared dead. And that pissed me off . . . It really made me furious.

There are many other examples of LBJ's apparent unconcern after the assassination, though none so immediate. For instance, on the evening of November 25, LBJ and Martin Luther King talked, and LBJ said, "It's just an impossible period – we've got a budget coming up."

That morning, he told Joe Alsop that "the president must not inject himself into, uh, local killings," to which Alsop immediately replied, "I agree with that, but in this case it does happen to be the killing of the President."

Also on the same day LBJ told Hoover, "We can't be checking up on every shooting scrape in the country."

By 1964, with LBJ in the White House and Poppy Bush the Texas GOP nominee for U.S. Senate, their relationship was highly cordial. An intriguing, if oblique, note from LBJ's assistant Leslie Carpenter to Walter Jenkins, a top LBJ adviser, dated August 14, 1964, referred to Poppy: "Someone may like to know that George Bush was in town today for the day . . . [Bush] also had a press conference. During it, he carefully refrained from saying anything critical of the President."

LBJ has also been plausibly characterized as secretly rooting for Bush to beat the liberal Democratic candidate for Senate, Ralph Yarborough, whom LBJ disliked greatly; since the Democrats held a solid two-third majority in the Senate, LBJ knew that his party could afford to lose the seat.

In any case, while in Washington, Poppy had a warm relationship with Johnson, notwithstanding Bush's persistent attacks on the Democratic Party, especially back in Texas.

One of the more peculiar relationships in an already bizarre enterprise resulted from Bush's choice of a surrogate to run Zapata Offshore's office in Medellín, Colombia. To begin with, there was the question of why a small, unprofitable company needed such far-flung outposts. Why, in particular, did it need one in Medellín, 150 miles from any offshore drilling locale – a city whose very name would later become synonymous with the cocaine trade? Bush's choice to represent Zapata in Colombia was Judge Manuel B. Bravo, of Zapata County, Texas.



Judge Bravo's singular claim to fame was his role in Lyndon Johnson's fraud-ridden election to the U.S. senate in 1948. As reports of an extraordinarily close race came in on election night, Bravo continually revised upward the Johnson count from Zapata County's Ballot Box 13 until LBJ was assured victory.

A federal investigation led to a trial, but by that time the ballots from Box 13 in Jim Wells County had conveniently disappeared from the judge's office. The lack of evidence effectively ended Johnson's peril. Johnson won by eighty-seven votes.

In 1967, President Johnson sent Poppy a note wishing him a happy birthday. The following year, LBJ's decision not to seek reelection paved the way for Richard Nixon's ascent to the presidency – and Nixon's steady sponsorship of Poppy Bush's own ascent to power. When Nixon was inaugurated in 1969, Bush took the unusual step of leaving the GOP festivities to see LBJ off at the airport. Soon thereafter, he was a guest at the LBJ ranch. There is no public record of what the two men talked about.

Certainly, it had been a tumultuous few years for America, and busy ones for Poppy. His astonishing ability to carry on parallel lives, one visible, one deeply hidden, continued undiminished. But soon, there would be an understudy: his namesake, George W. Bush.

# Judge in LaRouche cases tied to Bush drug ring

Accumulating evidence that George Bush and his operatives sponsored and protected the Western Hemisphere's cocaine operations of the 1980s, also implicates the Virginia judge who falsely imprisoned associates of Lyndon LaRouche. In the most important narcotics case in Virginia's history, attorney Clifford Weckstein played a hidden "fixer" role to protect a cocaine-trafficking apparatus, which was working in tandem with then-Vice President Bush and Bush employees such as Oliver North. Three years later, with Bush the President and Weckstein a state circuit court judge, Weckstein ran the railroad trials of Michael Billington and other LaRouche political associates who had fought to expose and wreck the Bush-North criminal apparatus.

### Weckstein and Caballero

On April 4-5, 1986, the Panamanian military, under Gen. Manuel Noriega, working with the U.S. Drug Enforcement Administration, arrested Lucas Gerardo Caballero Salinas (known as Gerardo Caballero) and several other Bolivian drug-traffickers in Panama.

Caballero and his partners had arranged to fly about 700 pounds of cocaine into southern Virginia for sale in the northeastern United States. His indictment in Virginia was important, chiefly because his father-in-law, Roberto Suárez Gómez (known as Roberto Suárez), was the main Bolivian gangster intermediary for Bolivian cocaine producers, who supplied the majority of the raw material to the Colombian cartels trafficking drugs into the United States. Roberto Suárez was also indicted, *in absentia*, in the Virginia Caballero case.

On April 9, 1986, Federal Judge James Turk assigned Weckstein's junior partner, former drug prosecutor William Cleaveland, to be Caballero's attorney. As Cleaveland later told this reporter, the case was managed by the firm, that is, by senior partner Weckstein, rather than by Cleaveland.

Weckstein himself had expert help. The most notorious and flagrantly corrupt U.S. lawyer for the South American cocaine cartels, "Diamond Joel" Hirschhorn of Miami, Florida, was in Roanoke, Virginia, during the globally important Caballero case, strategizing with his co-counsel, Clifford Weckstein. But Weckstein's partnership with the millionaire cartel representative was carefully hidden from the public: Hirschhorn was registered not in the Caballero case, involv-

ing the survival of his gangster sponsors, but only as a second to Weckstein in an unpublicized local trial of two-bit marijuana pusher, Alan Cohen, occurring at precisely the same time before the same judge. Judge Turk acceded to Weckstein's request on April 14, 1986 to admit Hirschhorn as Weckstein's co-counsel.

Weckstein sent his partner, Cleaveland, along with *Roanoke Times and World-News* reporter Douglas Pardue, to Bolivia. Weckstein's men worked with Caballero's family, and Suárez worked with his "Miami lawyers," for an arrangement which was to be carried out in the courtroom and in the news media.

Though honest anti-drug agents were at that time trying to turn members of the Bolivian organization to get at and destroy the structure top-down, this was blocked in the Caballero case. The dirty setup in Bolivia was protected. Gerardo Caballero was jailed for 20 years, and kept his mouth shut. Weckstein officially dropped the case on July 9, before the trial began; his role in organizing the strategy and outcome was covered up.

Pardue, an advocate of drug legalization whose newspaper was co-owned by Weckstein's in-laws, blatantly lied about the Bolivian crime organization. Pardue passed along the Weckstein firm's story that Caballero's father, a Bolivian executive with Gulf Oil, was a respectable "civic leader." He wrote that Caballero had an "aristocratic bearing" and "a heritage to back it up"; that his "grandmother was the British consul in the Bolivian city of Cochabamba"; and that Caballero's father-in-law, Roberto Suárez, was a rancher who had simply switched to the drug-trafficking business when he "discovered how lucrative cocaine could be."

But the Suárez-Caballero dope cartel had in fact organized the 1980 coup for the fascist "Cocaine Colonels," including Interior Minister Luis Arce Gómez, a cousin of Roberto Suárez. They had enslaved Bolivia to cocaine production.

### Bush and North exposed

As the Caballero case hung in the balance, with Bolivian kingpin Roberto Suárez under indictment in Roanoke, George Bush's treacherous role in managing hemispheric cocaine-trafficking began to be exposed.

In the July 28, 1986 *New York Post*, Niles Latham wrote about "Operation Blast Furnace," a strange "anti-drug" misdeployment of U.S. troops and helicopters into Bolivia, which had begun earlier in July and would continue into November. Latham wrote, "Vice President George Bush pressured the Pentagon into agreeing to the operation." U.S. military leaders considered it a Bush publicity stunt, Latham reported. Bolivian military leaders who were committed to fighting the cocaine cartel, in discussions with *EIR* at the time, fiercely criticized Bush's "Blast Furnace" as an empty provocation, a sabre-rattling use of U.S. forces in violation of Bolivian sovereignty which netted no significant drug traffickers or their infrastructure.
