## **Amendment IV**

**The right of the people to be secure in their persons, houses, papers, and effects, against unreasonable searches and seizures, shall not be violated, and no warrants shall issue, but upon probable cause, supported by oath or affirmation, and particularly describing the place to be searched, and the persons or things to be seized.**

## **18 U.S. Code § 242. Deprivation of rights under color of law**

**Whoever, under color of any law, statute, ordinance, regulation, or custom, willfully subjects any person in any State, Territory, Commonwealth, Possession, or District to the deprivation of any rights, privileges, or immunities secured or protected by the Constitution or laws of the United States, or to different punishments, pains, or penalties, on account of such person being an alien, or by reason of his color, or race, than are prescribed for the punishment of citizens, shall be fined under this title or imprisoned not more than one year, or both; and if bodily injury results from the acts committed in violation of this section or if such acts include the use, attempted use, or threatened use of a dangerous weapon, explosives, or fire, shall be fined under this title or imprisoned not more than ten years, or both; and if death results from the acts committed in violation of this section or if such acts include kidnapping or an attempt to kidnap, aggravated sexual abuse, or an attempt to commit aggravated sexual abuse, or an attempt to kill, shall be fined under this title, or imprisoned for any term of years or for life, or both, or may be sentenced to death.**

The American Disabilities Act [ADA] prohibits places of public accommodation having restrictions that would limit access to an individual with a disability. Under the ADA and the Health Insurance Portability and Accountability Act (HIPAA), I am NOT required to disclose my medical condition to anyone.

Department of Justice ADA Violation information line: 800-514-0301. Organizations and businesses can be fined up to \$75,000 for the first ADA violation and \$150,000 for any subsequent violation.

Your business is not required to follow guidelines that violate rights and safety. Guidelines are not law and are not enforceable by law.

YOUR BUSINESS CANNOT DISCRIMINATE against any patron who is not wearing a mask. This is a violation of civil, international and state law, which protects free and equal access to any business establishment of any kind, whatsoever.

Civil and or Criminal charges will be brought against you for enforcing discriminatory and provably harmful practices upon the private in pursuit of their life, liberty and happiness.

#### **42 U.S. Code § 2000a. Prohibition against discrimination or segregation in places of public accommodation**

##### **(a) Equal access**

**All persons shall be entitled to the full and equal enjoyment of the goods, services, facilities, privileges, advantages, and accommodations of any place of public accommodation, as defined in this section, without discrimination or segregation on the ground of race, color, religion, or national origin.**

##### **First Amendment**

**Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the Government for a redress of grievances.**

#### **10 U.S. Code § 1094 - Licensure requirement for health-care professionals**
