as an employee of Village Resorts Hospitality Group, LLC, or the Company's we may manage, own, and operate by Village Resorts Hospitality Group, LLC.

Village Resorts Hospitality Group, LLC, is a legally registered California limited liability hospitality company and not a race based, religious based, political, or social movement organization and it is the opinion of Village Resorts Hospitality Group, LLC, that a religious, political, or racial endorsement is an endorsement that sends a message, not in line with our definition of hospitality and our Mission Statement.

It is Our position that a political, religious, or racial endorsement or disapproval of the above is an endorsement that sends a message to non-adherents that they are outsiders, not full members of a political, racial, or religious community, and an accompanying message to adherents that they are insiders and favored members of a political, racial, or religious community not in line with Our Mission Statement.

While we respect the opinions that our employees, agents, officers, and stakeholders may have, all Persons are expressly forbidden from using their position, office, or influence to offer, endorse or accept an endorsement on behalf of Village Resorts Hospitality Group, LLC, and the Company's we may manage, own, and operate from any religious, political, or race based entity, individual or institution as the views and expressions of Village Resorts Hospitality Group, LLC, and the Company's we may manage, own, and operate that may be depicted for the purpose or reference made by those endorsed or accepted as those of Village Resorts Hospitality Group, LLC, and the Company's we may manage, own, and operate.
