Executive Order 79/2021

Central Executive Council
High Office of the Prime Consulship of the Republic

Of the 21st of May, by which the Workers' Republic of Eothasia hereby declares its lack of recognition of political and democratic legitimacy of the government of the Republic of Crossoveria.

BE IT ENACTED by the Consuls of the Workers' Republic, by and with the advice of the State Council of the Republic assembled, and by authority of the democratic institutions of the Republic, as follows:

On this date, the 21st of May of the year 2021, the High Office of the Prime Consulship of the Republic, by the powers vested in the Presidium of the Republic by the democratic institutions of the Nation, hereby solidifies the decision to retire any and all governmental recognition of the Republic of Crossoveria.

EXPOSITION OF MOTIVES

I

The political system of the Republic of Crossoveria is one of near absolute accumulation of power by one singular figure, referred to as the *Supreme Leader* of the Republic, currently occupied by Waldemar Erdogan Rochester. While this demonstrates the lack of adherence of the Republic of Crossoveria to the basic principles of a republic —as in, the political participation of its citizenship in the selection of all major political figures, which would include the Supreme Leader—, it also demonstrates the capability of the government of Crossoveria to extend itself over a nearly unlimited number of fields and circumstances in order to control unfaceted aspects of the everyday lives of the citizens of Crossoveria.

Despite having a democratically elected head of Government, the stability of this organism is questionable, with each president lasting a single year in office and having the ability to obtain four terms in total. Though the constant presence of elections is structured to give the appearance of a democratic institution, it is anything but; the constant and inefficient interruption of nationwide general elections conflicts the fluidity of the organ of government, allowing it to exist merely as a ceremonial body rather than one of any real political value or importance.

It is also evident in the political system of the Republic of Crossoveria that the separation of branches of political power —even disregarding the overarching presence of the Supreme Leader— is not present. The president of the Republic and head of Government is able to dismiss members of parliament, which effectively puts the legislative branch at the leisure of the executive branch, which itself acts as a mere puppet of the Supreme Leader. The ineffectual

authoritarian structure of the Republic of Crossoveria demonstrates the lack of political will, of democratic institutions and the desolate political landscape of the country.

II

The condition of civil rights in the Republic of Crossoveria is extremely poor, with citizens being consistently repressed for the most minor of offences. This extends to many of the civil liberties that have already been conquered in the modern world, such as the freedom of sexual orientation. Punishment is exercised in the vilest of ways, including torture and executions in the most atrocious of manners, including gas inhalation, beheadings, hangings and firing squads. As expected, protests against the government rarely end peacefully, with the oppressive regime undergoing strict attacks against the civilian population to disperse and disincentivise the congregation of those that would react against the government's totalitarian regime.

The establishment of what is known as the Codes of Citizenship is of extreme concern. In this text, it becomes strictly evident that the religious fundamentalism of the Republic of Crossoveria has proved absolute in its code of law and has decimated the possibility of conquering civil rights through peaceful methods. The fascistic elements of law make it clear that the Workers' Republic cannot and will not abide by the presence of such a government on Eothasi soil, and far less allow any form of political recognition of a regime that should, by any means necessary, be deposed and replaced with a proletarian government that ensures the safety and security of the working class of Crossoveria. It is for this reason that the Presidium of the Republic, in adherence to the moral code of the Republic and with the powers vested in it by the democratic institutions it represents and defends,

HEREBY DECLARES

Article 1. Recognition.

- 1. The Workers' Republic of Eothasia immediately removes any and all political recognition of the governmental structure of the Republic of Crossoveria.
- 2. The government of Crossoveria shall be considered an illegitimate dictatorial government and shall not be interacted with in the field of international diplomacy by the Workers' Republic.

Article 2. Members of Government.

1. All members of the government of Crossoveria shall be considered perpetuators of a dictatorial regime and shall have any and all assets and other properties in the Workers' Republic expropriated, in accordance with Article 53 of the Constitution and Organic Law 7/1986, of the 12th of February, regarding the Powers of Expropriation and Nationalisation in the Republic.

- 2. All members of the government of Crossoveria shall be strictly prohibited from entering Eothasi territory and space, including:
 - a. Airspace over the territories and national waters of the Workers' Republic.
 - b. Territories affiliated with the Workers' Republic.
 - c. National waters of the Workers' Republic.
 - d. Territories pertaining to the Exclusive Economic Zone of the Workers' Republic.
- 3. Any member of the government of Crossoveria not adhering to the specifications detailed in the second clause of the present article shall be properly detained by the security forces of the Workers' Republic and put at the disposition of the appropriate international authorities, regardless of the position of government of the member in question or the validity of diplomatic immunity.

Article 3. Commercial interaction.

- 1. The economic centres of the Workers' Republic of Eothasia are hereby prohibited from interacting with agents of the Republic of Crossoveria, regardless of their public or private nature, and cannot export, import, or otherwise interact with these agents.
- 2. There shall be no imports from the Republic of Crossoveria into the Workers' Republic, regardless of whether these imports are direct or via a proxy in another country.
- 3. There shall be no exports to the Republic of Crossoveria from the Workers' Republic, regardless of whether these exports or direct or via a proxy in another country, save for circumstances requested by international partners with the intention of humanitarian relief efforts.

Article 4. Military forces.

- 1. Any military forces of the Republic of Crossoveria entering within the Exclusive Economic Zone of the Workers' Republic shall be considered hostile agents and shall be engaged by the Eothasi military to ensure the security of the Workers' Republic.
- 2. Any act of aggression on behalf of the Republic of Crossoveria to the Workers' Republic of Eothasia, including trespassing on the Exclusive Economic Zone of the Workers' Republic, attacking or confiscating any and all economic interests pertaining to the Workers' Republic outside of its territorial waters or other such activities shall be considered an act of war and shall be responded to fiercely by the Workers' Republic of Eothasia.

Article 5. Asylum.

- 1. The Workers' Republic of Eothasia offers to the possibility of asylum to any and all citizens from Crossoveria seeking refuge from the prosecution of the government of Crossoveria.
- 2. The extension of the right to asylum to citizens of Crossoveria shall be in accordance with Article 13 of the Popular Constitution recognising the right to asylum, as well as

Organic Law 21/1914, of the 28th of February, regarding the Application and Right to Asylum in Eothasia.

3. The Workers' Republic shall cooperate with international partners to ensure that any and all migration crises caused by the exodus of citizens from Crossoveria to other countries of the world.

Article 6. Travel Restrictions.

- 1. Commercial flights between the Workers' Republic of Eothasia and the Republic of Crossoveria are strictly prohibited.
- 2. Any citizen of Crossoveria which has stepped foot on Eothasi soil and has not immediately requested admission into the process of request of asylum shall not be considered a refuge and shall not be allowed to remain on Eothasi soil, instead being immediately returned via commercial flight to the country from which they arrived.

Article 7. Ratification.

In the interest of defending the civil rights and liberties as conquered by the working class of the world, and in the hopes of advancing in the direction of the deposition of the dictatorial government and Supreme Leader of the Republic of Crossoveria and its internal political system, the Workers' Republic of Eothasia hereby ratifies Executive Order 79/2021, which shall be presented no later than fifteen days to the National Citadel for approval, by which political recognition by the Workers' Republic of the Republic of Crossoveria is hereby retired.
