#### Bunker Hill Day Parade Committee Seeks Community Support

The Charlestown Veterans/Bunker Hill Day Commemorative Committee has voted to dedicate this year's parade to commemorate the 150th anniversary of the completion of construction and the dedication of the Bunker Hill Monument as well as to honor our patriot forefathers who fought for freedom 218 years ago on the hills of Charlestown

during the Battle of Bunker

The committee is seeking the support of the residents, merchants and organizations for the 1993 Bunker Hill Day celebration in order that the events will serve as a significant and meaningful tribute to those who fought and died at the Battle of Bunker Hill.

The highlight of the cele-

bration will be the Bunker Hill Day Parade, which will be held on Sunday, June 13, commencing at 12:30 p.m. from the Hayes Square area of the town. This should be one of the largest and most outstanding parades in the Greater Boston area.

As you are most likely aware, due to both the fiscal constraints imposed on the city of Boston, the funds available from the city to help underwrite parades are extrememly limited, and the small reserve that the committee had built up in the parade fund in prior years is now non-existent. Thus, increased financial assistance must once again be sought from the community - from you the residents, local business people and community organizations - to make this, the 218th commemoration of the Battle of Bunker Hill - a success.

The fund raising for the parade and commemorative celebration again this year is being carried out by a small but dedicated group of residents. These people are giving many hours of their time to make this a truly memorable celebration for the community and (continued on page 5)

## State Officials Agree On Rink Safety Review

In response to last week's shooting outside Charlestown's Emmons-Horrigan-O'Neil Skating Rink, Rep. Richard Voke, Sen. Thomas Birmingham and senior officials at the Metropolitan District Commission (MDC) convened a meeting to discuss public safety issues regarding the rink and its patrons. As a result of this meeting, the MDC has embarked upon a full-scale investigation of that incident and others that have been reported since the shooting took place.

"Our rink is supposed to be an oasis for our kids, a place to escape the everyday trials and tribulations that affect inner-city youth. The last thing these kids and their families should have to fear is the type of violence reflective of last week's shooting," said Voke.

"It is intolerable to subject local kids to such perils anywhere, but especially at the local skating rink. Our kids should only be concentrating on ducking checks, not bullets, as they gather here to skate and enjoy

themselves," added Birmingham.

According to MDC Commissioner Ilyas Bhatti, his agency was already prepared to look into the situation. "Having Rep. Voke, Sen. Birmingham and local activists on board to help us with our review will only serve to make the investigation more thorough and community oriented," Bhatti stated.

Although the shooting took place outside the rink, MDC officials want to see

#### Temporary Ramp Connection To Be Outlined At Meeting Tonight

In a move that should have a dramatic effect on the completion of the Central Artery North Area (CANA) Project and City Square Park, the Massachusetts Highway Department (MHD) has announced construction plans to enable the existing overhead highway structure in City Square to be demolished several years ahead of schedule.

These plans will be outlined at a public meeting to be held in Charlestown tonight, Thursday, Feb. 18, at 7 p.m. at the Mary Colbert Apartments, 20 Devens St.

Prompted by the North Area Task Force (NATF) and other neighborhood organizations, MHD recently requested formal permission from state environmental officials to construct temporary ramps on the west side of Rutherford Avenue to connect CANA and I-93 during the design and construction of a revised Charles River Crossing for I-93. In the same letter, MHD also outlined plans to demolish the existing overhead connector once the temporary ramps are in place.

Although the CANA tunnels are nearing completion, the state's ongoing efforts to design the so-called Scheme Z Charles River Crossing for I-93 had threatened to delay full use of the tunnels, as well as demolition of the lone remaining overhead structure in City Square for as many as 6 to 8 years. The threatened delay arose from the fact that the City Square tunnels cannot be permanently connected to I-93 until the revised Charles River Crossing is finalized. MHD had concluded that the existing overhead connector in City Square would be needed during the re-design and construction phases for the Charles River Crossing.

The NATF learned last year that the Scheme Z redesign process would result in such a long delay in the completion of the CANA project, that NATF urged MHD to devise a temporary connection between the tunnels and I-93 to permit demolition of the existing overhead.

MHD initially expressed doubts about the ability to design a temporary connector. However, MHD agreed with NATF to commit substantial engineering resources to the effort. In late 1992 NATF, the Charles-

#### Harvard-Kent Math Team

The Harvard-Kent Elementary School has entered a team in the world-wide competition Mathematical Olympiads for Elementary Schools. The purpose of the competition is to cultivate problem-solving abilities in children who are in grades 3 through 6; some schools which only go up to fifth grade, such as the Harvard-Kent, enter and try their best without the stronger (typically) sixth graders.

The students, approximately 20 in all, meet once per week to practice solving word problems, then once a month each student must work on five tricky problems with no outside help. The problems are so difficult that half of all par-

ticipants get no problems correct out of five. Perhaps one of these young problem solvers will grow up and solve a difficult community problems like the problem of Charlestown being a so-called "hot spot" for elevated levels of certain illnesses.

contributed to the crime.

"We have a responsibility to Rep. Voke, Sen. Birmingham and the people of Charlestown to ensure maximum safety at this and all other MDC facilities. Should our review show that we are falling short of

this goal, I will be more than pleased to implement whatever changes are necessary to bring us up to this safety level," stressed Bhatti.

Voke and Birmingham, while pleased with the MDC response, are still disappointed that such an event occured.

"To the best of our ability, Sen. Birmingham and I will work to make sure that the MDC efforts compliment those efforts being made by local authorities and community activists," noted Voke.

"Rep. Voke and I will certainly not be satisfied until we know that everything possible is being done to keep undesirable outside elements out of our rink and away from our kids," Birmingham commented.



★ Residents Await Decision On Billboard . . . Residents from the Sullivan Square area of the town, representatives from several city agencies and Rite Media Inc. testified at a hearing before the Mass. Highway Department's Outdoor Advertising Division on Feb. 11 relative to a proposal by Rite Media to erect a billboard on top of 50 Brighton St.

The Neighborhood Council's Billboard Committee, chaired by Ken Stone, had met with residents and representatives of Rite Media earlier last week and 13 of the 14 residents present had voted in opposition to the installation of the billboard. Rite Media had offered \$7,000 per year toward upkeep of the Caldwell Street Playground for as long as the billboard is in place and the financing of some road repairs on the private portion of Brighton Street as mitigation measures.

At last Thursday's hearing, two Brighton Street residents spoke in favor of the benefits offered by Rite Media if the 14 foot by 48 foot double-sided billboard on top of 50 Brighton St. was approved.

Charlie Clabaugh, aide to Boston City Councillor Robert Travaglini, relinquished his opportunity to speak at the hearing to allow Wesley Taylor to voice his opposition to the billboard.

Others speaking in opposition to the billboard were Stone, who spoke on the Billboard Committee meeting; Dennis Sarno and Tom O'Donnell from the city Inspectional Services Department; Don Borenstein and John Deveroux from the city Law Department; Jim "Stretch" Walsh, regional administrator of the Boston Parks and Recreation Department, who outlined the plans for the new park on Caldwell Street; and Judy Evers, community liaison from the Mayor's Office of Neighborhood Ser-

Letters of opposition to the billboard have been submitted to the Outdoor Advertising Division by Travaglini, Rep. Richard Voke, Sen. Thomas Birmingham and City Councillor Rosaria Salerno.

The Outdoor Advertising Division has three weeks from the date of the hearing to announce its findings, granting permission or denial of the request for the billboard by Rite Media.

According to a spokesperson for the city's legal department, the city will appeal if the state board approves the billboard. They cited that the installation of the billboard at that site is a clear violation of the state's own regulations, specifically the distance from the proposed billboard to the Caldwell Street Park.

★ MDC Skating Rink . . . In response to complaints by residents of persons drinking alcohol and using marijuana in the vicinity of the Emmons-Horrigan-O'Neil MDC Skating Rink on Union Street, the State Police, including the Special Operations Division from Charles River Basin, will be increasing patrols in the area.

It was also reported that Boston Police Department patrols will also be increased in the area in response to concerns by parents relative to the safety of the children going to and coming from the rink following a shooting on Union Street on Feb. 10.

\* Street Reconstruction Update . . . Susi has pretty much completed the installation of the gas lights on the newly constructed streets to date. This past week, he took down the old light heads and installed new heads on Essex, Middlesex and Lyndeboro streets, and completed the new light heads on Monument Court. Most all of the lights installed were able to be lit. There are still a few lights that need service valves turned on before they can be lit, and there are a couple of poles and lights that are yet to be installed such as the one at the end of Ellwood Street at the alley to Adams Street and the few light heads on Nearen Row.

Susi has not gotten to the last few roof drains as yet, but hopefully he will get to them shortly.

Nothing new has happened on the Mead Street stairs contract and we have not been advised of any schedule changes for the remaining work. The sample railing with the painting method and system have been submitted to the Boston Redevelopment Authority for approval, and the contractor says he'll be on the site as weather permits.

# Temporary Ramp Connection To Be Outlined At Meeting Tonight

town Neighborhood Council, the Charlestown Preservation Society and other
groups and individuals
wrote state Environmental
Secretary Susan Tierney to
urge a temporary connector
as a condition of environmental approval for MHD's
proposed revisions to the
Charles River Crossing.

This month MHD wrote Tierney to announce plans to construct a temporary connection between CANA and the existing I-93 Charles River Crossing. MHD asked Tierney to permit the proposed construction as a mitigation measure without the need for further environmental review.

The MHD proposal calls for construction of temporary loop ramps west of Rutherford Avenue and I-93 over the B&M rail yards. These ramps, along with one other ramp between Rutherford Avenue and I-93, would connect U.S. Route 1 southbound to I-93 southbound and I-93 northbound to U.S. Route 1 northbound. (See diagram)

Upon receipt of MHD's letter to Tierney outlining the proposal, NATF immediately wrote Tierney to

NATF Co-Chairman Richard Johnston told the Patriot: "Those of us who have been following CANA over the years were very pleased with the state's decision to revise Scheme Z in ways which greatly benefit Charlestown. However, we were distressed that revising Scheme Z seemed to mean a 6 to 8 year delay in completing CANA. MHD's proposal for temporary ramps enables Charlestown to have the best of both worlds - a simpler and more attractive Charles River Crossing as well as an earlier completion of CANA and demolition of the existing overhead in City Square. Hopefully, the existing overhead can be taken down by early 1995 as the City Square Park is being finished."

Ken Stone, NATF's other co-chairman, praised MHD for its willingness to pursue temporary engineering alternatives which would facilitate completion of CANA. "MHD proved to be very responsive to com-



Dear Secretary Tierney:

The Charlestown North Area Task Force (NATF), a neighborhood organization which has been working with the Massachusetts Highway Department (MHD) on the Central Artery North Area (CANA) project for over 15 years, unequivocally and enthusiastically supports the construction of temporary connectors between I-93 and the Tobin Bridge as outlined in MHD's Jan. 8, 1993 letter to you.

As we wrote you on Nov. 18, 1992 as part of our favorable comments on MHD's notice of project change for the Charles River Crossing of the Central Artery/Tunnel (CAT) project, the proposed temporary connections are absolutely critical in order to permit a timely completion of the CANA project. The revised Charles River Crossing, as endorsed by the Bridge Design Review Committee, should be approved because of its numerous transportation and environmental benefits over Scheme Z. However, without the temporary connectors, the proposed revision of the Charles River Crossing would delay completion of the CANA project for as many as 6 to 8 years.

MHD should be commended for its responsiveness to community concerns about delays in completion of CANA and for its engineering creativity in devising a temporary solution for the I-93/Tobin Bridge connection. MHD's Jan. 8, 1993 notice to you is testimony to MHD's commitment to completing CANA in a timely fashion while accommodating the long-term needs of the CA/T planning process.

Specifically, NATF endorces all of the following MHD's positions:

that the proposed temporary connections be constructed:

• that the temporary connections are construction phase mitigation measures which are within the intent, objectives and general scope of the CA/T Project FSEIR Proposed

 that the environmental, public safety and convenience benefits of the temporary connectors will be substantial and greatly outweigh any adverse environmental effects;

that the temporary connectors do not constitute a project change and do not require further environmental review.

NATF urges you to confirm as quickly as possible, that no project change is involved and that no further environmental review is required. We are most anxious for construction of the temporary connectors to begin promptly—in hopes that the existing overhead structure in City Square, which the temporary connections will replace, can be demolished in time for completion of the City Square Park now being designed under the auspices of the Department of Environmental Management.

We also urge you to confer with the DEM officials as to the benefits of MHD's proposed action on DEM's efforts to create a gateway park in City Square by the end of 1994.



#### NUTRITION NOTES

Beans, Beans, Good For Your Heart . . .

So the saying goes. But the fact of the matter is that beans are just the nutritional ticket for those who are trying to follow a heart healthy diet. Dried beans (black, white, garbanzo, kidney, lima, navy and pinto) are good sources of protein; and when combined with a grain like rice or whole wheat bread, they make a complete protein similar to meat.

The beauty of beans is that they surpass meat in nutrional quality - being good sources of water soluble fiber, iron and B-vitamins, and with very little fat and no cholesterol. Beans make low cost meals, at about one-third the price per pound (or less) as most meat or poultry.

Beans can be purchased in two forms: packaged dried beans which need to be soaked before used in a recipe, or ready to use cans which can be opened, rinsed (the liquid they are in is salty) and eaten. For bean beginners, the second type is most convenient and allows for experimentation in salads, soups or as a last minute addition to your favorite recipes. Most beans contain 100 calories and a half gram of fat per

Try a more familiar recipe like chile to get to know beans. This one uses ground turkey, but meatless chile is also good and can be served with rice to make a complete meal.

#### Chile With Beans

1 pound ground turkey

l cup chopped green pepper

1 cup chopped onion

2 Tbsp. chile powder

The Boston Department of Health and Hospitals Communicable Disease Control Program has received reports in the past month of 10 confirmed cases and one suspected case of hepatitis A in Charlestown. According to Dr. Anita Barry, the director of the Communicable Disease Control Program, "The outbreak of hepatitis A in Charlestown appears to be resolving. We are hopeful that the majority of cases related to this outbreak have

already been identified and reported to us."

The Communicable Disease Control Program is continuing to carefully monitor the incidence of hepatitis A in Charlestown and to investigate each confirmed case. This investigation includes identifying contacts to the case who are at high risk for contracting hepatitis A due to a particular type of exposure, and instituting necessary control measures.

An injection of immune

globulin, if given promptly, may help to prevent the disease in persons who are at high risk of contracting hepatitis A. Those at highest risk are usually household contacts. School-aged children who are classmates of a child who has hepatitis A are not generally considered to be at high risk as a result of this type of exposure, and immune globulin is not generally recommended for the classroom contacts.

Barry stresses that for the

community in general, prevention is the key. Good personal hygiene, particularly in households with young children in day-care settings, is critical. Hands need to be washed thoroughly following toileting or diaper changes and before preparing food or eating. Children should not share their food or drinks with others. Fresh fruit and vegetables should be washed carefully before eating.

Hepatitis is an inflammation of the liver which can be caused by viruses. Hepatitis A, which used to be called infectious hepatitis, is common among children and adolescents. One out of every two Americans will have had hepatitis A by age 50. Usually, it is a mild infection which runs its course in several weeks, and over 95 percent of cases recover fully. Once an individual has acquired hepatitis A, the person is usually immune from future episodes.

The virus is found primarily in the stool of the person with hepatitis A, and it is commonly transmitted when contaminated hands, food or water reach the mouth, and the virus is swallowed (fecal-oral transmission). A case is contagious up to two weeks before and one week after the on-

set of symptoms. There is no cure for hepatitis A.

Sypmptoms of hepatitis A can appear 15 to 50 days after exposure but, if they appear at all, tend to do so at around 28 to 30 days after exposure. Initial signs and symptoms include: fever, headache, muscle aches, loss of appetite and itchy rash. After a few days, these may worsen to include nausea, vomiting, abdominal and joint pain, bad breath and a bitter taste in the mouth.
