MEMORANDUM AND ORDER FOR FORMAL PROSECUTION FOR HUMAN TRAFFICKING

The allegations in regards to illegal mining transactions, as well as the use of such to hide probable human trafficking are serious enough to warrant another superseding indictment. In this venue, the accused parties share higher penalties in the course of active collusion with **HARVEY WEINSTEIN**. As such, this will be against **WEINSTEIN** in both his public and private capacity for each offense.

As duly noticed on record when it comes to violating 18 U.S.C. § 241:

Your honors must note, that when it comes to public corruption and the likely-hood of severe offenses like trafficking we only need prove there is just cause for suspicion. The preponderance of evidence eclipses that threshold, as **WEINSTEIN** and Miramax have not denied any allegations. Certainly, they have not provided either sufficient reason or cause to Hold any doubt as to their purported crimes. That is to say we hold that Defendant **WEINSTEIN** and **CLINTON** violated **18 U.S.C. § 241** more than twice on the record your honors. In addition, they broke trafficking law.

Thereby in the first instance, we charge **WEINSTEIN** and co-conspirators with public fraud. We follow that up with additional crime of trafficking.

INTRODUCTION

By now, **HARVEY WEINSTEIN** is a household name. His crimes have gotten to into every aspect of American life and are legendary. Every bit of his public sleaze and debauchery, hides a more unseemly underbelly of waste and human trafficking. Although there is no evidence to charge him with underage trafficking thus far, the enormous volume dictates that he shall be hit with the offense of commercial exploitation. This is rightly guaranteed.

WEINSTEIN went out of his way to assault more than seventy actresses. In the course of those events, actress **KADIAN NOBLE** brought a class action against him for trafficking her as well as at least sixteen other victims in Europe. His holier than thou attitude is even less amusing than his mug shot. As submitted on record, we concur he engaged in an act of public corruption at least twice.

Count 1] We charge **HARVEY WEINSTEIN** with breaking the offense of of 18 U.S.C. §444 , the national bracket on human trafficking. The offense carries a penalty of up to fifteen years in prison. We further ask for in-depth review. [The military has options here, including public execution and life without parole in a managed facility.]

Count 2] In our estimation this crime is equally as serious. We charge **WEINSTEIN** to have committed the offense of 18 U.S.C. § 241 twice, with respect to a bid-rigging scheme on behalf of various public mines for private sale. He is ordered to surrender his passport. The penalty adds an additional seven year sentence. [Possible execution.]

Of course your honors, there is much more ground to cover on **WEINSTEIN** and **SPACEY' s** deals with the mines. We ask the courts be patient as it develops.

Next, we have little issue with charging **KEVIN SPACEY** with two offenses not yet covered. We charge him with breaking **18 U.S.C. § 241** (e.g.) for initiating an event leading to the Las Vegas shooting. His co-conspirator **MURREN** was aware of how things would look since at MGM he has various deals with **WEINSTEIN' s** properties.

Count 1] **KEVIN SPACEY** has violated **18 U.S.C. § 241** and is being charged with committing this offense twice. Once, in respect to his dealings with **WEINSTEIN** directly and once with **BARRICK GOLD**.

The offense carries a minimum fifteen year sentence. To further enforce for penalties, we ask military consort explore options. [As the Militia are taking acting oversight of these courts, they will explore whether capital punishment or life in prison is warranted for the range of offenses.]

Count 1] We have no issue charging **GIUSTRA** with breaking **18 U.S.C. § 241** twice, this time with **Lionsgate**.

We are assured he was quite aware what occurs if the quid-quo pro is discovered. The penalty carries an additional sixteen year sentence for public graft.

Count 2] In addition to his money-laundering with **CLINTON** and **WEINSTEIN**, there's no choice except to charge **GIUSTRA** with **18 U.S.C § 1591** for child trafficking.

This heinous offense carries a twenty year sentence.

We take note of the severity, remand it to ten years.

Given his unique position, we urge him to turn on

SOROS management so that this affair can end. [Military shall enforce either no supervised release, supervised release or life.]

AND NOW, on this day of December 2, 2017 during the fall season,
it is hereby ordered that the defendants be charged acting in concert
for the purpose of public corruption. All penalties are measured by strength.
In addition, it is so ordered that a subpoena be issued upon
HARVEY WEINSTEIN, FRANK GIUSTRA, KEVIN SPACEY and **HILLARY RODHAM CLINTON** to produce
all documents related to Uranium One which prove relevant. All materials will be
collected by local militia pursuant to chapter. As stated under the rules of military
law, this order stands binding to conduct swift service.

It is so ordered that **HARVEY WEINSTEIN, FRANK GIUSTRA, KEVIN SPACEY** and
HILLARY CLINTON be hit with offenses for violating **18 U.S.C. § 241** on record
a minimum of three times. This as your honors will note, is original state
law U.S.C code with RICO charges attached. They are to be seized with due
course then placed in cells until trial.

For all of these criminal offenses, national Private Attorney Generals will have a field day
making each offense stick with penalties. In addition, they will be required to testify on record.

- 1) It is further ordered that Defendant **HARVEY WEINSTEIN's** motion to subpoena records
or quash; to be **DENIED**.
- 2) It is further ordered that Defendant **KEVIN SPACEY's** motion to subpoena records or
have subpoenas quashed; is likewise **DENIED**.
- 3) It is further ordered that Defendant **FRANK GIUSTRA's** motion to subpoena records
for discovery; be **DENIED**.
- 4) It Is further ordered that Defendant **HILLARY RODHAM CLINTON's** motion to subpoena
records for Discovery; be **DENIED**. Sanctions and penalties in effect.
- 5) It is further ordered, that according to **Marbury V. Madison**: any required subpoenas
on each defendant will be enforced by force of law and arms. All able bodies and
governing council, National Sate Counsel, Private Attorney General designates or
authorized militia will enforce the orders.

IT IS FURTHER ORDERED that:

This Court's December, 2017 Amended Scheduling Order is amended as follows:

(a) All discovery shall be completed on or before February 10, 2018 and all dispositive motions filed not later than two (2) weeks prior to the close of discovery; and (b) All other deadlines will be deferred by ninety (90) days from the date of issuance in this Order.
