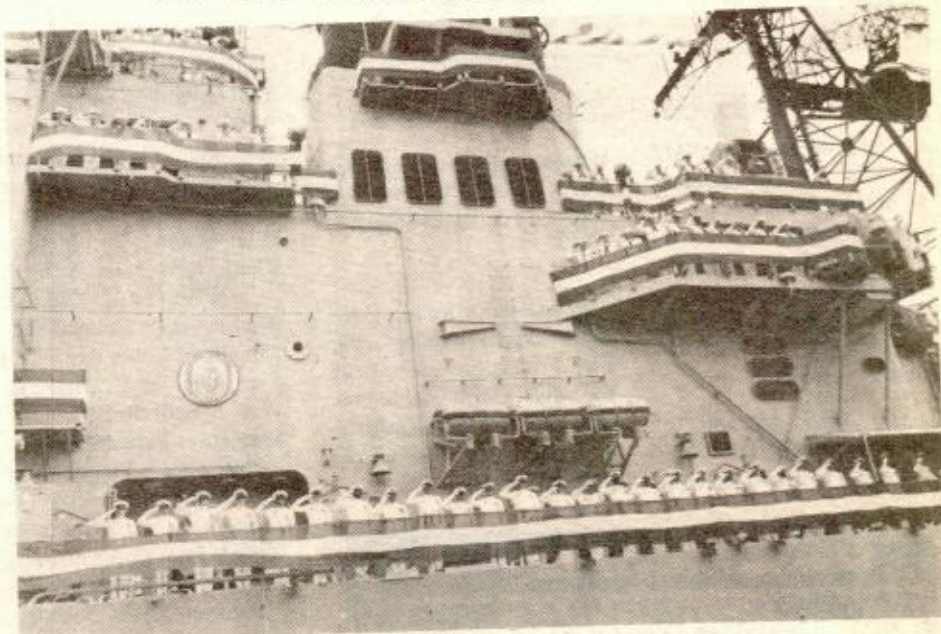

10,000 See USS Bunker Hill "Come Alive" At Commissioning Ceremony

Termed "A New Revolution", the USS Bunker Hill (CG-52) was commissioned into active service in the United States Navy at ceremonies in the Charlestown Navy Yard on Saturday, September 20, 1986.

The Commissioning, a tradition in the United States Navy that dates back to

1775, was held within sight of the Bunker Hill Monument which was erected to commemorate the heroic patriots who fought at Breed's pasture on June 17, 1775. This new ship, which bears the name USS Bunker Hill, pays honor to those who fought 211 years ago in a battle which the colonists

lost, but which proved to be a moral victory against the most powerful military power of that era and provided the inspiration for the colonists to continue their quest for independence from England — thus was born the American Revolution.

Officials Term Parking Adequate For North Area Construction Workers

With residential parking currently at a premium here in Charlestown, the thought of as many as 325 construction workers descending on City Square to work on the five to six year North Area Central Artery Reconstruction Project is alarming. However, rest assured, the consultants and engineers hired by the Massachusetts Department of Public Works (DPW) told the approximately twenty residents who attended the public meeting on parking issues at the Knights of Columbus Hall on Tuesday night, September 16th, that all parking required by the construction, including equipment storage and staging area, will be accommodated on site.

The project, simply stated, will replace the overhead roadway linking Routes 1 and I-93 to the Expressway with tunnels under City Square and loop ramps to the west of Rutherford Avenue. During the construction, traffic will be accommodated on a temporary detour structure which will be comprised of new and existing roadway. In total, the work will take between five and six years to complete. Six land parcels will be created as a result of the depression of the roadway into the tunnels.

Don Nicholas, Senior Project Manager from the engineering team Louis Berger and Associates, Inc., told residents that since parking is currently prohibited on the city streets included in the

construction area (namely, Chelsea, Water, Joiner, Grey, Chamber and the Chelsea/Water Connector), and all construction-generated parking needs have been satisfied, the only parking left to be addressed is the 23 parking spaces the National Park Service will lose in their lot on the Chelsea/Water Street Connector. The lot currently holds 72 cars. The 23 displaced by the creation of a new temporary ramp will be relocated to the DPW property west of the Maxwell Box Warehouse.

The average number of workers on the site will be 250, according to Nicholas. He explained that the tunnel construction will be done in three stages. During the entire project, space for 200 cars will be provided in the loop ramp area. Nicholas added that half of all parking area will be utilized for equipment storage and/or staging area.

The largest influx of workers will occur in the second and third years of construction work, estimated to be 325 workers. The first stage will take approximately two years to complete with work being done on the southern portion of the tunnels and the North Washington Street Bridge, as well as the loop ramp area. An additional 650 parking spaces will be provided in the City Square area. Thus, 425 total spaces will be available for the workers.

The second phase, also a two year period, includes

work on the central portions of the tunnels and the remainder of the North Washington Street Bridge, with City Square parking for 550 cars.

The final stage of work, which requires the least number of workers, around 80 or so, provides 1050 parking spaces in City Square alone.

There will be no physical barriers preventing the workers from parking on the city streets, but given the available parking area and the proximity to the work site, Nicholas said, "We have no reason to believe the workers would want to park off site." The engineer noted that chances were the workers would like to "keep an eye" on their vehicles to guard against theft or vandalism. Also, many of the workers will need to be closer to their cars, which may carry necessary tools and equipment.

While parking for the construction workers seems to have been satisfied and the current number of parking spaces utilized by the visitors to the National Park at the Charlestown Navy Yard accommodated, concern was raised that the future parking problems of the Navy Yard should be incorporated into this parking scheme.

An anticipated one million tourists a year visit the Charlestown Navy Yard, however, parking is only provided for 72 cars and buses. Ken Stone of the North Area Task Force told the consultants that the land parcels which will become available as a result of the roadway depression should not be utilized for future parking for the National Park Services, especially since the

park service is "not doing anything about their parking problem on their own land."

Other residents suggested that the National Park Service re-open their discussion with the Massachusetts Port Authority for the right to park cars underneath the Mystic Tobin Bridge. Glen Sadulsky, engineer from Howard Needles Tammen Bergendoff, asked, "What is the general consensus of the Charlestown community here as to the idea of parking under the bridge?"

David Donovan, resident, answered, "I think it's an excellent idea if it is done in an attractive way."

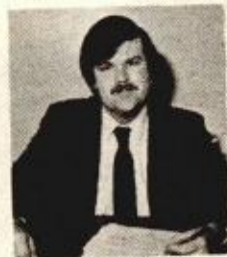
This idea of providing parking under the bridge is nothing new, stated Elaine McCarthy, "I've been involved in this parking situation (of the Navy Yard) for 12 years and maybe 50 meetings, and the only solution to the problem is under the bridge. The workers of the Navy Yard used to park there."

Mon O'Shea added, "The National Park Service can't invite all those people who are coming in from California without providing parking." John Debo, Assistant Superintendent of the Boston National Park, commented, "If we can't find parking for them (the tourists) they will find it themselves." As for the notion of parking under the Bridge, Debo said the park service has been meeting with Massport, "We re-

act very favorably to that (idea). It has a lot of merit." However, the assistant superintendent added, there were safety and legal matters associated with the idea which need to be addressed, but "we might be able to work them out, if the law-

yers don't get too involved."

The next meeting of the North Area Central Artery project is scheduled for October 21st. The subject of parking will be continued at that time, in addition to a variety of development issues.

The Niles Company's Property Management Division is managing two other commercial properties for Gunwyn. The Niles Company's Vice President and Director of Property Management, James T. Collins, said, "We're very pleased to be working with an architect of Graham Gund's calibre, and of course, it's exciting for us to be associated with a high quality development like The Schoolhouse."

Jan Brodie, a spokesperson for the owner/developer, said the decision to name The Niles Company as property manager was based on the Gunwyn Company's prior experience with Niles's property management division.

Explained Brodie, "We have been pleased with The

Niles Company's management of two of our commercial properties in Cambridge, and we are very familiar with their significant presence in the field of residential property management."

The Schoolhouse is a four-story building with enclosed basement-level parking. The 44 apartments consist of 22 one-bedroom, 19 two-bedroom and 3 three-bedroom units. Some of the apartments include additional rooms to be used as a study or den, and most have eat-in kitchens and walk-in closets. The units are all spacious and bright.

One-bedroom units include as much as 1050 square feet. Two-bedrooms offer up to 1,250 square feet. Three-bedroom units offer approximately 1400 square feet. They all have oversized period windows, which in many cases are over ten feet tall. The ceiling height in all units is 14 feet.

The architects incorporated much of the school's original detailing in its conversion. The marble entry features Greek columns leading to a grand central staircase. Inlaid panel wainscoting, triple vaulted ceilings and wrought iron railings can be found in both the apartments themselves, as well as in the public spaces.

The architects have also created a dramatic skylit atrium that fills the entire center of the 60 foot building. The building sits in the middle of the highly desirable Monument Square area, with the charm and history that Charlestown has to offer. Its location at the top of the hill, adjacent to the Bunker Hill Monument, provides magnificent views of Boston from almost all units.

The Schoolhouse has generated interest from all age groups, Brodie said. Leases have been signed with established Boston professionals, as well as newcomers to the area.

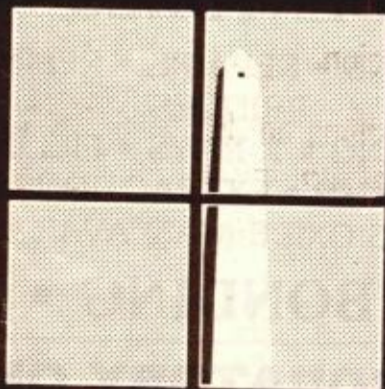

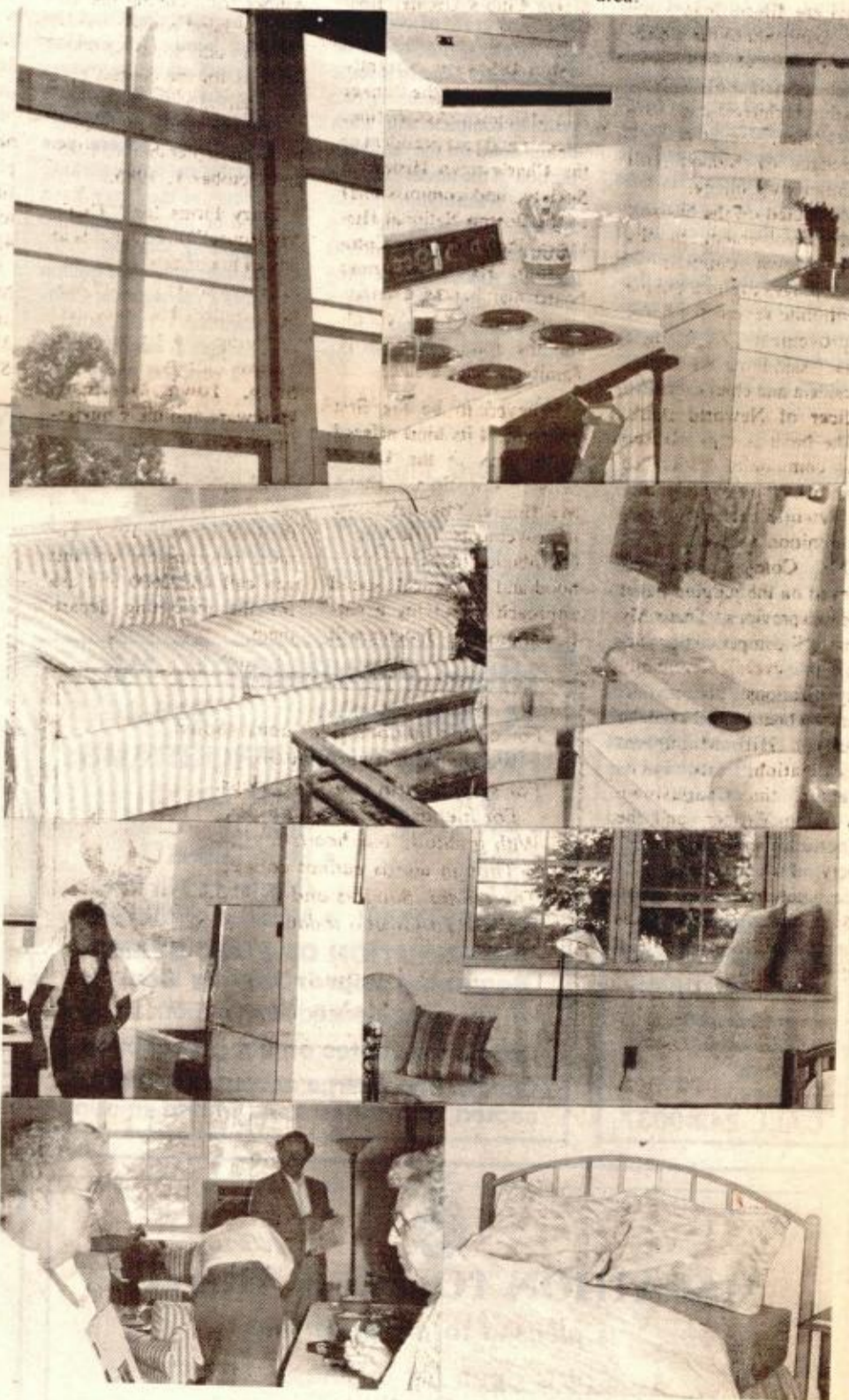

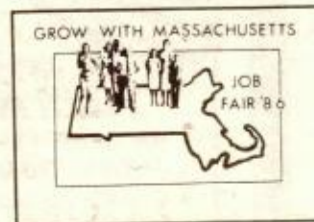

State Treasurer Crane Returns Unclaimed Insurance Proceeds

State Treasurer Robert Q. Crane has announced that his office is attempting to return more than \$2 million to 18,000 Massachusetts residents under the state's Unclaimed Money Law.

Treasurer Crane noted that this money has been reported to the Treasury by insurance companies doing business within the Commonwealth of Massachusetts. Included in the proceeds are unpaid benefits on health and liability insurance policies, unpaid life insurance benefits, customer overpayments and pension checks.

Under Massachusetts' Unclaimed Money Law (M.G.L. ch. 200A), accounts which have been dormant for at least five years are deemed to be abandoned and must be reported to the Treasury. The Treasury De-

partment then tries to locate the rightful owner or legal heirs to return the money.

"We are encouraged by the increase in compliance nevertheless, our efforts will continue until every dollar is returned," Crane said.

More than 6,000 accounts range between \$100 and \$500; 347 accounts between \$500 and \$1,000; 175 accounts between \$1,000 and \$10,000; and 10 accounts more than \$10,000. The remaining accounts are less than \$100. Last spring Treasurer Crane released the names of 26,000 Massachusetts residents who were owed more than \$13 million, most of this resulting from unclaimed savings accounts.

The President of College Financial Planning Services of New England, Gregory A. Leonard of Charlestown, recently appeared as a guest on WBZ Radio's Peter Meade talk show to discuss the importance of financial planning for a college education.

The main focus of the discussion centered around the availability of federal aid and how parents, even with family incomes in excess of thirty thousand dollars a year, can qualify for the nearly \$20 billion dollars the government sets aside for education each year.

According to Leonard, in 1985 one billion dollars in federal aid for education went unused. The reasons cited ranged from people not being aware that this funding was available to them to the improper form preparation by those applying which either disqualified the applicant or qualified them for less than they could actually receive. "Many parents disqualify themselves because

they don't fully understand the process," explained Leonard.

As an example, he used a recent case where the Chief Executive Officer of a Boston hospital, with a family income of over \$90,000 and three children in college, applied for federal aid on his own. When he was notified that he did not qualify, the hospital executive contacted Leonard's firm. After analyzing his situation and upon processing the new FAF (Financial Aid Forms), College Financial Planning Services

was able to secure over \$10,000 in tuition aid for the CEO and his family for the 1986-87 school year.

Leonard also fielded a number of questions from listeners who called the Peter Meade program with their concerns about how to afford college tuition for their children.

In addition to WBZ's Peter Meade show, Greg Leonard has appeared on WSBK TV-38's *Journal*, WROL's *Sherm Fella Show*, WTTP's Bruce Jeannot talk show, WCAP's *Special Assignment* and is scheduled for several more talk shows throughout the fall. Leonard and his staff are also scheduling seminars and work shops on college financial aid with several high schools, organizations and businesses during the next three months and again early next year.

Groundbreaking For Affordable Housing At The Charlestown Navy Yard

Mayor Raymond L. Flynn, announced the creation of affordable housing in the Charlestown Navy Yard on Harborpark Day, September 14, 1986.

This was an historic occasion in the development of the Charlestown Navy Yard. Originally, all parcels in the Navy Yard were designated for either commercial use or luxury condominiums. Under Mayor Flynn, through the newly created Harbor-

park, negotiations were begun between the Boston Redevelopment Authority, Immobiliare (developer), and the Bricklayers and Laborers Union, to provide affordable housing in the Charlestown Navy Yard.

As a result, 80 townhouse style residential units, ranging in price from \$72,000 to \$78,000, will be constructed by the Bricklayers and Laborers Non-Profit Housing Co., Inc. to be offered to

first time homeowners through a lottery. (Details on the lottery will be announced in later issues of **The Charlestown Patriot**.)

During the speaking program, Mayor Flynn stated, "The continuance of providing affordable housing for all of Boston's residents in all our neighborhoods is essential." This project underscores Mayor Flynn's commitment to the needs of Boston's neighborhoods.

Main And Warren Streets Reconstruction Project Update

The Main and Warren Streets Reconstruction project, which began the last week in April but never progressed beyond the first 1000 square feet of work, should start up again "shortly", according to a spokesman of the Massachusetts Department of Public Works (DPW).

Baker and Company, the Stoughton-based contractor awarded this project, was declared in default of their contract on August 20th by the DPW Board of Directors because of their lack of progress. Baker only completed 3% of the work, despite a lapse in the work schedule of 25%.

The bonding company, Aetna, who insured the project, has been in ongoing discussion with DPW Commissioner Robert Tierney as to how to complete the project, which has left Main Street between Albion Place and Mishawum Street in an utter state of disrepair behind jersey barriers. According to DPW Spokesperson, Scott Pickard, Aetna has advertised for contractor's bids. The deadline to submit work bids is Monday, September 29th, after which a new contractor will be awarded the contract.

"Things are moving," ex-

plained Pickard, "We have every intention of having some of the work completed before the winter." Despite the delay caused by Baker's lack of work since June, and the default in August, Pickard said he was somewhat confident that the project

would be completed by June 1987, the original completion date.

"The sooner we get this project done, the better it will be for us (the DPW) and the better it will be for Charlestown," concluded Pickard.

mony that took place before a crowd estimated to be 10,000 in number, was inspirational, with martial music, flags, banners and balloons all complimenting the varied speeches, many of which referred to the historical perspective, relating the Battle of Bunker Hill to this new vessel that bears her name.

Guests began arriving at

the Charlestown Navy Yard from 8:00 a.m. to secure seating for the 11:00 a.m. ceremony. The general public was seated on Pier 5, while the families of the crew and members of the Bunker Hill (CV-17) Association found their places on Pier 4. Members of the CV-17 Association, who served on the aircraft carrier **USS Bunker Hill** during World War II, held their annual re-

union in Boston to coincide with the commissioning of the new **Bunker Hill**.

A brief rain shower failed to dampen the spirits of the guests and the skies cleared before the ceremony began.

The arriving guests were treated to musical selections provided by the United States Naval Academy Glee Club from Annapolis, Maryland, who sang from the bow of the ship. The band on this

occasion was the Northeast Region Navy Band.

The crew of **USS Bunker Hill** lined the outer perimeters of the two piers and at 11:00 a.m., Commander William G. "Skip" Wheeler, USN, Executive Officer of **USS Bunker Hill**, opened the ceremonies. He welcomed the gathering, thanking them for "joining us in sending off the **USS Bunker Hill** for a long, productive



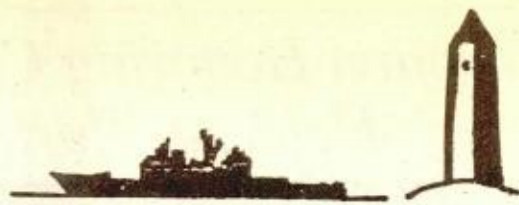

career in the Navy." He then introduced the official commissioning party, who were seated center on the deck of the ship.

Rear Admiral John R. McNamara, Chaplain, offered the invocation, stating, "More than two centuries ago, a band of citizen soldiers holding **Bunker Hill** against untold numbers, shocked a nation." He asked blessings on this ship with

"such an historic and challenging name." The Chaplain concluded, "May her crew take inspiration from her sister ship, CV-17."

"This ship represents the work of 13,000 dedicated employees at Ingalls Shipbuilding," stated Gerald J. St. Pe, Vice President of Litton Industries. "They gave three years of their lives to build her." He went on to say that this "honors the heroes of Bunker Hill by naming the ship in their memory, as well as honoring the people who built her and the people who will sail her." St. Pe told the audience that the building of this ship is an example of a public-private partnership, adding that it was built "ahead of schedule and under budget." Turning to Captain Philip M. Quast, USN, Prospective Commanding Officer, he said, "In working with you for the past three years, I know you and your men realize the re-

sponsibility placed on you from the name — **USS Bunker Hill.**"



VICE ADMIRAL George W. Davis, Jr., USN, Commander Naval Surface Force, U.S. Pacific Fleet, welcomed the USS Bunker Hill to the Pacific Fleet.

Vice Admiral George W. Davis, Jr., USN, Commander of the Naval Surface Force, U.S. Pacific Fleet, stated that he was pleased that this ship would soon be joining the Pacific Fleet. He referred to a Navy Captain who had spent six years in an Hanoi prison, as he addressed a POW/MIA vigil. Davis related, "The Captain had spoken of patriotism, not of his own, but of all America and was pleased at its resurgence. He spoke of freedom, not of his own, but for all Americans" and the fact that "it is our duty to protect these remarkable freedoms for our children." Davis referred to the many present from the Bunker Hill Association "who served on an aircraft carrier in World War II, protecting these freedoms."

"This ship is part of a revolution, as was its name associated with a revolution," stated Vice Admiral Joseph Metcalf, III, USN, Deputy Chief of Naval Operations (Surface Warfare). He referred to the insignia of **USS Bunker Hill** with the shield representing the aegis radar system and the sword being the missiles carried by

this vessel. He related the quotation attributed to Colonel William Prescott at the Battle of Bunker Hill — "Don't fire until you see the whites of their eyes." Metcalf stated that Prescott was outlining how far his soldiers could shoot. He contrasted this statement with the capabilities of the **USS Bunker Hill** which can reach out several hundred miles. He pointed to the crew of the ship, stating, "The Navy men you see lined up are volunteers — they feel the responsibility ... as this ship is our shield."



COMMENTING on the fact that this ship is an "engineering marvel" was Vice Admiral William H. Rowden, Director of Naval Sea Systems.

Vice Admiral William H. Rowden, USN, Director of Naval Sea Systems, noted that "this ship is an engineering marvel, made possible through Navy and private industry teams." He went on

to say that the **Bunker Hill** will contribute considerably to the country's defense posture. He concluded, "I salute those who will sail on her — her plankowners." (Plankowners are, in Navy tradition, the members of the crew at the time of a ship's commissioning.)

"The **Bunker Hill's** aegis radar system can shield a whole fleet for hundreds of miles," stated Walter T. Skallerup, Jr., General Counsel for the Navy. "It can view in all directions simultaneously." He noted the significance of the entry of this ship into the Naval fleet.

Edward M. Kennedy, Senior Senator from Massachusetts, was the Principal Speaker for the ceremony. He stated that he was honored to be present at the Commissioning of what he termed to be a "miracle of the modern Navy."

He acknowledged the presence of the CV-17 Associa-

tion, noting that they were, as the crew of the aircraft carrier **USS Bunker Hill**, "brave sailors of that legendary ship that participated in some of the most courageous battles in the South Pacific," and "no matter of time can dim what they did." He then asked that members of the CV-17 Association stand and be applauded.

Kennedy noted that the gathering was near the site of the Battle of Bunker Hill — "We lost the Battle but won the war because of it." He continued, "Bunker Hill is linked to Colonel Prescott's 'Don't fire until you see the whites of their eyes,'" pointing out that "we can't afford to wait that long today. If need be, **Bunker Hill** would be firing long before the whites of their eyes were in view."

Kennedy related the history of Boston Harbor, from the construction of "Old Ironsides" within the harbor, through her encounters during the War of 1812. He pointed out the contributions the Charlestown Navy Yard made to the defense of the country through the World Wars and until the Yard was

closed in the 1970s.

He also cited several Massachusetts firms that help build **USS Bunker Hill** — Raytheon, Bird Johnson, Martin Marietta and General Electric.

The Senator, in referring to the capacity of this vessel, stated, "This weapons control system can fire and direct more missiles at more targets, with greater accuracy than any system the Soviets have today, and we intend to keep that advantage in the future."

He continued, "There may be arguments in Congress on 'Star Wars' — there are no arguments in Congress for a strong defense and a strong Navy."

In conclusion, Kennedy offered a salute to those who will serve on **Bunker Hill** and, directing his remarks to the crew, stated, "Always be faithful to those other men — the patriots of Bunker Hill."

Senator Kennedy then called Captain Quast forward and officially placed **USS Bunker Hill** into active service in the United States Navy. Captain Quast read his official orders and ac-

cepted command of the ship. At this point, the Commissioning Pennant was raised, the first watch was set and the crew was "ordered to quarters". Crew members, in double time, climbed the gangways to take their position on each deck of the ship. The crowd applauded as the last man reached his appointed spot on the topmost deck. Then, to the music of the Navy Band, the crew stood at attention and saluted as the ship "came alive" with the release of red, white and blue balloons and a shower of confetti. The radar and deck guns turned and smoke issued from the stacks — the ship was now manned and "alive".

the people who had waited on the pier for the arrival of the ship last Monday and the warm welcome the ship and her crew received. He pointed out the hospitality of the Charlestown community, singling out two residents. He said, "I want to recognize Bob Gillen and Jim Conway — two true 'Townies' — my thanks for all you have done."

Quast told the gathering, "We have a lot of high technology on board this ship, in fact in might be called 'state-of-the-art'." He continued, "Anyone who goes to sea know the importance of the man. When you tour (this ship), take time out to meet the men — the finest crew in the United States Navy."

Then, turning to the families of the crew members on Pier 4, he said, "Important for the men who go to sea are those we leave behind on shore — the Navy families."

Chaplain McNamara concluded the ceremony with a benediction in which he prayed, "We are grateful for the genius who designed her

and the skill of those who built her — Bless the Captain and the crew as she has truly 'come alive'. May she have a future worthy of her past."

The distinguished guests then boarded a harbor cruise boat, the Edward Rose Snow, coincidentally a boat named after a noted New England historian, and were transported to a reception at the World Trade Center for the crew and invited guests.

Neighborhood Council President Submits Report On Land Parcels

Dear Mr. Coyle:

The Charlestown Neighborhood Council met recently and considered the proposed Requests for Proposals (RFPs) on the above named parcels. I am writing to you now to inform you of the results of those deliberations.

P-2A

The Neighborhood Council voted unanimously to recommend to you that the RFP for this parcel be amended as follows:

1. That the following language be added as a new paragraph after the paragraph entitled **Affordable Housing** in Section II:

To that end, all prospective developers will be required to submit as a basis for their proposals a statement of need defining the need for affordable housing in Charlestown. This statement should specify and quantify in an understandable way the number of families requiring low and moderate income housing in Charlestown, the size of such families, the cost and form of appropriate housing and the type and amount of financing necessary to afford such housing.

After stating this need, the prospective developer's proposal should thereafter:

1. Produce the maximum number of housing units that are financially and legally feasible to meet the stated needs;
2. Maintain and/or provide appropriate and necessary open spaces;
3. Suggest other locations in Charlestown where the developer would be willing to build low and moderate income housing;
4. Suggest other contributions the developer will make after designation to support and/or create additional low and moderate income housing units in Charlestown;
5. Specify the manner in which units will be distributed

As a result of these concerns, the Council voted to request that you delay this issuance of the RFP on this parcel until such time as a member of your staff meets with the Council's Development Committee and interested abutters. Michael Powers is the Chairman of said Committee and I would ask that he be contacted relative to said meeting which has been scheduled for September 18, 1986. Hopefully at that time all outstanding issues can be resolved.

Other Action

In a related matter, the council also voted to request that you and your staff make a written report to the Council on the status of the list of displaced persons who were displaced from homes that were taken when P-2A was cleared several years ago. We would like to see the list and know what your plans are to use this list now that you are at the point of soliciting proposals.

I am available to you and your staff to discuss the Council's actions if you require any clarification of same. Thank you for your attention to our requests.



Library Storage Facility Slated For Renovation

The former Armory on Bunker Hill Street, now utilized as a storage facility by the Boston Public Library, is slated to receive \$6.4 million out of the total \$799 million Capital Improvements six year budget, in order to renovate and modernize the building which, according to Mary Nee, the Director of the Capital Improvement's Office, "has decayed."

The director explained that the armory building has a number of problems, including "structural and mechanical" ones, which must be addressed if the building is to continue as a book depository. These problems are both internal as well as exterior. The work will be done in phases, the first of which will be an exterior rehabilitation. The final work will focus on internal

usage of the facility. A new, modern shelving system will be installed, which will not only improve the library's operations, but also allow the building to be used for housing City archives.

The Capital Improvements Program, which began last September, will continue in a "revolving forward five year planning" schedule. When asked if a Charlestown Police Station was included in future capital improvement plans, Nee answered that the City has been investigating various buildings and land sites in Charlestown for a possible location of a police station, but there have been no definite plans to date. The possibility of the station returning to its former City Square address has

not been ruled out. "There are not a lot of buildings or land available in Charlestown," explained Nee, for a police station. The former Charlestown Police Station, closed as a result of Proposition 2 1/2, was located at One City Square, but the Life Focus Center, a multi-service center for mentally retarded and physically handicapped individuals, currently occupies the building. "We've looked at the old police station (as a possible site for a future Charlestown Police Station)," continued Nee, adding the Life Focus Center is "outgrowing the space and they are in a position where they are looking to expand." Nee added that the current facility is not adequate for handicapped usage,

but the city is not looking to evict the Center in order to relocate a Police Station. Should the Life Focus Center decide that they do, in fact, need a larger facility, the City could use the

former police station as the new Charlestown Police Station. Nee said the city would "like to be cooperative and assist the Life Focus Center" to secure a new facility for their operation.

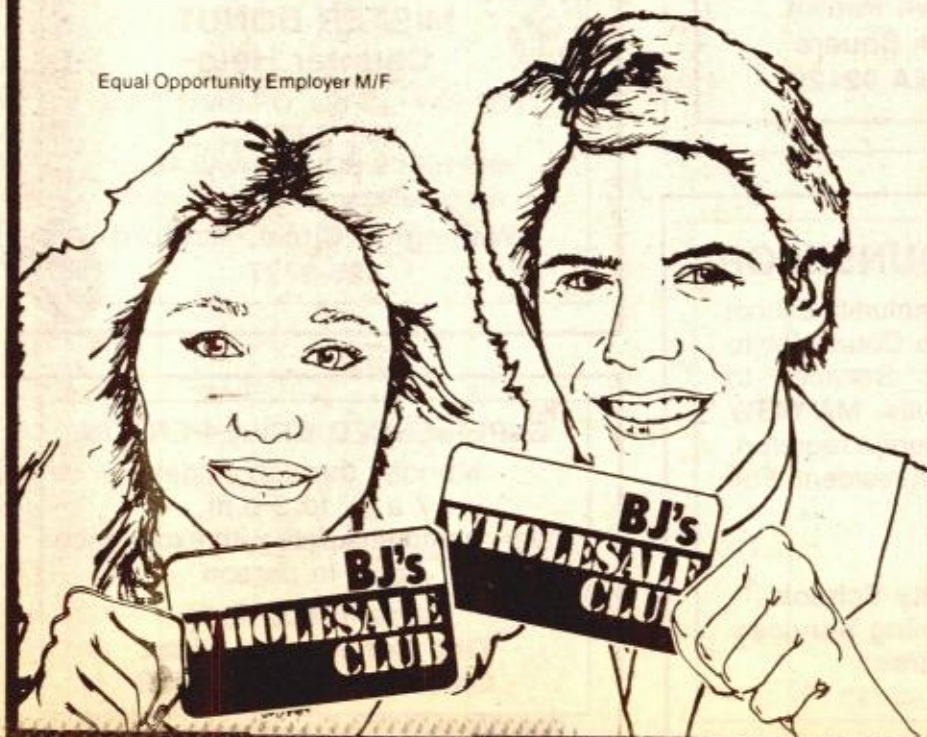

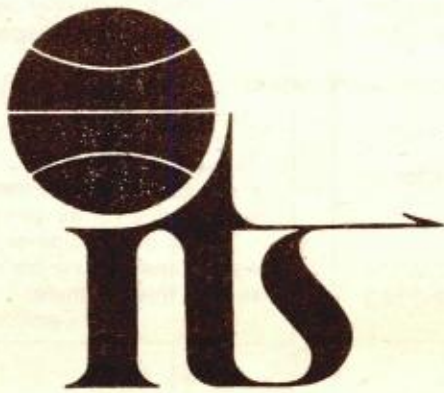
