



What challenges do your clients face?


- Unable to travel worldwide without the administrative burden associated with visa applications





Our Core Areas of Expertise

RESIDENCY PERMITS

- Grant the right to permanently settle down in the issuing jurisdiction (and that jurisdiction alone);
- In the case of Schengen
 countries, it also grants the
 freedom of movement within the
 Schengen border union;
- Permanent residency does not grant voting rights or the right to consular assistance.

CITIZENSHIPS

- In addition to granting the right to permanently settle down in the issuing jurisdiction, citizenship also provides a wide range of benefits such as the right to vote (*with some exceptions) and the right to consular services;
- Unlike (permanent or temporary)
 residency permits, citizenships
 are also hereditary (*in most
 cases, but with some exceptions);
- Citizenship in an EU country further grants the right to permanently settle down in any EU member country.

- Can be withdrawn
- Is likely to affect tax status

- Ability to pass citizenship onto future generations
