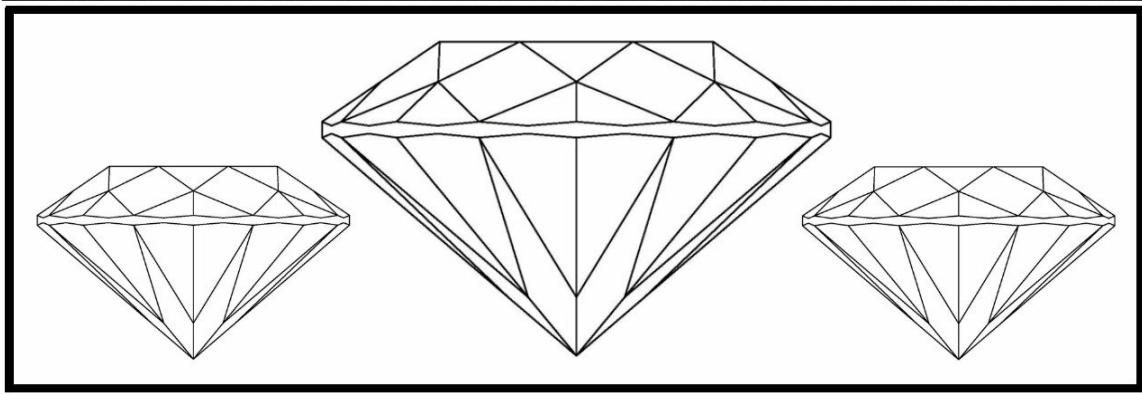

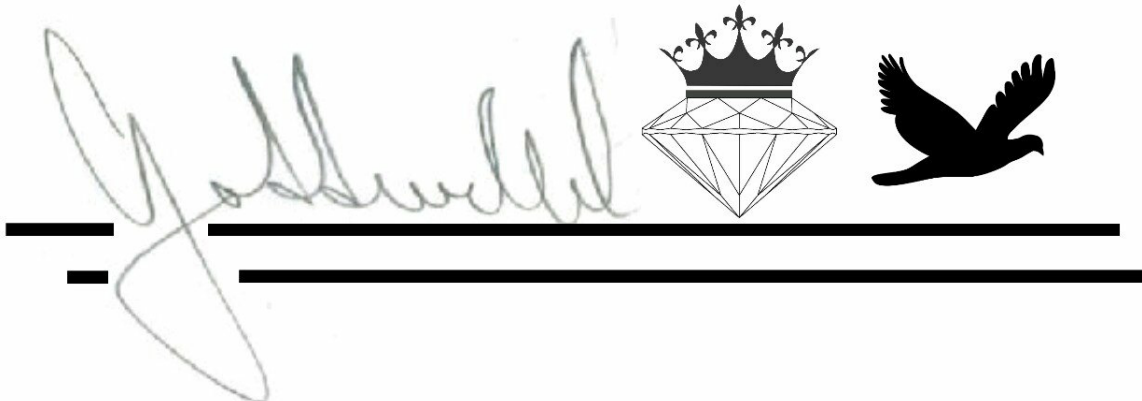

**Additional Protocol on the responsibilities of the United Nations and such obligations of legal enforcement as well as responsibility for respecting the urgent obligation to act for security and peace.**

1. Due to the infiltration of the terrorist organization into the International policy structure, the prosecutors of the ICT Council have the right to consider the appropriate process of the function of the international bodies, thereby launching their own choice of democracy over the foundations of the UN Charter and the right to decide on the changes to the Charter, of all entities abusing the bureaucratic position in order to promote International crime, the organization of International crime, the protection of an organized International crime network, and thus the decisions of the Council of State Courts, on changes in practices of the international text and the Charter of the United Nations, as acts permitting crime and criminal abuse of rights, legal principles and strategies to prevent the future recurrence of these crimes.

2. If the number of members of the Council of the International Criminal Tribunal is not sufficiently accountable for achieving responsible democracy for the purpose of deciding and amending the legal practice of a criminal purpose, the UNGA States shall have this purpose as a regulation above the legal basis of the Regulation by the Charter of the United Nations, and the main objectives of the UNGA Declaration and thus the importance of organized crime of the European Terrorist Alliance on the International legal level, meaning the value of this regulation as the nature of the purpose of the United Nations Organization, and the nature of the removal of the criminal movement from International political structures.



3. If the United Nations is to refuse its own exercise in accordance with the principles of law and founding facts for the purpose of establishing and declaration the United Nations, the UN and the rights of competence for the urgent response to the security and stability of legal rights and international peace must be replaced by the Council of the International Tribunal the right of the World Democracy of the States on the number of its own members, together with the convictions for the achievement of justice based on International Law and the Nature of the Wording of the Criminal Principle.

This affirms the interests of the United Nations and such organizations as worthless because of the illegitimacy of their ability to exercise their own political responsibilities and the function of the state, which also means that they are incapable of responding to the performance of the ICT's criminal justice function against terrorist members of the organization and active at International level.
