Instructions for completing an application for a Permit To Acquire a Longarm

This application form is for current licence holders who wish to acquire a firearm. YOU CAN ONLY PURCHASE ONE FIREARM PER APPLICATION. A permit is valid for 90 days.

Instructions to all applicants – follow these steps to complete your application

SECTIONS A and B APPLICANT'S DETAILS

You must enter your licence or permit number and you must complete either the Personal Details or Business/Club/Government Agency Details Section depending on who holds the licence or permit.

SECTION C SAFEKEEPING ADDRESS OF FIREARM

You MUST provide an address where this firearm is stored when not in use. If this address is the same as your residential address mark the box provided with an "X".

SECTION D TYPE OF FIREARM

Indicate the type of firearm you wish to purchase by marking the appropriate box with an "X". Remember, you can only apply to purchase one firearm per application. You may only acquire a firearm as authorised by your licence or permit.

GOOD REASON TO ACQUIRE A FIREARM

This reason must be in agreement with a genuine reason and related firearm category for which you hold a firearms licence. Signing the declaration confirms that your good reason for acquiring the firearm is directly related to the genuine reason and category of your current firearms licence.

SECTION E FEE EXEMPTION

Pensioners are exempt from fees for Permits to Acquire for all categories of firearms, if they hold a current Pensioner Concession Card issued by the Department of Social Security or Department of Veterans Affairs, or receive a Disability Pension or Armed Services Widows Pension from the Department of Veterans Affairs. Include a copy of your Concession or Pension Card if you have not previously obtained a fee exemption from the Firearms Registry, or the document previously supplied is no longer current.

Primary Producers please note that you must have the genuine reason of Primary Production on your licence to claim the fee exemption. If you do not have the genuine reason of Primary Production on your licence or you have ceased to qualify as a primary producer, you are not entitled to the exemption and you must not mark the fee exemption box.

Note: Health Care Cards are not accepted.

DECLARATION

Check the details on the application form. If all details are correct, sign and date the application.

Once you have completed the application you must, unless you are fee exempt, attach a cheque or money order, or complete the credit card authority below, for \$30 - DO NOT SEND CASH.
