Hurwitz Named Principal Of Charlestown High School

Boston Public Schools Superintendent Thomas Payzant announced to Charlestown community leaders that Charlestown High School Headmaster Stacey Johnson would be replaced by Marilyn Hurwitz, effective Nov. 20.

The early-morning Nov. 16 announcement at the school is one of the newly-hired Payzant's decisions to make positive changes

in the city's school system. Charlestown High lost its accreditation earlier this year. Payzant said that the high school will still probably be on probation after a required Dec. 1 report is due to accreditors.

Payzant said that he has taken action with a sense of urgency, but Charlestown could not expect immediate results.

"I am committed to get off probation as soon as we

can," Payzant said, "and not let it go beyond that."

Introducing himself to a dozen or so resident leaders Payzant said, "I'm the guy where the buck stops." Describing the day as an important one for Charlestown and the high school, he said, "It doesn't mean they are always easy, but personnel decisions are the toughest and most important."

Hurwitz officially took over as headmaster on Monday. Most recently Hurwitz served as assistant headmaster and program developer for ACC, a college preparatory alternative program. She has been

involved in BPS since 1970 and commented that her peers call her the *Joat*, the jack-of-all-trades. In her educational career her work has included, but is not limited to, coaching, developing programs for student services and leadership, and teaching.

"I'm not a miracle worker, but I am a hard worker," Hurwitz said. "I am committed to kids and excellence in education, and I want to raise the academic standards, work on the school-to-career programs and ask kids to be more responsible for

Hurwitz underlined her desire to have community involvement at the high school. "The community

is part of the educational process," she said. "The door is always open."

According to the school accreditation overseers, Charlestown High's success will focus on leader-

ship and academics. Payzant said he does not know why there are problems with accreditation, but he said it is more important to move forward than to look back.

"Success is to have teachers that are perpetual learners," Hurwitz said of wanting to support the strong Charlestown High faculty, "and to make kids perpetual learners too."

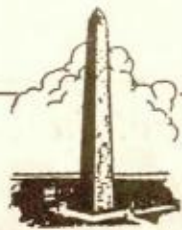

Menino said, "This festival is a chance for Boston's residents and businesses to let others know what we already know - that Boston is a city rich in holiday cultural traditions and neighborhood pride. Whatever the holiday tradition - whether it's Christmas, Hanukkah, Kwanza - celebrating light during this darkest time of year is a common theme."

The festival encourages residents and businesses to create outdoor lighting displays celebrating the city's cultural traditions. Residents will nominate winning displays by Dec. 7 through nomination papers available through Nov. 30 in daily newspapers, weekly neighborhood newspapers, as well as in the lobby of Boston City Hall. Nominations may also be made through Bosnet, the city's on-line information service at 635-3282.

The Mayor's Youth Council, comprised of two teen representatives from each of the city's nine city council districts, will judge all nominated entrants and select two winning displays - one for Best Residential Display and one for Best Business District Display - from each city council district. Menino will present awards to the winners at a special City Hall Plaza lighting ceremony on Thursday, Dec. 14.

★ **Kennedy Center Toy Drive . . .**

★ **Tobin Bridge Resident Stickers To Be Offered Jan. 1 . . .**

Massport will discontinue its commuter sticker program on Dec. 31 and instead will offer toll discounts for passage on the Tobin Memorial Bridge to residents of Charlestown and Chelsea only. All other passenger vehicles will pay a flat 50¢ toll for the trip into Boston. Outbound traffic will continue to cross the bridge without charge.

The commuter discount stickers are due to expire at the end of November, but will be extended through the rest of the year. The current commuter discount stickers allowing travelers to save 20¢ off the 50¢ toll were first offered in 1991 and were intended to last only two years. Massport extended the tickets at no extra charge for the last two years.

The discount stickers will be available to Charlestown and Chelsea residents for \$5 each, effective Jan. 1, 1996. Those stickers provide Charlestown and Chelsea residents with a discount of 20¢ per commute over the Tobin Bridge. Drivers with resident stickers will pay only 30¢ for the toll, rather than the regular 50¢. These stickers will be valid for discount tolls for the life span of the vehicle registered in either Charlestown or Chelsea.

The new stickers will be available to residents of Charlestown and Chelsea at central locations in the communities in

December. Notices will be placed in the local newspapers listing the locations for the sticker sales. Residents seeking the stickers must present vehicle registration, driver's license and a utility bill. Massport staff will affix the new sticker directly to the windshield at the time of purchase. Removal of the old sticker, as required by Massport and the Mass. Registry of Motor Vehicles, is the responsibility of the car owner. If you have questions, please call Massport at 242-7979.

A petition has been filed with the Boston Landmarks Commission, requesting that the property at 16 Harvard St. in Charlestown, the Edward Everett House, be designated a Boston Landmark. Following the preliminary hearing, the commission will vote on whether to accept the petition and, if necessary, to arrange for the preparation of a report to evaluate the significance of the property.

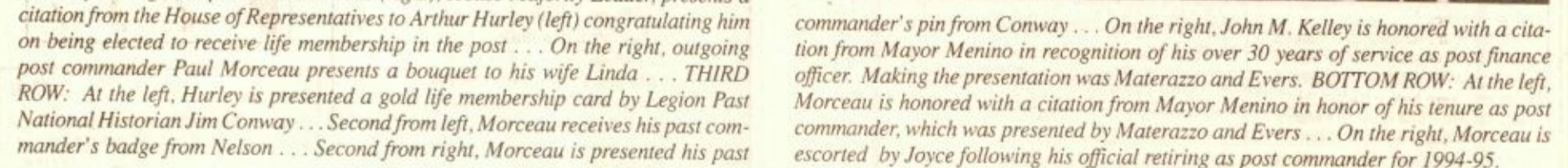
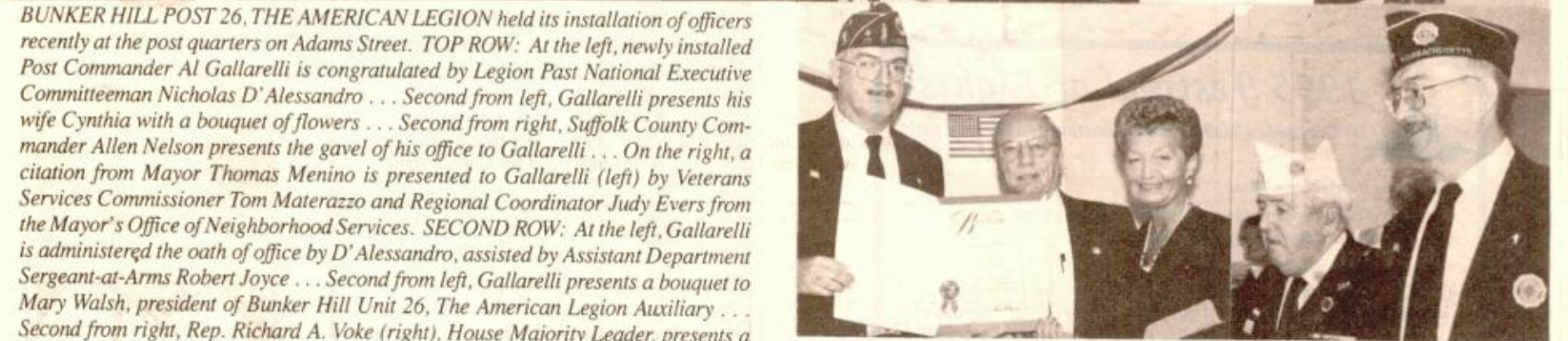

CNC Asks For Consultant In Planning Bunker Hill Street Lighting

The Basic Services Committee will recommend to the full Charlestown Neighborhood Council that there be a consultant to meet with residents on the most feasible reconstruction and street lighting plan for Bunker Hill Street. The unanimous vote came after a two-and-a-half hour Nov. 16 meeting with neighbors and Public Works Commissioner Joseph Cassazza in Bishop Lawton Hall of St. Francis de Sales Church.

The more than 100 residents attended mostly out of concern for what kind of lighting the city will provide for the length of Bunker Hill Street. Committee Chairman Billy Galvin reported that 90 percent of the more than 50 neighbors who spoke on their design preferences want gas lights similar to those found on Warren Street. A minority of residents argued for a

combination of gas and electric lighting because they said gas lamps alone are not bright enough for Bunker Hill Street.

The city had installed an electric lamp in a gas light housing along with three other lamps in Hayes Square for neighbors to consider as an alternative, following a summer committee meeting. But residents told Cassazza that the prototype lamp was harsh and unacceptable.

Annette Tecce of the Charlestown Preservation Society said that the group had done a light study on High Street, which is comparable in width to some parts of Bunker Hill Street. Tecce said that the study showed gas lamps are adequate, adding that all of Charlestown should be consistent because it is a "small urban village with a lot of history."

Cassazza said he disagreed with the findings of

the Society's light study. "You cannot light a street as wide as Bunker Hill Street safely from one side to the other," he said. "There will be a dark spot in the middle of the street."

CNC member Don Haska had done his own light study and presented his findings of street lamps around the city and said that while he preferred gas lights, a combination of electric and gas would be in the best interest of public safety. Haska suggested the double acorn electric style mixed with the colonial gas type. "I'm suggesting an island of light with ribbons of light in between," he said.

At times the meeting grew heated as some residents claimed that the Bunker Hill Street neighborhood was being slighted because of a lower-economic standard for that part of Charlestown than such areas as Town Hill

and Monument Square. Neighbors argued that the original designs for reconstruction called for gas lamps, that they increase property values and maintain continuity in Charlestown.

Local architect Jack French said that gas lamps bring "softness to the world." French was applauded when he told committee members and Cassazza: "The lighting is a red herring. It's really economics. This town has paid its dues. We spend more money in taxes than we get back in city services."

And Main Street resident Rosemary Kverek asked, "If the street is too wide for gas lights to be effective, can you consider narrowing the street?"

Other suggestions to allow for using only gas lights were to stagger stop signs, install traffic lights and control speed through design. The reconstruction

plan includes planting trees and sidewalk replacement along the length of Bunker Hill Street and was expected to begin sometime next spring. Particular types of trees can help or hinder street brightness and also need to be seriously considered in the design phase of reconstruction.

Committee member Bill McCabe told residents, that while the gas-lamp alternative "is not a popular stand, I will work on your conscience." McCabe said he believed that the acorn lights are better for public safety, such as pedestrian traffic, the elderly and children. "Crime thrives in darkness," he said, "and accidents happen in darkness."

Committee member Jim Conway said that gas lights "might look good and you might get a better feeling, but they're not very practical."

"You have given me an

impossible task." Cassazza said. "I can't recommend all gas lights. You're trying to make a residential street out of a major thoroughfare. There is no street in Boston that has the geometry of this street that is all gas lights."

Cassazza told residents that he will go back and report what he heard but any final decision is beyond him. Cassazza also took information about problems, such as water leaks and noisy electric transformers, from Bunker Hill Street residents. He encouraged residents with particular concerns to contact Judy Evers at the Mayor's Office of Neighborhood Services, 635-3485, and she would refer them properly.

The Basic Services Committee will make its recommendation for a design consultant to the full council at its December monthly meeting.

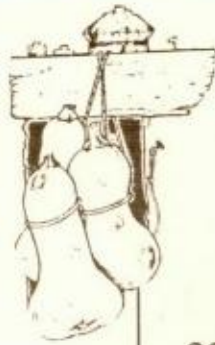

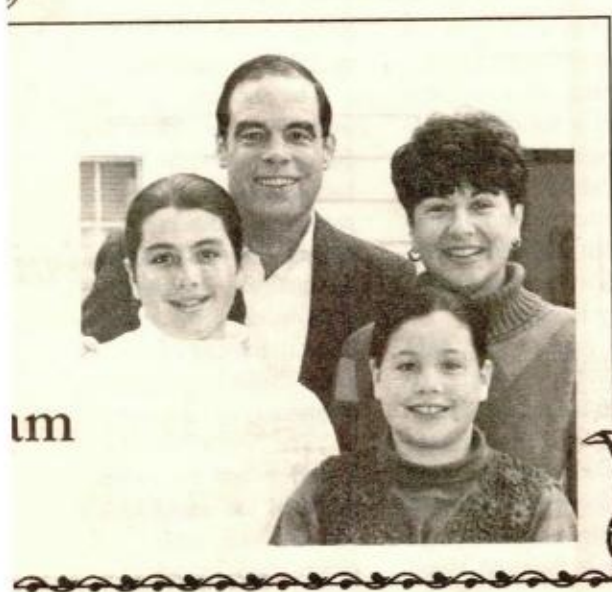

Local Podiatrist Volunteers For New England-Wide Hotline

Dr. Craig Tenzer of Charlestown joined podiatrists from all over New England in volunteering to answer questions from the public about foot health during the second annual American Podiatric Medical Association, Region I Podiatry Hotline.

This free service, held on Nov. 10, allowed people from the six New England states to call toll-free and ask a podiatrist about proper foot care. "It was a rewarding experience to be able to help so many

people with their foot complaints," said Tenzer.

"The type of questions I received at the hotline mirrored the complaints I see on a daily basis in my office," said Tenzer.

Crowley's ship also participated in several multinational exercises with forces from Albania, Great Britain, Greece, Italy, the Netherlands, Sardinia, Spain and Turkey. While spending 133 days at sea, Crowley and fellow sailors also visited France, Greece, Italy and Spain.

Crowley has been in the Navy since August 1991.

A certified research administrator (CRA), Gilbert



YOUR FAMILY AS A TAX SHELTER

As deductions and tax shelters become harder to find, don't overlook opportunities under your own roof - your family.

First, make sure you claim all the exemptions, deductions and credits to which you are entitled. An elderly or sick parent may qualify as a dependent if you provide more than half their support, even if they don't live with you. Similar rules apply to a child who lives away from home, perhaps with a divorced spouse. If a parent or child meets the dependency tests, you can also deduct any of their medical expenses you pay, subject to the normal rules. If you work, don't forget credits such as the credit for child care expenses or the earned income credit.

Another strategy is known as "income splitting" - shifting some of your income to your children to take advantage of their lower tax rates. A child under age 14 pays no tax on the first \$650 of investment income and is taxed at 15% on the next \$650. Make a cash gift to your children, and invest the funds to earn interest or dividends which will be taxed at these lower rates. Investment earnings above \$1,300 in any year are taxed at the parent's top rate, so consider investments for your child such as low-dividend, growth stocks which should produce lower earnings in the current year without sacrificing long-term profits.

If you own a business, consider employing your children. Your business will get a wage deduction while the child will be taxed at low rates or not at all. But make sure the wages you pay are reasonable for the job and keep good records.

To celebrate the anniversary, the company this year will present a beautifully restored and enhanced production of everyone's favorite ballet with new scenery by Helen Pond and Herbert Senn, new costumes, choreography and special effects.

You will learn about what it takes to become a ballet dancer, how costumes and scenery are constructed, and the many programs available at the BB's Center for Dance Education. With the assistance of BB volunteer and supernumerary Michael Noel, Fodor will present a hands-on display of such "props" as a tutu, a "Nutcracker" costume and pointe shoes. The talk will be further illustrated by slides taken behind the scenes at the ballet.

A reception will follow the program, sponsored by the Friends of the Charlestown Branch Library.

Granite Exhibit Opens At The Commonwealth Museum

Secretary of the Commonwealth William F. Galvin has opened a new exhibit at the Commonwealth Museum, "Granite: Enduring Legacy of Mass.," which will emphasize the growth and development of the granite industry and its status today. This free exhibit will run through August 1996.

Photographs, maps, visuals, as well as granite sculpture and other artifacts will be featured. Videos will be shown on the history of the industry, the technology it uses today, and an overview of related sites including many from Quincy, Cape Ann and Chelmsford.


"Granite: Enduring Legacy of Mass." provides an historical overview of the granite industry and its start in Quincy through the transition from building stone to monument stone, from quarry to cutting sheet and sculptor studio. It will deal with the pioneers, workers, owners, immigration and the changes in the industry today. Other granite areas in the state and in New England which were part of the development of the industry are covered in the exhibit.

The exhibit is a collaboration of the Commonwealth Museum with the Metropolitan District Commission, Department of Environmental Management-Halibut Point State Park, National Park Service-Bunker Hill Monument, city of Quincy, the Quincy Mayor's Office, the Quincy Historical Society, The Friends of the Blue Hills, and the Mass. Bay Railroad Enthusiasts Inc.

A supplementary geological exhibit shows Mass. rocks and minerals, the tectonic formation of the state, and how and when the various granite in the state were formed.

The Commonwealth Museum is located at Columbia Point, 220 Morrissey Boulevard next to the JFK Library in Boston. The hours are 9 a.m. to 5 p.m., Monday through Friday, and 9 a.m. to 3 p.m. on Saturdays. Admission and parking are free.
