lower right corner of the last page of the document, place fingerprint over stamps. Then sign through stamps. This makes you the sole Authority, Judge, Banker Banker over the document. You also need to place your sovereign flag on the top of the document. This can be your coat of arms, your seal, draw or paste, tape it on the document. This is due to the law of the sea.
