DECLARATION OF UNITED STATES CITIZENSHIP OR PERMANENT RESIDENCY

UNDER THE INTERNATIONAL TRAFFIC IN ARMS CODE OF FEDERAL REGULATIONS (ITAR CFR) SECTION 120.8, IT IS UNLAWFUL FOR ANY US CITIZEN TO PROVIDE FIREARMS INSTRUCTION OF ANY KIND TO ANY NON-UNITED STATES CITIZEN, PERMANENT RESIDENTS HOLDING A VALID PERMANENT RESIDENT GREEN CARD ARE EXEMPT FROM THIS RESTRICTION.

IN AN EFFORT TO CONFORM ALL LOCAL, STATE, AND FEDERAL LAWS, WINDING BROOK INDOOR SHOOTING RANGE REQUIRES A DECLARATION OF US CITIZENSHIP OR PERMANENT RESIDENCY FROM ALL STUDENTS PARTICIPATING IN ANY FIREARMS RELATED TRAINING.

120.9 Defense Service. (a) Defense service means:

1. the furnishing of assistance (including training) to foreign persons, whether in the US or abroad in the design, development, engineering, manufacture, production, assembly, testing, repair, maintenance, modification, operations, demilitarization, destruction, processing or use of defense articles;
2. The furnishing to foreign persons of any technical data controlled under this subchapter (see 120.10) whether in the US or abroad; or
3. Military training of foreign units and forces, regular and irregular, including formal or informal instruction of foreign persons in the US or abroad by correspondence courses, technical, educational, or information publications and media of all kinds, training aid, orientation, training exercise, and military advice.

FOREIGN PERSONS IS DEFINED AS ANY NON-US CITIZEN RESIDING IN THE US WHETHER OR NOT SAID PERSON HAS LEGAL IMMIGRATION STATUS, PERSONS HOLDING PERMANENT RESIDENT STATUS SHALL NOT BE DEFINED AS FOREIGN PERSONS AND THEREFOR NOT HELD APPLICABLE TO 22CFR 2019.

BY SIGNING BELOW, YOU HEREBY DECLARE THAT YOU ARE A US CITIZEN OR GREEN CARD HOLDING PERMANENT RESIDENT AND THEREFOR ARE ELIGIBLE TO RECEIVE LAWFUL FIREARMS INSTRUCTION FROM WINDING BROOK INDOOR SHOOTING RANGE.
