



## CANINE CONCIERGE AGREEMENT & WAIVER FORM

I understand that I am solely responsible for any harm caused by my dog(s) while my dog(s) is/are attending daycare and/or boarding at Canine Concierge. I also understand and agree that in admitting my dog(s), Canine Concierge has relied upon my representation that my dog(s) is/are in good health and have not harmed or shown aggressive or threatening behaviour towards any person or any other dog.

I further understand that due to the way that dogs interact with one another, minor cuts and scratches can occur even though the dogs are carefully supervised at all times. While my dog(s) is/are in the care and custody of Canine Concierge, if I am unreachable in the event of an emergency, I hereby authorize Canine Concierge, its agents, and/or representatives to seek immediate veterinary care for my dog. I understand that all costs in connection with, veterinary, medical or other treatment shall be my responsibility.

I recognize that the health of the Dog is the owner's responsibility. I hereby represent that all required vaccinations (Rabies, Bordetella, Distemper / Hepatitis / Parvovirus) or titers for the Dog are up to date and will continue to remain so for as long as the Dog attends the Canine Concierge. Vaccines are not guaranteed and there is a small risk that my dog may still contract a contagious disease or illness.

I hereby release and agree to save and hold harmless, Canine Concierge, it's directors, officers, shareholders, employees, assistants, members and agents from any and all liability, claims, suits, actions, loss, injury or damage of any nature or kind, or for any liability, claims, suits, actions, loss, injury or damage which I or my dog(s) may sustain or which may be caused in any way by my dog(s). I specifically, without limitation, agree to fully indemnify Canine Concierge for any and all such liability, claims, suits, actions, losses, injury or damage.

I also certify that my dog is appropriately licensed with the City I reside and that Canine Concierge is not responsible for any fines due to the absence of licenses/dog tags.
