I hereby represent that all required vaccinations (Rabies, Bordetella, Distemper / Hepatitis / Parvovirus) or titers for the Dog are up to date and will continue to remain so for as long as the Dog attends the Canine Concierge. Vaccines are not guaranteed and there is a small risk that my dog may still contract a contagious disease or illness.	
I hereby release and agree to save and hold harmless, Canine Concierge, it's directors, officers, shareholders, employees, assistants, members and agents from any and all liability, claims, suits, actions, loss, injury or damage of any nature or kind, or for any liability, claims, suits, actions, loss, injury or damage which I or my dog(s) may sustain or which may be caused in any way by my dog(s). I specifically, without limitation, agree to fully indemnify Canine Concierge for any and all such liability, claims, suits, actions, losses, injury or damage.
