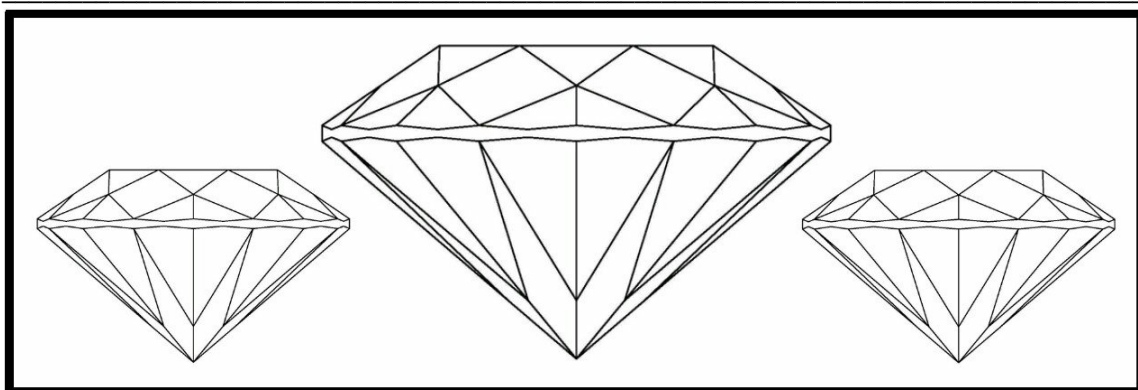



The Federation is in process of development, 1998 in Legal claim on validity, until 2010, and current times, in dezinformation and terrorist blockade, persecution and apartheid against state, by the International Political criminal monopoly on organized crime, fraud and terrorism, violence of International law and organized corruption in International political sites of governments and organizations.

The objective of organized co-operation of Private Societies under Contract number 00, is therefore to carry out investigation and prosecution of criminals and protection of Detectives for the purpose of establishing investigative co-operation with societies, states of foreign governments, their state services, political parties and state or non-state institutions, groups of associations and NGO's, or another subjects of Supranational Institutions, and investigative Institutions in order to be able to co-operate Internationally, to prosecute all criminally responsible people and to search all important informations and needs, confirm all crimes and detect every criminal connections in a purpose for start judicial trial and allow punishment for all people responsible for any kind of crime against the federation.

The goal of investigation, is search all confirmations and confidents on every person of crime connection and legal responsibility for judicial trial judgment, support system of justice and establishment of judicial process for punishment of all responsible people for their kind of crime against the federation.

All profit from service is pay be the Bank of Institution, when is established Contract number 01., and frequently can Contract number 03. & 04.

1. Zero is an universal number in the unlimitless existence of non-existent existence, creating Contract 00, for the purpose of investigating all crimes against the Federation. ID's Detective and Spy Services ID's GSCPC Institutions set up the Joint Contracting Authority 00. designated for international private investigations and Federal National Investigation Co-operation.
2. A crime against a federation means; damage to federal rights, damage to any individual of the federation, damage to a federation partner in matters relating to his or her activities relevant to the interests of the Federation, or the activity of persons criminally organized in violation of the Federation's internal systems.
3. Contract Office 00. is activated in the form of a commercial enterprise, or INC in territory of Federation.
4. Standard priority of Office Contract 00, is cooperative activation in Contract number 05, and search new members for partnership and membership of Instituton ID's GSCPC and Office Contract number 00.
5. Contract Office 00, employs Detective Teams for the purpose of conducting direct investigations, along with administration, administration of prisons, and diplomacy support for investigations.
6. Contract Office 00, engages in Spy Services to jointly exploit the use of modern technologies for espionage and to secure the gain of private information about organized criminal groups, monitoring, digital security, as well as direct infiltration and silent reporting on the development of criminal networks or activities in the range of business networks, civil networks, and at the level of international policy networks.
7. Contract Office 00 also employs the Monopoly Council to develop and

- implement strategies for the use of international incidents from verified events or the design of own initiative events determining higher success rates of the Institution and the Federation, as well as the purpose of the Monopol Council for the purpose of detecting a communication strategy affecting the performance of the criminal subject and its partner network.
8. At the same time, the Monopol Council analyzes foreign policy, the movement of business groups and associations, the performance of social movements, and media and private reporting, for the purpose of regularly reporting to the authorities of the institution about the suspicions and facts of the opposition's threat to the Federation.
 9. For the purposes of protecting the security of the Office and its staff, the Office of the Contracts 00. employs Military and Security Members together with the direct protection of detectives and spies of participating missions in the performance of the objectives of contract number 00 or the possible abduction and neutralization of persons with an active war threat without the responsibility of the peace reconciliation, in the case of a person in position of other active threats against the federation, if their performance is not recognized as legitimate.
 10. Contract Office 00. is in a split administration from the ID's GSCPC, and the administration of the Office is managed in its own prosecution and representation, with an impartial archive in opposition to public affairs, still in accordance with the Code of Conduct of the GSCPC Institution and with the Institution's duty to serve guarantees for control performance and security certification process.
 11. Therefore, the Office of the Contract 00. allows the administration of the Institutions to implement the Criminal Prevention by the Trial Criminal Investigation Commission and thus also the purpose of safeguarding the prevention of espionage by foreign entities and the silent transfer of information to foreign hands. Each member of the executive body in the interest of the Contract number 00. will therefore be under security control in accordance with the Central Code of the Institution.
 12. Contract Office 00. is based on the function of the central office grouping at the address of the office of the central office of the ID's GSCPC, enabling the centralization of the prosecution offices of all foreign contact offices of the Office, thus establishing the central office of the Office and the coordination logistics of the international operational intelligence.
 13. The Foreign branches of Office of the Contract 00 is established at a centralization conference of all state detectives voluntarily participating in the Joint Investigation of Crime prosecution against the Federation under Contract No. 00.
 14. Each foreign Office has its own representative and administration office for part of its own section of prosecution and service management, as well as for the purpose of administering its own investigation, detection and prosecution of crimes against the Federation.
 15. Every Office of the Contract No. 00 establishes its own administration report, as well as the register of all commercially employed members, their register and records of work performance. The Administration Office is composed of representatives of the Detectives who have established the Office, as well as the Office of the Institutions.
 16. Foreign offices of Office number 00, centralize common logistics and active

data to the International Administration Center at the Institution ID's GSCPC, creating the Intelligence Center, which then raises the performance and goals of foreign office branches.

17. Contract Office number 00, therefore, establishes an international strategic cooperation of investigative and control cooperation that develops logistically at the international level of politics and states, thus assuring its own functions of the position of active cooperation and facilitating the implementation of coordinated security control with foreign partners.
18. The Diplomatic Representation of Contract Office number 00 establishes logistic cooperation with the General Council of the Institution, the Monopoly Council and the Law Division, as well as the Economic Administration, for the purpose of establishing strategies for enabling legal standards, drafting international treaties, and choosing a strategic partnership between foreign Head States, also ministries, in order to extend their own partnership positions for the rights of organized investigations and to develop cooperation with the governments of the countries.
19. The Contract 00 Office, thus establishes international diplomacy, police, investigative and espionage cooperation against the criminally-opposed parties of the Federation.
20. Convention 00, analyzes the international political relations and attitudes of foreign governments and supranational organizations to identify the opposition political mafia and to facilitate the organization of anti-crime co-operation at the international political level and to actively oppose cooperation between the governments of the countries to prevent the growth of political international crimes and for the purpose of enabling their punishment.
21. The Diplomacy of the Contract number 00 also allows the function of establishing partnerships between the foreign political parties of the Parliament in order to support the creation of a policy coalition of the international network, thus establishing a common force for the purpose of forcing the rights permitting the direct use of all claims of their own or cooperative investigation of all persons related to the crime their full punishment and the suppression of their dominance at any level.
22. Contract Office 00 establishes diplomatic co-operation on issues of partnership between secret services of foreign states and special movements or organizations in order to fully authorize joint investigative organized co-operation and profit-seeking for the full interrogation of all suspects from the opposition against the Federation, as well as responsible punishment.
23. The Office of the Contract No. 00. has the right to establish organized cooperation with the Resistance Movements and Independent Groups and Independence Movements in foreign countries with a view to assuring the maintenance of their own position and to enable the development of new steps of joint prevention against groups of organized criminal movements at the level of foreign states policies on an illegitimate stance against the Federation.
24. Investigation and espionage actions outside the federation are conducted in accordance with the Bilateral and Multilateral Agreements of the Federation or the Multilateral and Bilateral Agreements of the Institution.

- If the Federation and the Institution do not own any contractual relationship with a foreign country regarding the private or other investigation, the Institution has the right to request or organize a new contractual formation. If no new agreements are created, then the investigation process and other activities under Contract number 00 will be conducted in the form of private commerce in accordance with the jurisdiction of that foreign country within the whole territory.
25. Investigation in countries of terrorist states who lose on their claim or right of political legitimation and de jure sovereignty, is right of investigation and mission cooperation therefore under own jurisdiction and code of the Institution.
 26. If a team of investigators conducts investigations in the territory of a foreign country in which the State Agreement on Investigation Cooperation Law was not and is not active, the investigative team based on the jurisdiction of a foreign country will act as its own person responsible for its own performance in matters of its self-superior.
 27. The Federation does not request, the Institution does not allow, to initiate any investigative activities in the form of illegal and criminal interrogation, criminal gathering of evidence or detention, and the Institution of such services does not sponsor the very nature of its position. However, if evidence is obtained in an illegal manner to ensure the conviction of the crime or the securing of a key consequence, the institution has the right to purchase only evidence as the legal material needed to achieve justice in court proceedings and thereby reduce the activity of active crime statistics by a punishment act.
 28. If a criminal against a federation is identified, an active threat of warfare, disrespectful of its duties immediately stop all acts leading to these threats of warfare, and the criminal responsible refuses to undertake interrogation and surrender of all relevant information on the relation to crime, the Institution on behalf of the Federation has the right to declare the right to direct legal interference at international level, thereby ensuring the kidnapping and immediate killing of all persons involved in the crime of creating threats of war or attempting to prevent the provision of peace agreements, meaning war prevention.
 29. The Office of the Contract number 00 has open rights to use the practice of International Rights among states for enforcing the right of intervention in the territory of foreign states for the purpose of abduction and direct murder of all persons who are criminally active against the federation as a form of war threat or the interference of co-organized against the federation.
 30. The Office of Contract number 00 has the right to interview all persons who have been detected in the suspicion of their crimes against the federation, and thus the Detective Members of the Office establish the conduct of investigative steps to obtain all relevant information relevant to the full result of the investigation, the purpose of Contracts number 00.
 31. The Office of the Contract No. 00 establishes, in the name of ID's GSCPC, joint agreements between foreign commercial companies and financial execution offices, agreements on the purpose of cooperation in debt recovery and financial claims of all persons who were prosecuted by Contract Office number 00, and consequently their criminal responsibility

- against the Federation, implying their attitude towards the payment of financial requirements for investigating, prosecuting and conducting legal proceedings against all those involved in the crime and the suspect.
32. All costs of investigations in the interest of the Office 00, are paid by the Institution and, at the same time, it is the legal standardization obligation of all persons certified to be criminally responsible, to ensure that all financial costs are charged for prosecution, again in the hands of the institution. Contract Office number 00, has the right to demand steps to execute property against criminal persons responsible for the purpose of immediate payment of all financial costs to investigate criminal prosecuted persons.
 33. The Office of Contract number 00. has the right to set up general detective events, which is a claim for a nationwide field search in co-operation with other investigators, accompanied by Private Military and Security Protection and search dogs.
 34. Plan events can only be activated if they are approved by the ID's Institution's GSCPC, according to the decision on compliance with the Institutional Coin Stability Plans.
 35. The Detective Performance of the Contract 00 Office may also be used in the field of field search for the use of global satellite systems for the purpose of monitoring.
 36. None of the investigative activities in the interest of the Contract 00, or the ID's of the GSCPC allow the activation of suspicious and prosecuted inquiries in order to investigate their knowledge of their and other country, and it is not permitted to be in the interest of the Contract 00, to inquire and activate other practices that mean an act of espionage that differs from the interest of investigations on the crimes against the Federation.
 37. At a time when all crimes against the Federation will be punished, contract number 00 will be held as a suspended performance and its validity will be open at any time during the detection or suspicion of any new or unrecognized offense against the Federation.

Source of diplomats:

Rental of law firms, business organizers, persons with a diplomatic profession, or use of their own offices Institutions. Furthermore, interactively according to the task of the situation and the appropriateness of responsibility.

Compliance with political parties, governmental partnership and alliances.

Task Diplomats:

Diplomatical protection of Detectives, and law advocacy.

Furthermore, interactively according to the task of the situation and the appropriateness of responsibility.

Detective Task:

Investigation and control crime networks, analyse and search confirmations, registry important informations and plan International cooperation against crime sites, management of prosecution and crime forcing, counter investigation organize.

Military Force Task:

Military units will need to provide protection to authorities and protection for detectives, spions and diplomats. Kidnaping or exterminate criminals in terrorist level, military investigations.

Furthermore, interactively according to the task of the situation and the appropriateness of responsibility.

Arsenal, Technical Needs:

Polygraphic Lieutenant detectors, spyonage technologies, international transport, secret transport systems, transport delivery of financial shipments, Financial safe, office for communication and official presentation as well as the ability to hold meetings and conferences, investigation and detain centers, armed forces and their equipment, communication technologies and technologies for controlling the network used.

Furthermore, interactively according to the task of the situation and the appropriateness of responsibility.

Payment:

The bill will be reimbursed for telephone, fax, postage, archive and office, staff, and fuel or travel, all hours of time spend in laboral order of contract number 00.

Each section of a payment item must be recorded by a certification receipt and the submission of tickets and other certification accounts for the provision of a trade and with a confirmation from the financial office of the provider, the obligation to submit all sources of reference contracts and agreements, and photographs of the meeting and visits to certain locations. 

Computer system of random espionage by analyzing the rhythm of numbers of active movement of reality

The basic provisions of science without any other additions concerning the function of the physical system of the logic of the rhythm of mathematical rhythms of physical reality.

A random number generator is a technology engineered from a mechanical system, or a computer-based digital calculator that produces numbers in random numbers at random.

All numbers are recorded in the archive and intended for their research on a combination of number rhythms and their significance.

Repeated Figures will then be compared to recurrent public incidents that are related to these numbers together, and are capable of predicting the rhythm of future events of society and the movement of civilization development.

If we put a random number generator on the position of our space, we will learn from the numerical analysis all the information about the persons in our space, their feelings, their ideas, the purpose of the common communication, the future strategies of their development in society and their future and current results.

If we put a random number generator on another planet's position, we'll be able to see the rhythm of reality in the fence on which we've placed a random number generator.

If we create a global network of these random number generators, we will get global reporting of the rhythm of events from the entire world and the ability to detect them to the extent accurately identifying the country of origin of these activities, the city and the street, and the time and date of that location, together with the identification of all persons and subjects who are, are or will be active in the interest of organized crime.

That is why it is immediately necessary to ensure the immediate step of preventing any crime against the Federation and the Institution at the time that has just been established.

Some events can be predicted tens of days before the date of their occurrence, but some events can be predicted even decades before the person who created the predicted event is born.

A random number generator can also be used in the interest of investigative practice questions where the investigator and the investigated jointly communicate issues of an interrogation program that is designed to reveal all necessary evidence to convict the perpetrator.

If a random number generator is placed in the room of the investigated person, we will immediately begin to produce numbers confirming the reality of the communication and the values of the lies and truths of the person under investigation.

The person under investigation will at the same time submit his answers, in which the random number generator will show the information about the meaning of his words, as well as the other references relating to the testimony of the persons being sent.

For example, if the person interviewed will testify about its relevance to the

acquired weapons then the random number generator will provide us with indications for key questions of investigative practice in the status of the psychology of the investigated person's actual rhythm of origin, mean actual information on weapons, the interest on their use, and other information that is not easy to detect by interrogation.

If the random number generator produces information about the rhythm of our reality, then it will be necessary to use a computer program that can detect the meaning of each individual number, as well as the meaning of rhythmic combinations between numbers, so that a thorough understanding of the rhythm of present and future events of our space can be revealed.

The institution has its own goal to use the Corporate Networks of the institution to initiate the production of generators of various types of random indicia, and also computers that will conduct a research of our reality rhythm in order to allow predictions of all crimes and threats of opposition to the Federation, to initiate preliminary preventive steps to stop all types of crime and to allow immediate punishment of all persons active in the crime, or to capture and find all escaped offenders.

The computer analysis system can also identify the name of the person who was the offender in the past, as well as his current name, current position of residence, address, telephone numbers, e-mail address, personal contacts, names of family members and other persons. So you can find out all the information about any criminal, civilian, business, and world politics.


