Rutherford Avenue Study Seeks Community Response

Two different visions for the future of Rutherford Avenue will be presented to the Charlestown community at the Knights of Columbus Hall on Monday, May 18 at 7 p.m.

These design proposals show the corridor from City Square to Sullivan Square with a communityoriented, pedestrian friendly environment - fewer lanes for traffic, tree-lined sidewalks for people and new open space and development opportunities.

The most dramatic changes are proposed for the Sullivan Square area,


which could be returned to its original "square" character, with the removal of the Mystic Avenue viaduct, the reconstruction of the rotary into a surface intersection with signalized pedestrian crossings, and the creation of new public (continued on page 6)



Sail Away With Author Lincoln Paine At The USS Constitution Museum

Learn about the history of ships "from Noah's Ark to the Exxon Valdez," from Lincoln Paine, author of Ships of the World - an Historical Encyclopedia at the USS Constitution Museum in the Charlestown Navy Yard on Wednesday, May 27, beginning at 6 p.m. The lecture is sponsored by the Lowell Institute.

Paine's presentation Ships of the World - an Historical Encyclopedia is part of the USS Constitution Museum's Seafaring Scribes Series. The lecture is open to the public free of charge and will be held in the museum's Figgie Theatre.

Paine's comprehensive book traces each ship from its inception and design to its final duties. Ships of the World - an Historical Encyclopedia offers readers details regarding each vessel, its story and trivia. Paine's book is a must for all history buffs, fans of naval history, and followers of technological evolution.

Guests attending Paine's lecture will be treated to a slide show presentation and reception. A book signing will follow in the museum store.

"The book has many wonderful tales of life on the sea. Each entry makes readers feel like a part of the crew. His piece on the USS Constitution adds emphasis to the work the museum does to preserve the ship's rich past. Paine's historical overview

of each ship enables readers to imagine themselves on board," said the museum's acting education director, Michael Bonanno.

The author's section on the USS Constitution chronicles the ship's battles during the War of 1812, how the nickname "Old Ironsides" was coined, the USS Constitution's trip around the world from 1844 to 1846, and how it became a national treasure.

Paine was the editor of Sea History magazine and director of the Schooners Foundation. He is an active member of the American Sail Training Association. He lives in Portland, Maine with his wife Allison, and his two daughters.

Rutherford Avenue Study Seeks Community Response To Design Proposals

(continued from page 1) open space or park at its center. Such design changes, combined with a potential reduction in traffic volumes due to better flow on the Central Artery, could greatly improve the living conditions for residents, visitors, workers, students, businesses and travelers alike. Short-term improvements for the Rutherford Avenue corridor will also be proposed at the May 18 meeting.

Since last fall, Charlestown residents, area stakeholders, and public agency representatives from the state, Boston, Somerville, Cambridge and Everett have been working with the Boston Transportation Department (BTD) and its consultant team - Frederic R. Harris Inc., Rizzo Associates, IFC/Kaiser, The Halvorson Company, Ann Donner and John Vitagliano - on this urban design and transportation study.

These participants have made up a Working Group,

chaired by Ken Stone, the Central Artery/Tunnel Project (CA/T) liaison for the Charlestown Neighborhood Council. The goal of the Working Group is to propose a new future for the Rutherford Avenue corridor and the surrounding communities, to be pursued once the CA/T is complete. A clear vision, with strong community support, will enable this proposal to seek public funding and move forward with the environmental review process.

On Monday, May 18 at 7 p.m. at the K. of C. Hall, BTD and the consultant team will present preferred alternatives for the revised Rutherford Avenue corridor design to the Charlestown community. The presentation will include the background and thought process behind these proposals and the community input that has shaped them.

Each of the two draft alternatives meets the fundamental goals of: 1) accommodating all modes of

transportation, including cars, trucks, transit, pedestrians, bicycles and rail; 2) enhancing the overall livability of Charlestown and adjacent communities by improving the physical and visual environment and facilitating the community's development goals; and 3) physical and financial feasibility.

These alternatives represent the synthesis of many viewpoints and ideas and tradeoffs. They are based on the study's assumption that after the Central Artery/Tunnel Project, much regional traffic can be diverted back onto I-93, and that Rutherford Avenue could become more of an urban street. This would make possible things which seem fanciful today: pedestrians will want to use the sidewalks and will be able to cross Rutherford at signalized crossings; access by pedestrians and vehicles to destinations along Rutherford will be improved from all directions; crossing City Square will be easier and shorter due to fewer lanes; crossing at Austin and the Gilmore Bridge will be more pleasant due to the expanded and planted pedestrian areas and removal of the U-turns; crossings at Sullivan Square will be safer and more pleasant with the viaduct and rotary removed and signalized crossings and park space

introduced.

Bicyclists will be able to safely ride the corridor, in a variety of bike-oriented conditions. The rail cross-

ings will be improved. Rutherford will help connect parts of the community, no longer acting as a moat or divider.

The May 18 meeting will also address issues related to truck use of Medford Street, Chelsea Street and Rutherford Avenue, as well as ideas for immediate improvements which can be made in the near future while plans for the larger corridor project are developed. There will be time for discussion and comments.

"The RACTS Working Group has had great participation from the community and various public agencies. We have made a lot of progress over the last nine months and are eager to share our ideas with the rest of the Charlestown community," said Ken Stone, Working Group chair. "We hope that our neighbors will join us on May 18 to learn how such an eyesore and headache of a roadway could actually someday enhance our community."

TRAVEL EXPENSES - WHAT IF YOU DIDN'T KEEP THAT RECEIPT?

You have your own business and manage it well. But somehow, when you go out of town on business, all those little receipts just disappear. Your tax preparer heaves a deep sigh when you confess, once again, that you don't quite have everything.

All is not lost. There is another way to get a deduction for those travel expenses without those pieces of paper.

First, the bad news. There are some basics you can't do without. The time, place and business purpose of the travel are essential pieces of information. However, most folks can reconstruct this from their calendars. The next must-have item is an actual bill for your lodging.

The good news is that receipts are not required for other travel expenses under \$75. And if you can't remember or reconstruct what those might be, there is an IRS-approved solution called the "per diem method."

Every year, the IRS publishes tables of acceptable daily deductions for meals and incidental expenses while traveling on business in locations all around the world. These tables even recognize that it is probably more expensive to eat and do laundry in New York City than in Bakersfield, California. The only downside of this method is that the incidentals will be treated like meals, and only 50% will be deductible. This may be a price you are willing to pay for not having to worry about keeping those minor receipts or tracking small expenses.

This event affords an opportunity for people to join together, share their grief at the loss of a loved one or friend, and gather strength from people who spend this time at the vigil just because they care.

The vigil consisted of prayers, reading of the scripture, several speakers and musical selections by Marybeth and Paul Kelly, whose magnificent voices echoed throughout the church. Readings were done by Debra Kerns Maher, Helen Kerns and Coleen Hoell

Terry Titcomb welcome the gathering. She noted that "this is a day for us to remember our loved ones and be together... we are here to remember all lives lost too soon." She pointed out that if "fists had been used rather than weapons, all of our loved ones would be here today."

Participants then gathered on the steps of the church as bouquets of balloons, each carrying the name of a victim of murder, were released into the late afternoon breeze.

Boston Police Department (BPD) Officer Cecil Jones remembered Officer Jim McNamara. He recognized the McNamara family and thanked them. Jones, referred to the Vigil program, which listed many of those who had been "taken too early. He also spoke of the sense of "love and support" present in the church.

Peter Looney, chairman of CHarlestown Against Drugs (CHAD), spoke to the members of the McNamara family and called the late officer "friend."

He told the gathering that CHAD "supports youth groups to make sure the young people will have something to do."







Update On Assisted Living Facility In Charlestown

The Charlestown Interagency on Aging (CIA) continues to move toward its goal of getting an affordable Assisted Living Facility (ALF) built in Charlestown.

Assisted living provides a system of care beyond that which can be provided at home but less than would be done in a nursing home. They are a special combination of housing, personalized supportive services and health care designed to respond to the individual needs of those who need help with activities of daily living but do not need the skilled nursing care provided in a nursing home.

In most programs, each resident has an apartment with a kitchenette, bedroom and bathroom. In addition, the dining room serves three meals a day. Residents are provided help, as needed, with bathing, eating, dressing, toileting, walking, medication reminders, housekeeping services, laundry, chores and transportation. Services of a home health care agency are also still available such as nursing, home health aides, physical therapy, occupational therapy and speech therapy.

Staff is available 24hours a day to meet scheduled and unscheduled needs and there is a 24-hour security service as well as planned social and recreational activities.

Muhammad Ali-Salaam, deputy director of Community Planning for the Boston Redevelopment Authority (BRA), came to the March CIA meeting. He shared information he has gathered while planning the development of an ALF in Mattapan.

Mike Flynn from the Elderly Commission and liaison to the BRA, came to the February meeting to discuss the ALF project.

CIA members have met on a few occasions with Jack Millerick and Kevin O'Halloran of the Life Focus Center. O'Halloran has attended the last several CIA meetings as some LFC clients are also in need of supportive housing. The possibility of a collaborative housing venture that would serve both the frail elderly and the LFC clients who are intellectually and physically challenged has been discussed.

Tom McIntyre of the Bricklayers Union, which is a non-profit housing developer, remains interested in building an ALF here.

The CIA is trying to find some free land on which to build this ALF. With the limited amount of empty space in Charlestown, this is a challenge and every lead is being pursued. With all of the CIA's recent contacts and encouragement from them, the CIA feels hopeful that some land will soon become available.


