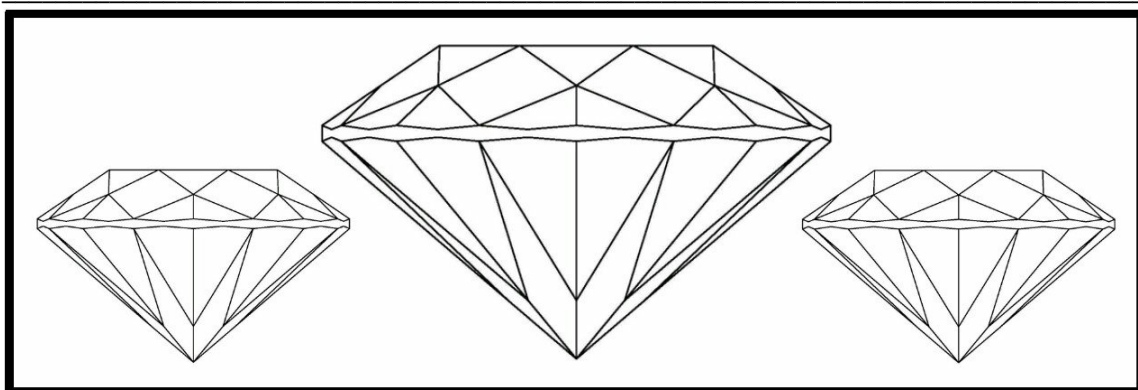

Act of Crime Amnesty in the case of Humanitarian Cooperation and Demonstration of Moral Humanity Criminal Neutrality

In order to stabilize the interests of our mutual legal parties, between the Imperium of Diamond's Federation and the States based on the crime of genocide, nausea and the fundamental narratives of International law, the level of disasters that make up, the purpose of this document is to establish a foundation for mutual friendship and mitigation of the consequences of criminal Activities.

The syllabus of the goal of neutrality is therefore;

However, any politician who is in the position of a mandate responsible for the exercise of legal rights must, as a threat to the internal network of corruption and government crime, demonstrate and secure the objectives of the state administration for the purpose of humanitarian missions to stabilize clean and non-food supplies in countries threatened by famine. National food production guaranteeing independence from food shortages and famine.

Preventing drug shortages and proposing a financially non-inflationary market for pharmaceuticals to provide a stable treatment for the population of states endangered by poor and inadequate healthcare skills for their nation.

Ensuring the development of education in setting up agencies for education in medicine, teaching, politics and advocacy, trade, industry, agriculture and family and social affairs, third world countries and percentually illiterate countries.

Supporting states facing disasters and regular health food supplies and technological means to stabilize civilization and ensure internal governance.

Active support for crime prevention and conflict, the achievement of the world's support to the security of all nations, and the demonstration of the reality of one's own interest not to embark on a step in the creation and growth of war.

Legitimate recognition of the ID's federation's integrity and enabling free mobilization for the purpose of stabilizing ID's civilization according to the character of UN Charter principles & UNGA Declaration's.

Stopping blockades and acts of dismantling, preventing the growth of criminal networks in their own society, and enabling ID's to strengthen full freedoms, effective in peaceful and friendly development.

Personal respect for the principles of International law and thus the refusal to extend the incitement of corruption, fascism and terrorism in order to maintain the stability of the state and the government in times of full capacity to enforce the law of International law.

The act of Neutral status means stopping the full responsibility of crime from acts of government and leaving only the responsibilities for controls on the safe state of civil and political performance without threat.

The act of neutrality can be punishable by a conditional punishment unless the act of neutrality is used for the purpose of a genuine intent of refusal to support the growth of the terrorist network.


The act of neutrality and the right to such a punishment amnesty is not recognized if its user does not act to stop the terrorist domination and development of a criminal organization.

Political persons who are already an active criminal have the right to confirm their act of neutrality and thus to demand a reduction in the liability of the punishment if the performance under the statute of neutrality confirming the principles of moral humanity is confirmed.

Amnesty can only be issued on behalf of the Federation's ID's jurisdiction, and in this case above the basis of a confirmation of the application of International law, meaning the ability to fully purify a neutral name Internationally.

In the event of widespread complications and violations of rights due to criminal consequences, Amnesty Penalties may be blocked by all parties and the aim is to apply full penalties at the level of the entire organized network, as well as political, commercial and social relations in the countries of terrorist states.
