

These types of fraud can take on many different forms; the perpetrators are sophisticated and they use modern technology to their advantage. First Canadian Title, a title insurance company, estimates that mortgage fraud in Canada has surpassed \$100 million in total value. Real estate or title fraud happens about twice a week in Canada, with most victims elderly. But, by taking some simple precautions, you can prevent it from happening to you.

How does real estate title fraud happen?

When you bought your home the ownership was transferred to you and you were given the title to the property in your name. The government land registration documented this and anyone searching the records will see you as the owner.

Real estate fraud occurs when a thief obtains the title to your property through a fraudulent transfer document. Unfortunately it can be very simple and it is almost always tied into an event of identity theft. The fraud artist will target your house, forge the transfer deed and then register the title to the property in their name. Next, they forge a discharge of the existing mortgage and then borrow against the clear title. Of course the fraudster does not make any payments and when the lender serves notice that it intends to foreclose, the scheme is at that point brought to the attention of the real owner.

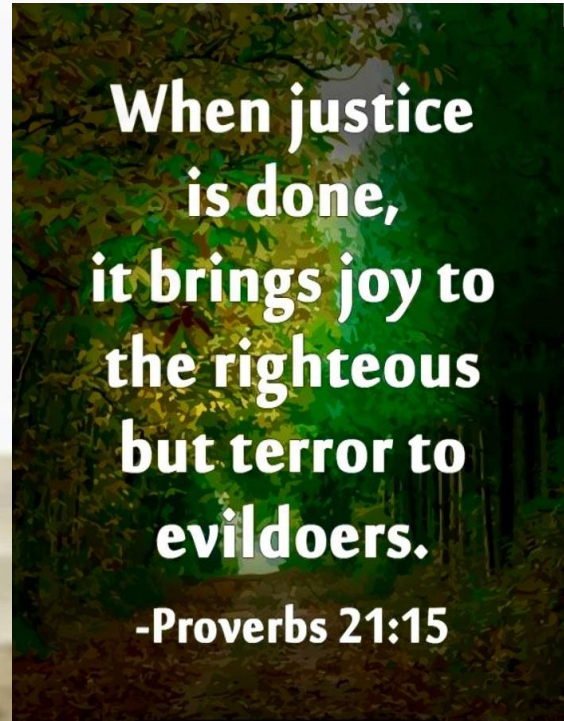

According to the Financial Transactions and Reports Analysis Centre of Canada (FINTRAC), there are a variety of methods for laundering money, including through real estate transactions.

The large amounts paid for real estate make it an attractive option for laundering proceeds of crime. For example, by paying a mortgage down with illegitimate funds, criminals try to turn illegal proceeds into legitimate equity in real estate. Or, by paying real estate lease payments with cash from the proceeds of crime, the cash can become legitimate.

Money Laundering and Real Estate Transactions



Money laundering happens when a person conceals criminal sources of money or assets. It is a larger problem in Canada than most people are aware.

The results of a May 2019 Expert Panel on Money Laundering in BC Real Estate suggests conservative estimates of \$46.7 billion was laundered in Canada in 2018 alone. Money Laundering undermines the rule of law and is also a contagious practice causing damage to reputations, institutions, and Canadian society as a whole.

“Money laundering and its effects corrode the very fabric of society. It impacts all spheres of a functioning democratic society: political and civil, social, and economic. It damages the quality of life of residents of the countries, provinces and cities where it is prevalent.”

Anti-money laundering

Money laundering is a serious crime that affects Canadians' safety, security and quality of life. It is a process used to disguise the source of money or assets that come from illegal means.

Criminal organizations rely on laundered funds to feed other activities like corruption, fraud, human trafficking, and trade in drugs and firearms. It also poses a threat to the integrity and stability of the global financial system and the broader economy.

This is a complex and rapidly evolving problem, which the Government of Canada takes very seriously. Since 2019 the Government has provided \$319.9 million and \$48.8 million ongoing to strengthen the Anti-Money Laundering and Terrorist Financing Regime. Key investment areas include:

Mortgage Fraud

In April 2009, the BC Court of Appeal held that **unless a mortgage is granted by the true owner of a property, the mortgage is invalid and the owner's title will be returned to its original state.**

What is the difference between money laundering and racketeering? ^

One of the most common racketeering offenses is money laundering. In brief, it is **the process of making funds generated from illegal activity appear to have been from a legitimate source.**

A public commission into money laundering in BC, headed by former judge Austin Cullen, was launched in 2019, largely as a result of the Dirty Money reports; it is expected to deliver recommendations in May 2022.

VACI, too, owes its existence to German's probing, which he said inspired him to suggest the institute's creation to the ICCLR.

Its backers include former Canadian prime minister Kim Campbell, who has been recruited to VACI's advisory board.

At the institute's launch, Campbell characterised money-laundering and corruption as "an inoperable cancer" from which no country – including Canada – was immune.

Stoney Creek CIBC bank manager stole \$1.7M from seniors, deceased customers: police

A woman who was a bank manager at a CIBC branch in Stoney Creek is facing fraud charges, police say, after investigators say she stole nearly \$2 million from seniors and customers who had recently died.

The 60-year-old Burlington woman was arrested Tuesday morning and charged with fraud over \$5,000, possession over \$5,000 and breach of trust, according to police.

Police say she has resigned from her position at the bank.

Hamilton police got involved on April 25 after the service says its major fraud unit received a tip from CIBC's corporate security about an internal probe alleging one of their employees had taken a large sum of money from customers.

A lengthy investigation followed and police say it found the woman stole \$1.7 million between 2008 and 2015.

She was taken into custody Tuesday and released on a promise to appear in court on October 24 at 9 a.m.



Instances of title fraud are still rare in B.C., but they are on the rise—possibly due to soaring real estate prices in the Lower Mainland. As real estate prices increase, so does the size of the mortgages potentially exploited by fraudsters.

While the Parcel Activity Notifier cannot prevent someone from either impersonating a property owner or from submitting fraudulent documents to the land title office, it can provide a warning to owners when a transfer or mortgage relating to their property is submitted for registration. In the case of title fraud, an owner could then take steps to protect title to the property.

Appendix B: More Information on Money Laundering Legislation

Updated on: Oct 13th, 2021

(1) Money Laundering Under the Criminal Code

The *Criminal Code (RSC 1985, c. C-46)* establishes offences on the possession of and dealings in the proceeds of crime, money laundering and the financing of terrorism.

(i) Possession and Money Laundering Offences

It is an offence under **section 354(1)** of the *Criminal Code* to possess any property or the proceeds of any property knowing it was obtained by or derived from the commission of an indictable offence.

Section 462.31 of the *Criminal Code* addresses money laundering. These cases are often disputed as family members may be motivated to make false claims in an attempt to maximize the money they can get out of a deceased relative's estate.

In BC where home prices alone are often worth \$1 million or more, manipulating a testamentary document of an elderly or vulnerable **Women** considered to be an extremely serious crime.

Some cases may originate in the Estate courts and ultimately result in a police investigation and charges. These are extremely serious charges.

Other cases involve manipulation of trust accounts or money held in trust relating to an estate. It could be the executor, trustee, or 3rd party that is alleged of wrongdoing.

The crime of fraud over \$5000 is subject to up to a maximum of 14 years in prison which is documented in **Section 380 (1)** of the Criminal Code of Canada which reads:

380 (1) Everyone who, by deceit, falsehood or other fraudulent means, whether or not it is a false pretence within the meaning of this Act, defrauds the public or any person, whether ascertained or not, of any property, money or valuable security or any service,

(a) is guilty of an indictable offence and liable to a term of imprisonment not exceeding fourteen years, where the subject-matter of the offence is a testamentary instrument or the value of the subject-matter of the offence exceeds five thousand dollars; or ..

(b) is guilty

(i) of an indictable offence and is liable to imprisonment for a term not exceeding two years

The degree of alleged planning and sophistication involved in the offence is also extremely important. The relationship between the alleged victim and the accused is also very important. For example in the context of a department store fraud over \$5000 charge, it is considered much worse to be the store Manager than a part time weekend cashier. This being said, even the cashier is looking at a potential jail sentence if found guilty/convicted.

Common law Tort of Invasion of Privacy

As noted in the Issues Paper, there was, until very recently, no common law cause of action for invasion of privacy in Canadian law. However, on, the Court of Appeal for the province of Ontario unanimously recognised the tort of intrusion upon seclusion in 18 January 2012 in its judgment *Jones v Tsige*.¹⁵

The elements of this cause of action are as follows:

- The defendant's conduct must be intentional;
- The defendant must have invaded, without lawful justification, the plaintiff's private affairs or concerns; and
- A reasonable person would regard the invasion as highly offensive, causing distress, humiliation or anguish.

Since this decision was rendered by an appellate court, it should be expected to influence the development of the common law throughout the other Canadian common law jurisdictions. For an in depth look at the decision, see the following article "Coming here? The Canadian privacy tort: *Jones v Tsige* [2012] ONCA 32 (CA)" by Bruce Arnold.¹⁶

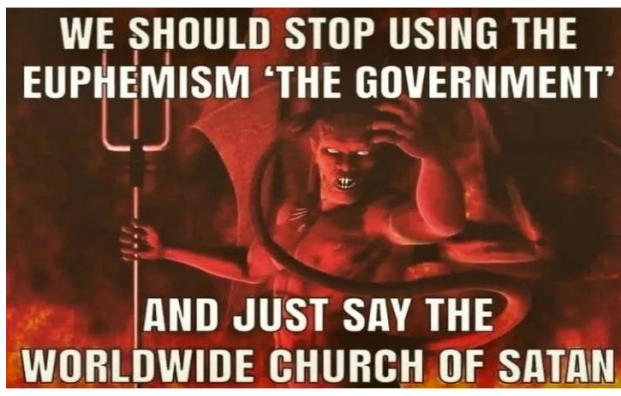

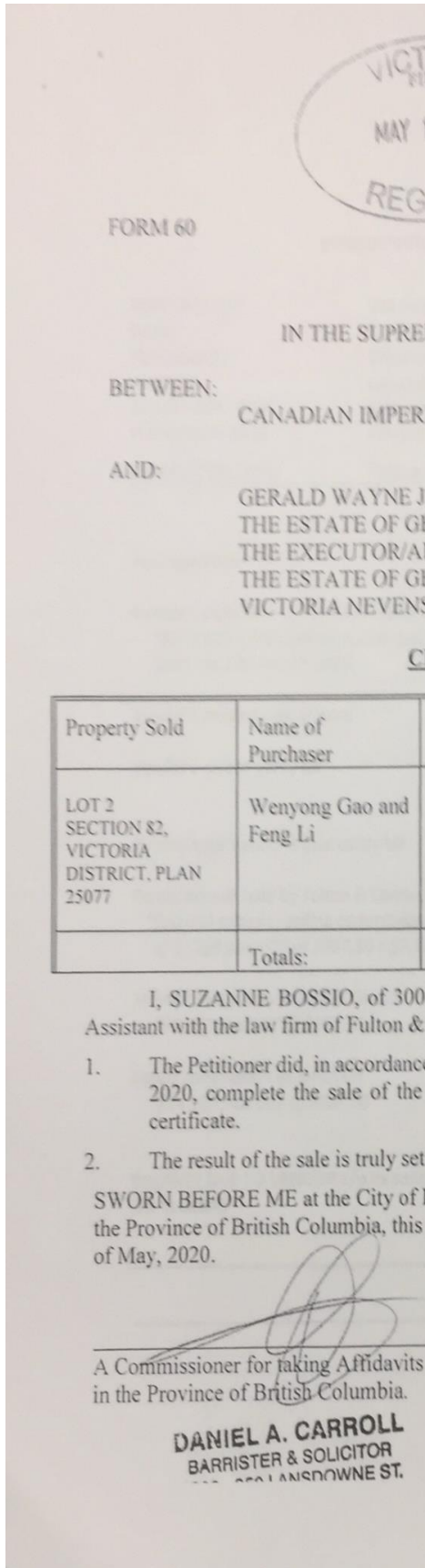


The court found that under the Act, a mortgage granted by a person who obtained their title by fraud or forgery is invalid and the Act preserves the *nemo dat quod non habet* rule⁶ with respect to charges. So even where a mortgagee has relied on the registered title and dealt *bona fide* with a non-fictitious registered owner, a mortgagee does not acquire any estate or interest in the lands on registration of their mortgages where they have been granted by a person who had no valid interest in the lands and such mortgages are void.

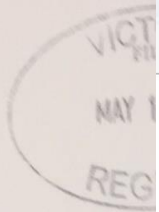
The decision confirmed the security of fee simple title to land, while increasing the burden on mortgagees to carry out more fulsome due diligence with respect to their borrowers.



A judge is an officer of the court, as well as are all attorneys. A state judge is a state judicial officer, paid by the State to act impartially and lawfully.
