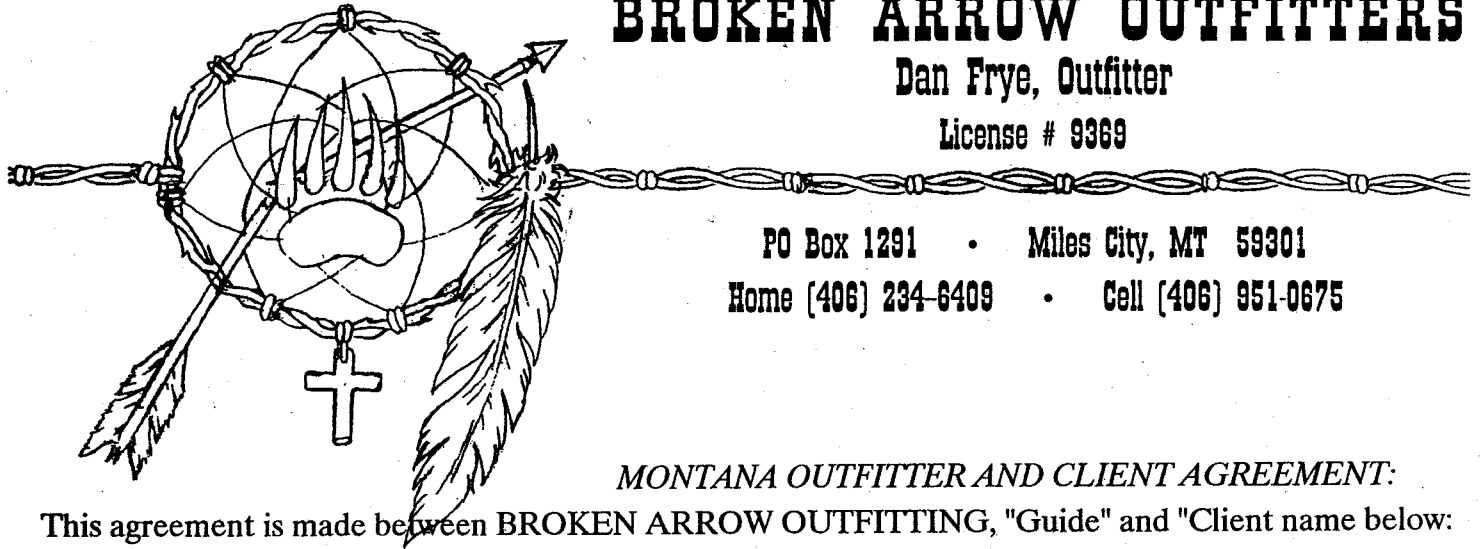

3. **LIABILITY:** Client is responsible for all of his or her own clothing, firearms and personal belongings. Guide is not responsible for any damage or loss to Client's property. Client will obey all State and Federal hunting and fishing regulations and all safety instructions of Outfitter, guides and employees. Client will reimburse Guide for all costs or fines resulting from Client's violation of any State or Federal law or regulation.

4. **ACKNOWLEDGEMENT OR RISKS AND RELEASE: PLEASE READ CAREFULLY:**

WARNING: There are significant elements of risk in any adventure, sport, or activity associated with any outdoor activity including hunting and fishing and the use of any equipment therewith. I realize that they cannot be eliminated in a wilderness environment. Some of these elements, but not limited to, include hiking in a rugged country, encounters with wildlife, animals and insects, temperature extremes, inclement weather conditions and the unavailability of medical attention in the wilderness, the handling of firearms and being near others that have firearms in their possession. I understand these risks, hazards, and dangers described above. I understand that these activities require good physical conditioning and the degree of skill and knowledge necessary for me to engage in these activities safely. I AM VOLUNTARILY USING THE SERVICES OF BROKEN ARROW OUTFITTING, WITH FULL KNOWLEDGE OF INHERENT HAZARDS AND DANGERS INVOLVED, AND HEREBY ASSUME AND ACCEPT ANY AND ALL RISKS FOR MYSELF AND ANY MINORS I AM RESPONSIBLE FOR.

5. Deposits- to book with Broken Arrow will roll over to the following year if unsuccessful in the Montana Draw. The \$2,000.00 deposit is put to cost upon successful tag draw, at which time the remaining balance of payment must be set up with Broken Arrow. If hunt is canceled for unforeseen reasons after the payments have been made the deposit is nonrefundable, remaining balance will be refunded. Broken Arrow suggests trip insurance for all hunts.

6. Shot Clause- any animal hit by the client is that client's animal. The client can and will do everything possible with the help of Broken Arrow guides to acquire that animal. No other animals will be hunted that year after a hit has been made.

7. Gratuities- To maintain a high quality of service from guides and staff, gratuities are expected. The industry standard for guides is 10%. The cook staff standard is \$100.00 per person for the week of service. Please pay a quality gratuity.
