★ 425 Medford Street . . . J.M. Cashman Inc., in accordance with an agreement reached by the company, the city of Boston, the Charlestown Neighborhood Council and the Intervenors in the State Building Code Appeals Board case, continues the removal of glacial till and other materials presently at 425 Medford St.

In a report to CNC Chairman Peter Looney, Cashman had removed a total of 301 truck loads of material as of Jan. 1. Looney said the report indicated that there were 25 or fewer truck loads per weekday and that in the previous weeks, the company did not work a full five-day week. Cashman is limited to removing the material to Monday through Friday between the

hours of 9 a.m. and 3 p.m. only. Each of the trucks containing Cashman material are visually identifiable with a magnetic "C" on the side.

It is expected that the removal will be completed by Jan. 17. If the materials are not removed by that date, Cashman will inform the Council and the Intervenors.

- ★ City Square Park... The Department of Environmental Management, the lead state agency responsible for final design guidelines for City Square Park, will be hosting a meeting on the park on Thursday, Jan. 14 at 7 p.m. at the Mary Colbert Apartments, 20 Devens St. All are welcome.
- ★ Boston Conservation Commission Hearing . . . The Boston Conservation Commission will hold a public hearing in Room 801 at Boston City Hall on Wednesday, Jan. 13 to review several projects to determine conditions, if any, to be imposed in order to protect the interests of the public and private water supply, ground water, prevention of pollution, flood control, prevention of storm damage, protection of fisheries and land containing shell-fish, and protection of wildlife habitat.

At 7:30 p.m., the commission will hear the notice of intent submitted by Bay State Express to undertake building demolition in the buffer-zone area at the Massportowned 265 Medford St. in Charlestown. This is the property formerly owned by Somerville Lumber.

Immediately following the last hearing, scheduled for 8:15 p.m., the commission will hold a public meeting. For further information, call 635-3850.

★ MWRA Valve Work . . . The Massachusetts Water Resources Authority Waterworks Division will be exercising main-line valves during the weeks of Jan. 11 and 18 which may affect Perkins Street and Broadway at the Somerville line.

The work is expected to cause rusty water and pressure loss. The pressure loss should be anticipated for the week and the rusty water should be anticipated for up to two weeks after the work is completed.

It is important for residents living in these areas to be aware of the possibility of rusty tap water occurring from this work so that they can draw a few gallons beforehand and/or hold off on doing laundry. According to the MWRA, the rusty water does not create a health hazard.

If you have questions or concerns about rusty water or pressure loss, call the MWRA at 241-6057.

★ Health Alert . . . The Food and Drug Administration's Boston District Office is warning consumers who are allergic to peanuts not to eat any Waleeco Dainty Filled Candies, packaged in 2-pound card-board cylinder containers because of undeclared peanut butter in the product. The candies, manufactured by the F.B. Washburn Candy Corporation of Brockton, are being recalled because there may be peanut butter in the filled candies and the ingredient is not listed in the ingredient statement. People who are allergic to peanuts run the risk of serious or life-threatening reactions if they consume the candies.

An estimated 53,000 2-pound cylinders of the candies may have been distributed in this country, primarily in New England and the eastern seaboard states. The com-

pany has notified its distributors of the recall, and the distributors are contacting local retailers to withdraw the product from their shelves.

Consumers allergic to peanuts should not eat the product, however, it is not harmful to those persons who are not allergic to peanuts.

★ Street Reconstruction Update... Susi is completing downspout to sidewalk roof drain connections and performing other work in preparation for a winter shutdown. Susi expects the first of several deliveries of new gas light heads this week and will install them as they arrive, contingent on other assembly part deliveries.

The Middlesex Corp. has shut down for the winter with the exception of railing and street light installations at the Mead Street Stairs (40 Flights). The railing post master was approved and they are now into production casting. The installation of railing and lights is anticipated in February.

Building 75

The council dispensed with the regular order of business to allow for a presentation on the proposed development of Building 75 in the Charlestown Navy Yard as a new home for BioTransplant Inc. This biomedical research firm is presently housed in the Building 96-79 complex just inside Gate 5.

Victor Karen, deputy director for economic development for the Boston Redevelopment Authority (BRA), told the council that the rehabilitation of Building 75 would "create 50,000 square feet of job-producing space."

He explained that over the past few years, several proposals have been made for the use of the structure, including housing and the moving of the building to the area adjacent to the proposed aquarium to house commercial ventures, and both have fallen through. Karen went on to say that the use of the building by BioTransplant is in accordance with the Navy Yard Master Plan which was approved by the council and the tenant wishes to stay in the Navy Yard, close to the Mass. General facility and be able to expand. He pointed out that this historic building would be rehabilitated under this plan and

provide the needed expansion space for BioTransplant.

Dr. Elliot Lebowitz, president of BioTransplant Inc., explained to the council the firm's need to expand. He said that the company, whose work includes research into the prevention of organ transplant rejection, is presently sharing 30,000 square feet of space with Diacrin Inc. He noted that both companies are outgrowing the space, and BioTransplant's move to Building 75 would allow for the expansion of Diacrin while they both could remain close to MGH.

Lebowitz spoke of the formation of a BioSafety Committee with the assistance of the council, whose membership includes retired Justice Mary Brennan and Bunker Hill Community College biology instructor Dr. Greg Gillis. He told of the company's work with the community, supporting local charities and utilizing local vendors whenever possible. He added that five of its 34 employees plus a co-op high school student are Charlestown residents.

Architect Randy Lewis presented schematic drawings of the one-story shed type building that runs between 13th and 16th streets, adjacent to the Building 199 parking garage. He said that the building, which was built in 1848, was used to store wood from which all the masts and spars produced in the Navy Yard were

Lewis went on to say that "virtually every piece of the

building will be rebuilt" at an estimated cost of \$10 million. He added that the development would stay within the outline of the existing building and all details that can will be restored.

Jim English, representing BioProperties which is a part of The Raymond Group, said that his firm and the National Association of Government Employees (NAGE), that was awarded tentative designation for the building from the BRA in 1985, would be the developers under a long-term agreement with the BRA who would remain the building's owner. Bio-Transplant would be the building's tenant.

Karen was asked if other approvals had to be obtained prior to the development. He said that the plan has been presented to the Department of the Interior, the Mass. Historical Commission and the Boston Landmarks Commission and the several small issues that were raised by these bodies could be addressed within two to three months.

Karen said that the financing package is moving ahead and he has asked the development team to look to a February date for final designation from the BRA in order to complete the renovation by late 1993.

Looney referred the proposal to Cunha, chairman of the Development Committee. Cunha said that he anticipates a minimum of two committee meetings to allow the area neighbors to look at the plans and provide an opportunity for the development team to return to the community on any questions raised.

Conway asked that the developers should come to the committee meeting with an agreement in hand from the parking garage in Building 199 as to the number of spaces that would be available to the firm's employees. He also asked that material on the development be forwarded to the members prior to the Development Committee meeting to allow them to review it.

Attorney Joe Balliro addressed the council on behalf of Tony Costa. He told the members that negotiations between Costa and the owner of the former J.J. McCarthy's on Main Street had fallen through.

Costa made an impassioned plea to the council for support if and when he finds a site in Charlestown to open a "simple familytype restaurant." Looney asked him to forward a letter to the council as soon as he finds a suitable location.

new parcels that would open up with the construction of the Charles River Crossing as part of the Central Artery project. It was referred to a committee consisting of Keyes, Mansfield and Stone to investigate.

A letter from Dorothy Healey of Main Street was referred to the Basic Services Committee. She wrote to the council that traffic on Main Street should be limited, with trucks, school buses and commuter traffic directed to Rutherford Avenue.

In response to a request from the Healthy Charlestown Coalition, it was voted that the council send a letter informing them that the council would become a member, and that the chairman of the council would be named its representative.

Looney reported that a check had been received by the council in the amount of \$5,200 from the \$50,000 in mitigation money distributed to the community by the Massachusetts Water Resources Authority. The money has been earmarked for a Charlestown Emergency Fund, under the direction of the council. After a lengthy and at times heated discussion, Looney said that he would come to the February council meeting with recommendations on the establishment of a committee to disburse emergency funds.

Gillen reported on a meeting that day (Jan. 5) with Boston School Superintendent Lois HarrisonJones, Michael Fong and Charlestown High School Principal Stacey Johnson. He had coordinated the meeting in response to complaints by the proprietor of Jopa's restaurant that were expressed at the December meeting. They concerned problems arising from CHS students at the bus stop located in front of her store at the corner of Concord and Bunker Hill streets from early morning until mid-afternoon.

Present at the meeting were Looney, Mansfield and Keyes, members of the council's executive committee; residents Paul Flynn, Margie Fitzpatrick and Margie Kent; Judy Evers, community liaison from the Mayor's Office of Neighborhood Services; and Gil-

len.

According to Gillen, the meeting was productive. The problems were explained to the superintendent and he said she told them she would look into the situation and get back to them with a response. They asked for a tightening up on the release of the students. He added that there will also be meeting scheduled with Deputy Superintent Robert Hayden of Area A of the Boston Police Department.

Gillen said that the object of these meetings is to ease the problems of neighbors in the area.

The next meeting of the council will be held on at 7 p.m. on Tuesday, Feb. 2 at the K. of C. Hall, 75 West School St.

School Registration Dates For Boston Public Schools

Boston Public School (BPS) Superintendent Lois Harrison-Jones announced that a city-wide school open house program would be held during the second week of January to kick-off the school registration process for the 1993-1994 school year.

For students entering grades 1, 6 and 9 in September 1993, the registration process begins this week and ends on Jan. 15.

Students now in the BPSs will be given applications at their school. Parents whose children are not presently enrolled in BPSs should visit a Parent Information Center and fill out an application. Children must be 6 years old by Sept. 1 to enter grade 1.

Registration for Kindergarten begins on Feb. 22 and ends on March 19. Children must be 4 years old by Sept. 1 to enter Kindergarten I, and 5 years old by Sept. 1 to enter Kindergarten II.

BPS students in all other grades will not be given applications, but will automatically be assigned to the same school for next year. If parents want their children to go to a different school, they can apply for a transfer between Feb. 22 and March 12. Parents whose children are not presently enrolled in the BPS, and who will be entering grades 2, 3, 4, 5, 7, 8, 10, 11 or 12, should visit the Parent Information Center in their zone between Feb. 22 and March 19 and fill out an appleiation.

To help parents select the

right school for their children, all schools will hold open house from Jan. 11 through 15, from 8:30 a.m. until noon daily. It is recommended that parents call ahead to determine if the school will open at 8:30 a.m. since some elementary schools do not start their day until 9 or 9:15 a.m. If these dates are not convenient, parents should just call the schools they most want to see and arrange a tour.

Any questions about registration, school visits or the open house schedule can be answered by visiting or calling one of the Parent Information Centers between 9 a.m. and 5 p.m. Monday through Friday.

Alternative Learning At Bunker Hill Community College

People who continue to learn throughout their lives have many times found a way to translate this learning into college credits.

The Alternative Learning Accreditation Program (ALAP) at Bunker Hill Community College is seeking new students or those already enrolled to inform them of this opportunity.

Students enrolled in a degree or certificate program may find that the actual time required to complete their college studies may be shortened.

In order to receive ALAP

THANK YOU HOLY SPIRIT FOR FAVORS GRANTED credit, a student must provide evidence that the quality and quantity of prior learning is equivalent to college-level course work. ALAP advisors assist students to identify and document those learning experiences that are worthy of college-level credit.

According to William E. Iannelli, coordinator/advisor of the program, between 12 and 15 percent of each graduating class since 1985 has utilized this program.

A five year study (1985-90) determined that those people who receive credit through the ALAP program also achieve higher than average grades in their traditional college course work.

Credible learning may result from specialized military training, volunteer work or programs which lead to various certificate and professional credentials. Prior learning may translate into as many as 45 credits toward completion of an associate's degree.

Many private and public sector employees with a variety of backgrounds have already taken advantage of the program.

A student must satisfy college requirements to become eligible for the program. Fees are charged for credits awarded.

All persons who are interested in enrolling in an associate's degree or certificate program at BHCC are encouraged to contact the ALAP office at 241-8600, ext. 229 and make an appointments to explore the possibilities for credits toward their degree or certificate.



Plan Now For The Upcoming Income Tax Season

You may not be thinking about taxes now, but income tax filing season is just around the corner, and now is the time to start planning. Starting early will allow you time to gather missing information or forms you may need to complete your return.

Over the next few weeks you should receive some very important documents that will help you complete your income tax returns. Your records should include W-2s, 1099s and bank interest statements. Also, the IRS will send you a tax package based on the return you filed last year.

Don't just sit back and wait for the mail, use your time now to put together any records you may need to support deductions. This would include: medical and dental payments, real estate tax receipts, mortgage interest payments and childcare payments.

You may also want to check whether the tax withheld from your paycheck, or the estimated taxes you have paid, will be enough to cover at least 90 percent of your 1992 tax bill. If it is

not, you may consider increasing your withholding.

If you haven't filed returns in past years the IRS can help you. "As part of our Non-Filer Program, our employees have been trained to assist you in obtaining the information you need to file these returns," said Gerard R. Esposito, Boston IRS district director.

If you have specific tax planning questions or need assistance with a prior year return, call the IRS toll-free tax assistance line at 1-800-829-1040 or visit your local IRS walk-in office.

I am responding to a letter written to the editor of the Boston Globe opposing the articles about violence in Charlestown. This certain letter used a phrase "unfortunate incidents in an isolated segment of the community," to which I would like to respond.

One more thing, the economy instead of the CHarlestown After Murder Program (CH.A.M.P.) should be blamed for the declining revenue in the real estate profession. Wasn't that the true motivation to write the letter? That's what I call "isolated ignorance."


