**MICHAEL AQUINO** and **TEMPLE OF SET** {**Michael Aquino**: private agent}  
(**Michael Aquino and Temple of Set et al** with prejudice)

AND NOW, on this day of December 22, 2018 during the fall season, it is hereby ordered that the defendant be charged with national racketeering under the R.I.C.O. act of **U.S.C. 18 Chapter §1961** including conspiracy to spy on citizens and conduct child trafficking, which is treated as a crime of illicit subversion. Child trafficking of any type at this juncture is a serious crime.[treason]

All penalties are measured by severity and resolve of listed offenses. In addition, it is so ordered that a subpoena be issued upon **MICHAEL AQUINO and the TEMPLE OF SET (Michael Aquino: as Temple of Set's private agent )** to produce all records pertaining to **The Temple of Set and Presidio Army Base** child-trafficking crimes which prove relevant to these investigations related to money laundering. All materials and collaborating partners will be seized by local militia and sergeants pursuant to chapter or state on the accused as well as any publicly known accomplices under force of arms by the provost marshal's service. Any actions in concert or otherwise taken in tandem with the investigation(s) of **Uranium 1** are to be formally re-examined by assigned state Juror assemblies. Each and every instance of child sex trafficking conducted in the interest of promoting treason, must be doubled for the offenses with added penalties, as it results in citizens who despise government. As stated under the rules of military law in Article 50, this order stands binding to conduct swift service to protect the integrity of every voter.

It is so ordered that **MICHAEL AQUINO {Michael Aquino in private}** shall be hit with added offenses for violating **18 U.S.C §1592(b)** on record three times, alleged breeching of **18 U.S.C. §2384**, 2 times hence within RICO and conspiracy to commit public subversion. Additional offenses are added to this record to include bribery **18 U.S.C. §1091** and **18 U.S.C. §2381** the crime of open sedition against the public trust.

This as your honors must note, is original national law **U.S.C code** with RICO based racketeering charges enforced upon the defendants involved. Should the accused refuse to self-incriminate or show up at the scheduled hearing, warrants will be issued for on-site constables and U.S. Marines to seize the accused bringing them into these chambers to be summarily arraigned. The defendant's actions are a gross violation of the public trust and subversion to thwart state election laws. The defendant will be seized and summoned before state or national Grand Juries who continue a nationwide investigation of Electoral Fraud, breech of the public trust and assorted on record crimes directly linked or pertaining to **Uranium 1** in all venues.

For all of these alarming crimes of racketeering and violating the trafficking laws, national Private Attorney Generals will have a field day on each offense sticking with penalties. In addition, he is summoned to testify on record before the national and state **Juror assemblies** on his deeds involving each of the elections and **Uranium 1**, the federal election and national races.

- 1) It is further ordered that Defendant **MICHAEL AQUINO's {Michael Aquino; private agent of Temple of Set}** motion to subpoena records or quash; is now **DENIED**.
- 2) It is further ordered, that according to **Marbury v. Madison**: any required subpoenas on each defendant will be enforced by force of law and arms. All able bodies and governing council, National State Counsel(s), Private Attorney General designates or authorized militia will enforce the orders.

IT IS FURTHER ORDERED that:

This Court's December, 2018 Amended Scheduling Order is amended as follows:

(a) All discovery shall be completed on or before December 24, 2018 and all dispositive motions filed not later than two (2) weeks prior to the close of discovery; and (b) All other deadlines will be deferred by ninety (90) days from the date of issuance in this Order. This order shall cover all scheduling and Grand Jury proceedings extending outward to 2019 as specified.
