I just met with Bill Campbell on this as this, is his zone. He did speak with the homeowner regarding the basketball hoop and the ROW. There was a discussion about the flags and the 'possibility' that they may have to come down but Bill stated for now leave them up. There was no directive to remove it. Meeting with my folks yesterday I directed them to leave any American flags alone. If we get a specific complaint about them we will look at it and make a determination on a case for case basis, though I don't anticipate that happening. Where the information regarding a complaint from a Hasidic neighbor came from is unknown. My folks are clear that there is no reference to that with this enforcement as it is a 'general enforcement' of ROW based on recent complaints.

Hi Ken,

Received a call from Michelle Sheppard, along with her neighbors, the Linke's, who live in Brookwood Two. Michelle said her neighbor, Mr Linke, was contacted by Code Enforcement and told he had to take his American Flag off the telephone pole it was hanging on. Just wanted to verify this with you. She also said all the basketball hoops on the curb had to be removed. She was complaining that it stemmed from a Hasidic neighbor that had to have his signs removed from the front of his house. 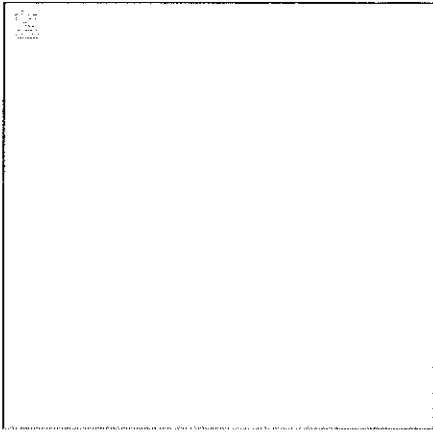

I have been looking into the situation at the intersection of Cedar Swamp Road and Commodore Boulevard in Toms River, which seems to have a high rate of accidents in the township and has been the site of many of our towns more serious crashes. That intersection, although a county road, has some obvious issues brought up by our readers in recent days due to multiple crashes there. Not sure if this helps, I know our code enforcement is out fighting the scourge of basketball hoops around town, but maybe we can take a look at some public safety before any other children are maimed or die at this intersection.

1) 2 very large residential projects are being built right now just west of this intersection, over 1400 units, possibly 2,000 more vehicles daily.

2) Going south on cedar swamp, there are 2 lanes going into one, with very limited room on the south end for a merge.
3) no left/right turn lanes.

I wanted to ask two things.

- 1) Are there any plans to remedy this intersection or bring it up to standards for the amount of traffic that will soon be flowing through once the two very large apartment projects are done.
- 2) For the township, I noticed the following code, and a building on the southwest corner that is apparently in violation of municipal code as is the building/sign on the northeast corner. I assume that municipal code was added as a safety device for drivers, perhaps could be part of the cause of the high rate of accidents.

It has occurred to me from some vantage points the red signage is behind and often subdues the traffic signal.

I can only imagine the below section of the township code book was specifically designed for traffic safety and has had

two revisions to improve the level of safety over the past 15 years.

From Jackson Township's online code book...

§ 244-207 Signs.

A.

General requirements.

(1)

No sign shall be erected, altered, constructed, reconstructed, placed, replaced or otherwise displayed which is not in accordance with the standards and requirements established in this section. Unless otherwise specified in this section, the erection, alteration, construction, reconstruction, placement, replacement or display of any sign, except "No Trespassing" and "No Hunting," shall require a sign permit.

(2)

No sign shall be placed on or affixed or attached to a building or structure or erected independently for any purpose other than to identify a permitted business, occupant, service, office, address, process, use or product offered, sold, conducted, manufactured or assembled on the same premises. A sign may include the name of the business, a brief general description of principal products or services offered or sold, phone numbers and Web sites, but may not include specific brand names unless they are a part of the registered trade name of the establishment. No sign displaying the colors of red, green or yellow shall be permitted within 200 feet of a traffic signal.

TOMS RIVER -- Eruvs are appearing in parts of North Dover, drawing questions -- and concerns -- from some residents.

But Township Administrator Paul J. Shives said Toms River doesn't regulate eruvs, and said legal research conducted by the township indicates "there is no legal basis for municipalities to do so."

An eruv is a visible boundary, often made of wire strung between utility poles, that allows Orthodox Jews to carry objects like house and car keys, to push strollers, or to carry children, on Saturdays (the Jewish Sabbath) and other Jewish holidays.

As more Orthodox Jews have purchased homes in Toms River, eruvs have been erected in several neighborhoods, Shives said.

And in Jackson, some Orthodox Jewish residents have questioned why the township recently began issuing violation notices to several homeowners for objects "encumbering" the public street or right-of-way lawn between the sidewalk and street.

In most cases, the notices were issued to homeowners with simple hockey nets or basketball hoops.

But some members of the township's Orthodox Jewish community are questioning whether the timing of the notices is linked to their request to build an eruv.

Shives said that Jersey Central Power & Light Co. must give written authorization for installation of an eruv. The township does check to make sure permission has been received from JCP&L in areas where eruvs have been installed.

Eruvs have appeared in sections of North Dover where Toms River moved last year to ban door-to-door real estate soliciting for five years, following complaints from residents about aggressive real estate agents.

The township is still in mediation with Rabbi Moshe Gourarie, who filed a lawsuit against Toms River in March 2016, charging that "anti-Semitic hostility" and local opposition to the township's ultra-Orthodox Jewish population are the reasons why the his Chabad Jewish Center has been told it needs a variance to operate as a house of worship on Church Road.

The U.S. Justice Department is also still investigating Toms River's zoning laws affecting religious land uses.

We offer the following document to the citizens of Mahwah and Upper Saddle River for their perusal. The conclusion states

"A local government's allowance of an eruv, which converts the public domain into the private domain and into the property of the Orthodox Jewish community, is a violation of the Establishment Clause of the Constitution. A local government that disallows an eruv under a neutral law of general applicability, consistently applied, does not violate the Free Exercise Clause of the Constitution or RLUIPA. If, however, a local government disallows an eruv by applying a seemingly neutral law in an unequal manner, or is motivated by religious discrimination or stereotyping, it violates the Free Exercise Clause and RLUIPA.

Sine courts and commentators have failed to thoroughly analyze eruvim or articulate a consistent legal framework, local governments, opponents and proponents of them have had little guidance in making their decisions. Although it is understandable that courts, local governments, and scholars have been sensitive to the burdens imposed on Orthodox Jewish worship absent an eruv, their analyses have glossed over the problematic constitutional aspects of eruvim, thus appearing to be results-oriented in holding that an eruv is constitutionally permissible.

It is not the role of American law to alleviate the internal burdens of Orthodox Judaism or any religion. It is the role of the courts and local governments to uphold the Constitution and safeguard all citizens' rights to be free from religion."

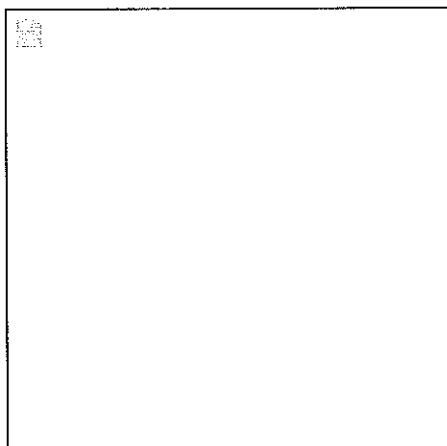
