- Research your market: You need to know if there is an opportunity to turn your idea into a successful business.
  - Who are you potential customers?
  - Who is your competition?
  - What is your competitive advantage & Value?
- Write your business plan:
  - This is the GPS or your business.
  - It's a roadmap for how to structure, run, and grow your new business.







#### Write your 1-page business plan:

- 1. Executive summary
- 2. Market opportunity & analysis
- 3. Sales and marketing plan
- 4. Product or Service
- 5. Competitive analysis
- 6. Key financial information: Budgets & Forecasts
- 7. People requirements & Operations
- 8. Overall Strategy: Key metrics & Milestones







- 3. Fund your business:
  - How much money will you need to start and run your business?
  - Do you have the funds? Where will you go for the funds? How is your credit?
  - Do you need to borrow it? What are your sources & interest rates?
- 4. Identify your business location/market:
  - Are you renting an office?
  - Are you launching an online store?
  - Will you be working remotely from your home?







- 5. Choose a business structure:
- The legal structure you choose for your business will impact your taxes and will also determine your personal liability.
- Check with your CPA or your lawyer.
- Options are: Sole Proprietor, Limited Liability Company (LLC), Partnerships Corporation (S Corp), Corporation (S Corp), Corporation (B Corp), Corporation Non-profit








- 6. Choose your business name:
  - You need to make sure the name is available to be used (Texas Secretary of State)
  - Make sure the domain is available (Go Daddy).
  - You need a domain for your website.
- 7. Register your business:
  - Register with the Texas Controller of Public accounts
  - Certificate of formation from the Office of Texas Secretary of State







- Get Federal and state tax ID:
  - You need your Employee Identification number (EIN)
    which is the tax ID for your company. This is issued by
    the IRS
- Open a business bank account & and a business credit card:
  - Keep personal and business separate (in different accounts).
- 10. Set up a Bookkeeping system:
  - Some of the best known are Intuit QuickBooks Online, FreshBooks, Wave, Xero, and Sage.


