YOUR VOTE DOES COUNT

On Tuesday, November 15, "Townies" and citizens across the city of Boston will have the opportunity to exercise one of the greatest rights we as American citizens have — the right to elect the leaders of our government. However, we will only benefit from this right, if we exercise it and that means, **getting out to vote.**

Too often we leave it up to the "other guy" to make the same choice that we might make, thinking that our one vote "doesn't really count." If this attitude prevails next week, the man of your choice may not be the one to take the office of mayor of Boston in January, because he didn't get that single vote.

Presently, the polls show Raymond Flynn leading Melvin King by a substantial margin. Because the *Charlestown Patriot* endorses Flynn for Mayor, we are heartened by this prediction. Unfortunately, though, it is this type of information that sometimes lulls voters into a false sense of security, thinking that their man — our man — is a shoe-in for the final election. Although Charlestown voters put Flynn on top in the preliminary, we must remember that he will not be on top again, city-wide, unless we and others who support his ideology, combine strength and vote for him. For this reason, the *Patriot* urges you to vote.

Flynn has shown the greatest consistency in political viewpoints and more empathy to Charlestown community needs than his opponent. He has been a man of action to all his constituents as a city councillor as a state representative and never shunned the "dirty jobs" which may have had negative political impacts on his career. He is a man with foresight and one who accepts the lessons taught by hindsight. His honesty, sincerity and open-mindedness have never been needed more as our city faces the tough economic and social problems of the 80's.

Ray Flynn has long stood by Charlestown. The *Patriot* asks that we, the residents of Charlestown, now stand by him.

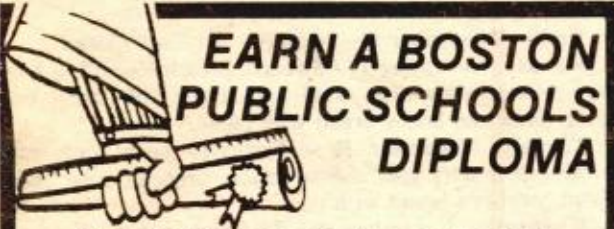

Views On Dental Health

HOW SUCCESSFUL ARE IMPLANTS?

Dental Implants are devices placed on or into the bone, and are used to support a crown, bridge or denture when there is inadequate gum or bone remaining. Although many designs and variations have appeared over the years, all implants share in common the necessity of one or more posts protruding through the gum, on which the replacement teeth are supported.

The use of Implants can be traced back to the Egyptians, but the most research has occurred in the last twenty years. Despite this extensive research, the success rate is only 50%. The two main reasons for failure are rejection by the bone, and infection at the site of the supporting post.

Until such time as more promising longevity can be achieved, the use of Implants must still be considered experimental rather than routine treatment, and is to be undertaken only after all forms of conventional treatment have been considered.

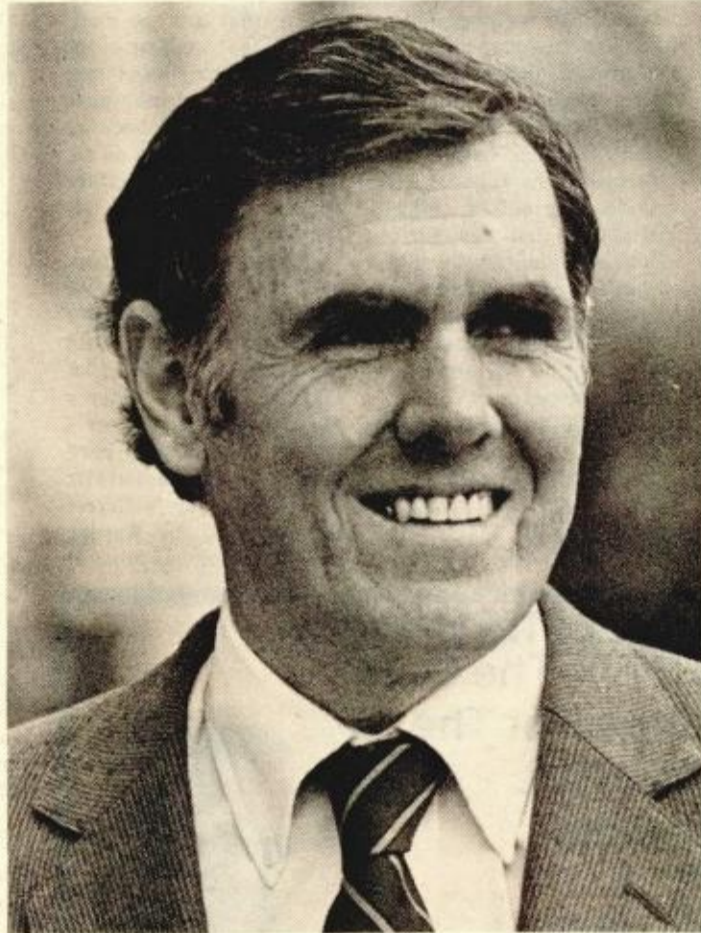

Hot Line To Answer Voting Questions

With the greatest voter registration drive in the City's history coming to an end, the City of Boston's Board of Election Commissioners is now making last minute preparations for the November 15, 1983 final election. The preliminary election was historic on two counts. First, the electorate was composed of more newly registered voters than ever before and second, the turnout of voters shattered all previous records. Commissioner William Arrigal noted, "We're dealing with an electorate that is well in excess of a quarter of million people. Despite the inevitable problems in an undertaking that large, the problems we encountered were relatively few and minor."

On the day of the final election, the department is expanding from the previous twenty five up to fifty telephone lines to receive calls from precinct wardens relative to problems in their areas. This expansion should help to alleviate complaints that wardens often encountered busy signals when they tried to contact the department previously. More important however, is the Voter Hotline that the Election Department will set up several days prior to the election. Voters will be able to call in and confirm their voting status, clear up any problems, and find out where they vote.

Monday, November 14 — 9:00 a.m. - 11:00 p.m.

Election Wardens Warned Of Voter Fraud

Having registered more than seventy thousand new voters, the City of Boston Election Department is now making final preparations for the November 15 election. With the number of newly registered voters expanding the size of the electorate by approximately twenty-five percent, precautions must be taken to insure against voter fraud at the polling place. For that reason, and at the suggestion of Secretary of State, Michael Joseph Connolly, the Election Department Wardens have been instructed to request, at random, proof of identification and residency from individuals wishing to vote. This represents an effort being undertaken with the cooperation and assistance of the Boston Police Department.

Election Commissioner William Arrigal, in explaining the department's decision on these random checks stated, "First and most importantly, it should

be clearly understood that the Election Department is not seeking to make it more difficult for people to cast their vote - the fact remains, however, that any time you expand the size of the electorate so quickly and by such large numbers, at least the potential for fraud exists. It's this potential that we're attempting to respond to. Added to that are the usual rumors that we hear in the Election Department that some individual may have voted more than once or may be planning to do so. Again, it's the potential for fraud that we're attempting to reduce."

Wardens will, at random, ask people waiting to cast their vote for some proof of identification and residency. This proof of residency will be either a Massachusetts driver's license or an identity card from the Massachusetts Department of Welfare. Barring that, the Warden will also accept as proof of

residency a recent utility bill with the individual's name and address imprinted thereon.

Again, Wardens will be asking at random for some proof of residency. They will not do so for every voter and will not do so to the extent that it unreasonably detains those wishing to exercise their franchise, but every voter should be prepared to show proof of identity and residency. Boston Police officers stationed at the polls have been instructed to lend their full assistance

to the Wardens in this area.

If convicted of misrepresenting one's identity or residence for the purpose of fraudulently casting a vote, the penalty is "imprisonment for not less than six months, nor more than one year." In any case where an individual does seek to fraudulently cast a vote, the Election Department will follow the case through in order to affect arrest, conviction, and imprisonment, stated Commissioner Arrigal.

They are entitled, "Tomi Ungerer: Storyteller" and "The Story Of A Writer."

"Storyteller" is about popular author and illustrator, Ungerer, who talks about his work and features scenes from three of his story books. "The Story of A Writer"

talks about Ray Bradbury, author of Fahrenheit 451 and Something Wicked This Way Comes. The film discusses how Bradbury gets ideas and works out stories for his science fiction novels.

The films will be shown at 3:30 p.m.

Suggested readings in conjunction with this program includes Cricter, The Beast of Monsieur Racine, and The Three Robbers, all by Tomi Ungerer. Also suggested is R is for Rocket and Dandelion Wine by Ray Bradbury.

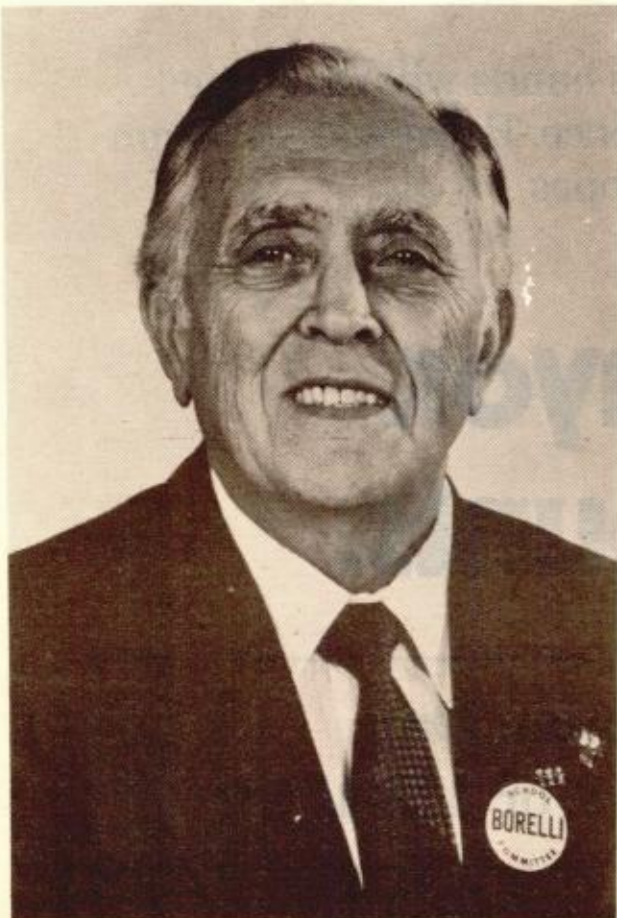

Begins Plans On Re-development Of Hoosac Pier

Massport Executive Director David W. Davis and other state and local officials presided at a groundbreaking ceremony Monday for the Constitution Plaza project at Hoosac Pier in Charlestown.

Speaking on behalf of the Charlestown Community was Patriot Publisher Gloria Conway.

Immediately adjacent to the U.S.S. Constitution and the Bunker Hill Pavilion on the Charlestown waterfront, Constitution Plaza will provide a total of 160,000 square feet of office and restaurant space, and has been designed to enhance public access to the waterfront, including both increased pedestrian open space, and expanded parking. The existing Constitution Marina will be part of the final development plan for the area, providing an attractive berthing site for private pleasure craft.

Consisting of two low-rise buildings on the 15.73 acre Hoosac Pier site, the new development is a joint venture of O'Connell Development Company and Corcoran, Millings, Jennison, Incorporated. Construction will be completed in approximately eighteen months.

"We are very excited about this project for two reasons," said Massport Executive Director Dave Davis. He added, "First we have found a developer that recognizes the enormous potential of the Hoosac Pier location and is also aware of the need to develop Constitution Plaza in ways that are compatible with the interests of the neighboring community. Second, this project provides another example of Massport's commitment to developing productive uses for its unused and outmoded water-front cargo facilities."

Congratulating Massport on their revitalization project, Conway said she hoped the new developers and tenants of Hoosac Pier take advantage of the untapped community resources.

"Exclusive of affirmative action, there is no need to go outside the Charlestown community for the employment field."

Conway mentioned the recent dialogue which has been created between Mas-

sport and local agencies to secure jobs for Charlestown residents and said, "Charlestown welcomes you — and hopes that this groundbreaking marks the beginning ... not only in renovation of this site, but also in the creation of a mutually beneficial workforce from the Charlestown community."

The Hoosac Pier site was acquired by Massport in

1959 as one of the original Port properties under the statute creating the Massachusetts Port Authority. It was used for the receipt and shipment of waterborne general cargo until the shift to containerization of cargo. The construction of Moran Terminal in 1972 rendered Hoosac Pier obsolete as an active maritime facility. Since that time, Hoosac has served as a general

merchandise warehouse. Constitution Plaza is the third major project in Massport's continuing program of waterfront redevelopment, which includes BOSCOM, the \$85 million dollar computer marketing and merchandising development at Commonwealth Pier, and the \$18 million dollar modernization and rehabilitation of Boston's Fish Pier.

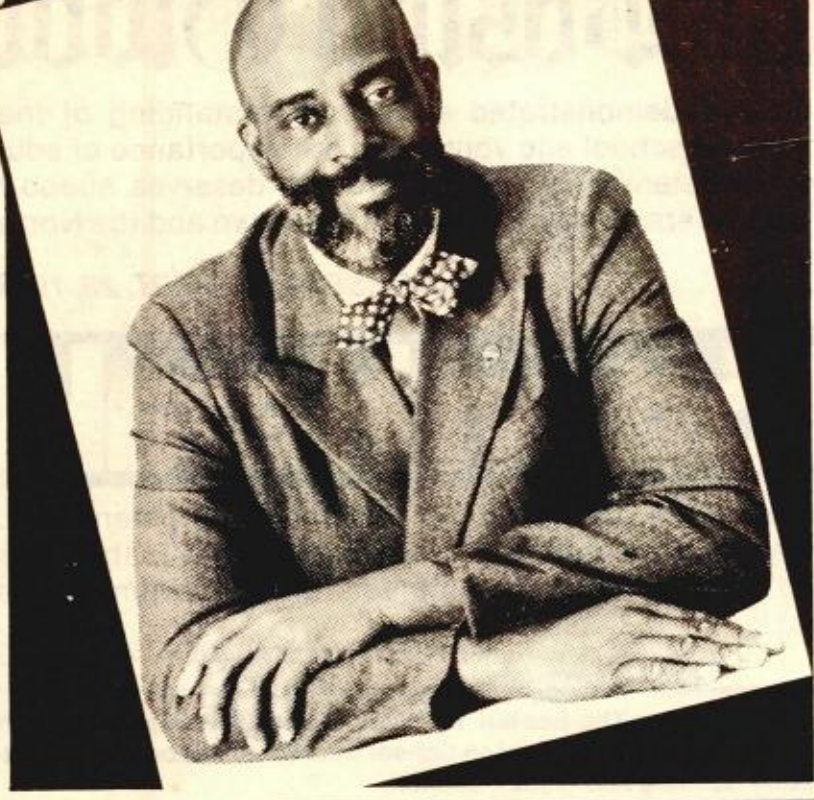

Five Elected To Task Force

Five new members were elected to the Bunker Hill Tenants' Task Force Board of Directors, last week. The new members are Terry Titcomb with 98

votes, Rosemarie McCarthy with 89 votes, Pauline Correia with 73 votes, Robert Stearns with 69 votes, and Kathleen Hutchins with 64 votes.

These members were elected for two year terms.

The Task Force ballot also included three non-binding questions.

The first question was, "What should the three top Task Force priorities be?" The top priorities selected by voters were: Work on crime and vandalism prevention (81 votes); improve BHA response to tenant problems (59 votes); and provide assistance to tenants with housing complaints (48 votes). Ten other priorities received a significant number of votes.

The second question was, "What are the three worst problems faced by Development residents?" Voters overwhelmingly chose roach infestation as the worst problem (82 votes); followed by poor streetlights/sidewalks (37 votes), and drugs and alcohol (36 votes). Fifteen other problems were widely mentioned by voters, including vandalism, poor maintenance, and illegal dumping.

The third question was "What are the three most needed services in the Multi-Service Center (that will open next spring)?" The top voter selections were elderly services (60 votes); alcohol/drug counseling (57 votes); and services for the handicapped (38 votes). Fifteen other desirable services were selected by many voters.

The election also featured a voter-eligible raffle for which there were three winners. Helen Garafano won a \$25 gift certificate to Johnnie's Foodmaster. Helen Fraser won a \$25 gift certificate for the Mount Vernon Restaurant. Patty Adams won a pair of Bruins tickets. Their names were respectively drawn by Mary Fisher, Helen Sweeney, and Judy McCarthy.

While this year's voter turnout was 40% higher than last year's, it only represented 16% of the Development households. The Task Force will con-

tinue to expand tenant participation opportunities, by which voter turnout will improve in the future.

The Task Force would like to thank Rita Feeley, Irene Spritzer, Nellie Gilgunn, Ellen Allen, and

Bob Urquhart for their valued assistance in running the election. The Task Force also thanks all voters, whose responses have provided valuable information that will guide Task Force activities.

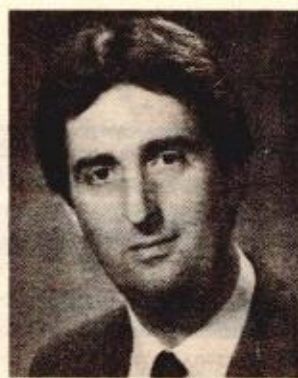

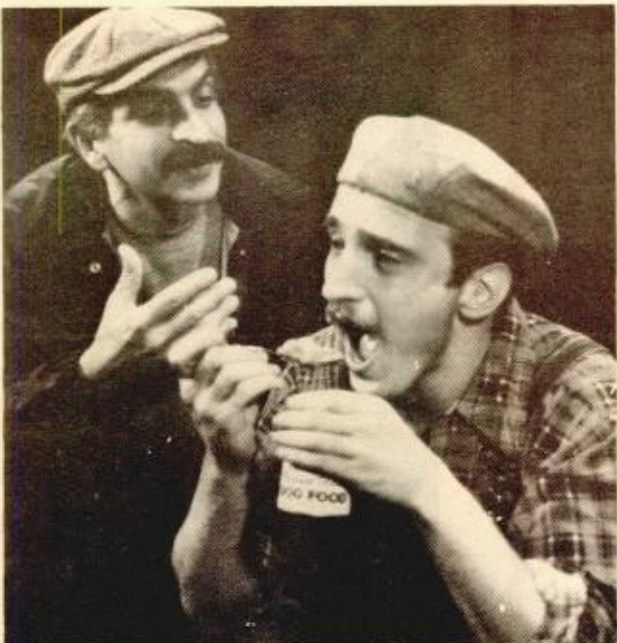

Diploma Program Starts November 14

There's more to adult education at the Kent/Charlestown Community Schools than reading, writing, and math. On November 14, the External Diploma Program will begin, and new students will be added to the GED program already in progress. As the starting date approaches, the community school staff is busy planning the new services which will be offered to the community. Many of the people who decide to get their GED or diploma are concerned about getting jobs or improving their current job standings. For this reason, the Community School has been working closely with Bunker Hill Community College, the Kennedy Center, and the Educational Opportunity Center of Boston, arranging skill-training courses and workshops in the area of career planning.

Workshops will be conducted during class time in both the day and evening programs. Topics will include how to find out about job openings, how to handle job interviews, filling out job applications, and writing resumes. Vocational interest tests will be explained and then administered to anyone who is interested. Students will be informed of programs available at local colleges and training schools, and will discuss ways of getting tuition aid.

Representatives from these agencies will be available for informal consultations with individuals before and after the workshops. People not enrolled in the classes are in-

cluded photography, CPR/first aid, accounting, office skills, food preparation, and word processing.

The new skill-training courses being offered by the Community School will give people a chance to begin to develop job-related skills. Students in these classes will get a taste of what it might be like to work in a certain field.

The first course, typing, is already underway. The course proved to be very popular, and both sections were filled. It will be offered again some time after the first of the year. Other courses scheduled to begin in January in-

clude photography, CPR/first aid, accounting, office skills, food preparation, and word processing.

Information about these workshops and courses can be gotten by calling the Community School office, 242-2770, between 2:30 and 9:00 p.m., Monday through Friday. There's still time to enroll in the External Diploma Program or in GED classes. The next starting date for these is November 14. Daytime classes will be held on Mondays, Wednesdays, and Thursdays from 10:00 a.m. to 1:00 p.m. Evening classes will be on Mondays, Tuesdays, and Thursdays between 6:30 and 9:30 p.m.

King Receives Positive Response Despite Trailing Polls

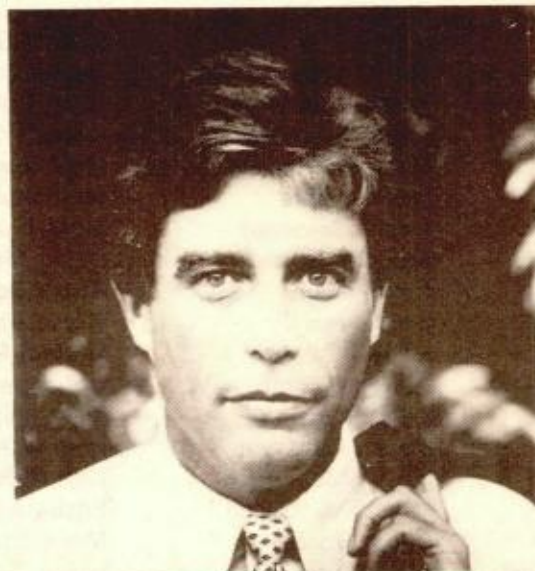



FLYNN: THE PEOPLES' MAYOR

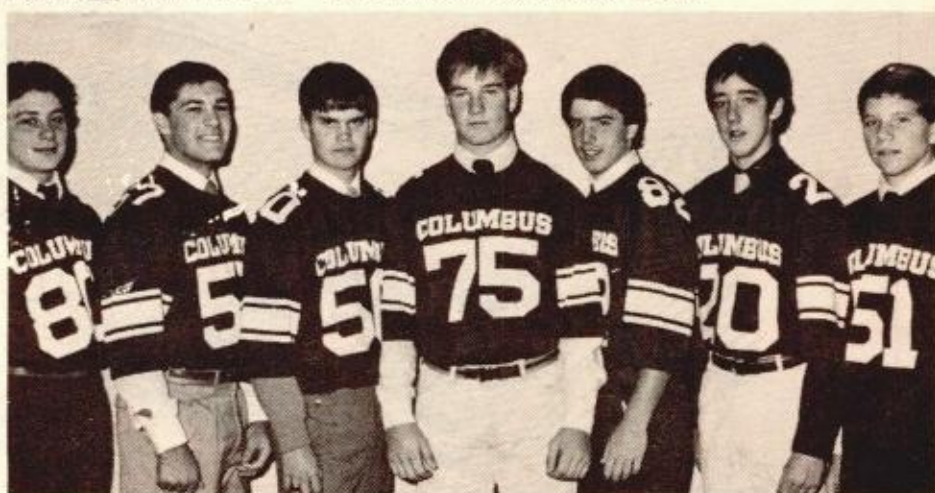

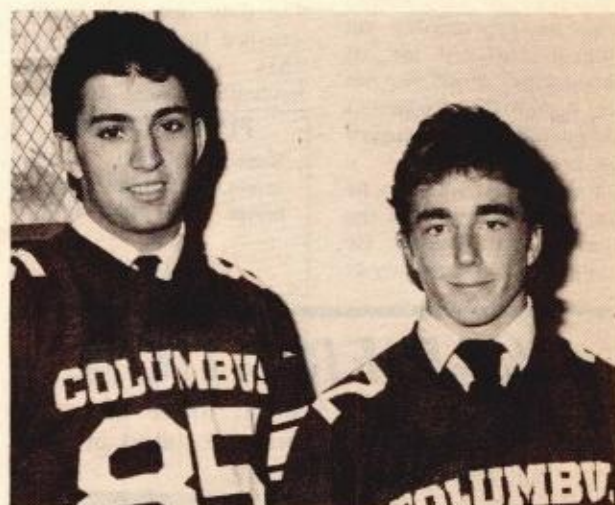

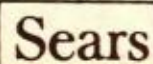

Facts About Drugs - F.A.D.

The first Chemical People T.V. special on Channel 2 (WGBH) was shown Wednesday night, November 2. The program was aimed at informing each community that the problem of drug abuse among adolescents is not going to go away and that it is, indeed, epidemic. The facts are startling: 3 million problem drinkers under 18 across this nation; 3,000 of these young people die in accidents a year; 60% of high school seniors have smoked pot; 109,000 smoke grass every day; 17% have used cocaine. Addiction is known to happen quicker in teenagers whose bodies are not fully developed and who are encouraged to become heavy users before they are out of senior high.

Charlestown residents were encouraged to come to a mini-town meeting at the Boys and Girls Club. There were only eight of us there, but the small group had a lively discussion about the use of drugs in this town. Some of the comments were: "People who live in Charlestown don't consider alcohol a 'drug'." "We sure have problems here but we keep them in the family. We don't talk about them." "A lot of people come to Charlestown to buy drugs because they are sold so openly here." "Everyone knows where to get drugs." "The police don't do anything." There was the feeling that a crisis where someone is killed is what bring the problem to the surface and then interest dies down. One of the suggestions that was mentioned was the need for parents to share their common concerns about their teenagers, including drug use and abuse.

The group agreed to return and bring others to view the second program on Wednesday, November 9, at the Boys and Girls Club.

On October 29, 1983, Officers observed a car parked in the middle of Tufts Street with it's lights on. As the Officers drove towards the vehicle, the vehicle suddenly began to speed in the direction of the cruiser. The vehicle then stopped a few feet from the cruiser. When the vehicle stopped, a man fled from the passenger side of the vehicle. This man was arrested on a warrant from Charlestown District Court. The Officers then asked the operator of the vehicle to exit the car. When the driver got out of the car, she was unsteady on her feet, and had slurred speech and glassy eyes. She did not have a license in her possession. She was placed under arrest for operating to endanger, operating

under the influence of alcohol, and no license in possession.

On October 29, 1983, Officers heard an alarm sounding at the Union Office Supply Co. on Cambridge Street. When the Officers arrived at the scene, they noticed that approximately 19 windows, and two glass doors had been smashed. The Officers then began interviewing witnesses to the crime, and through this process, they obtained the name of the suspect and his current location. The Officers then proceeded to the corner of Brighton and Cambridge Streets. When they arrived at this location, they observed the suspect standing on the corner. The officers approached the man and placed him under arrest for willful & malicious destruction of property. The owner of the above business responded and secured the location.

On November 2, 1983, Officers observed a vehicle run the

stop sign at Park and Henley Streets. The Officers then pulled the vehicle over. The operator, a 24 year old Everett man, did not have a license in his possession. The operator told the Officers that his license had been revoked. The Officers then ran a check on the man through the computers at headquarters. The results of this check was that the man's license had expired in 1975, and had never been renewed. The man was then placed under arrest for unauthorized use of a motor vehicle.

On November 3, 1983, Officers responded to a call of an assault at 480 Main Street. When the Officers arrived, they spoke to two young girls. The girls told the Officers that while they were walking on Main Street, a man approached them, opened his trench coat, and exposed himself. The Officers then conducted a search of the area, to no avail. The Officers gave a description of the man to the Detectives of Area A. A Detective has been assigned to this case, and this incident will be further investigated.

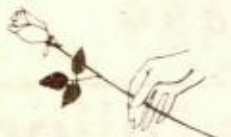

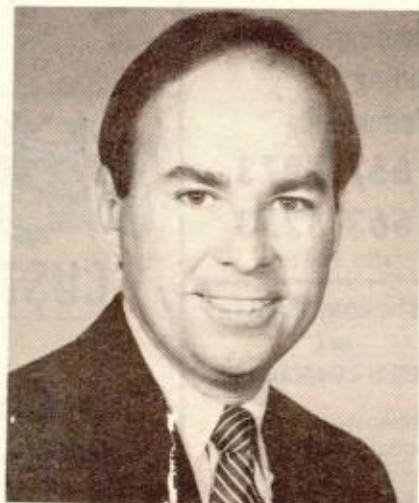
