## Charlestown Neighborhood Council Sets A Busy Agenda Of Meetings

The period of relative quiet during and after the holidays has come to a close for the members of the Charlestown Neighborhood Council. With the month of February comes numerous meetings involving issues throughout the town from the Navy Yard all the way to Brighton Street.
Fifteen council members and a few hearty residents and businessmen braved the cold of Feb. 2 to attend the monthly meeting. Council members in attendance were Chairman Peter Loowere Chairman Peter Loo-
ney, First Vice Chairman Tom Cunha, Second Vice Chairman Mel Stillman, Treasurer Nancy Keyes, Moe Gillen, Bob Scalli, John Dillon, Kate McDonough, Jim Conway, Bill Galvin, Dennis Collins, Judy Brennan, Bill McCabe Judy Brennan, Bill Members and Edna Kelly. Members
Ken Stone, Tom Pitts and Jim Mansfield were working; Kay Whelan is recuperating from surgery; Jeanne Davis was ill; and John Iacoi was absent.
Randall Stafford, MD, a member of the staff at Bunker Hill Health Center (BHHC), reported on a study he conducted analyzing the causes of death in Charlestown. He stated that this study was a follow-up on one done during the 1980s that showed a high heart disease mortality. From this previous study and its results emerged the Cardiac Advisory Board to address this issue and the annual Healthy Heart Day held each spring.
held each spring.
Stafford stated that, in addition to the follow-up, his study identified the other causes of what he called excess deaths which were the number above the expected causes of death. It also would offer help in shaping the policies and future acthe policies and fu
tivities of BHHC.
According to Stafford, examined death certificate information from 1985 through 1990 , looking at the broad categories of the cause of death and comparing the death rates in Charlestown to the rest of Bos-
ton.
The results of Stafford's study indicated that heart disease was the number one cause of death in the town during those six years, with 331 out of a total of 932 deaths. Based on expected deaths from heart disease, there were 93 excess deaths. The second highest cause of death in the town was lung cancer, followed by chronic lung disease and pneumonia.
Stafford said the results of the study were somewhat surprising in that Charlestown is a working-class community and does not have the problem of poverty prevalent in other areas. The staff at BHHC is trying to identify why people are dying, noting that the common denominator in the four categories of cause of death is smoking. He added that without the factor of smoking, Charlestown's death rate would be lower than Boston's.
Stafford referred to Sandra Bock, PA-C, also on the staff at BHHC, who is lead-
ing a group to help people to stop smoking - an addiction that he admitted was very difficult to quit. This pilot program will get underway on Wednesday, Feb. derway on Wednesday, Feb.
17 at BHHC. Interested persons should call BHHC at 242-5700 for registration information.
Bock said that her concern is the young people. She noted that there are a tremendous number of chiltremendous number of chidren with asthma and respi-
ratory conditions that are directly attributable to smoking. She said that she sees how strongly the community feels about its children and its residents should strive to be a smokeless community if not for themselves, at least for the young people.
Several council members asked about environmental considerations including the exhaust from the traffic on the surrounding roadways, diesel trucks and even the emissions from the airplanes landing at Logan. Stafford said that there is no doubt that living in the city

Stafford and Bock asked for the support of the council in BHHC's efforts to address the problems.

Ken Auclair from Store 24 spoke to the council. He stated that Domino's Pizza, the subject of a Jan. 20 meeting run by the council, had talked to Store 24 about opening a shop adjacent to the Thompson Square Store 24. He added that Domino's had not negotiated a lease and he was surprised when he learned that the firm's representative had come before the community.
Auclair introduced Dr. John DeJong who operates Boston Mobile Veterinary Clinic and would like to open a clinic at the Thompson Square site. DeJong stated that Charlestown is about the only part of Boston without a veterinary clinic and there is a need here.

(continued from page 3 ) DeJong stated that the clinic would operate during daytime hours, essentially 9 a.m. to 5 p.m. In addition, he said that Diane Brennan who operates Groomtown on Main Street, would like to join him at the 1,500 square foot store. DeJong noted that he has worked out of Groomtown one day a week for the past $21 / 2$ years.
Looney said that the council would set up a meeting during the month to which abutters and interested residents would be invited. He also asked that Store 24 be represented to answer questions that arose during the meeting on Domino's. Conway asked that DeJong come to that meeting with some ideas on traffic volume.

Greetings were extended by Piedad Robertson, Secretary of Education for the Commonwealth, and by Boston City Councillor Albert "Dapper" O'Neil. Councillor John Nucci praised LFC and presented a council resolution to Voke. Councillor Bruce Bolling spoke of the significance in honoring Voke and commended LFC on its 15 years of service. He was joined by Councillor Charles Yancey in presenting LFC with a council resolution.
Sen. Thomas F. ## Needed: Health Care For All

To the Editor,
I attended Gov. William Weld's press conference on Jan. 25 when he put forth his proposal to help seniors with medigap health insurance. Does he think seniors cannot runch numbers just as well as his staff?
We were certainly not fooled by his $\$ 500$ income tax deduction. There are too many of us living just at or slightly above the poverty level for that to help!
Twenty million dollars in subsidies for low income seniors offers little relief when Blue Cross Medex costs us \$118 a month now. With the 28 percent increase the non-profit insurance giant is asking for, we will be paying $\$ 152$ a month - an increase of over $\$ 400$ a year. The $\$ 25$ to $\$ 30$ a year per person you are offering just doesn't cut it, governor. You are just pouring it into Blue Cross - which is why they spoke so highly of your proposal at the press conference!

What we need is health care for all. Cradle to grave. Cost containment. Root out the fraud, help doctors with their malpractice insurance and let us seniors live the last years of our lives in the Commonwealth of Massachusetts with food on our tables and clothes on our backs
I do want to thank the governor for finally moving out of the cave he's been in and admitting that seniors have a problem paying for health care. But his proposal is like one snowflake in a blizzard - it is lost in the storm of rising costs that force low-income seniors to live the barest existence.
Rep. Ed Lambert (D-Fall River) has proposed a bill that I hope and pray all seniors, regardless of income, will get behind - for the good of all. We need a freeze on health care costs.

merger are a disgrace to the Catholic church community in Charlestown.
The general feeling of those who have experienced any of this school merger "process" is that it has been dysfunctional and that the church leadership has willingly participated in the dysfunction.
Last year, the school community at St. Catherine's School was rocked by the removal of Sister Catherine Loughran as principal with no valid reasons ever given. She had devoted 17 years of her life to the parish and the children of that school. This year we are told by those who have been involved in the "process" that Father John Stagnaro, who has been a wonderful principal at St. Francis de Sales School, is being treated in the same manner by those in control. This happens after he has given five years of faithful care and concern to the students and parents of St. Francis de Sales School.
As we lose our schools, our identity and our principals, we parents are only told that everything has been done in the course of a fair "process." If the church is to be credible, a concern for good individuals should be more important than a so-called "process."
Since the Principal's Selection Committee announced its results, much information has come forward about how biased the committee seemed to be and how people's names were signed to letters and statements who had actually walked off the committee. But all of this, I'm sure, is just part of the "process." When a school site was selected, the issues of location, safety and financial viability were found to be less important than other considerations we were told by those who were involved in the "process."
As a Catholic who has lived in Charlestown for many years, I have observed this "process" cause parishes and schools, priests and people to deal with each other in ways which should be a disgrace to the church.
As a parent who will soon have to make a decision about the future Catholic education of my child, I must now begin to engage in my own "process." Simply being given a form and told to sign on the dotted line and to send the check (non-refundable) will no longer be enough for me. The priority of my "process" will be what is best for my child, as I choose a school. It would seem to me, that the Catholic church in this town is going to be dealing with too many of its own internal problems, which have been self-inflicted as a result of the "process," to be dealing with Catholic education in the years ahead. There is an old saying Physician Heal Thyself! These words are also applicable to an institution such as the church.
As parents, we must do what is best for our children, not the "process." There is another apt saying for this situation - Let the Buyer Beware.
