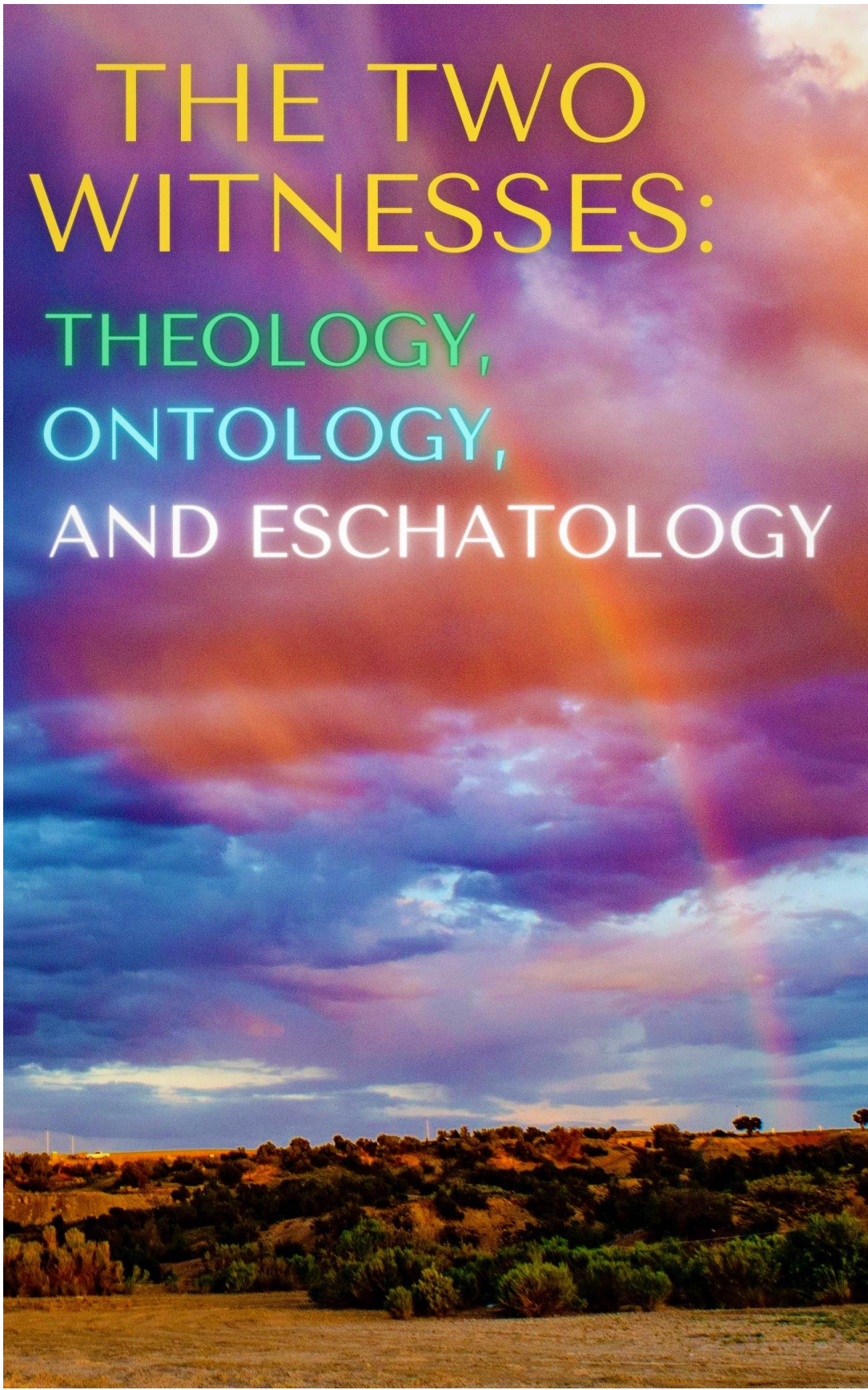

The Two Witnesses: Ontology, Theology, and Eschatology

Witness 1

The role of the Two Witnesses in Christian theology and eschatology is greatly misunderstood. If you browse the most popular theories on the Two Witnesses, you will usually find people saying that they are either two groups of people or Moses, Elijah, Enoch, or some other Biblical figure reincarnated, literally wearing sackcloth, and as usual they are 100% convinced of this narrative.

What they are missing is that the Two Witnesses will be hated by the world - but why would the world hate prophets like Moses and Elijah? People would treat them like celebrities. The answer is that they are *not* Moses, Elijah, or anybody who has already lived, but rather, they are two people of this generation who will share painful truths in a time of great deception.

When Jesus began his ministry, no one could handle who he really was, as they had preconceived notions about who the Messiah would be and had built a preconstructed eschatological narrative that he didn't fit. In the same vein, when the Two Witnesses are revealed, they will not be met with love, but rather, they will be met with scorn and hatred, because they will not be who the world wants them to be. The Two Witnesses will not fit the preconstructed eschatological narrative that the world has built.

Indeed, the Two Witnesses are not merely roaming preachers and prophets, witnessing to the lost at the end of the world. Rather, they play a key role in a trinity of blood sacrifices underpinning the Bible as a whole; and indeed, the destruction and creation of reality itself.

Blood sacrifices are a key component of the Bible, comprising the thematic spinal column of the text, without which we can only dimly comprehend its true meaning. Our universe is underpinned by three blood sacrifices: that of Adam, Jesus, and the Two Witnesses.

1. Adam gave up his life because he loved Eve and wanted to be with her even after she ate of the tree. In doing so, he condemned the world.
2. Jesus gave up his life because he loved humanity and wanted to be with us, despite our fallen state. In doing so, he saved the world.
3. The Two Witnesses will give up their lives because they love each other, the people of the fallen world, and the truth of Jesus Christ enough to do so. Their willingly shed blood will condemn the world for the last time and comprise its final death warrant.

These three points in humanity are genetically connected and comprise the Messianic "Line of David". In it, humanity finds its birth, life, and death. The only thing powerful enough to bring about the end of the universe is a willing, innocent blood sacrifice like those performed by Adam and Jesus, and it will happen when the Two Witnesses are killed for spreading the truth.

Thus, the Two Witnesses must represent the archetypal man and woman, symbolically closing the door and ushering in the final condemnation of the world begun by Adam. They must be innocent, blameless, pure of heart, and fully aware of the ramifications and implications of their sacrifice. This makes them the final lambs led to the slaughter, whose blood will be the last testament written against this world when it is spilled.

As the sacrifice of Adam and Eve condemned humanity's first spiritual womb and ushered in the physical universe, the sacrifice of the Two Witnesses will condemn humanity's physical womb, and usher in the creation of the final spiritual world. Thus, the dualistic nature of mankind and reality itself, the constant struggle between light and dark, positive and negative, male and female, good and evil, will have been both created and ended by a man and a woman together.

Homosexual prostitution inquiry ensnares VIPs with Reagan, Bush

'Call boys' took midnight tour of White House

A homosexual prostitution ring is under investigation by federal and District authorities and includes among its clients key officials of the Reagan and Bush administrations, military officers, congressional aides and U.S. and foreign businessmen with close social ties to Washington's political elite, documents obtained by The Washington Times reveal.

One of the ring's high-profile clients was so well-connected, in fact, that he could arrange a middle-of-the-night tour of the White House for his friends on Sunday, July 3, of last year. Among the six persons on the extraordinary 1 a.m. tour were two male prostitutes.

Federal authorities, including the Secret Service, are investigating criminal aspects of the ring and have told male prostitutes and their homosexual clients that a grand jury will deliberate over the evidence throughout the summer, The Times learned.

Reporters for this newspaper examined hundreds of credit-card vouchers, drawn on both corporate and personal cards and made payable to the escort service operated by the homosexual ring. Many of the vouchers were run through a so-called "sub-merchant" account of the Chambers Funeral Home by a son of the owner, without the company's knowledge.

Among the client names contained in the vouchers — and identified by prostitutes and escort operators — are government officials, locally based U.S. military officers, businessmen, lawyers, bankers, congressional aides and other professionals.

Editors of The Times said the newspaper would print only the names of those found to be in sensitive government posts or positions of influence. "There is no intention of publishing names or facts about the operation merely for titillation," said Wesley Pruden, managing editor of The Times.

The office of U.S. Attorney Jay B. Stephens, former deputy White House counsel to President Reagan, is coordinating federal aspects of the inquiry but refused to discuss the investigation or grand jury action.

Several former White House colleagues of Mr. Stephens are listed among clients of the homosexual prostitution ring, according to the credit-card records, and those persons have confirmed that the charges were theirs.

Mr. Stephens' office, after first saying it would cooperate with The Times' inquiry, withdrew the offer late yesterday and also declined to say whether Mr. Stephens would recuse himself from the case because of possible conflict of interest.

At least one highly placed Bush administration official and a wealthy businessman who procured homosexual prostitutes from the escort services operated by the ring are cooperating with the investigation, several sources said.

Among clients who charged homosexual prostitute services on major credit cards over the past 18 months are Charles K. Dutcher, former associate director of presidential personnel in the Reagan administration, and Paul R. Balach, Labor Secretary Elizabeth Dole's political personnel liaison to the White House.

In the 1970s, Mr. Dutcher was a congressional aide to former Rep. Robert Bauman, Maryland Republican, who resigned from the House after he admitted having engaged in sexual liaisons with teen-age male

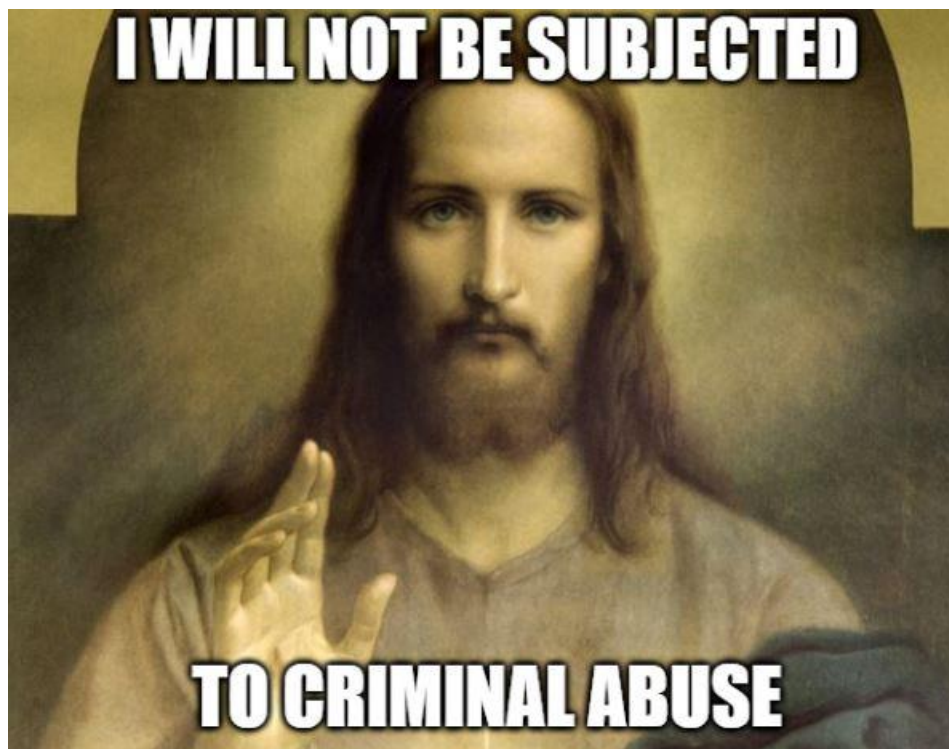

If You're Not Being Canceled, You're Not Telling the Truth

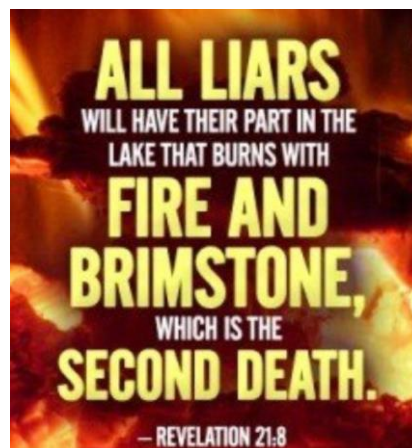

The Only Real Truth: Jesus Christ

However, occasionally I do find someone willing to engage in a good-faith discussion, with real arguments and questions, and I truly enjoy that. I find that all the positions at the top of this post are easily defensible with mainstream sources, and I have personally written many pages demonstrating the truthfulness, historicity, and reliability of the Bible.

Now, most people, including me earlier in life, would be rightfully skeptical of a claim like “The Bible was written supernaturally by God”, and would want some proof of that. Well, if you were God and you had to do this – prove supernatural authorship in a written text in a way we can comprehend – then there would only be two ways to do it.

First, you could predict the future and foretell future events accurately, which no one else in history has ever been able to do *even one time*. Or, you could create some sort of intricate, inhumanly complex pattern or code within the text that would only be detectable with computer technology, which is unfakeable, demonstrable, and compelling.

As it turns out, the Bible does both. There are numerous confirmed prophecies in the Bible, which we wrote about [here](#). It also contains extraordinary equidistant letter spacing (ELS) codes that could never have been placed by scribes using handwriting. These codes are only possible if the Bible really was written by God, channeled supernaturally through people, and are his “Signature”, or a way that even the most skeptical of people can prove to themselves that the Bible is true.

These codes run throughout the Bible when the original Hebrew text is placed on a grid. By taking a particular letter, you can skip a certain interval that remains steady, and find words with meaning and context by skipping that same number of spaces, making the letters equidistant from each other.

This is an example of an ELS code:

In the following table (with $h=114$ letters in each row) we see ELS's with minimal skips for

- 1) המהרש"ל (the Maharshal—see Table 8,n.33).
- 2) י"ב כסלו (12th of Kislev)—the date of his death.
- 3) ה'ש"ל"ד (=5334, corresp. to 1573)—the year of his death.
- 4) שלמה (Shelomo)—the first name of the Maharshal.

Now, we'll talk more about these codes later, and discuss how researchers have used technology and cryptology techniques to prove this and lay all of this out in studies, books, and computer programs, along with the various failed attempts to debunk them.

However, if you went into a church and surveyed the people there, you would probably find that at least 90% of the people there have never heard of "Equidistant Letter Spacing codes", and the ones that had heard of "Bible codes" don't understand them very well and aren't familiar with the various arguments and studies written on them.

What this tells you is that there must be other good reasons to believe the Bible is true, and the truth is that most people don't really care about codes, prophecies, or other apologetica.

No, most people just *feel* that the Bible is true, and they *observe* the world around them, which clearly fits what the Bible describes. The Bible tells us that a supernatural evil rules this world, and [good people will often suffer while bad people will mostly prosper](#) and get away with things. This plays out every day, in which God's people suffer for the sake of righteousness and glorifying him, while evil people live lavish and hedonistic lifestyles, ultimately writing the terms of their own execution.

Now, this *feeling* and *observing* the truth of the Bible is a perfectly valid way for them to verify its reality, and there are literally billions of people alive for whom this is the truth. However, for those who are not like them, such as me, the crazy thing about Christianity is that no matter how skeptical you are, if you really try and debunk it - you just won't be able to. Even without a supernatural or miraculous experience, every single person alive can conclusively prove to themselves that the Bible is real through codes and prophecies.

So far, every Biblical prophecy has been either fulfilled or is well on its way, every historical event is set accurately, and people, places, and things described all fit. [Acts and Luke have been described as some of the finest history books ever written.](#) Throughout the Old Testament, time and time again, stamps and seals ([bullae](#)) have corroborated the names and dates of kings and leaders given in the Bible. Events like the [Tower of Babel and the destruction of Sodom and Gomorrah, even the Exodus](#), really do have tangible evidence we can look at, evaluate, and accept today.

[Halley's Bible Handbook](#) is the best resource that can be read along with the Bible, describing some incredibly well-cited Biblical archeology along with commentary on each passage. This book is on its 25th edition, beginning in 1924 at 16 pages and growing to 1,136 pages as of the latest edition. In it, you will find thousands of examples of truly compelling and interesting research that repeatedly prove the accuracy and reliability of the Bible.

There's no way to fake the indelible mark that the Bible left on society, which is written into the very archeological core of civilization and man's ascendance itself. There is no atheist reverse version of this book, because it would be impossible, as no archeological or historical discovery in history has ever directly contradicted the Bible.

No, all the atheists and materialists have is bluster, insults, censorship, and fallacies. They all think they're the next Christopher Hitchens, but the problem with these people, and even him, is that they can never construct a worldview of their own. They are good at insulting and attacking people's beliefs, but they never provide a better worldview to believe in. On the contrary, their worldviews, when they can even manage to elucidate them, uniformly suffer from irrationality, are illogical, conflicted, unsupported, and often appeal to authority, consensus, or opinion in an attempt to justify what little tenets they offer.

That being said, I was asked these four questions in a thread the other night, and I enjoyed them so much I thought I would share them and write up a little response to them:

I'm just trying to make sure I really understand your position on this, you are making the claim that:

- 1.) The default afterlife is one of eternal torture.
- 2.) In order to be "saved" (i.e. avoid this eternal torture), you have to "believe" (something that I would think is involuntary) that a certain historical event happened roughly 2000 years in our past, namely that Jesus Christ died and rose and that Jesus Christ was God incarnate.
- 3.) The reason why you should believe in this historical event is because it is written in a book, the Bible, which is worth trusting because it was supernaturally authored by God himself.
- 4.) The reason why you should believe that the Bible was supernaturally authored by God himself is because it contains ELS codes which are statistically meaningful, as proved by three Israelis in that study that you outlined.

Now, these are excellent questions, and they touch nicely on a lot of core doctrines of the Christian faith. Let's take a look at these questions and examine the answers for each of them.

- **Is the default afterlife one of eternal torture?**

The answer to this is no. There is no "default afterlife". Each person's afterlife is determined by their **actions, thoughts, and words**, which are usually expressed in combination as "**faith**". However, while it's impossible to prove 100% that eternal conscious torture, rather than annihilationism, eventual redemption, or something else entirely happens, **it's by far the most likely, well-supported, and common-sense interpretation of what the Bible says.**

Let's look into this further. My favorite part of the whole Bible is [Matthew 25](#), in which Jesus gives us the clearest view yet of what we can comprehend "the afterlife" will be like. He describes a judgment, in which humanity is bisected into two halves, one **good** and the other **bad**.

For those who believe the Bible, this is what we can expect to happen after we die, based on Revelation, Daniel, Matthew, and Ezekiel:

You will suddenly awake. No one is in heaven or hell yet, and all of humanity is gathered before a Great White Throne. This is the true tabernacle, or temple of God, the one that has existed before the world began, and the one we emulated on Earth, where God “resided” with the Israelites. The temple being a place of ultimate judgment, demonstrated by killing animals, makes it a fitting place for the judgment of humanity – and there will be a deadly sacrifice taken.

This throne is encircled by something like an “emerald rainbow”, and God himself will have an appearance like fire or glowing precious red minerals. There will be something like “flaming wheels” underneath it, which render it mobile, likely the “wheels within wheels”, or “gyroscopes” described by Ezekiel, some sort of living beings covered in eyes and sparkling like diamonds. Ezekiel interestingly describes the throne as “blue, like a Sapphire”, rather than white, implying the throne can change color. In front of the throne is a “sea of crystal or glass”, likely where humanity will be gathered, the four immensely powerful Seraphim angels, and either something like a menorah, with seven burning lamps, or seven angels or beings that represent the [“seven spirits of God”](#).

Surrounding this throne are 24 “elders”, who wear gold crowns and reign with God in the throne room. This apparent “council of elders” may or may not assist in the judgment of humanity. Upon the shekinah, glory seat, bema seat, or mercy seat, as it is variously known, will sit Jesus. This is almost certainly the actual lid of the Ark of the Covenant, containing the real 10 commandments, Aaron’s rod, and a pot of manna, or else some sort of spiritual analog of it. He will sit between the two golden angels on the lid, and his glory will be like the sun.

His appearance will be so terrifying that even his worst enemies will fall to the ground in fear. And yet, his appearance will be glorious as well, the most beautiful thing ever seen by humanity. With our spiritual eyes and knowledge, every human being will instantly recognize his divinity and unmatched power.



The Bible describes the physical universe as de-materializing instantaneously with a “roar”, fleeing away from the face of “he who sat on the throne”. No place will be found for the heavens or the old Earth - this universe is gone for good, dissipated like a drop of water on the surface of the sun.

Jesus tells us that “all the angels” will also be gathered there. All of creation, for the first time, will finally be together. Jesus says that he will judge us based on one criteria, apart from faith in him: I was thirsty and you gave me drink, hungry and you gave me food, I was a stranger and you took me in, I was naked and you clothed me, and I was sick and in prison and you came to me, with the clarification that this applies not actually to himself but the fellow humans gathered there. “The books will be opened”, and judgment will begin.

No doubt, this experience will be quite a shock for some people. Based on numerous NDEs, I suspect that each personal bema seat experience involves a “life review”, in which the individual re-experiences their life through spiritual eyes, perhaps even feeling the consequences of their own actions. It’s possible that professing Christians who are right with God simply skip this judgment sequence, but this is not confirmed fully.

Jesus says that “all authority to judge has been given to me”, and that “the only way to [unity with] the Father is through me.” Many people misinterpret this verse. What he is saying is not that you must be a “Christian” to be saved, but rather that he reserves the sole, sovereign, and unilateral authority to judge humanity how he will. This means that those who never heard of Jesus can still be saved “through him” if he finds them worthy.

What should concern modern Christians is that Jesus refers to a specific group he will reject, who will call him “Lord” and claim that they have even “prophesied, drove out demons, and performed miracles in his name.” Now, this is a very troubling verse, implying that even some among “Christians” or those who thought they were following Jesus, will find themselves in the “bad” group, rather than the “good” group.

This stark dichotomy of “good” and “bad” is unnatural to humanity. When we look around, people generally seem like good people who want the best for themselves and everyone else. I don’t think anyone but a small minority of humans would realistically be willing to sentence a fellow human to a literal eternity of suffering. However, Jesus does imply that this is to be the fate of those on the “Left hand” or “goat” side, saying:

Then they will go away to eternal punishment, but the righteous to eternal life.

Now, I think this is about as clear as it gets. It does seem that human souls are eternal, being part of God, and will suffer some sort of extremely unpleasant, apparently eternal, afterlife. That said though, being human, I have a strong hope within me that maybe there is some hidden catch that allows most or all people to go free eventually, but we just don’t know that for sure, it’s not up to me, and it’s not in the Bible.

I think most people would prefer either annihilationism, universalism, or some form of eventual redemption, but we can't actually say that's in the Bible, and a common-sense interpretation of Jesus' words, in [multiple other verses as well](#), tells us that [some people will suffer eternally](#). They made every choice they made using free will, and during judgment they will fully realize all the chances they had to simply repent, change their ways, or accept Jesus as savior.

This leads into question number two:

2.) In order to be "saved" (i.e. avoid this eternal torture), you have to "believe" (something that I would think is involuntary) that a certain historical event happened roughly 2000 years in our past, namely that Jesus Christ died and rose and that Jesus Christ was God incarnate.

As we can see from the above answer, the events of Judgment Day are a little more complex than this simplistic interpretation. It's easy to "believe" that Jesus lived and died on the cross, as even people like Bart Ehrman and other atheists and agnostics "believe" in Jesus the human being existing, walking the Earth, and suffering crucifixion. In fact, there is [not a single historian or academic](#) who could tell you with a straight face that Jesus of Nazareth, likely known as something like [Yeshua ben Yosef](#), didn't exist. The evidence is indisputable, and all other theories surrounding the origins of Christianity have been [thoroughly dismissed as fringe science pseudo-history](#).

Jesus exploded onto the scene making unprecedented claims to divine authority, his life acting as a nuclear bomb dividing the timeline of human history into "before" and "after". He is by far the most famous, influential, and important person who has ever lived, and no one else has ever even come close to recreating the kind of worship and devotion he inspired in his followers. Jesus is simply too well-attested, too historically documented, and too influential to have not existed. So, what does it mean to "believe" in Jesus, really?

On a simple level, it means to *also* accept the supernatural parts of his life, as described in the Gospels. Secondarily, Jesus describes himself as the "**Word** made flesh", and I believe that accepting the truth of the full Bible (Word), as it is, literally, in its entirety, is the *other* component to "believing in him". This is not "involuntary", as the Bible is so contrary to our usual experiences in life that it must be carefully examined and picked apart before **intentionally** or **voluntarily choosing** to believe in it. The Biblical narrative is *not* intuitive, or something you can believe in involuntarily. True belief is a deliberate choice that must be made by rejecting all the evidence right in front of your face that seems to say that what happened in the Bible is *impossible*.

For those who truly believe these two things with all their heart: the divinity of Jesus **primarily**, and the truth of the Bible **secondarily**, within the best of their knowledge and ability, a metaphysical change comes over them – they are "saved". Nothing else can save you, not communion, not water baptism, not consecration, not prayers, not preaching, not good works, not dedication, not going to mass, and not church attendance. You simply must accept on faith that the world you see is not as it appears, and that Jesus' words and the narrative of the Bible, as it is given, are true.

Now, this is truly an interesting proposition. It's impossible to fake, as God will always know your heart. It's so difficult that many adults can't bring themselves to do it, but simple enough that a child easily can. It's available to anyone, in any situation – even at the very end of your life, in the darkest, most desperate situations, the ones that you don't make it out of alive, you can still make the choice to accept salvation without any tools or companionship required. I've even personally known mentally handicapped people who are capable of comprehending and passing this test.

Christianity is a brilliant and unique religion, constructed in such a way that its very core tenets reveal its supernatural nature to those with eyes to see. What I personally think it means to be "saved" is, essentially, no matter how your judgment seat experience goes or what you did in your life, you will be on the good side, with the sheep. However, this is at the discretion of the only being with the authority capable of making these kinds of judgement calls, the only one who is omniscient and omnipresent in all of us for every moment we are alive. **Many think they are saved and will not be, and many never knew about salvation and will be saved.**

I find that the "serial killer who repents at the end of his life" thought experiment isn't played out much in real life. True repentance is rare, and it is very difficult to change a heart at the end of its life. Most people remain the same throughout their adult lives without change, and most either die unexpectedly or after their mental state has deteriorated too far to think clearly enough about accepting Jesus.

That being said, it is definitely possible, and I have personally seen a difficult, unlikely, and surprising deathbed conversion that I thought was legitimate. I'm sure if you interviewed men on death row, most of them would [say they are repentant](#) and profess a faith in God, having been spurred on by the desperation of prison and a unique foreknowledge of their impending death. Whether or not their repentance is valid is up to God only, but the fact that he makes it *possible*, and even seems to care *more* for people like that, is incredible and speaks volumes about his merciful and loving nature. Remember, "I was in prison, and you came to me".

To answer the question simply, no – "believing" in the resurrection and divinity of Jesus isn't the *only* way to salvation, but it's certainly the most reliable, effective, and convenient way to get there. However, if you heard the Gospel and rejected it, you're almost certainly completely out of luck. For those reading that have heard this message, Jesus is now the only way. And remember – ["faith without works is dead"](#), and the dead will be judged ["based on what they have done."](#)

3.) The reason why you should believe in this historical event is because it is written in a book, the Bible, which is worth trusting because it was supernaturally authored by God himself.

This question can be answered in the affirmative. Yes, if the Bible was supernaturally authored by God himself, it would certainly be worth believing in these claims. The question is – what evidence is there to believe that this is true?

There's plenty of secular evidence to corroborate the crucifixion of Jesus, with historians marking it as the most certain aspect of his whole life. The Gospels are four extremely strong primary sources, and to throw them out means that you would have to apply the same criteria to everything else too, which would leave us with essentially no sources or knowledge of antiquity at all, even [things we take for granted](#). Really the key question of the entire Bible comes down to this: Who do you think Jesus was?

Jesus was either:

- A crazy, apocalyptic Jew spreading Messianic claims, maybe deluded, mentally ill, or simply taking advantage of a sweeping and growing Nationalism and expectance within the Jewish community. They expected a prophesied warrior-king whom they believed would free them from Roman rule. Jesus could have been taking advantage of this movement to achieve fame, power, and fortune, and was simply so dedicated to the ruse that he went all the way to the cross.
- Exactly who he said he was.

Now, these are the only two options. If Christianity is *not* true, no rational person should believe it. If Jesus is not the Son of God, then no rational person should be a Christian, as Jesus was either crazy or a lying blasphemer. The point here is, he wasn't simply a "good teacher" – **you either must accept all of him exactly as he says he is or reject him entirely**. However, there are some incredibly strong reasons to think that the "materialistic, power-hungry deceiver who simply got too caught up in his own lies or mental illness and ended up accidentally getting himself executed" view of Jesus is *not* true, and the more rational conclusion is that Jesus was simply telling the truth. So far, there have been no secular or materialistic explanations for the following three facts, which are uniformly recognized as true by historians and New Testament scholars alike:

1. Jesus' tomb was in a public, known location, and was found empty. It would have been easy to prove Christianity false by simply providing the body of Jesus, but no one could do that.
2. Multiple individuals, groups of people, skeptics, and even enemies of Jesus had experiences in which they genuinely believed that they saw appearances of a risen Jesus post-crucifixion.
3. The disciples suddenly and irrevocably came to believe in the resurrection of Jesus, despite having every reason not to, as a bodily resurrection before the end of the world was not a Jewish belief, nor was a Messiah who would actually physically die and resurrect.

Unless these three facts can be explained by secularist atheists, the more logical conclusion is that Christianity is true. Any materialistic explanations for these three great unexplained facts, such as the "apparent death/swoon" theory, or the "stolen body" hypothesis have been soundly and universally rejected as untenable, implausible, and unsupported. Indeed, there simply *is no* materialistic explanation for these three facts and the corresponding series of events that followed.

4.) The reason why you should believe that the Bible was supernaturally authored by God himself is because it contains ELS codes which are statistically meaningful, as proved by three Israelis in that study that you outlined.

Essentially, I would answer “yes” to this. I think that just the ELS codes that are proven to exist within the Bible are compelling enough to be sufficient evidence, even by themselves, to accept it at face value. Now, we’ve covered many other reasons to believe in the Bible besides these, such as fulfilled prophecy, specifically the following, with more detail found [here](#):

1. Ezekiel's prophecy of the creation of the State of Israel in 1948
2. Messianic Prophecies
3. Daniel’s Little Horn and Beast prophecies
4. Nahum’s Ninevite prophecy
5. Jeremiah’s Edom prophecy
6. Prediction of the destruction of Tyre
7. Joshua’s Jericho prophecy
8. Isaiah’s prophecy of King Cyrus
9. Nine prophecies of the end times fulfilled

However, in the face of a complete and total lack of any explanation for these ELS codes from the materialist side – short of “coincidence”, of course, I have to say this stands as 100% irrefutable and undeniable proof of God’s existence. That’s all they ever have as a rebuttal - “coincidence”. Eventually, their coincidence theories just become untenable.

Essentially, to accept an atheistic, materialistic worldview, or any denial of these beliefs and the ontology laid out within this writing, you must accept that a *tremendous*, indeed, *impossible* number of coincidences happened. It really comes to a point where accepting randomness and chance as leading to this exact state of things lacks plausibility and cannot be supported by common sense exegeses and interpretations. Indeed, there really are no coherent, supported explanations for the universe and human life on Earth beyond Christianity, as any other worldview just lacks the evidence and arguments to support it, including atheism. The best they can do is attack Christianity, but they never offer anything else besides a coincidence theory.

So yes, the “statistically meaningful” ELS codes proved by “three Israelis” in their studies *is* a good reason to believe the Bible is true. Let’s delve into this deeper and cover some new information (if you’re tired of reading about Bible Codes, skip ahead to page 26).

Bibliomancy, or the art of reading future meaning into the Bible, is an ancient practice, and one that many Christians still use when they open to a random verse for help during difficult times. Let's look at a quote [from the University of Pennsylvania about this remarkable phenomenon](#):

In the 11th or 12th century, a Jewish woman in Byzantium named Maliha wrote to her brothers in Egypt that she wanted to come visit them, but that when she looked into a Torah scroll she found a bad omen forecasting failure if she were to make the journey.¹ Something in the passage that caught her eye seemed to presage evil. Maliha was practicing bibliomancy, fortune telling by opening the pages of a sacred book at random and spotting a message there -- a practice widely known in the classical, Jewish, Christian, and Muslim worlds.²

Bibliocryptography, or the practice of finding meaningful codes within the Bible, is even more well-attested, ancient, and congruent with Christian theology, and has a storied and fascinating past. Grant Jeffrey describes the history of Bibliocryptography as follows in [The Signature of God](#):

The Original Discovery of the Bible Codes Rabbi Michael Dov Weissmandl was a brilliant Czechoslovakian Jewish scholar in astronomy, mathematics, and Judaic studies. In the years before World War I, he found an obscure but intriguing reference to the Bible Codes in a rare book written by a fourteenth-century rabbi known as Rabbeynu Bachayah. The book described a curious pattern of letters encoded within the Torah by skipping an equal number of letters. This discovery inspired Rabbi Weissmandl to begin exploring to see if he could detect other examples of similar codes hidden within the Torah.

Dorum Witzum, one of the primary original Bible Code researchers, [describes it as follows](#):

There is an old Jewish tradition about a "hidden text" in the Hebrew Pentateuch (the Five Books of Moses), consisting of words or phrases expressed in the form of equidistant letter sequences (ELS's) -- that is by selecting sequences of equally spaced letters in the text. Since this tradition was passed orally, only few expressions that belong to the "hidden text" were preserved in writing (Rabbenu Bahya, 1492 and Cordovero, 1592); actually almost all the words and the syntax are unknown. Rabbi H.M.D. Weissmandel (Weissmandel, 1958) was the first to try to show the existence of such a "hidden text", by finding interesting patterns consisting of ELS's.

Now, the University of Pennsylvania article goes on to the usual debunking (more on the debunkers below), but what's interesting is that they can never say that these codes don't exist. Rather, they challenge the methodology and techniques used to find them, Biblical translations, and the complexity of the mathematics, stating, "It is virtually impossible for non-mathematicians to examine their evidence."

This is clearly a false and disingenuous statement, as Grant Jeffrey and other researchers have laid out easily distinguishable ELS codes, with more detail found [here](#) and in Jeffrey's book. The following graphic from Jeffrey's book shows a great number of ELS codes which, astonishingly, are all found within one chapter of Isaiah 53, a classic Messianic prophecy ("[pierced for our transgressions](#)"), and which are quite easy to examine by simply finding the starting letter and following the ELS interval sequence:

There are literally no other examples in *any other texts ever written* of this many meaningful and contextually significant ELS codes found within just a few chapters. To say that this evidence is too difficult to understand is just an outright intentional lie, which Biblical critics resort to far too often out of sheer desperation to discredit their least favorite book.

However, the mathematics and patterns involved can get quite complex - if you want to prove the truthfulness of the codes beyond any doubt. Let's look at what Harold Gans, a retired cryptographer, says about these codes. Having access to resources, equipment, and knowledge that most people don't possess, he is a reliable authority to digest and disseminate this information.

Gans was a retired [senior cryptologic mathematician for the U.S. Department of Defense for 28 years](#) and a researcher who mathematically examined sophisticated foreign government intelligence codes for the U.S. Army. Upon reading the [original Torah codes paper in *Statistical Science*](#), he thought it was "[ridiculous](#)", and attempted to disprove the findings at the urging of his wife. As an intelligence specialist dealing with complex codes and computers, Gans had the technical ability to test the claims and data for himself, so in 1989 he created an original computer program to check the data involved in the Bible Codes study.

Gans has now publicly confirmed the existence of these codes using advanced analytic techniques and [his own sophisticated computer program](#). Bible Code computer programs are widely available and can be used by anybody. As a result of his discoveries, Professor Gans calculated that the odds against this occurring by chance was 1: 200,000, and he spoke publicly throughout the world about this extraordinary evidence proving divine authorship of these texts. In an interview, Gans made the [following extremely enlightening statements](#) regarding his studies of these codes:

One pattern [in the Seminar book] was mathematically interesting. It is referred to as the Aharon Code, and it appears in the first Torah reading of Vayikra. The Torah text concerns the sacrifices made in the Temple by the Kohanim, the sons of Aharon. The code consists simply of the word "Aharon," which appears as an ELS in this section 25 times.

So the first thing I did was check the calculations myself. I got the same number. I then calculated the probability of observing 25 such ELSs when around 8 were expected by chance. The probability was significantly small: less than 1 in 500,000.

It was at that moment—sitting there with my calculator in hand—that I thought, "Hmm." For the first time, I thought that maybe Torah Codes couldn't be dismissed so quickly.

There was, however, one presentation which caught our attention. This was a complicated scientific experiment, designed and executed by Dr. Rips and Doron Witztum, which later became known as the Great Rabbis Experiment.

They had found that the names of great rabbis in Jewish history were encoded in close proximity to the encoding of their dates of birth and death. The Great Rabbis Experiment is relatively complex. It appeals to the scientist, not the layman.

Any text will produce a certain number of meaningful-looking patterns and word associations, even the back of a cereal box. Your subjective judgment may lead you to imagine relationships between words and to perceive meanings, where none may exist.

The computer enables us to look through millions of configurations in search of interesting or unexpected patterns. A mathematician can then calculate the likelihood that these patterns happened by chance, while a non-mathematician would be at a loss to evaluate them correctly.

Professor McKay and his colleagues [the debunkers] never claimed to have discovered real codes in those non-Torah texts. Their only “successful” results were obtained by deliberately rigging the experiment in such a way that the layman wouldn’t recognize the mathematical flaws.

The public does not understand that these critics openly admitted that their research did not result in the discovery of even a single valid code in any text other than the Torah.

As I stated, however, looks are deceiving. ELS word patterns can be found in any text. Any passage in a newspaper can produce real words with equal letter spacing. But these are random occurrences; they are not codes.

To find a coherent phrase or even one meaningful sentence in this manner would be rare, indeed. There are hundreds of Torah Codes, however, consisting of coherent phrases and sentences, many of which convey explicitly meaningful information about the Torah and shed light on the Torah itself.

The critics who “discovered” codes in works of English literature did not claim to have used proper scientific protocol. They concluded that since they were able to produce patterns that looked like our codes, this must have been how we got our results.

There are strict mathematical criteria that determine the definition of a code. What is, and is not, a code? Appearing as an ELS is only one of several criteria. The most important criterion is that the configuration of ELSs found must have some well-defined mathematical or structural property that is highly unexpected.

In other words, it must be highly unlikely that this so-called “code” occurred by chance. This criterion is crucial. The standard scientific criterion for “highly unexpected” is that the odds against its occurring by chance are greater than, or equal to, 1,000 to 1. This must be determined by use of sophisticated software that executes what is known as randomization tests. Once one applies the criterion to the critics’ “codes,” a mathematician can see immediately that they do not qualify as codes.

[His study](#) reads as follows:

[Witzum’s] result has been challenged on the basis that it is difficult to verify that all components of the experiment were completely a priori. We present a new experiment that is algorithmically structured so as to be demonstrably a priori, and which extends the original results. A significance level of 4×10^{-6} is obtained for this experiment.

A portion of the study can be seen below, demonstrating the mathematical complexity of proving beyond any doubt that these patterns are real, unprecedented, and significant:

(See [12] for the explicit computation of $D(W)$). His conclusion:

The compactness of patterns formed on the surface of a cylinder by ELSs of a priori selected famous Jewish personalities and ELSs of their communities of birth or death is **smaller than can be attributed to chance**. Now, the debunkers, a group of secular scientists who questioned the results obtained, really had a hard time with these codes. After their failed attempts at debunking, they made the remarkable statements that [they were “harming their careers”, they miss the “good old times”, and they “have better things to do than codes.”](#) They conclude their attempt to debunk divine authorship of the Bible by stating, **“It is a good time to quit.”**

Various other attempted [debunkers](#), after attacking the authors for their alleged “tuning”, [appeal to Theology in a bizarre and fallacious manner](#), in an attempt to discredit the authenticity of the ELS results. They say, “Judaism does not encourage missionary attempts to recruit non-Jews. The Talmud states that ‘...the proselytes are as burdensome to Israel as leprosy’”, as if this has any relevance whatsoever on the veracity of the ELS codes.

Essentially, allow me to sum up their responses:

Yes, the codes exist. Yes, you can prove they are there. However, there *must be something wrong*, because if you’re right, that means that I am wrong, which would be bad for me.

Therefore, there must be some undisclosed issue with your methodology and reasoning, I just don’t know what it is, can’t show where it is, and can’t prove it exists.

We see this heavily in the [Penn State article](#), where they delve at great lengths to insist that the Bible is just *too poorly translated* to rely on any codes that could have survived. Regardless of their paragraphs of speculation and conjecture about potential translation issues, the Bible is the single most accurately passed-down text we have, and the Masoretic Hebrew is a functional, attested, and predictable method to search for codes. The manuscript evidence that we have on the Bible is solid, and anyone who says otherwise just doesn’t want to believe it could possibly be true.

So yes, any rational person should accept these codes as compelling enough to believe in the Bible, especially on top of its other indicators of truthfulness and supernatural authorship.

It Is Irrational to Not Fear God

Many people are in for a real shock when they eventually realize that they are entirely at the mercy of Jesus Christ, with a literal infinity of eternal suffering or bliss at the stake. Given that the Bible is by far the most likely explanation for what happens after we die, I think that most people should actually be a lot more scared of God.

Think about it – the capacity for human suffering is immense. Trapped helplessly in our fleshy bodies, our nervous system can transmit *tremendous* amounts of suffering to our very consciousness itself. Even a simple lack of stimulation, like being locked in a dark box with a feeding tube sustaining you for a lifetime, presents unimaginable, unthinkable suffering. These thought experiments are morbid, but they pale to nothing in the face of an *eternity* of active suffering. **Truly, it is a terrible thing for sinners to fall into the hands of an angry God.**

This means that we should fear the afterlife a lot more than the laissez-faire, nonchalant attitude most people have about it. Really, it's almost beyond our capacity to imagine or comprehend the importance of this. If the Bible is telling the truth, and there is solid proof that it is, a literal eternity of conscious experience is at the stake. Imagine being trapped in a spiritual body somewhere you don't want to be, *forever*, and you will quickly recognize the importance of taking a second look at that dusty ol' Bible. However, most people don't really seem to care at all. They think they are strong, but they don't realize that humanity is actually extremely weak, vulnerable, confused, and lost. We don't know why we're here, or even where we are really, and if a being greater than ourselves wants to condemn us to hell, well, that's just too bad for us. We are lucky, in fact, that God is as fair, just, and merciful as he is.

Even from a simplistic "Pascal's wager" standpoint, it makes sense. It really does – atheists love to tell you that Pascal's wager has been "debunked" by an appeal to various other Gods or belief systems, or even a hypothetical anti-Christianity God, but there really is far less evidence for any of these other religions or belief systems than Christianity, including atheism. The preponderance of evidence on the side of the Bible indicates that the Christian God has a far higher chance than any of the others of being real, meaning that Pascal's wager is still active.

Really, it just makes sense. You literally lose nothing by believing in God and trying to be nice to other people, and you can potentially gain everything. By sinning and rejecting God, you are subjecting yourself to a life of misery, expounding interest payments of sin that never stop, a difficult yoke of material existentialism which is doomed to fail upon your inevitable death, and likely 'karmic' consequences for your harmful actions. You also reject *rationality itself*, as I have pointed out literally hundreds of reasons why the worldview I lay out is by far the most likely, supported, logical, veridical, well-sourced, evidential, explanatory, and rational worldview.

Like I said earlier, just *feeling* and *observing* the truth of the Bible is a good enough reason to believe it, and those who reject it do so not because of any evidence, but because they simply *do not like what it says*.

Mankind Is Doomed Without Jesus Christ

Another question I was asked was, “Why can’t we have a ‘pantheist anarchist’ society where everyone believes what they want, because believing in a God is good enough?” Now, this is a new one for me – I’ve never heard of “pantheist anarchists”. The answer I gave is that a created or contingent being can never succeed on its own indefinitely. Something that exists in this universe will always die, always succumb to entropy, and always fail. Without a connection to our divine, eternal source, mankind is lower than the worms digging through the thin film of biomass on top of our meaningless rock of a planet.

The reason we are lower than even the insects crawling in the dirt, given the atheistic perspective, is that humanity is critically, monstrously, and terminally flawed. Worldwide, there’s about [1000 reported murders per day on average](#), and in the United States alone there’s approximately [1000 rapes of people above 12 per day](#), with another [200 or so child rapes thrown in there](#). Every day. This isn’t even counting state-sponsored killing, wars, deaths that were covered up, or information from countries like North Korea, China, or Iran that don’t report statistics like these accurately.

The amount of suffering created by human hands through a lack of knowledge, greed, lust, covetousness, anger, and all the other things warned about in the Bible is unimaginable. This boggles the mind – all we had to do was follow the Ten Commandments, and Earth would be close to a paradise already. Instead, there seems to be a deep, fundamental, problem or issue with mankind at his very core.

People love to blame the devil, or even God for these evil actions, but as far as we know, all of these acts of rape, torture, and murder have been committed by human hands alone. Without God, any random animal alive has more dignity, honor, and purpose than mankind - the psychopathic primate who tortures, kidnaps, rapes, and murders his fellow humans simply as a hobby.

Perhaps the atheists and materialists are right, and there is no God. So what? Mankind is, then, simply a deranged, violent monkey, destined shortly to wipe himself out and fade into a never-ending universal obscurity, whose remains, at best, might be analyzed by some future, more advanced species before being forever obliterated by our expanding sun.

At this point, only God can redeem us. Judging by the state of things, you would think we developed an allergic reaction to *not killing each other literally every day*. The question is – what is it about mankind that makes what he “wants” so evil?

Last night, I watched an excellent movie from 1991 called *The Inner Circle*, which chronicles the true story of Joseph Stalin's personal cinema projectionist. The point of the movie was that everyone was constantly lying to each other except the protagonist, who is called "naïve" several times throughout the film. Indeed, he is, as his childlike worship of Stalin and belief in the truthfulness and benevolence of the state continue his entire life, even after bringing it to ruins.

However, what about all the other people, who are clearly shown to see through the propaganda, and understand that they are ruled by evil with an iron fist? [A famous slogan from Soviet Russia is this](#), "The ultimate power – they know we know they lie to us, but they do it anyways, because there is nothing we can do about it."

We know they are lying, they know they are lying, they know we know they are lying, we know they know we know they are lying, but they are still lying.

- Attributed to Aleksandr Isayevich Solzhenitsyn

I would say that these masses of willfully lying people represent the fundamental issue with humanity. Our susceptibility to delusion on a mass scale and our desire, craving even, for subjugation. Even though everyone knew they were being fed lies and their lives had collapsed around them several times in the last decades, they still loved their cruel overlords so much that a deadly crush formed when Stalin's body was displayed, in which the Russian people trampled and killed over a hundred of their fellow citizens to see their beloved leader's body. This is something I just can't comprehend. **What is it about us that makes us crave subjugation so badly that we will kill each other just for the honor of kissing the boot grinding us into the dirt?**

Going back to the film, the people around the protagonist, who willfully, tacitly, and explicitly continue to carry on their massive lies and delusions, are no better than he, who at least truly believes he is doing the right thing. **Maybe, they are even worse.**

Of course, there are consequences that come from standing up for the truth, even death at times, but without the truth, what is the point of living? 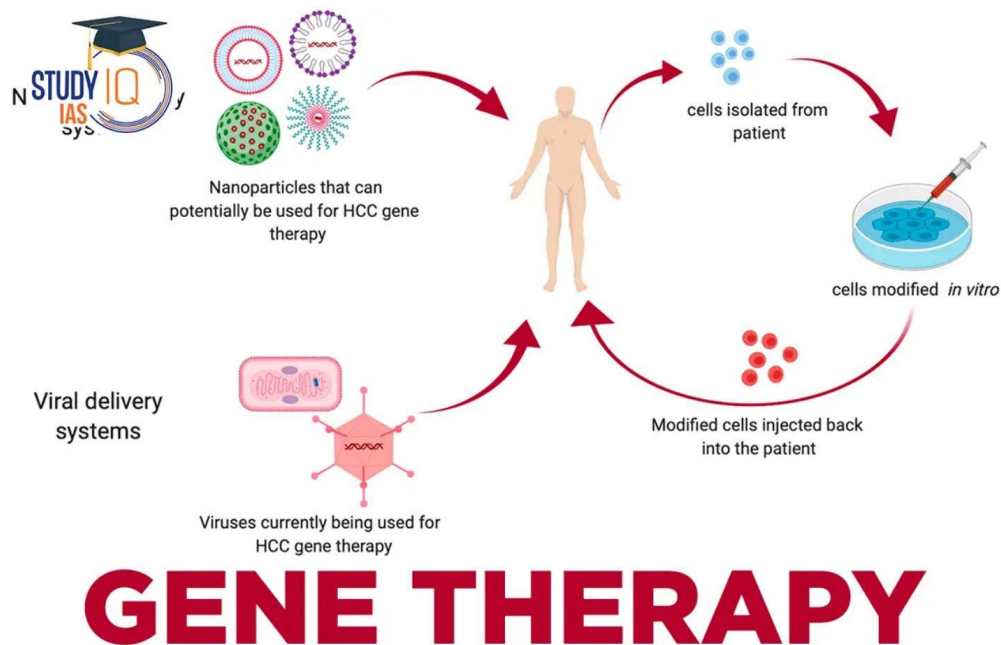

After all, the power structures shown in this movie never disappeared, they just went underground. 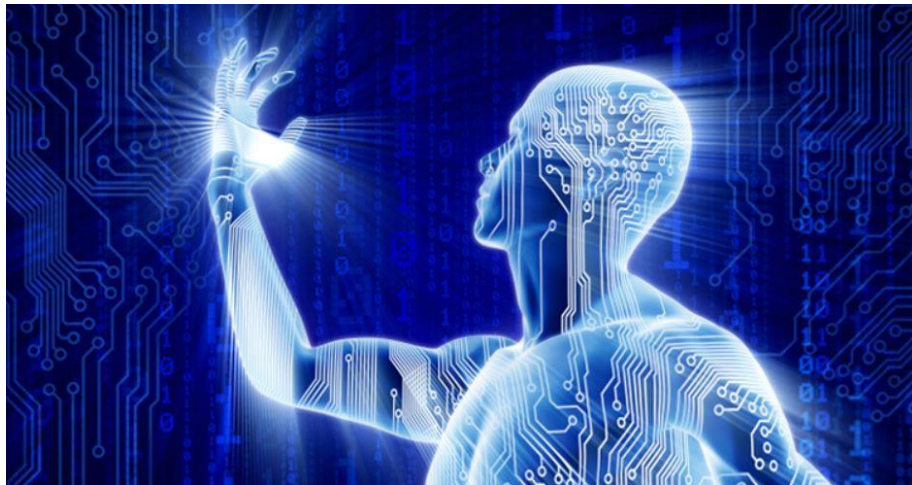

What they learned is that the only way to control someone's mind is through fear. If you traumatize them enough, you can create a new personality. Of course, those running these experiments already knew that, as occultic secret societies have been doing this for thousands of years. They were just refining their techniques.

Through events like planned wars, state-sponsored terror, false flags, deliberate poverty and starvation, political control, and a media that sticks to the script no matter what, the Synagogue of Satan has been playing humanity for over a century, using fear as both the carrot and the stick.

From the Lusitania, to the Balfour Declaration, to World War II, to the founding of Israel, the invention of the computer, the false dichotomy of Capitalism or Communism (“wouldn’t wanna starve like that other guy, would ya?”), through 9/11, and now Covid and the gene therapy injections: it is all connected.

A human soul, at birth, is innocent and pure, and a certain amount of trauma is required to “break” a soul, or snap someone so hard they never fully come back. This was, essentially, [the CIA’s sinister goal in the MK Ultra program](#) – the ability to completely break down and rebuild the mind itself. Personally, I think they succeeded, but it just doesn’t look the way that anyone expected. If the whimper that is the 21st century really is the last days of mankind, it’s even more boring and dystopian than the worst predictions foresaw.

Thesis: Bad actors are manipulating fear on a global scale. Fear is contagious, and an organism around fear instinctively knows it, affecting their behavior. Humans are made to pass fear onto each other through a series of terroristic actions, controlled governments, manufactured wars, and false flag attacks, and the ripple effects of this fear are used to shape the world into the vision of its ruler – Satan.

Unfortunately, the only endings I see are bleak for the majority of people alive today. They are listless and spiritually dead, sleepwalking through life. Mankind has become a domesticated beast of burden, broadly unable to even *think* in paradigms that would allow him to challenge his masters.

The earth is inhabited by an inhuman evil. Human evil can be reasoned with, satiated, or defeated. Inhuman, undefeatable evil, like the evil pervading the actions of the Synagogue of Satan, speaks of a “power and principality” in high places – again, the Bible tells us [exactly who owns this world](#). **It’s really not even an open secret anymore - everyone is playing ball.** The inability of the majority of mankind to question the systems they are born into is his critical flaw, as is his inability to imagine different possibilities.

I guess my point is that a common-sense interpretation of the facts of the 20th and 21st century suggests that Satan is literally on the Earth, pulling strings behind governments, and putting things in place to end the world. Satan is, of course, really just a tool that God uses to entrap people. You see, God wants evil people gone for good. **They were once part of him, but they will be forever separated.** Satan was created to lure all the people that chose an easy life, those who murder, steal, and cheat their way through life, always hurting but never helping, into a trap from which there is no escape.

God, being infinite, used to contain evil. [Isaiah 45: 7](#) reads, “I form the light, and create darkness: I make peace, and **create evil**: I the Lord do all these things.” That’s the master plan behind all of this, to reunify with God as a whole, but only infinite Good, forever.

Why do you think they call it the Wedding Supper of the Lamb? What happens after a wedding is called a consummation. In this sense, I think we will experience a direct, complete, and perfect unity with God, through his son Jesus Christ. Not all Christians know that Jesus actually prayed specifically for them:

Jesus Prays for All Believers

My prayer is not for them alone. I pray also for those who will believe in me through their message, **that all of them may be one, Father, just as you are in me and I am in you. May they also be in us** so that the world may believe that you have sent me. I have given them the glory that you gave me, **that they may be one as we are one - I in them and you in me - so that they may be brought to complete unity.** Then the world will know that you sent me and have loved them even as you have loved me.

Now, how's that for a prayer? What the heck does that mean? I don't think any human can understand, but I am definitely going to do everything I can to make sure that I am a part of it. Anything else sounds like hell.

When people say that "heaven sounds boring", they don't understand that the glory of it will be literally orgasmic. God tells us we will be "married" to him and Jesus, and anyone who envisions heaven in strictly physical, human terms, like we will just be strolling around sniffing flowers and singing worship songs for eternity, is missing the point. Those heaven NDEs are nice and all, but they don't represent what is truly in store for those who make the cut (although it's possible that this is what "saved" people experience while they wait for Judgment Day). The consummation of the Wedding Supper of the Lamb will be incredible beyond anything we can possibly imagine.

At the end of the day, I think humanity lost sight of the fact that not being right with God can have serious consequences. He is too content, too happy in his little snowglobe, unaware that he is only a small, relatively meaningless player in an inconceivably vast game where the stakes are literally life and death. "The universe has always been here", he says, laughing. "Where would it ever go?"

Our ancestors were lucky, in that their world was a lot easier to remain right with God in. Humanity today has become perverse and wrong, like an appliance designed with planned obsolescence in mind. Indeed, mankind has always had an expiration date – 6,000 years. Why do you think the Sabbath is so important to God, anyways? An obsession with "rest" - not exactly what you'd expect from an omnipotent deity.

The clue can be found in the "one day to God is like a thousand years" verses. God gave us a prophetic foreshadowing of the amount of time we have here, built into our very week, our very being. 6 days of work, and 1 day of rest. The Earth: 6,000 years of mankind's turmoil and war, then 1,000 years of peace during Jesus' millennial reign. That's why the seven-day week is so important to God, it's a way to instinctually tell everyone that there's an end date. – an end date that we are coming up on within our very lifetimes – and there's no doubt that the herd senses this coming. Like animals sensing the onset of an earthquake or volcanic eruption, mankind is sensing the tremors of the world soon coming to a violent and supernatural ending.

6,000 years:

- **Adam – Abraham: 2,000 years**

During this period, the Nephilim were on the Earth. Mankind was at his lowest stage of development and turned very evil. God intervenes and only Noah survives, preserving the Adamic bloodline that would lead to Jesus. The next stage begins when God makes his covenant with Abraham at approximately 2,000 B.C.

- **Abraham – Jesus: 2,000 years**

There are so many parallels in the Bible you just have to love it – Noah in the Ark, Isaac on the wooden pyre, Moses in the basket, and Jesus in the manger, then the cross. All enclosed in wood, protected and kept safe by God. Without Jesus, no human would be saved.

During this period, mankind was in an intermediate stage of ethical and moral development, having been given the Ten Commandments and instructions for temple worship, along with the concepts of repentance, penance, and sacrifice, demonstrated through ritualistically slaughtering animals.

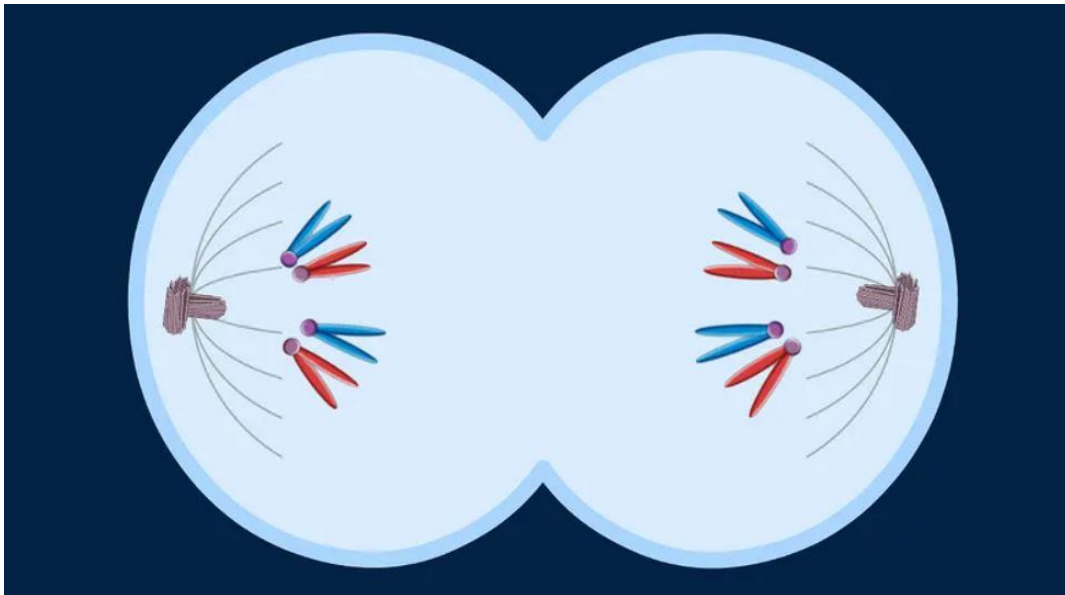
God directly intervenes in the world in different, more direct ways than he does in the final church period. The Israelites supernaturally carve out a territory for themselves from their overwhelmingly powerful neighbors, which can be seen as a front in God's genetic war. The two temples that mimic scenes of God's Throne Room, where the judgement of humanity will happen, are set up in Jerusalem at various times, again an analogue of the *real* Holy City.

The Israelites fail at every turn, never learn their lesson, and cannot stop sinning, even with direct proof of God's existence available. Their leaders continuously spit in God's face, disobeying his commands and killing his prophets.

Step by step, the symbolic, mythological, and moral compass of humanity is built up. It's always important to remember how many generations lived before petroleum products and computers, and how different their lives were than ours. *Thousands and thousands of years* of humans just being born and dying, living in rural agricultural communities, experiencing the joy, pain, drama, excitement, and heartbreak that is human existence.

Each one of us is a little piece of God. That's really what it says in the Bible, and there's a lot of good reasons to believe it. Honestly, I think deep down inside themselves, everyone knows that this is true, even if they wouldn't admit it.

All of these thousands and thousands of years of literally billions of people, all interacting in different ways, were to test the nature of God himself, and slowly... slowly... slowly... coagulate one side from another. A sort of *divine mitosis*, if you will.



- **Jesus – End: 2,000 years.**

Jesus coming onto the scene really changed the game. Before that, it was considered cool and fashionable to openly sacrifice your infants to Moloch. Jesus forced the Satanic power structures around human sacrifices underground because he brought people into the light and told them that they have value for the first time.

That's why the hate for Jesus is so ingrained into our society – they want you to hate everything about him because he was the only one who ever exposed them and made *them* run and hide. Jesus peeled back the curtain of reality in a way that no one else ever has, and honestly, his story makes sense. I believe it, and it rings authentically true to me. Born in a *manger*, riding a *donkey*, unimaginable *suffering*, utter *rejection* by his people – not your average theology, is it?

Between the years 2-400 A.D., the Bible was compiled and put together, with no real disputation as to what the canonical Bible is. About two hundred years after this, right around the time the Bible would have begun to spread rapidly around the world, say 5-600 B.C., Satan created a counterfeit version, through which he would deceive unimaginably vast swaths of what should have been God's people.

This counterfeit Bible is the Qur'an. I think a common-sense interpretation based on textual criticism, historicity, ideology, and just generally everything about Islam, makes it obvious that the Bible is the superior choice. For one thing, this Muhammed guy was just an overall shady character, murdered a bunch of people, became a warlord, and [married a six year-old](#). He was clearly just like all our rulers today, and indeed, most other people you see around you. Sinful, fallen. Just human.

Jesus of Nazareth was inhuman, living a sinless life genuinely like no other, simply walking into and out of death like nothing, teaching us once and for all that there is more beyond the veil. I'm not able to make a sure judgment either way on the status of Muslims being judged by Jesus, but it's definitely not a best-case scenario.

Now, I have high hopes for mankind as well. These are difficult times, but if anyone believes these words, and believes in the Bible, they likely have great things in their future. Just not in this physical universe. That's the whole point – those who can let go of the *fruit of the knowledge of good and evil*, described as "*pleasurable*" to the eye, will gain more than they can imagine. Conversely, those who think this is all that matters, spend their lives chasing sin and pleasure, hurting others, making desperate moves because they think one life is all that they have, those that hold on to the physical world until their knuckles are white – they will lose their lives.

The key is to let go.

Anyways, this church era is where we currently are. God doesn't manifest physically on Earth the way he used to, as *we never stopped sinning either way*. People love to say, "Well, why doesn't God just come down and show himself? If he did that, I would *definitely* be a good person and believe in him." The truth is that people never cared enough to stop sinning or do what he said anyways, even *with* direct proof.

Instead, we now have the Holy Spirit working on Earth, occasionally performing miracles or saving an innocent person from suffering. You find the Holy Spirit when you buy the homeless people food. You find the Holy Spirit when you treat a child with love, rather than hurting them. You find the Holy Spirit in a room inside a nursing home, when one of the workers genuinely loves the people they care for, and they laugh together.

This is the essence of Jesus' church. It is not a building - it is simply when one human being *loves* another for no reason, just because they exist. At the time, that was apparently a pretty radical concept. Today we are so oversaturated by the word "love" that we have lost sight of its meaning. I know, I know – "There are 4 different types of love in the Bible: Philia, Eros, Storge, and Agape."

The Bible defines the word Love as filtered through these four lenses: the love between friends, lovers, and family respectively, for the first three, and the famous *Agape* love as the most unique and compelling.

Agape [has been defined as](#), "pure, willful, sacrificial love that intentionally desires another's highest good." Now, this is the Holy of Holies, the real Holy Grail. Love – the source of Life itself. God's very own nature, revealed to us, mere humanity.

And honestly, it's not even that complicated. "Do good things to one another." Simple, right? Logical, even. **It's the kind of thing a monkey could come up with while sitting under a banana tree.**

Still, people make it complex. They have somehow turned the word *love* into something divisive, manipulative, and backwards. People are no longer allowed to have independent thoughts and views, or they will be accused of being *hateful*. Satan, in one of his grand final acts, has twisted the word *love* so badly that most people don't even know what it means anymore. *"Is 'love' about accepting LGBT people or something?" "If I put a 'love wins' border on my profile picture, will I get into heaven?"*

All over the media, we hear about "love" and all of the definitions of it that we are force-fed, but none of these ever mention the simple, but profound, "[Law of the Prophets.](#)"

"'Love the Lord your God with all your heart and with all your soul and with all your mind.' This is the first and greatest commandment. And the second is like it: 'Love your neighbor as yourself.' All the Law and the Prophets hang on these two commandments."

So, it was laid out for humanity quite simply. We need to love God first and foremost, and then, we need to treat others the way we want to be treated. Jesus's teaching is not complex, and yet, somehow humanity has still completely failed. You must always remember the other side of the Mercy Seat – the Judgment Seat. There will be literally billions of people who were violently assaulted, killed in wars, murdered, raped, tortured, or worse. The blood on our hands will be immense. While some of these victims may forgive their aggressors – the very quality that made them sheep rather than goats – the accused won't be getting off easy in the spiritual world.

At this point in my analogy, the hypothetical person cracks a beer, a big no-no in prison camp, because he thinks he's in a luxury condo. He is literally telling me he is in Miami at the beach, but I can see the barbed wire and snow behind him.

"You know, you're really not supposed to drink beer in here."

"Oh, I'm so scared - the 'guards' from your 'prison camp' are going to come 'arrest me' right? Well, I haven't seen any guards in months. I think I will live here, this is my home now."

"Actually, this is a prison camp in the snow, and the guards are right over there in that tower. You are losing touch with reality, man."

At this point, the other person succumbs to hypothermia and dies, content in his delusion that he really was in a luxury condo in Miami. But he wasn't - he was a lost, broken soldier, dying of sepsis, thousands of miles from home, alone in the snow.

Now I'm stuck here with this guy's dead body and a beer bottle that I have to get rid of somehow. Inevitably, the war ends, and soldiers show up and take me home. When I get there, I'll be judged on how I fought in the war and how I treated all the insane hallucinating people in the prison camp.
