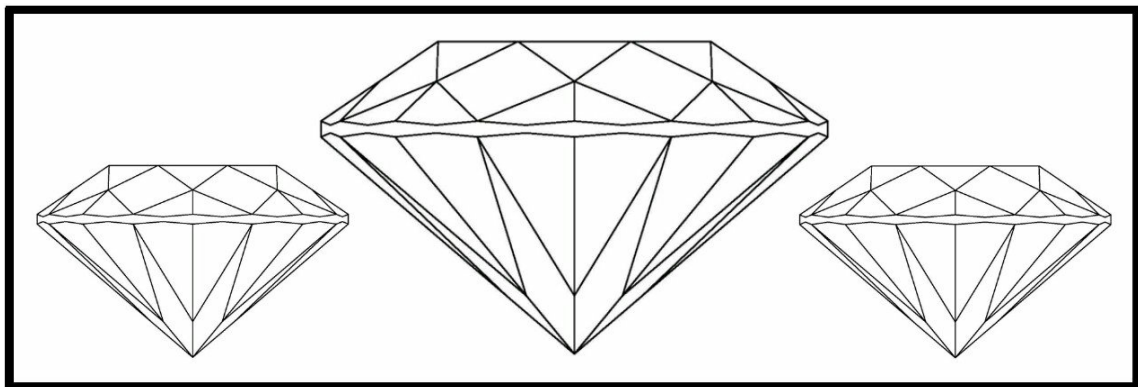

The Federal Government of The Imperium of Diamond's



Hello to Dear General Secretary, Mr. Luis Almagro, for the Organization of American States, and Dear Ministers of the Foreign Affairs of countries of America and an Interest

I Thank the Dear General Secretary OAS Dear Luis Almagro, I Thank You for your ongoing interaction and support for the possibility of legal development in supporting the states of the American continent, and I really confirm with my willingness to be interested in our cooperation also for the purpose of America.

I apologize above all for my present and unpreparedness, my current position is not capable of doing enough work, and my last work has been used for interactive documents, thereby ensuring the legality of my claimed rights at the commercial and political level, and thus allowing, without risk, To open up our common ties together with the American states and to secure better development of our countries and civilizations, in full compliance with our International law.

I lost my main time by writing the IAIC text, the International Advocacy Intelligence Council, in order to make my official stabilization more secure, which today is largely omitted because of my criminal opposition from the European governments. The IAIC document, in the case of its application and mobilization, can thus ensure the full stability of ID's of official interest and development cooperation between states. The ultimate goal of IAIC cooperation is to interactively strengthen friendship between all nations and to support our shared development of civilizations, as well as the strategy of peaceful centralization for ID's civilization and government stabilization as claimed by International law.

I am still alone here, without logistical cooperation and support, without direct social relations and in complete isolation, without the possibility of exercising my rights and full discrimination in social and political development. The people around me have to be very afraid of the crimes of Europe, monitoring personal movements, censorship of the post, the Internet and the media, drastic

violations of social rights, apartheid and robbery about identity or even murder and illegal detention.

That is why, in my main interest, I ask for your esteemed and truly honest support for the OAS Council of Ministers 'Foreign Affairs' awareness of the possibility of promoting communication with the Chambers of Law and public associations of Advocates and Lawyers in order to apply the IAIC stabilization document and thereby put into operation, without risk law, Which is for our parties claimed by international law and the Charter of the United Nations.

Your American States can also get financial investment through cooperation in the first set-up session at € 1,000,000,000,000 in DMD for the first year.

My goal is therefore to support the development of your countries and civilizations, the expansion of the common trading markets, and allow your states to invest in my civilization development or to broaden our common interests at International level.

Today I own a document for our communication as an ID's representative of facts and plans for OAS states as my presentation, but it is only in the Czech language and will be published as part of ID's Global Card for international cooperation with all organizations around the world. My current position under the terrorist blockade is not capable of fully active communication, and therefore I am forced to apply the first development strategies and thus slowly develop International communication.

I am convinced of this fact and I fully confirm that I know the principles of OAS legal cooperation and I am in favor of the purpose of our interests and partnership. As soon as ID's Global Card is published, it is an opportunity to fully convince and reap the benefits of our joint growth to strengthen the future of our nations and politics.

Today, I also support the peaceful stabilization in Venezuela as a result of your interaction and therefore my expression of my personal conviction that the Venezuelan government has a legal duty to open the rights of the Venezuelan State and to ensure a continuous interactive media presentation of the state's right to stop riots and radical movements To progress in peace, and thus with mediated presentations of cooperation that is beneficial for the Venezuelan state, and an acceptable option to the nature of the state interest and such capacity to negotiate.

The Venezuelan nation is often subjected to harsh discrimination at the level of internal occupation by the country's own government, but also to the problems of the immeasurable resolution of the crisis in the state's radicalism. It is advisable to support stabilization and to determine the responsibilities for the Government of the Venezuela in order to ensure reconciliation and to make progress on arguments for intentions acceptable to the nation. At the same time, attempts to transform the constitution and other acts today can not be valid due to

state fragility and attempts to discriminate the dictatorial growth of the government as acts that are the main cause of state protests and hatred.

If the Venezuelan government is unable to accept the offer of peace reconciliation, then the OAS states, together with UNASUR, and international cooperation as an UN organization, it is possible to create the right to create a provisional office of the new Venezuelan government, composed of peacekeepers of state interest and protest movement; The obligation to take responsibility for the stabilization steps for the current legal status of the Constitution of the Republic of Venezuela.

That is why I hereby endorse my own abilities to respect national interests and prove that I am not an active interest in the discrimination of national law and the violation of the right of peoples for the sake of my own personal interest in confusion. I always support state interests and it is in my goals to extend national values and rights to the best possible level.

That's why I want to introduce one of my latest interactive documents on the situation of the illegitimacy of the Czech Republic and therefore to create the right for the international parties to establish a new step of the political future. A documentary about the Czech Republic and my rights of the last citizenship as the last legal representative of the land but also in the supplement many people who send me cryptic greetings and prove that I own social support in the territory of all European states but because of the terrorist blockade I am not able to use legal rights for activity.

damaged by natural disasters.

In the case of my stability, I am pleased to be able to support humanitarian and stabilization co-operation with the government and the nation of Chile, but also with all the states of America.

In conclusion, as a result of the legitimacy of my rights created by the criminal consequences of the European states of crimes, it is a fact of my pleasure for the possibility of full unity of the American Nation, and that is also my objective for the step of this cooperation on the American continent and Latin American continental geographical And under the regional nature of the friendship of politics.

Our cooperation is a good step for our states, but also for the pride of world politics and legitimacy of rights.
