The Meter Maids Are Coming!

In the coming weeks, the streets around the skating rink, St. John's Church and the Mary Colbert Apartments will have some new additions to the scenery - meter maids.

About 70 Charlestown residents from Precinct 1 met at a Neighborhood Council meeting on June 26 and voted to implement resident parking in their area. Parking will be restricted from 7 a.m. to 7 p.m., five days a week.

The streets included in Precinct 1, which are the only ones affected by the parking program, are Austin, Devens, Harvard, Lawrence, Lynde, Prescott, Seminary, Union, Washington streets and Old Rutherford Avenue.

The decision to establish resident parking came after months of resident complaints due to commuter use of local parking spots and the eventual overcrowded streets that this caused.

"The program should be in effect by the end of August," said James Mansfield, director of Enforcement for the Boston Transportation Department (BTD).

"All residents will have to go to the parking clerk at Boston City Hall with their vehicle registration and a proof of residency, such as a bank statement or a utility bill, to receive a parking sticker," he added. A resident's vehicle must be registered under their name and Charlestown address in order to receive a parking sticker.

The question was asked of Mansfield as to the procedure with a leased vehicle. He stated that the lease agreement must carry the person's name and Charlestown address. The person will then bring in a utility bill or bank statement along with the lease agreement in order to obtain a sticker.

About eight months ago, residents finally asked what could be done about the situation. A representative from BTD came to a Neighborhood Council meeting and gave some options. The residents then decided that they wanted resident parking in the area.

In order to implement the program, petitions had to be signed by more than 50 percent of the occupants of each street in Precinct 1 where residents expressed a desire for residential parking. When that was completed, the city came back with an acceptance plan and a proposal

★ Boat Service Links Waterfront's Top Attractions . . . Massport and the city of Boston have started an innovative boat service on Boston Harbor which will provide a first-ever link between some of the waterfront's top cultural institutions and tourist attractions. The new service is called "Boston By Boat: The MuSEAum Connection" and is the first public initiative of the joint Massport/Boston Redevelopment Authority (BRA) partnership -Seaport Economic Development Plan.

Boston By Boat will run until Sept. 24. It will include stops at docks located at the Children's Museum, Computer Museum, New England Aquarium, Burrough's Wharf (North End), Museum of Science and the USS Constitution. The boat operates daily from 10 a.m. to 5 p.m., including weekends.

Representatives of Massport and the BRA agreed to begin Boston By Boat on a half-season basis this summer with the intention of running the service next year from spring until fall. Brochures containing the service's schedule will be available throughout Boston and at Logan Airport as well as at each dock where the boat stops. Fares are: adults unlimited all day, \$5; adults one way, \$3; children under 12 unlimited all day, \$4; and children under 12 one way, \$2.

As an added bonus for using the boat service, the Children's Museum, New England Aquarium and Museum of Science are offering reduced admission coupons to boat riders. When a Boston By Boat ticket is purchased, the boat operator will give the rider coupons redeemable at each of the three institutions for \$1 off admission. This offer is valid until the service ends on Sept. 24.

Ceremony Marks Naming Of Terry Ring Way



restricted parking for the precinct, each street will have its own restrictions.

It is thought by some that resident parking will solve some of the problems, but not everyone feels that it is the best solution.

Neighborhood Council member William Galvin expressed his concerns about the plan at the meeting. Galvin said that he felt that resident parking was a

The program is made possible by a \$35,000 grant from the state office of Public Safety. Besides the law enforcement and Boys & Girls Club participation, the program employs 20 Suffolk Country youth as peer leaders.

Increased Adult Education Funds For Charlestown

Sen. Thomas F. Birmingham and Rep. Richard A. Voke have announced that the Legislature's initiative to increase state funding for adult basic education will provide for the expansion of services offered in Charlestown.

The Charlestown Community Centers have been awarded, by the Department of Education, an adult basic education grant of \$79,000, compared with \$59,000 allocated to the same program in fiscal year 1995.

It is estimated that almost one-third of the

state's adult population could benefit from basic educational assistance and that less than five percent of these individuals could have been helped by the fiscal year 1995 program offerings. The additional funds are being used to expand opportunities in a variety of adult education

Birmingham, chairman of the Senate Committee on Ways and Means, included the additional \$4 million in that committee's fiscal year 1996 recommendation. "The budget process entails prioritizing the many areas of

government expenditure," Birmingham. noted "Including additional funds for adult education was one of our easier choices. Adult basic education is a necessary complement to our commitment to day care, K-12 education and higher education."

"Pleased to have done my part in providing Charlestown with these education resources, this action will serve to arm Charlestown's residents with the necessary tools to improve their quality of life as well as that of their families," stated Voke, who as Majo-

rity Leader of the House, helps set legislative priorities for the Legislature.

In fiscal year 1996,

there will be more services for illiterate adults learning to read, write and compute. The increase will also provide more opportunities for refugees and immigrants to speak, read, write and obtain citizenship. For these individuals, as well as for other adults working toward high school diplomas, basic education is the key to opening the doors to employment and training programs, jobs and higher education.

If you drive to the location, all of the vehicle expenses to and from the location may be deductible. (If you fly, generally only your ticket is deductible.) With proper planning, you should be able to deduct most of the costs of lodging in transit and at the convention, as well as 50% of meals for yourself.

EFL Notebook

Charlestown started off the weekend last Friday by dispatching Medway 6-0, to pick up its first win of the season.

The defense stood out in the Townies victory, especially the defensive backfield tandem of Rob Priestap and Rob Ferraro. However, Ferraro broke his wrist against the Tigers and Priestap entered the game with a groin injury, therefore wreaking havoc on Charlestown's already depleted

"That hurts," Townies co-head coach Jack Green said amid the post-game celebration after his team's first victory, the first in the history of the rejuvenated Townie franchise and the team's first road victory since the 1992 season.

"The important thing was that we won the game," Green added. "This was a must-win game for us. We just want to keep the momentum rolling and knock off Merrimack." Charlestown lost its previous encounter with the Outlaws, 26-0 at Haverhill Stadium, where both teams will meet again tomorrow night, Aug. 4, at 8 p.m.

Charlestown, 1-3, scored its only touchdown of the tilt nearly midway through the second period, when wide receiver Orlando Soto hauled in an Eddie Sullivan toss from six yards out to punch in the winning score. The touchdown broke an 11-quarter Charlestown scoreless skid.

The star of the game, though, was Ferraro. The veteran defensive back snared two interceptions and returned one 101 yards before it was called back due to a clipping penalty. It was on that play where Ferraro suffered the injury. After falling in the end zone due to exhaustion, Ferraro landed on his right wrist. He was diagnosed on the field with a broken wrist, an injury, depending on its severity, can take four to 10 weeks to heal.

"We don't know how long Rob Ferraro will be gone, but probably for a good part of the remainder of the season," Green added. "Priestap is day to day with his groin injury."

The Town Team's defensive line also stepped up to the occasion, as Tony Natola and Marty Kane each grabbed a fumble. "Those were two key fumble recoveries that both came at opportune times," Green said.

Charlestown defensive back Rob Ferraro was named the EFL's Defensive Player of the Week for his performance Friday against Medway. Others receiving honorable mention for offensive and defensive recognition were Ed Sullivan, Orlando Soto, Marty Kane and Tony Natola.
