**ROCKY MOUNTAIN VICTIM LAW CENTER TAKES CASE OF RACIST, ANTI-SEMITIC HOMOPHOBIC WOMAN**

**Denver, Co. January, 28, 2019** - The Rocky Mountain Victim Law Center, a 501(c)(3) organization that prides itself on providing free legal representation and services for “victims of violent crimes” has taken the case of a racist, anti-semitic, homophobic woman whose social media postings suggest murder and death of various minorities.

The legal battle began when Joseph A. Camp initiated and sought damages for defamation of character after Camp claimed that Tristyn M. Weber falsely accused him of strangulation. Weber has since admitted she lied and recanted those allegations hours after Camp’s August 2016 arrest by Wheat Ridge Detective Mark Slavsky. Camp has attached copies of reports and made available audio created by law enforcement, prosecutors and attorneys for Camp on numerous occasions in which Weber admits to her lies. Camp was ultimately convicted of Attempted Influence of a Public Servant after he threatened suit against the Wheat Ridge Police Department. His criminal appeals are ongoing.

Currently the defamation case is pending review by the Colorado Court of Appeals and has seen a surprise appearance of Katherine Houston, the Legal Director of the Rocky Mountain Victim Law Center, on behalf of Weber. It is unknown if Houston was aware of the racist, anti-semitic, homophobic death threats made by Weber on several of Weber’s Facebook profiles when she agreed to represent Weber *pro bono*. Calls to Houston’s office have gone unreturned.

For his part Camp is upset about the hypocrisy of the representation stating “*here is a woman spewing the most vial, disgusting death wishes against minorities, who has admitted in multiple recorded conversations to police, prosecutors and my own defense team of lying, now being represented by an organization that gets partial funding from the State to defend real victims of people like Ms. Weber. Why? Because she is a female?. Meanwhile real victims of violent crimes are being denied representation by this organization and the State because of the expenses this litigation will drain from Ms. Houston’s organization.*”

Camp, who has largely represented himself, has filed nearly 20,000 pages of pleadings in over 35 state and federal civil cases with various degrees of success, including a

successful reversal and remand of a first impression litigation in which he sought, as a private citizen, a court order demanding assignment of a special prosecutor or First Judicial District Attorney Peter Weir to prosecute Weber, her mother, and Wheat Ridge Police Department's Detective Mark Slavsky for False Reports, and Attempted Influence of a Public Servant. This case is on-going as the trial court has refused to reopen in violation of the mandate from the Court of Appeals.
