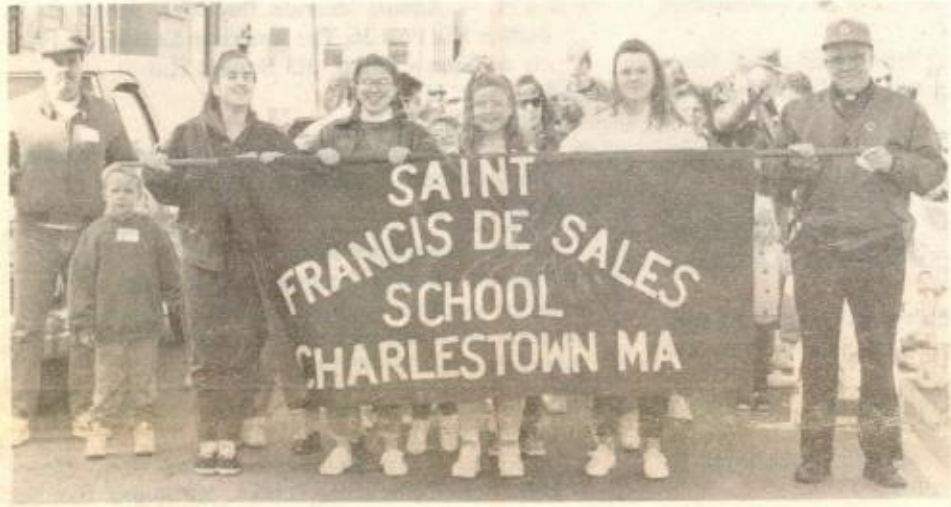

### Neighborhood Council Election Results Being Challenged

The Charlestown Neighborhood Council Election for precinct representation on the council, held on Oct. 26, is being challenged by the incumbent council member from Precinct 3, Bob Wallace. The race for the seat between Wallace

and former council member Bill Galvin was so close, it took a closed-door session of the Council Election Committee to decide the winner.  
After the ballots were tallied, Wallace and Galvin each reached 77 votes, with four additional votes under

dispute. Two of those votes were thrown out, one a blank vote and the other had marks beside both candidates' names.  
The two crucial votes that ultimately decided the election were ballots that also had both names checked

### Neighborhood Scores Victory — Dangerous Building Coming Down

Oct. 25, when Mayor Raymond L. Flynn announced to them that the building would be demolished. After many months of pleading

with the city to either develop or demolish the structure, the news of its removal was taken as a victory for

themselves and the entire community.

Mayor Flynn told those gathered outside the building, located between Lexington and Ferrin streets, that he was personally committed to the safety of the community. He said that in order to ensure that safety, it was necessary to tear down the structure and decide at a later date what would take its place.

The Mayor thanked the residents of the neighborhood and members of the Charlestown Neighborhood Council for their diligence in seeking a solution to the safety concerns. He especially commended CNC Chairman Dennis McLaughlin and council members Jim Conway, Mel Stillman, Peter Looney, Bob Wallace and Development Committee Chairman Tom Cunha for their efforts and continued insistence that the city come to a decision to demolish the building.

Pat McGuigan, director of housing and neighbor-

hood development for the Public Facilities Department, stated that the building would be torn down before the holidays. Discussions on the future development of the property, he said, should continue through public neighborhood meetings.

Boston City Councillor Robert Travaglini stated: "Some things take longer than they should. The constant efforts of the neighborhood residents to draw attention to a vacant, deteriorating, unsafe city building finally paid off.

"The Mayor and Public Facilities Department," he continued, "are committed to removing that building before the first of the year — that's the first phase. The second phase will be the development of a building. Whatever decisions are made by city bureaucrats, I guarantee they will reflect the suggestions of the community."

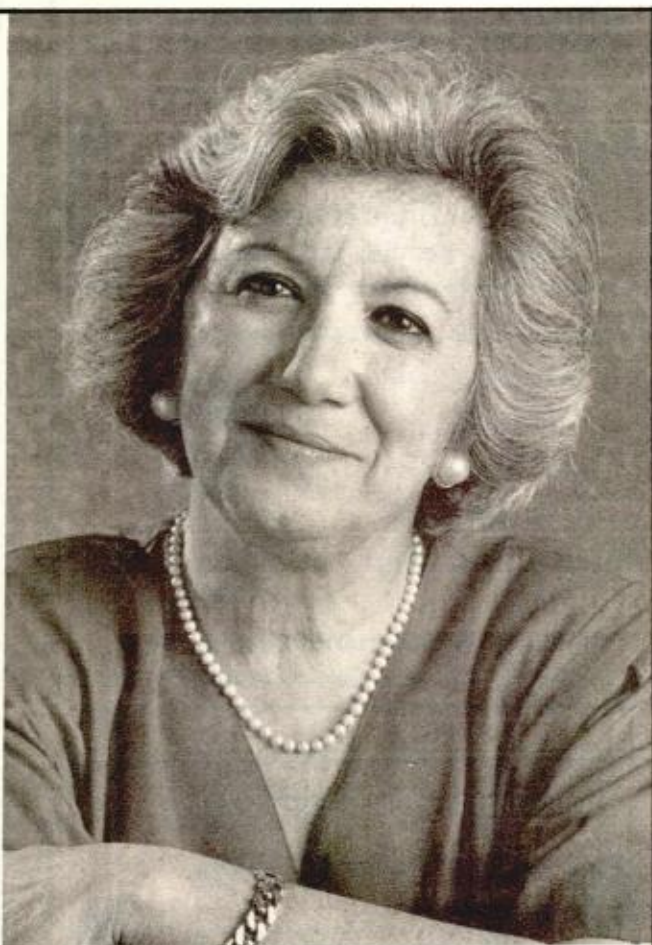

### Not For Nothin' ... But Have You Heard ...



• **Today Is ... Halloween!** ... Do you know the true meaning for the holiday? Halloween is another name for All Hallows' Eve and is the eve of All Saints Day. The trick-or-treat habit can be traced to ancient times when such pranks were performed — in deadly earnest — by adults. With roots in 5th century BC Ireland, it was celebrated as Samhain, or summer's end. Ancient Celts doused the fires on their hearths to make their homes cold and undesirable to disembodied spirits, believing that this was a time of year when those who had died during the previous year selected bodies of persons or animals they would inhabit during the coming 12 months. She was also called a witch because she was an independent and outspoken woman ... Some customs die hard!

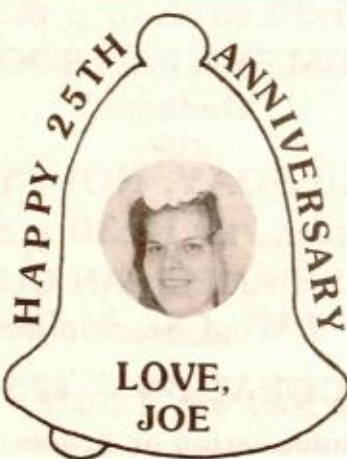

The meeting will be co-sponsored by the Charlestown Neighborhood Council Basic Services Committee and the office of City Councillor Robert Travaglini. Representatives from the Charlestown Youth Hockey Association, the Metropolitan District Commission, the Boston Redevelopment Authority and the Boston Transportation Department have been invited to address this parking issue.

All concerned residents are urged to attend.

★ **CANA Update** — Judy Evers, community liaison from the Mayor's Office of Neighborhood Services, met Elaine McCarthy and Ken Stone of the North Area Task Force on Oct. 24 in City Square to take a first-hand look at the pedestrian crossings at the Central Artery/North Area (CANA) project. The group met at the intersection of Water and Gray streets where they were joined by Ed Barr, CANA coordinator, and Bill Rogers, resident engineer on the project.

Evers stated that she went to the CANA site after hearing numerous complaints from Charlestown residents on the difficulty they found in crossing through the traffic in City Square. While standing on Water Street, she said it became clear to her that there was a problem with vehicles not stopping for a red light at the designated pedestrian crossing.

She informed Barr that two young women were accosted on Water Street last year because of inadequate lighting in the area. Barr stated that the street lights are on a photo synthesizer which turns them on as daylight goes down. He said that he would tour the area and make sure that all lights are in working order to ensure the safety of people walking through City Square.

Upon her return to City Hall, Evers spoke to Boston Transportation Department Commissioner Richard Dimino about her observations. Dimino reported to her that after a recent discussion he had with Massachusetts Department of Public Works Commissioner James Kerasiotes, a commitment was made to return the detail police officer to Gray and Water streets. "This is a result," he said, "of city, state and neighborhoods working together to ensure the safety of all Charlestown

residents."

Dimino concluded: "I feel progress has been made in addressing the concerns of the neighborhood."

Evers said: "I'm completely satisfied with the timely manner in which the decision was made to restore the detail. It's very important to the community."

Stephen Collins, community liaison with the Central Artery/Tunnel projects, stated that he and Barr hope to continue discussions on the CANA project, including neighborhood concerns, with members of the Public Safety Committee of the Charlestown Neighborhood Council. He invited members of that committee to tour the construction site during rush-hour traffic to witness for themselves the conditions pedestrians and traffic are facing during those times of day.

City Councillor Robert Travaglini, chairman of the Council's Commerce and Transportation Committee, who has been monitoring the project, stated: "I am pleased that the CANA project has responded to the community's concerns regarding pedestrian safety. I am confident now that the lines of communication have reopened, they will remain open."

Collins stated that residents with concerns about the CANA project should call him at 951-6005. Evers stated that her number is 725-3485 if residents needed to contact her on this or any other city matter.



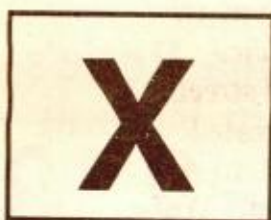

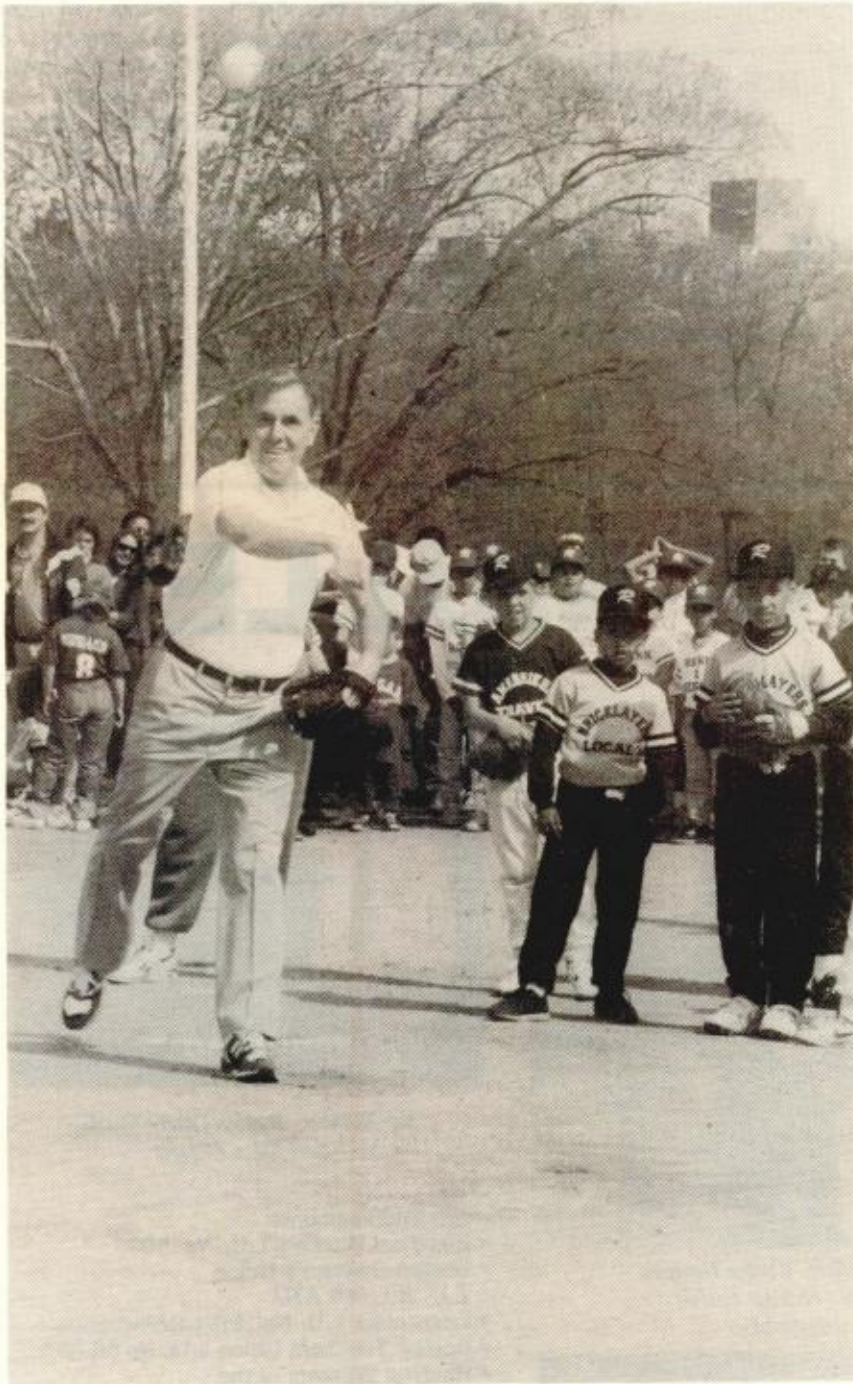

off, but in each case the voter crossed through the vote for Wallace, with one voter placing his signature on the ballot.

Election Committee Chairperson Kate McDonough ruled that Galvin had won the election by the two disputed votes after the closed-door meeting where council members voted to agree with the decision of Ethel Blackwood, an election observer from the League of Women Voters.

Regarding the challenge, McDonough stated: "Mr. Wallace has told me that he has decided to lodge a formal protest of the Charlestown Neighborhood Council Election. This letter will become part of the report of the Election Committee to the Neighborhood Council at the Nov. 14 meeting. At that time the full Council will have the opportunity to review the details."

Council members who participated in the ruling were McDonough, Dennis McLaughlin, Jim Mansfield, Peter Looney, Kay Whelan, Mel Stillman and Kevin Roche.

Wallace is basing his official challenge to the election results not only on the two disputed votes, but also on a vote cast by a man who, he said, drove up to the polling place in a car bearing a New York license plate, produced a New York driver's license as identification and a New England Telephone Co. bill displaying a Charlestown address. Wallace stated: "How do we know whether that was his bill or his father's who he could be living with. I challenged that vote at the time it was cast, but nothing was done about it."

Wallace's challenge also includes his opinion that inadequate facilities were provided the voter at the

election, giving no privacy for ballot decisions. He also stated that candidates were allowed easy access to the voting place, leaving open a question of impropriety.

He stated that he contacted the Attorney General's Office and the League of Women Voters for advice on his rights to challenge the election. After these discussions, he stated: "In the absence of any regulation in the Council By-Laws to cover these contingencies, I feel the Neighborhood Council should declare the election null and void and a new election be held."

The decision is now up to the Neighborhood Council. Whether they will allow the challenge to go forward or to vote in favor of the Election Committee's decision on Galvin's victory remains a question until the November monthly meeting on Thursday, Nov. 14.

## 'Townie Santa' Begins 10th Year

year, Townie Santa, through donations and an evergrowing group of volunteers, provides over 100 elderly shut-ins with a hot turkey dinner and boxes of gifts.

Townie Santa was born from a conversation between four Charlestown residents in November 1982, centering around the idea that something should be done for the shut-ins. In less than one month's time, this group expanded, money was raised, meals cooked and 48 baskets were delivered.

The four probably never

anticipated that their discussion would be so contagious. Townie Santa has a unique way of drawing residents together who may not otherwise share similar interests. One reason for the attraction, states a committee member, is the simple fact, Townie Santa is a good cause. Another reason may be that inbred Charlestown responsibility of taking care of one's own. Or, more importantly, it may be that joy one receives from giving — something too personal for words. Whatever the reason, each year the group of volunteers grows.

Each year, Townie Santa expands with new faces from all parts of Charlestown. Some of them deliver the baskets, others pack them and others do the work behind the scenes. Last year, there were volunteers from as young as 6 to over 75 years of age. Almost 400 people donated either time, money, gifts or services in 1990 whereas the first year, there were about 20 or 30 volunteers.

Beginning each fall, letters are sent to merchants, businesses and organizations within and affecting Charlestown, seeking con-

tributions to the Townie Santa fund. Canisters are also placed throughout the town for coin and bill donations. Articles begin to appear in **The Charlestown Patriot** inviting residents to come to organizational meetings, or to submit the names of those they feel are in need of a visit from Townie Santa, or to send in monetary donations. All donations are publicly acknowledged in the **Patriot**, however, as many as 10 percent of those who donate wish to remain anonymous, donating just for the sake of Christmas.

In 1982, the Townie Santa fund was approximately \$1,000. In 1990, this figure rose to more than \$10,000. However, this does not truly reflect the total in donations received, since no value is placed on the gift donations. All the money received, with the exception of postage costs, goes directly to the packages.

"People wonder how much stuff we give out in these boxes," related a committee member. "Well, just ask anyone who had to deliver one of them to a person living on a third floor, and they'll tell you how heavy these boxes are."

Those who are considered eligible are persons over 60 years of age who are shut-in with limited finances and family contact.

The selection of the names of recipients for a Christmas package is not an enviable or easy task. There is a screening committee who researches the names that are submitted and determines who will receive a basket. And despite the screening committee doing an excellent job, there is always someone else who

also deserves a basket.

"You never get everyone," said a committee member, "You often hear later that we missed someone, but that's through no fault of the screening committee. This is why we ask the cooperation of agencies and residents in submitting names — and we are asking that the names be submitted by Monday, Nov. 18 to allow us an opportunity to finalize the list of recipients before it gets too close to the day of delivery."

An important fact to remember is that the idea behind Townie Santa is to bring some Christmas cheer to the elderly shut-in. A committee member concluded, "These boxes do more than supply a person some much needed household and personal items — they tell the shut-in that we, the community, haven't forgotten them."

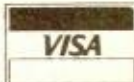

The Can Share drive is expanding its outreach this year by adding drop-off sites at all Boston polling places on election day, Tuesday, Nov. 5.

"We have been working with the Boston Election Department to provide drop-off sites at all 252 polling places in Boston, including the seven precincts in Charlestown, and

we want to let people know that when they vote they can share," said Can Share Coordinator Helen Lynch.

According to Lynch, the food that is donated in Charlestown on election day will be picked up by the Charlestown Food Pantry and distributed to Charlestown residents.

Lynch also stated that food will be collected at the Charlestown Post Office at One Thompson Square through Nov. 15.

The Boston Can Share Food drive was initiated in 1985 by Mayor Flynn's Advisory Commission on Hunger to help meet the demand for emergency food assistance during the holiday season. The first annual Can Share drive collected nearly 20,000 cans — last year's drive collected more than 280,000 cans.

Suggested items for contribution include infant formula, evaporated milk,

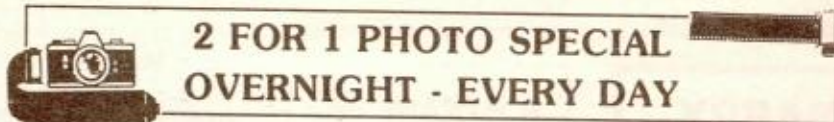
meals in a can — such as ravioli, beef stew or soups, peanut butter, whole grain cereals or canned tuna.
