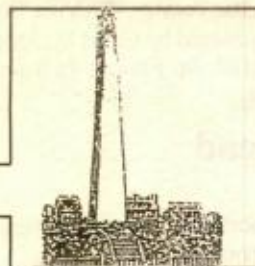

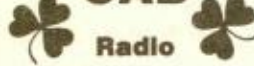

Charlestown Neighborhood Council Begins New Year Of Meetings

The September meeting of the Charlestown Neighborhood Council brought a full complement of council members back from a month-long hiatus. It also brought a full lineup of issues in need of review by the council's subcommittees.

Council members in attendance were: Chairman Dennis McLaughlin, Vice-Chairman Bill Galvin, Secretary Stephen Collins, Tom Cunha, Mel Stillman, Ken Stone, Francis 'Bud' Coleman, Kay Whelan, Jim Conway, Bob Scalli, Jim Mansfield, Ellen D'Ambrosio, Peter Looney, Kate McDonough, Dan Kovacevic, Ed Callahan, Nancy Keyes, Bob Wallace, Moe Gillen, Kevin Roche and Ed O'Connell.

Seven council members elected in an at-large race in 1988 are now up for re-election. This election will be held on Saturday, Oct. 13. The location and time for the election have yet to be determined. The availability of nomination papers and more detailed information will be announced in the next edition of the *Patriot*. Any resident of Charlestown 18 years of age or older is eligible to run for an at-large seat. Council members who presently hold these seven at-large seats are: Stephen Collins, Moe Gillen, Peter Looney, Dennis McLaughlin, Kevin Roche, Mel Stillman and Kay Whelan.

The council meeting opened with a presentation by the MBTA on the Authority's proposal to construct a parking garage in Sullivan Square to accommodate the ever-increasing need for commuter parking spaces. Howard Haywood, MBTA assistant director of construction, informed the council that the garage concept was only in a preliminary study stage.

Haywood stated that Louis Berger Associates have been hired to conduct feasibility studies on three possible Sullivan Square sites. The three sites being considered are existing lots at Cambridge and Spice streets; at the present Sullivan Square 'T' station; and on 'T'-owned land on Alford Street between West and Main streets.

Haywood requested the

council's input and advice in proceeding with the garage proposal. The matter was referred to Housing and Development Committee Chairman Cunha who will schedule a public meeting with abutters, businesses and 'T' personnel at a convenient location within the Sullivan Square area. No date had been set for this meeting at press time, but will be announced in an upcoming edition of the *Patriot*.

Haul Road Committee Co-Chairmen Moe Gillen and Bob Wallace

Gillen presented a petition to the council signed by 80 residents of Short and Baldwin streets stating their opposition to any increase of traffic, especially truck traffic, on their streets due to the construction of the haul road.

He also read a memorandum from Boston Redevelopment Authority Senior Project Director Don Klabin that outlined the progress of the proposal. That progress report told of an extension to the contract with Bruce Campbell & As-

sociates for transportation planning and engineering services; the BRA's commitment to a complete traffic bypass of Medford Street; the BRA's response to concerns raised at public hearings; and the continued readiness of the BRA to discuss additional plans with the committee, abutters and businesses. The committee had not scheduled any meetings at press time, but the *Patriot* will announce that information as it becomes available.

Development Committee Chairman Tom Cunha

Cunha stated that he had "a full plate" of development issues before him that require attention and public hearings. These parcels include The Raymond Group proposal for Parcels 4 and 7 in the Charlestown Navy Yard, Main Street and Lawnwood Place and the former Nancy Sales building on Terminal Street. He stated that meetings will be scheduled to discuss each issue individually. Those meeting dates will be announced in the *Patriot*.

Cunha also addressed the

committee's concern with the process taken by the BRA in granting final designation to the developers of Building 104 in the Charlestown Navy Yard for affordable housing units. Cunha stated that no community meetings were held to discuss the proposal before designation was granted, a process usually taken between the BRA and the Neighborhood Council. The council voted approval to send a letter to the BRA Board of Directors explaining their disapproval of the process taken by the Authority on the designation of Building 104.

Community Awards Committee

Chairman Tom Cunha

Cunha announced that the committee held its first meeting on Sept. 4 and March 30, 1991 was set as the date for the first annual award's night. He invited all council members and community residents to participate on this committee and informed them that the next meeting will be held on Sept. 20 at 7:30 p.m. at the K. of C. lower hall.

Mitigation Committee Chairman Bill Galvin

Galvin reported that the committee held a meeting on July 30 and heard discussions on the Master Plan for the Charlestown Marine Park that would include pre-approval for non-maritime industrial use of the upper floors of the Amstar

building.

He stated that the use of the former Revere Sugar refinery on Medford Street as a personnel transfer site by Massachusetts Water Resources Authority as part of the Boston Harbor Cleanup Project was still under discussion between Massport,

the owner of the site, and MWRA, a Massport leasee. Galvin said: "MWRA said they would not move forward until Massport agrees. Massport said they would not allow a personnel transfer site until the community agrees."

Galvin stated that no meetings on these issues have been scheduled at this time.

Other Business

Washington Street resident Tom King came before the council to request its intervention on the Massachusetts Department of

Public Works Scheme Z plan as part of the Central Artery/Third Harbor Tunnel Project. King stated that all residents of Charlestown should be concerned with the proposed elevated roadway that, he stated, "would make the old 'El' look like a child's toy and the Tobin Bridge look like a covered bridge."

King explained that the ramp elevation of Scheme Z is equivalent to an 11-story building, "the highest density highway in the world," he stated. He requested that

the council get involved in mitigation discussions with MDPW and give a forum for the community to vent their displeasure with the proposed ramp system.

McLaughlin appointed Coleman as chairman of this committee to oversee the MDPW Scheme Z plan. No meeting date had been set at press time.

The next Neighborhood Council meeting will be held on Tuesday, Oct. 2. It is an almost guarantee that development issues will dominate that meeting.

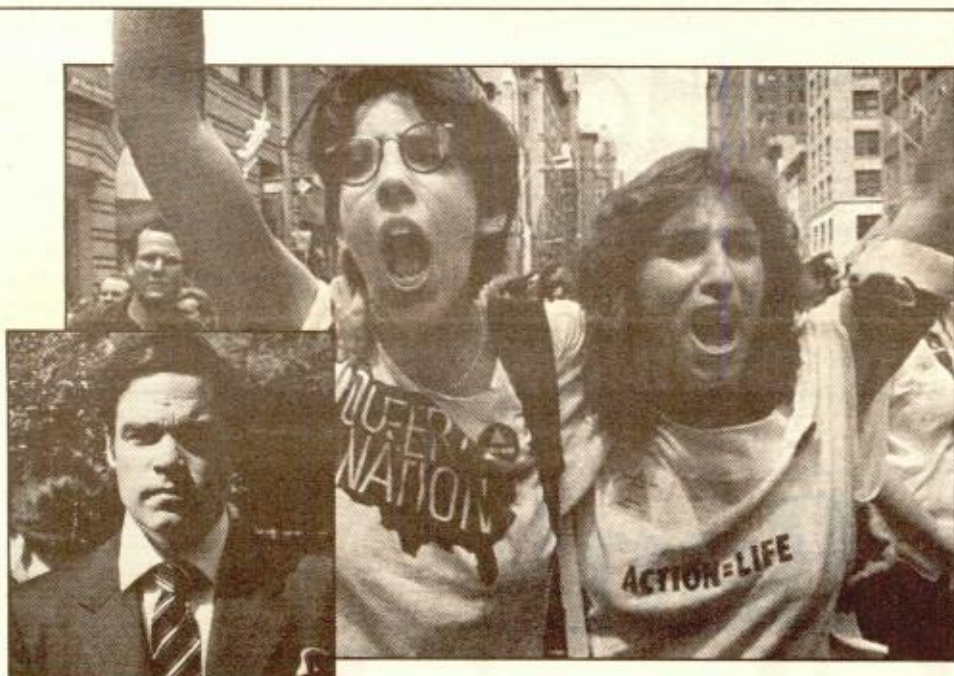

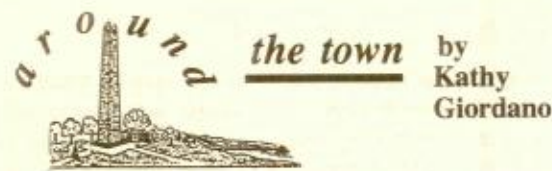

★ **Primary Election** — Charlestown's political analyst Jim Walsh has delivered his prognostications for the Tuesday, Sept. 18 Primary Election. Jim's record has been outstanding. Let's see how he does next week. His predictions are as follows:

- The overall turnout of voters for both the democratic and republican primaries will be moderate, at best. Expect a combined turnout of 33 percent (plus or minus two points).

- Speaker of the House George Keverian will win the primary race for state treasurer with a 10-point spread over runner-up Rep. Bill Galvin. State Sen. Richard Kraus will finish a distant third.

Republican Predictions

- Former U.S. Attorney Bill Weld will defeat House Minority Leader Steve Pierce as the party's nominee for governor.
- Sen. Paul Celluci will defeat state Rep. Peter Torkildsen in the lieutenant governor slot.

Charlestown Predictions

- In Charlestown, the results will differ just a bit from the statewide results. Look for John Silber to top Frank Bellotti by an 800-plus vote margin. Clapprood will win in Charlestown, but Jim Shannon will top Harshbarger and Rep. Bill Galvin will top Keverian and Kraus.
- In the race to succeed state Sen. Fran Doris, Tom Birmingham will defeat Mark Strahan in Charlestown and will win the election by 20 percentage points or better.

★ **Massachusetts Water Resources Authority** — inaugurated a \$261 million, 10-year water and ground transportation system on Aug. 29 that will move thousands of construction workers, dozens of trucks and tons of equipment as part of the Boston Harbor cleanup project. Barges, tugboats, ferries and buses will be utilized to transport equipment, vehicles and workers to the primary construction site at Deer Island, Winthrop.

In a press release announcing the transportation system, MWRA outlined their plans to use the former Revere Sugar Corp. refinery site on Medford Street "as a third terminal for transportation of workers to Deer Island by ferry beginning in 1991."

Discussions at Neighborhood Council Mitigation Committee meetings have clearly defined the neighborhood's objections to the use of the former sugar refinery, now owned by Massport, as a personnel transfer site. Massport has leased a portion of the land to MWRA, but lease restrictions on the use of the land are still in the negotiation stages between the two authorities.

★ **Tobin Bridge Update** — Massport Community Liaison Dorothy Connolly informs us that work being done on the Tobin Bridge is proceeding on schedule and is expected to be completed on Sept. 28. Jersey barriers will be removed during the weekend of Sept. 28 and 29, Connolly stated, and there will be temporary lane closures during that time while work is performed.

Connolly stated that painting the Charlestown side of the Tobin Bridge is tentatively set for the Spring of 1991.

Voke Says CANA Interviews Underway

Based upon continuing discussions with Massachusetts Department of Public Works Commissioner Jane Garvey, Rep. Richard Voke says he expects the CANA Liaison position to be filled by months' end. Voke says that a timely decision and other related matters were talked about during his most recent contact with the MDPW.

"In addition to stressing the need for action on this important appointment, I also reaffirmed my belief that the person hired should be selected on merit, and not any other factors. The

people of Charlestown deserve a liaison chosen on the basis of what he or she knows, not who he or she knows. I am very committed to this principal," stressed Voke.

According to Voke, powerful Chairman of the House Committee on Ways and Means, a number of "quality" candidates have expressed interest in the vacancy. "I have had the opportunity to share my views on this position with a number of candidates. The MDPW was impressed with those receiving interviews last week, and expect to be

making call-backs on those who received the highest grades. While it will be tough to replace David Flanagan, I am confident that the professional search be-

ing conducted by the MDPW will produce a new liaison all of Charlestown can rely upon," concluded Voke.

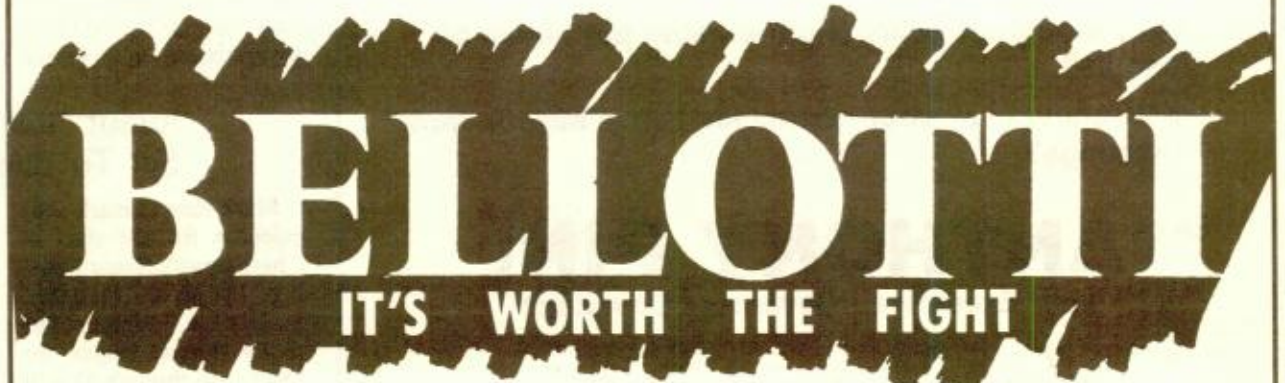

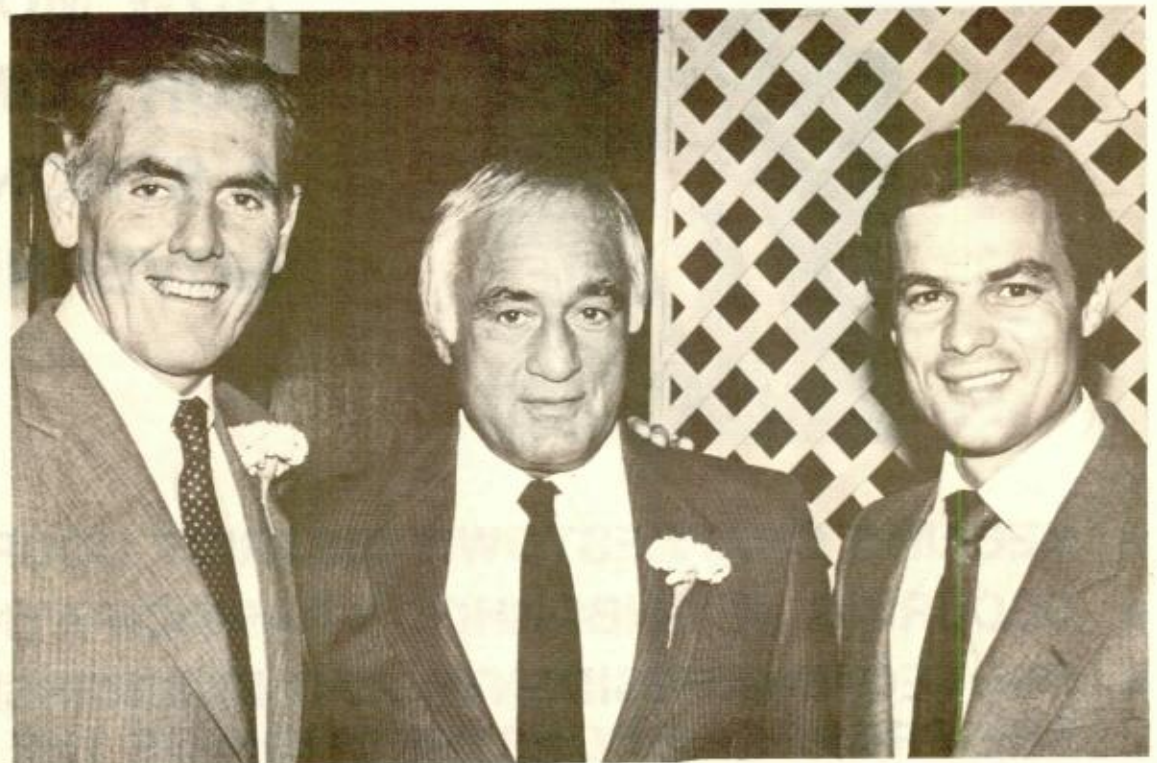

Surplus Food Distribution In Charlestown Sept. 19

Action for Boston Community Development and the Kennedy Center announce that registration for surplus food is now underway. The federally funded program will distribute free food to income-eligible Charlestown residents on Wednesday, Sept. 19 from 11 a.m. to 3 p.m. at St. Catherine's School Hall on Tufts Street. Butter, peanut butter, flour and honey will be distributed.

All surplus food must be

distributed the same day it reaches its distribution facility. Leftover food will be sent to local food pantries, shelters and soup kitchens.

If you have a current surplus food registration card, bring it with you.

If you have not received a current registration card, but receive benefits from any of the following programs, you are eligible to receive an ABCD surplus

food registration card which will entitle you to receive free surplus food. The eligible programs include: Veteran's Benefits; Fuel Assistance; Food Stamps; Welfare; Women, Infants and Children (WIC); Headstart; AFDC; or Medicaid (not Medicare). If you don't receive any of these benefits, call the Surplus Food Hotline at 357-6000, ext. 238 to find out if you are eligible to receive surplus food.

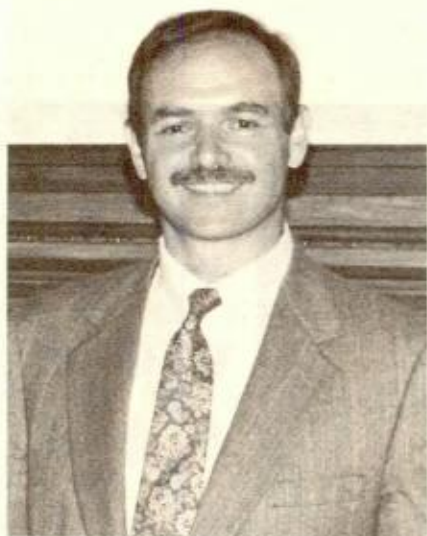

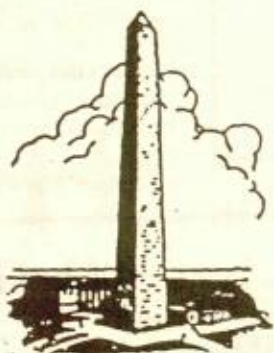

is time that we had people who were not members of the bar put in a position where they could have a positive influence upon what was happening in our court system."
Hurley stated that most of the states in the United States have provisions for elected judges and while he would not want to provide that system in Massachusetts now, at least in the interest of democracy the existing system should be opened up to members of the general public.
Hurley went on to say that the logical method of accomplishing this would be to provide for a mandatory training period for all judges, the non-lawyer judges as well as the lawyer judges. The non-lawyer judges would then have the opportunity of being provided with a rudimentary background necessary for them to administer, not only common sense, but justice.
