## A Journey Toward Destiny

On Friday, Aug. 28, a young man from Charlestown will embark on a journey that will change his life for eternity. In answer to an inner call, he will venture onto a path that was charted nearly 2,000 years ago. Delayed by uncertainty, and at times denial, he now knows that the course before him leads toward his life's destination.

This outgoing, athletic and energetic man will take the short drive from his home on Tibbetts Town Way to Lake Street in Brighton. Warmed by the embrace of family and friends who join in the jubilation and admiration of his decision, he will walk through the doors of St. John's Seminary and begin a life of service to God and mankind.

Matthew "Matt" Stillman, a 26-year-old Boston Water and Sewer Commission employee, concedes that entering the priesthood was the furthest thought from his mind when the principal at St. Benedict's Grammar School approached him as a sixth grade student and simply asked him the question. "Of course not," was his immediate response, but within two

weeks he found himself sitting before Sister Stephen Marie's desk talking about becoming a priest. "Ever since that day, the idea never left my mind," Matt said.

During his sophomore year at St. Clement's High School, he spent an awareness weekend at St. John's Seminary, but still put the thought in the back of his mind "to rethink about it."

Matt says, "The idea was always there," and in 1988 he found himself drawn to the spirituality of the Franciscans and went to the

order to talk about their life. "There again," Matt admits, "the thought left," and he continued on his daily routine.

Again that inner voice beckoned him and he returned to St. John's Seminary for a visit, but once more he took time to "rethink and wait."

Last April, Matt decided to talk to his pastor, Father Ron Coyne at St. Catherine's Church who told him it was time to act on it. With that encouragement, he began the required process by

### ★ Charlestown Street Reconstruction Update . . .

Judy Evers, community liaison from the Mayor's Office of Neighborhood Services, stated that city and BRA officials toured the street reconstruction area on Aug. 25

with a priority list of unfinished work by John Mahoney Construction Co. She related that most of the residential concerns have been addressed and the remaining problems will be checked on. According to Evers, a decision has been made to allow the contractor to go forward. Permits will be issued to open Lexington, Seminary and Lawrence streets with the provision that the streets be closed as work is completed and community concerns be addressed.

Ralph Cunningham, resident engineer with Bryant Associates, states that work will begin on these streets this week. Leaflets are being distributed and signs will be posted for no parking. The water main crew should be

starting on Seminary Street on Aug. 27 and drainage work should begin on Lexington Street.

Cunningham reports that the contractor has been adjusting all the manhole frames and covers to grade in the streets already done with the base and binder pavement. The contractor also paved the sidewalk on Concord Street. In addition, the contractor will continue work on Lyndeboro, Middlesex, Putnam and Ellwood streets and Monument Court to get them to the point of base and binder paving and sidewalk installation. The contractor plans to work closer behind the paving and sidewalk crews to close up and back up the new side-

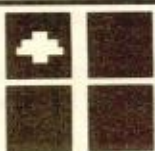

## Charlestown Youth To Set Sail On 'Spirit Of Massachusetts'

New England Historic Seaport, Inc., located in the Charlestown Navy Yard, is pleased to announce that during its annual five-day whale watch program, there will be six Charlestown young people participating as volunteers, assisting the crew of the 125-foot schooner **Spirit of Massachusetts** for the entire five-day period. They will be helping the crew sail this exciting tall ship that took part in the Christopher Columbus celebrations in the cities of San Juan, Puerto Rico, New York and Boston.

This adventure will take the **Spirit** to the Stellwagen Bank between Gloucester and Provincetown in New England. Stellwagen is the feeding ground for the whales during the summer months. Participation of the Charlestown young people is part of the Seaport's educational programs for youth carried on aboard the **Spirit of Massachusetts** in New England, the Eastern Seaboard of the United States and in the Caribbean. The program is designed to fit young people to become productive citizens and to teach them self-discipline and cooperation. Each year the **Spirit of Massachusetts** carries on over 3,500 hours of educational programs for youth between the ages of 15 and 25 from

The **Spirit of Massachusetts** will leave Pier No. 3 in the Charlestown Navy Yard on Sunday, Aug. 30 and return on Sept. 3.

The **Spirit of Massachusetts** carries out educational programs 12 months of the year. Some are for college credit while others are for their value in maturing our young people.



## Hurley Files Legislation Limiting Judges' Terms To Six Years

Governor's Councilor Daniel G. Hurley announced that he is filing legislation for consideration by the state legislature that would

limit most judges to a six-year term.

The Hurley proposal would not affect any currently sitting judges, but

would only apply to future judiciary appointments.

Hurley stated: "The courts are becoming the dominant branch of government in many areas of life and are causing dissatisfaction with the present workings of the Democratic theory of government."

Hurley also stated that "the public finds judges are the least accountable to the public of any branch of government because they are appointed for such lengthy terms."

During the past few weeks we have heard of

"burnt out judges," early retirement plans for some who according to a **Boston Herald** editorial, will be "collecting that \$60,270 pension toward which they never contributed a nickel. Restructuring Massachusetts courts so that all judges in our state serve for a fixed term of six years would have many positive effects.

"The rotation of judges would allow more people to become involved in the process of public service through judicial service, and in a democracy this

opening of our courts to more public involvement can only lead to improvement," said Hurley.

The Hurley proposal would also allow the governor to waive the single six-year term for a judge by appointing a judge to one other six-year term on a court of wider or superior jurisdiction, and also includes that no Chief Justice could be named until he or she had served in that particular court for at least three years. This would limit a Chief Justice's term to three years in any Massa-

chusetts court. Hurley stated that judges who are "burnt out" should resign. He also said that his legislation would limit the terms of judges thus ensuring more active judiciary members.

Hurley is a past Democratic City Committee Chairman and a member of the Democratic State Committee and the Democratic Leadership Committee. He is also a past Greater Boston Executive Director of the St. Jude Children's Research Hospital.

(continued from page one) returning, once again, to St. John's

He had made his decision, but ironically had to wait for word from the seminary as to whether he would be accepted. "Every step made me more excited," he said, "but not nervous."

Decision date would arrive on July 21. He went to work as usual that day, he recalls, but the day would turn out to be anything but usual. The wait was made easier through the support and encouragement of his co-workers. Finally, the telephone call came and the voice at the other end told Matt: "I'm making you a proposition that will change

the rest of your life." He remembers hanging up the phone and jumping for joy. "It's been like a high ever since," he said.

Matt's parents, Mel and Maureen, were the first to be informed. His father greeted him with open arms, saying: "My son, the father!" Both were filled with pride, he remembers, with tears rippling across their cheeks.

The response from the community has been full of congratulations and good wishes. Matt said: "It feels good to see the town behind me. Their support has motivated me."

He has found the same support at work, church and at the Pop Warner football practices, the league he

## C.Y.O. & St. Catherine NEWS

• **Confirmation II** — The three parishes of Charlestown — St. Mary, St. Francis de Sales and St. Catherine of Siena — are beginning a joint Confirmation program for Catholic youth from both public and parochial schools wishing to be confirmed in their faith. The program will be a two-year course designed to prepare the students to receive the Sacrament of Confirmation.

### Voke Wants To Stop Charging Seniors For Medical Records

State Rep. Richard Voke announced his support for a proposed law that would stop health care providers from assessing the disabled and elderly a fee for copies of their medical records. The exemption would be granted when elders and disabled individuals apply for federal aid in helping defray the cost of medical expenses. The initiative, which passed the House of Representatives with the overwhelming support of Voke and his Democratic colleagues, was devised to require health care providers to waive the exorbitant fees charged individuals who seek copies of their files.

"Many of these folks, who are in the most dire need, currently cannot even afford to apply for benefits under the Social Security Act, because of costs such as medical record fees," commented Voke. "Our bill will empower the elderly and disabled to apply for federal assistance without the demand for fees for medical records," added

Voke.

Medical records are required by federal assistance programs as proof of disability. Access to these necessary files is a problem for many in need of aid; an increasing number of health care providers are charging costly fees for copies of medical records. The fees are as much as \$8 to \$10 per page, with files that contain a large amount of paper work.

"It is unconscionable," said Voke, "that our seniors and disabled citizens, many of whom are struggling just above the poverty line, are being forced to forgo applying for medical relief due to the high costs of obtaining official documentation recognizing their ailments."

Voke also pointed out the initiative would allow more people to apply for federal aid, thus freeing up badly needed state resources. "The bill saves money on the state end and allows disabled and senior citizens to receive essential medical services at the same time," concluded Voke.
