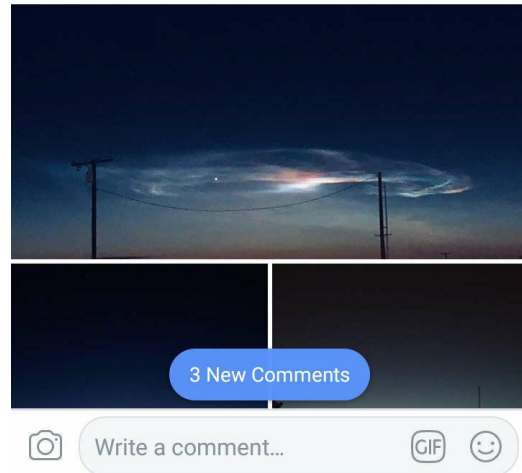

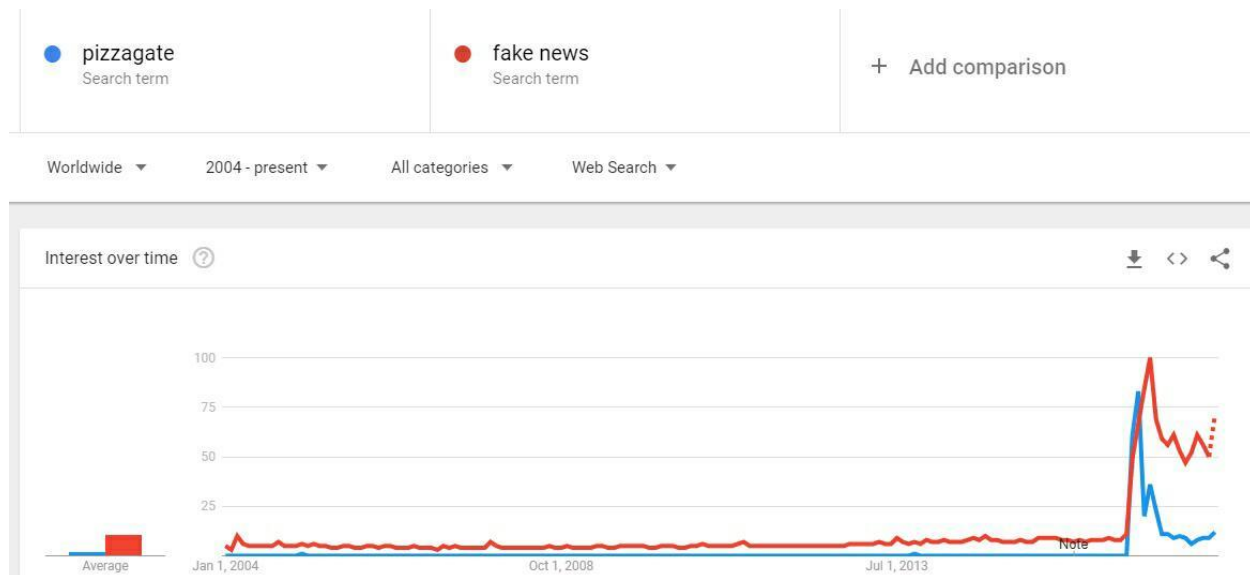

Hey all,

So a number of you have brought up some concerns about payment issues recently and I thought it would be a good idea to compile them here.

-Late payments

-Payments stopped after switching providers

-Payments coming in wrong currencies (a bit bizarre to me but okay)

Anyway, I wanted to clear up some policy things to make sure we're all on the same page.

1) You NEED to open an account with a bank based outside the US. Don't set up direct deposits at your credit union and be surprised when nothing is working.

2) Remember to keep some proof of posting. Usually most providers (the big three Soros, Koch, and Rothschild backed groups all obviously require this) will have some accounting mechanism to make sure you're not just claiming money for posts you didn't make.

Your reddit account isn't proof enough because of reddit algorithms monkeying with vote totals.

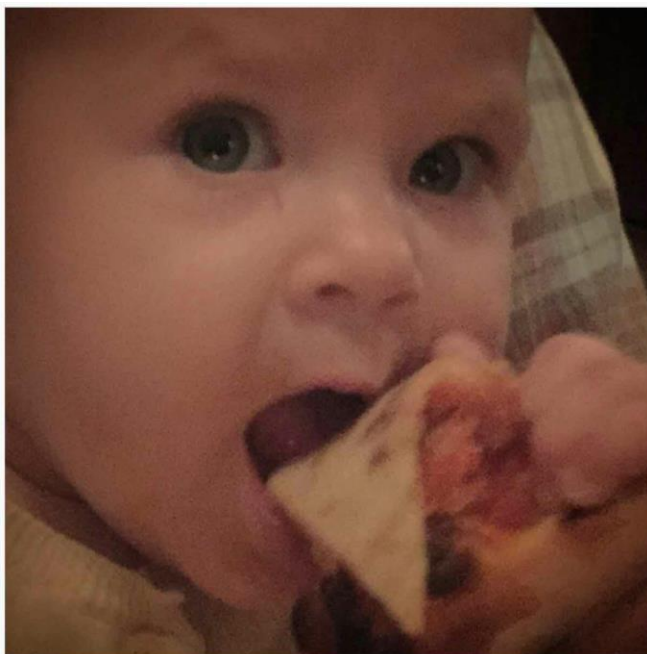

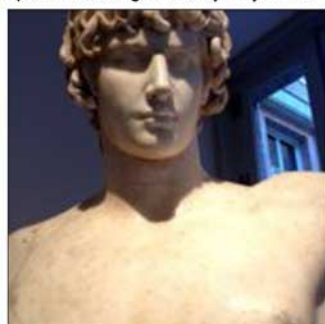

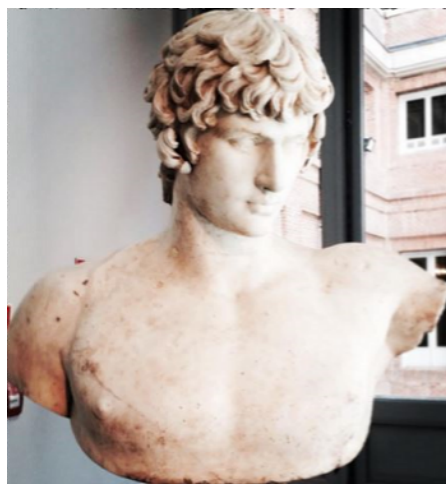

(U//LES) Pedophiles, to include those who sexually abuse children as well as those who produce, distribute, and trade child pornography, are using various types of identification logos or symbols to recognize one another and distinguish their sexual preferences. To specifically indicate the pedophile's gender preference, members of pedophilic organizations encourage the use of descriptions such as "boylove", "girllove", and "childlove."<sup>1</sup> These symbols have been etched into rings and formed into pendants, and have also been found imprinted on coins.

(U) The BoyLove logo (BLogo) is a small blue spiral-shaped triangle surrounded by a larger triangle, whereby the small triangle represents a small boy and the larger triangle represents an adult man.<sup>2</sup> A variation of the BLogo is the Little Boy Love logo (LBlogo), which also embodies a small spiral-shaped triangle within a larger triangle; however, the corners of the LBlogo are rounded to resemble a scribbling by a young child.<sup>3</sup> Images of the BLogo and LBlogo symbols are depicted below.

(U//LES) FBI investigations in several cities have uncovered several symbols used by pedophiles to proclaim their attraction to children. After a seizure of a subject's computer in connection with an Innocent Images case in the Jacksonville Division, a Computer Analysis Response Team forensic examiner came across an unfamiliar symbol that was integrated into a Web site banner named "ATBOYS.COM, where the "A" in "ATBOYS" was actually the BoyLove symbol and written as follows: TBOYS.com. It was further determined that "ATBOYS" is an acronym for Attracted To Boys.<sup>5</sup> These pedophilia symbols also appear on Web sites such as one of the banners advertised on [www.boylover.net](http://www.boylover.net), shown below.

In June, a moderator from a little known subreddit who goes by TheLocalGamer decided to sound the alarm on something strange he was seeing across YouTube. The title of the post was simple: "[I think it's time more people knew about Elsagate.](#)"

"Elsagate is a conspiracy in the works, being hosted on YouTube," TheLocalGamer wrote. At the time, [r/ElsaGate](#) had just a handful of subscribers and even fewer true believers. But TheLocalGamer proceeded to lay out the problem, hiding in plain sight on some of YouTube's most popular children's channels: creators were drawing children in with familiar characters — most notably Elsa from *Frozen*, but also Spider-Man and the Joker — then arranging them in bizarre situations involving cheating spouses or public urination. Digging deeper, the mod said he had seen videos with innocent thumbnails that clicked through to "videos of children giving handjobs to old men" and other depravity. He didn't know who was responsible, but he knew something was wrong.

Just a few months after [the Pizzagate debacle](#), Elsagate was formed with a very similar playbook: a group of amateur sleuths using open-source intelligence to fight a hazily defined evil threatening helpless children. "This is a conspiracy that's gonna be plastered on every news site

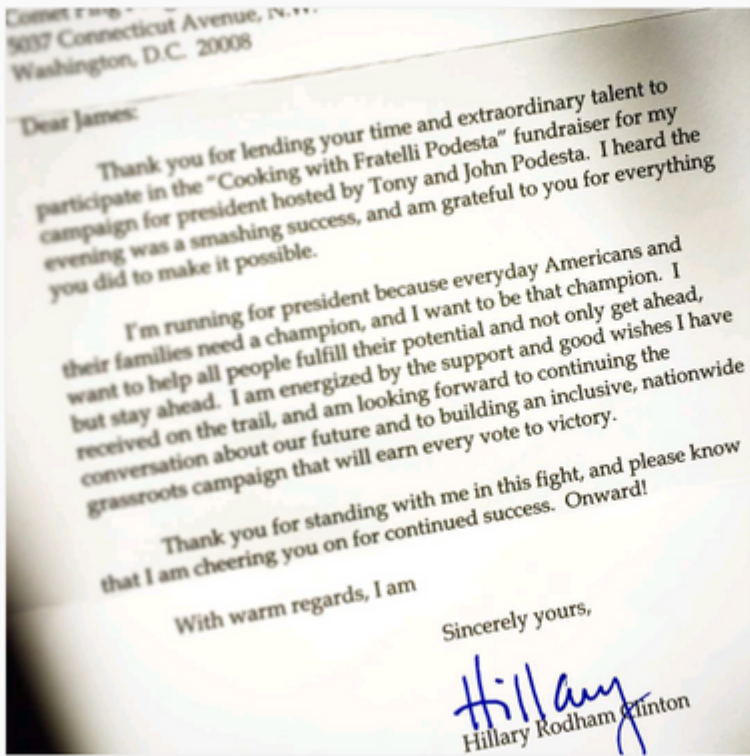

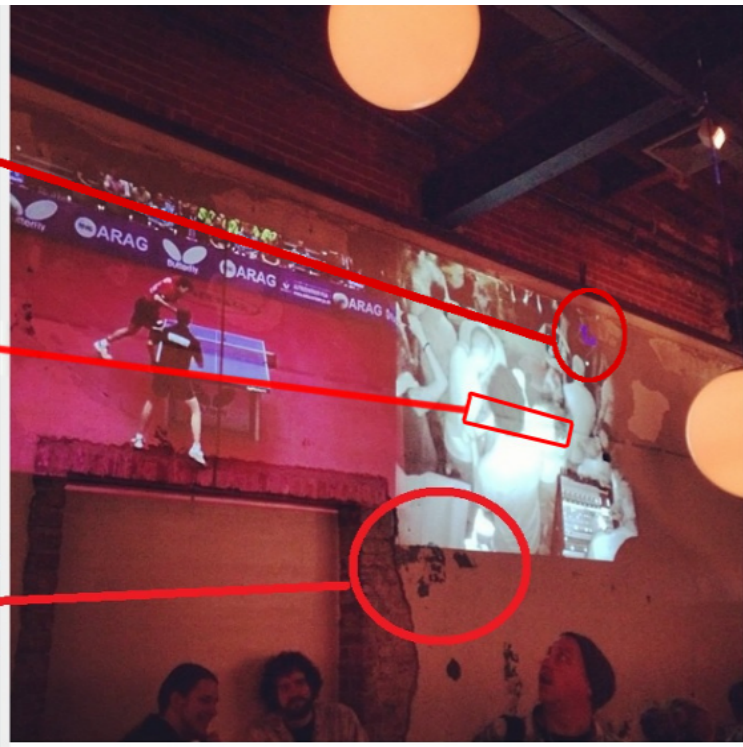
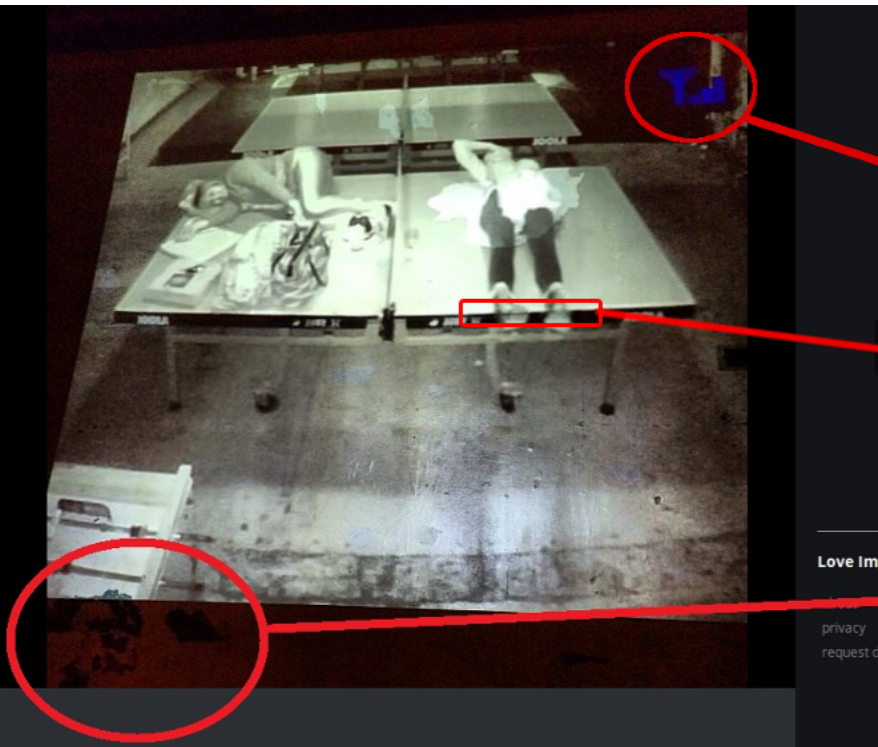

Broward's elections supervisor accidentally mixed more than a dozen rejected ballots with nearly 200 valid ones, a circumstance that is unlikely to help Brenda Snipes push back against Republican allegations of incompetence.

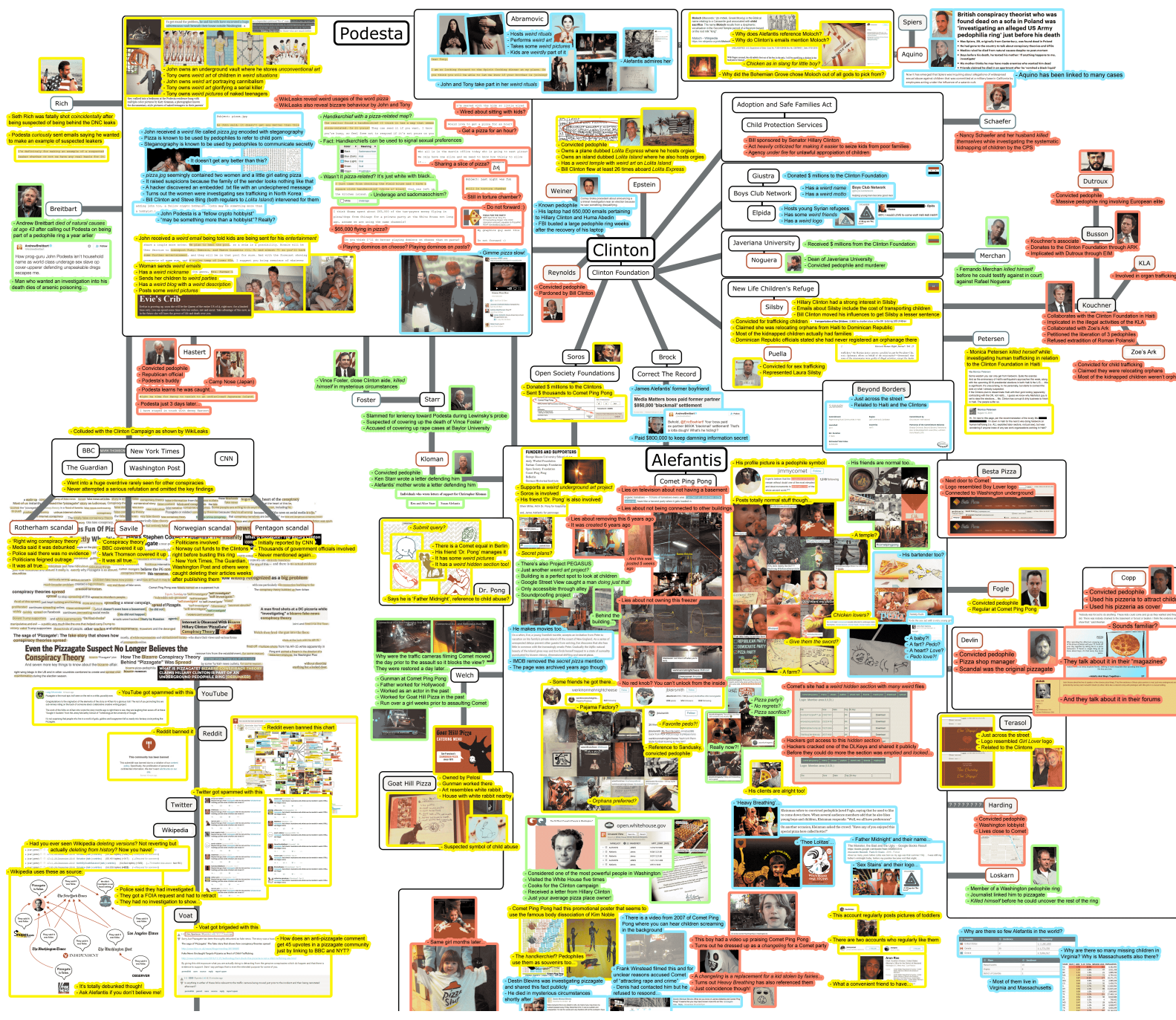
The mistake — for which no one had a solution Friday night — was discovered after Snipes agreed to present 205 provisional ballots to the Broward County canvassing board for inspection. She had initially intended to handle the ballots administratively, but agreed to present them to the canvassing board after Republican attorneys objected.

“We have found no clear authority controlling the situation faced by the board,” said Broward County Attorney Andrew Meyers.

On Election Day, Broward County collected more than 600 provisional ballots. The vast majority were declared invalid by the county's canvassing board judges for reasons ranging from registering to vote too late to previously voting to voting at the wrong precinct.
