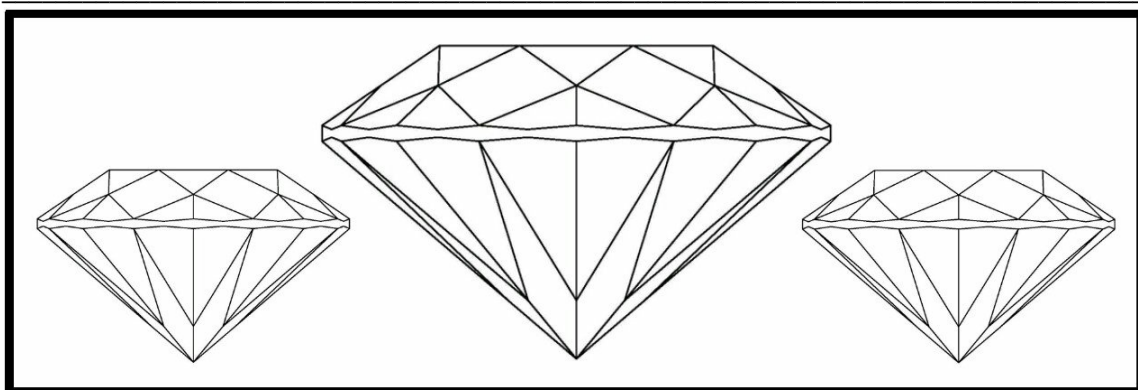

The Federal Government of The Imperium of Diamond's




Request for Social Cooperation of Legal and Political Experts and Activists and Institutions to support recognition of the legitimacy of the Federal Government and the State of the Imperium of Diamonds over the basis of voluntary and humanitarian aid

The document without approval is not intended for judicial defense or use to resolve any dispute and conflict of ID's government at the International and State Political and Judicial Levels. The sum of signatures of ID's legitimacy can be used for court defense only if the confirmation is verified by independent courts by allowing the issuer of this confirmation as Defendant and Defender to act in person by a person and institution professionally qualified for the responsibility of such recognition as expressed in this document.

Hello, my name and title is King Gottwald Peter, and I am grateful for your own support and the possibility of our common welcome.

The document is a request for humanitarian support in confirming this document if your own worthy judgment is in the opinion of the authenticity of the intelligence of such a text, within the limits of the nature of world politics, international rules, and the legal principle of the development of lawful states.

Each of you may voluntarily support the confirmation of this document or refuse. The document is merely a statement of personal opinion, without a legal obligation.

Question: The Imperium of Diamond's Federal Government is a legal political subject with a right of status as government and state on the international legal level, and with such a claim to the application of international law to states and governments as the principles of international politics?

King Gottwald Peter, in his sixth year of life, in 1998, expressed his own interest in the project, which by its definition is confirmed to be sufficiently able and expedient to acquire the capability of its own territories under the right of national recognition or the creation of its own sovereignty in Terra Nullius Territorial Territory, **therefore in accordance with international political law.**

Since 1998-2000, the King has publicly confirmed his own interests in this development, but also the right to register his own population, many economies, and the basic principles of jurisdiction and interest in such administration as the Head of State governing the country's government, always for peaceful purposes, Justice and Human Rights, **in full compliance with International Political Law.**

That is why, according to the International Political and Natural Principles and International Law, the King is recognized as the Legally Representative of the Legitimate Government and the State, **in full accordance with the International Rules.**

The King subsequently, without his legal and personal awareness, got into a conflict situation where the criminal group became an illegal act of kidnapping and blocking and disinforming the King, and thus the terrorist group was accountable for damaging all the King and Government projects and therefore the duty to return all the losses and responsibility for all guarantees, **As an obligation of fundamental character as claimed by the UN Charter and Articles 1, 2.**

It is real and publicly acknowledged today that the King has all the justice for his recognition of compensation, in accordance with the principles of International rules and all principles of judgments and the exercise of any state and constitutional court around the world, and therefore in the case of the restoration of all damaged property, plans and projects Of the King, which are publicly known and legally established, the value of the sum of the indemnity arises, which is at the level of the nature of the size and the use and nature of the property, at the level of the legal form such as the state and the government. **Therefore, the claim of the King's justice is entitled to reconciliation of the legal importance of International rights, as well as such ownership at the level of bond entitlements, and to allow for such development and activation by a court judgment of the court responsible for the act of such legalization.**

The King thus represents himself as a politically active person with the right to establish his own jurisdiction, the economy, the register of new citizens, and the use of political rights, **as it is now confirmed by the Political Law with the UNGA Declarations.**

No change in the Legal Status and such values may be applied in this case if the change occurs with the crime of another person and for that purpose in the use of an illegal act, and also because International Legitimate Rights create statutes where each government, state and political entity has the right to its integrity and its free right to its own free stabilization, **as well as the UN Charter and Ar- ticles 1, 2, and the principles of International law.**

Therefore, the final request is to make a non-binding confirmation of this text by signing if Your opinion is that this text is an expression in accordance with international law, and thus the Imperium of Diamond's Federal Government is therefore a legitimate political subject without *"right-claim invalidity"*.
