§2 Participation in the prize competition

1. Participation in the prize competition is possible via Facebook. The participant's Facebook profile must be public. Participation is free and does not require you to place an order. An order will not increase a participant's chances of winning. All judges' decisions are final. By participating in the competition, the user accepts these Terms and Conditions of Participation.

2. To enter the competition, the participant must comment the THOMAS SABO Rebel at heart FB post from the 14th November of 2020 with why they would like to win the David Garrett fan package as well as follow the THOMAS SABO Rebel at heart Facebook page.

Participation is deemed successful only if the above steps are fulfilled.

3. Participating in the competition is possible until Thursday, 19th November 2020. Winners will be contacted via Facebook Direct Message not later than 20th November 2020.

The winner will be drawn at random drawn by a THOMAS SABO jury.

The winner will be notified via a message sent on Instagram Direct. The prize expires if the prize cannot be transferred to the winning participant immediately following initial notification for reasons for which the participant is responsible. The participant is responsible for ensuring that the data entered are correct and up-to-date.

§3 Exclusion from participation in the prize competition

§4 Cancelling the prize competition

THOMAS SABO reserves the right to cancel the draw in its entirety or in part (for example, for certain prizes or special draws). This particularly applies in the event that the draw cannot be conducted as planned; for example, in the event of computer viruses, software and/or hardware errors and/or for other technical reasons that do not merely result in minor impairments.
