As a result of retaliation and reprisal, on April 14, 2009, Mr. Mitchell filed an EEO complaint alleging “discrimination and reprisal for whistleblowing on the bases of Race (African American), Color (Black), Gender (Male), Sexual Orientation (Gay), and Hostile Work Environment. Then on June 4, 2009, Mr. Mitchell filed a whistleblower complaint with the Office of Special Counsel whose complaints then led to the national discovery of the VA Waitlist scandal that erupted in national headlines beginning on February 24, 2014. It is the proceeds of the civil and qui tam litigation that Mr. Mitchell intends to use to further develop and operate the properties owned and managed by Village Resorts Hospitality Group, LLC.

Despite my attempts to dispel any rumors Village Resorts Hospitality Group, LLC, continues to review published reports and is in receipt of communications from individuals requesting hotel cancellations, dinner reservations and more.
