Only the Court may change this Order. The Petitioner/Alleged Victim cannot give you legal permission to violate this order. If you go near the Petitioner or other protected persons, even with their permission, you may be arrested. **You act at your own risk if you disregard this WARNING.**

### WARNING TO PETITIONER / ALLEGED VICTIM

You **cannot** change the terms of this Order by your words or actions. Only the Court may allow the Respondent/Defendant to contact you or return to your residence. This Order **cannot** be changed by either party without obtaining a written court order.

### NOTICE ABOUT FIREARMS AND DEADLY WEAPONS

As a result of this Order, it may be unlawful for you to possess or purchase a firearm, including a rifle, pistol, or revolver, or ammunition, pursuant to federal law, 18 U.S.C. 922(g)(8). If you have any questions whether these laws make it illegal for you to possess or purchase a firearm, you should consult a lawyer.

This Order may be subject to the exceptions pursuant to 18 U.S.C. 925(a)(1) with respect **only** to the official use of government-issued firearms or ammunition for the use of any department or agency of the United States, Ohio, or its political subdivision. This exception does not apply if the Defendant/Respondent has been convicted of an offense of violence, for example domestic violence, menacing by stalking, etc., against a family or household member.

### NOTICE TO ALL LAW ENFORCEMENT AGENCIES AND OFFICERS

The attached Protection Order is enforceable in all jurisdictions. Violating this Protection Order, whether it is a criminal or civil protection order, is a crime under R.C. 2919.27. Law enforcement officers with powers to arrest under R.C. 2935.03 for violations of the Ohio Revised Code must enforce the terms of this Protection Order as required by R.C. 2919.27, 2903.213, and 2903.214. If you have reasonable grounds to believe that Respondent/Defendant has violated this Protection Order, it is the preferred course of action in Ohio under R.C. 2935.03 to arrest and detain Respondent/ Defendant until a warrant may be obtained. Federal and state laws prohibit charging a fee for service of this order.

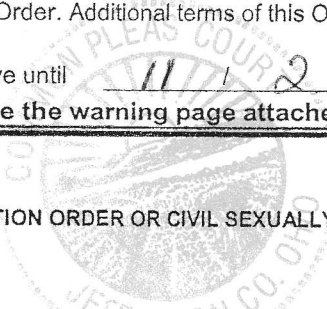

This proceeding came on for an *ex parte* hearing on 10/12/15 (Respondent not being present), upon the filing of a Petition by Petitioner for a civil stalking protection order or civil sexually oriented offense protection order against the Respondent, pursuant to R.C. 2903.214. In accordance with R.C. 2903.214(D)(1), the Court held an *ex parte* hearing not later than the next day that the Court was in session after the Petition was filed.

The Court finds that the protected persons herein are in immediate and present danger and, for good cause shown, the following temporary orders are necessary to protect the persons named in this Order.

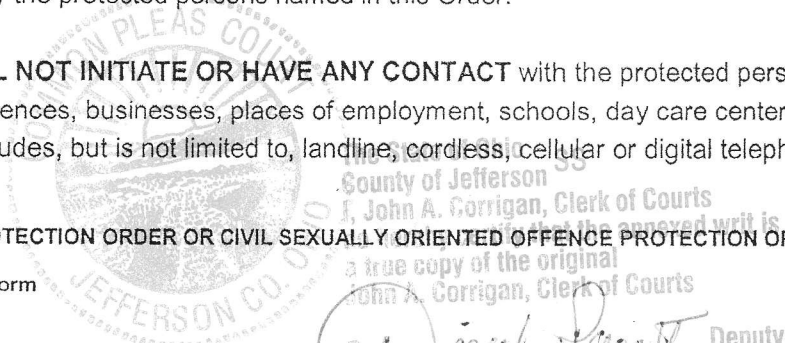
**RESPONDENT SHALL NOT ABUSE**, harm, attempt to harm, threaten, follow, stalk, harass, force sexual relations upon, or commit sexually oriented offenses against the protected persons named in this Order. [NCIC 01 and 02]

**ALL OF THE PROVISIONS CHECKED BELOW ALSO APPLY TO THE RESPONDENT**

- 1. **RESPONDENT SHALL NOT ENTER** or interfere with the residence, school, business, place of employment, day care centers, or child care providers of the protected persons named in this Order, including the buildings, grounds, and parking lots at those locations. Respondent may not violate this Order **even with the permission of a protected person**. [NCIC 04]
- 2. **RESPONDENT SHALL NOT INTERFERE** with protected persons' right to occupy the residence including, but not limited to canceling utilities or insurance or interrupting telephone service, mail delivery, or the delivery of any other documents or items.
- 3. **RESPONDENT SHALL SURRENDER** all keys and garage door openers to the following residence:

If Respondent accidentally comes in contact with protected persons in any public or private place, Respondent must depart *immediately*. - 5. **RESPONDENT SHALL NOT REMOVE, DAMAGE, HIDE, OR DISPOSE OF ANY PROPERTY OR PETS** owned or possessed by the protected persons named in this Order.
- 6. **RESPONDENT SHALL NOT INITIATE OR HAVE ANY CONTACT** with the protected persons named in this Order or their residences, businesses, places of employment, schools, day care centers, or child care providers. Contact includes, but is not limited to, landline, cordless, cellular or digital telephone; text;



instant messaging; fax; e-mail; voice mail; delivery service; social networking media; blogging; writings; electronic communications; or communications by any other means directly or through another person. Respondent may not violate this Order **even with the permission of a protected person.** [NCIC 05]

7. **RESPONDENT SHALL NOT CAUSE OR ENCOURAGE ANY PERSON** to do any act prohibited by this Order.

8. **RESPONDENT SHALL NOT POSSESS, USE, CARRY, OR OBTAIN ANY DEADLY WEAPON** at any time while the Order remains in effect unless Respondent is excepted for official use pursuant to 18 U.S.C. 925(a)(1). [NCIC 07]



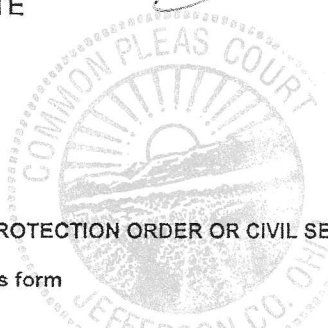

**PRO SE MOTION PETITION FOR EMERGENCY ORDER OF PROTECTION IN YOUR JURISDICTION**

COME NOW the respondent(s), (**Deric Lostutter**), on an emergency basis, and respectfully move this Court for the following emergency relief:

1. For this Court to issue emergency protection order to Deric Lostutter against Petitioner based on the evidence contained herein.
2. For this court to recognize that I found out the case number, before it was heard by the magistrate or judge, via Twitter, on behalf of Petitioner's supporters/friends, in an effort to intimidate me into silence. (**Exhibit AA**)
3. For this court to recognize that the online alias used on Twitter.com of **Samantha Cook** (Petitioner) is known as "**@S4mij0**", and the online alias of her live-in boyfriend **Robert J Ashdown III**, is known as "**@breakbeatjunkee**". Their accounts can be found at <http://www.twitter.com/s4mij0> and <http://www.twitter.com/breakbeatjunkee> respectively.  
**(EXHIBIT A1)**
4. For this court to recognize the pending charges against Petitioner **Samantha Cook** in the State of North Carolina including **arrest warrants** for her, and her live in boyfriend, **Robert J Ashdown III**, a male living in Wintersville, Ohio, born in 1982, Warrant numbers: **15cr060016 15cr060018** respectively.
5. For this court to recognize that Petitioner **Samantha J Cook** has issued a death threat (**Exhibit A**), with the help of who she claims to be her Ex-Husband to myself, and that threat put me and my



family in belief of imminent danger as discussed in Winston-Salem North Carolina Police Report # **1558558** taken 10/29/15 by Officer Short of the Winston Salem Police Department.

6. For this court to recognize that Petitioner's boyfriend Robert J. Ashdown III also, in concordance with the threats against me, communicated a 3<sup>rd</sup> party threat of violence when I sought help from friends and family. (**Exhibit B**)
7. For this court to recognize that Petitioner has exclaimed via online application "Twitter" that Petitioner enjoys my suffering at Petitioners hands. (**Exhibit C**)
8. For this court to recognize that Petitioner, friends and family of the petitioner, have been acting with malice, towards myself, my company, and friends and family, making unfounded claims, providing no proof of claims, and causing monetary damages and mental distress. (**Exhibit D**)
9. For this court to recognize that under Ohio code **Section 2903.211, .214** (menacing by stalking) does not limit public figures from protection of the code.
10. For this court to recognize under North Carolina CyberStalking Statute **§ 14-196.3. Cyberstalking**; specifically section **B**, subsection **3**, "Electronically mail or electronically communicate to another and to knowingly make any false statement concerning death, injury, illness, disfigurement, indecent conduct, or criminal conduct of the person electronically mailed or of any member of the person's family or household with the intent to abuse, annoy, threaten, terrify, harass, or embarrass." Was violated by Petitioner on multiple occasions when Petitioner messaged friends, and business clients to deter away support or financial stability for myself and my family.
11. For this court to recognize that Petitioner has taken it upon herself to contact my wife's child's father, who is engaged with us in a heated custody battle (Case: 15-CI-01654) of an 8 year old boy, to remove the child from the home of the father where heroin is present and police have arrested the father, Anthony Beaven. (Case: 15-F-01173) Petitioner has allegedly communicated

embarrassing information, in an effort to thwart my wife and I's efforts to obtain custody, and keep her son safe, again violating North Carolina CyberStalking Statute § 14-

**196.3. Cyberstalking;** specifically section **B**, subsection **3**. (**Exhibit E**)

12. That this court recognizes the malicious intent of Petitioner in the 9<sup>th</sup> point of this motion, and bars petitioner from all contact with persons involved, and or related to my wife's custody case. (15-CI-01654)
13. For the court to recognize that upon request, investigators can, in alignment with Twitter's Guide To Law Enforcement, request an archive of all communications from Petitioner, and see that there are over 1000 tweets, mentions, mostly unsolicited, directed at harassing, defaming, or otherwise damaging myself, my family, and my business.
14. For the court to recognize that Petitioner and her boyfriend have endorsed cyber-attacks against a news website that I am an investigative journalist for, Truthvoice.com which ultimately failed at unauthorized access. (**Exhibit F**)
15. For the court to dismiss any case against myself, and recognize that only after **REPEATED** antagonizing, I have issued few responses in self-defense, and have ceased all communication, however the Petitioner, and her boyfriend, continue to harass me to this day.
16. For the court to recognize that Petitioner has attempted to trick the court by acting like the victim instead of the antagonist, and thus I move the court to grant myself a protection order against the Petitioner, her boyfriend, Robert J Ashdown III, and their friends and family, and bar them from any further contact with my family, friends, employees, business, and otherwise constituents, past present or future indefinitely.
