B.2 Maximum Number of Athletes per NOC:

For each gender, the overall quota per NOC will be restricted depending on the allocated NOC event quota places, as follows:

- a) Maximum 9 athletes for NOCs that have qualified for the Team Pursuit event and have also been allocated the maximum quota for all individual events for the respective gender.
- b) Maximum 8 athletes for NOCs that have qualified for the Team Pursuit event and have also been allocated one (1) or more quota places for all individual events for the respective gender.
- c) Maximum 7 athletes for other NOCs for the respective gender.

The total number of entered athletes per gender cannot exceed the highest number of quota places allocated to the NOC for one (1) of the events, plus the number of other events for which the NOC has been allocated at least one (1) quota place taking into consideration the above conditions.

As an example:

An NOC is allocated the following event quota places:

- Men's 500m 3 start positions
- Men's 1000m 2 start positions
- Men's 1500m 1 start position
- Men's 5000m 1 start position
- Men's 10000m 1 start position
- Men's Mass Start 1 start position

The highest number of event quota places is 3 (in Men's 500m) plus 5 other events having at least 1 athlete (1000m, 1500m, 5000m, 10000m and Mass Start). This brings the total to 8. Thus for quota allocation purposes:

- If the NOC also qualifies in the Men's team pursuit, the NOC can be allocated up to 8 Men quota places.
- If the NOC does not qualify in the Men's team pursuit, the NOC can be allocated up to 7 Men quota places.

B.3 Type of Allocation of Quota Places:

Quota places are allocated to the NOC as allocation of event quota places, and this allocation sets a limit for the overall number of NOC quota places. The selection of athletes for its allocated quota places is at the discretion of the NOC subject to the eligibility requirements.





C. ATHLETE ELIGIBILITY

All athletes must comply with the provisions of the Olympic Charter currently in force included but not limited to, Rule 41 (Nationality of Competitors) and Rule 43 (World Anti-Doping Code and the Olympic Movement Code on the Prevention of Manipulation of Competitions). Only these athletes who comply with the Olympic Charter may participate in the Olympic Winter Games Beijing 2022.

C.1 Age Requirements:

All athletes participating in the Olympic Winter Games Beijing 2022 must be born before 1 July 2006.

C.2 Additional IF Requirements:

C.2.1 Achievement of Qualifying Times

To be eligible to be entered for the Olympic Winter Games Beijing 2022 within the quota places earned by the respective NOC, athletes must have achieved ISU Qualifying Times in the period between **1 July 2021** and **16 January 2022**. The applicable qualifying time standards and conditions for approval of achieved qualifying times will be announced in an ISU Communication, not later than 1 August 2020. As per ISU Regulations, only athletes from NFs (ISU Members) are allowed to enter ISU sanctioned competitions, which include ISU World Cup Speed Skating Competitions.

D. QUALIFICATION PATHWAY

Allocation of NOC event quotas (qualification places for each event) according to Olympic Qualification Classifications (OQCs) are based on results from designated ISU World Cup Competitions season 2021/2022 (for more details please refer to the respective ISU Rules and ISU Communications).

There will be OQCs for Men's and Women's Team Pursuit and for each of the individual events/distances (500m, 1000m, 1500m, 3000m, 5000m and Mass Start for the women's events; 500m, 1000m, 1500m, 5000m, 10000m and Mass Start for the men's events).

However, in accordance with D.2.2., if the host country has athletes who are placed in the respective events/distances Reserve List (as per D.2.5), the host country will be allocated event quota places up to a maximum of two (2) athletes in the 500m, 1000m, 1500m, Mass Start (Women and Men), 3000m Women and 5000m Men and one (1) quota place in the 5000m Women and 10000m Men per event.

E. CONFIRMATION PROCESS FOR QUOTA PLACES

Following each qualification event, the ISU will publish the results, as well as the current qualification ranking lists (OQC), on its website <u>www.isu.org</u>.

ISU will publish a list of provisionally allocated quota places and inform the respective NOCs by 24 December 2021. The NOCs will then have until 16 January 2022 to confirm if they wish to use these quota places, as detailed in paragraph **G. Qualification Timeline.**





F. REALLOCATION OF UNUSED QUOTA PLACES

REALLOCATION OF UNUSED IF QUOTA PLACES

If an allocated quota place is not confirmed by the NOC by the deadline for confirmation of quota places, or is declined by the NOC, the quota place will be reallocated on the condition that the total quota per sport of 166 athletes is not exceeded. The reallocation will be done according to the ranking order in the respective OQC Reserve List as per D.2.6. Priority shall be given to NOCs that have not already been allocated a quota place for the event/distance concerned.
