The undersigned is informed and believes that:

COUNT 1

On or between January 1, 2016 and December 31, 2016, in the County of Los Angeles, the crime of GRAND THEFT BY EMPLOYEE OR AGENT, in violation of PENAL CODE SECTION 487(b)(3), a Felony, was committed by DUSTIN BRIAN CISNEROS and ADAM NG, who on and between 1/1/16 and 12/31/16, and while defendant(s), DUSTIN BRIAN CISNEROS and ADAM NG was/were an agent, servant, and employee of QUADRANET ENTERPRISES, did unlawfully take money, labor, and real and personal property from QUADRANET ENTERPRISES which aggregates to a value of nine hundred fifty dollars (\$950) and more in any 12 consecutive month period.

COUNT 2

On or between January 1, 2017 and December 31, 2017, in the County of Los Angeles, the crime of GRAND THEFT BY EMPLOYEE OR AGENT, in violation of PENAL CODE SECTION 487(b)(3), a Felony, was committed by DUSTIN BRIAN CISNEROS and ADAM NG, who on and between 1/1/17 and 12/31/17, and while defendant(s), DUSTIN BRIAN CISNEROS and ADAM NG was/were an agent, servant, and employee of QUADRANET ENTERPRISES, did unlawfully take money, labor, and real and personal property from QUADRANET ENTERPRISES which aggregates to a value of nine hundred fifty dollars (\$950) and more in any 12 consecutive month period.

COUNT 3

On or between January 1, 2018 and December 31, 2018, in the County of Los Angeles, the crime of GRAND THEFT BY EMPLOYEE OR AGENT, in violation of PENAL CODE SECTION 487(b)(3), a Felony, was committed by DUSTIN BRIAN CISNEROS and ADAM NG, who on and between 1/1/18 and 12/31/18, and while defendant(s), DUSTIN BRIAN CISNEROS and ADAM NG was/were an agent, servant, and employee of QUADRANET ENTERPRISES, did unlawfully take money, labor, and real and personal property from QUADRANET ENTERPRISES which aggregates to a value of nine hundred fifty dollars (\$950) and more in any 12 consecutive month period.

COUNT 4

On or between January 1, 2019 and April 30, 2019, in the County of Los Angeles, the crime of GRAND THEFT BY EMPLOYEE OR AGENT, in violation of PENAL CODE SECTION 487(b)(3), a Felony, was committed by DUSTIN BRIAN CISNEROS and ADAM NG, who on and between 1/1/19 and 4/30/19, and while defendant(s), DUSTIN BRIAN CISNEROS and ADAM NG was/were an agent, servant, and employee of QUADRANET ENTERPRISES, did unlawfully take money, labor, and real and personal property from QUADRANET ENTERPRISES which aggregates to a value of nine hundred fifty dollars (\$950) and more in any 12 consecutive month period.

Furthermore, as to count(s) 1, 2, 3 and 4 the offenses alleged are related felonies, a material element of which is fraud and embezzlement, which involved a pattern of related felony conduct, and the pattern of related felony conduct involved the taking of, and resulted in the loss by QUADRANET ENTERPRISES of, more than one hundred thousand dollars (\$100,000), thus subjecting to the additional punishment provided for in Penal Code sections 186.11(a)(3) and 12022.6(a)(1) and (2).

Furthermore, as to count(s) 1, 2, 3 and 4 the offenses alleged are related felonies, a material element of which is fraud and embezzlement, which involved a pattern of related felony conduct, and the pattern of related felony conduct involved the taking of, and resulted in the loss by QUADRANET ENTERPRISES of, more than five hundred thousand dollars (\$500,000), thus subjecting to the additional punishment provided for in Penal Code sections 186.11(a)(2).

COUNT 5

On or between January 1, 2016 and April 30, 2019, in the County of Los Angeles, the crime of GRAND THEFT BY EMBEZZLEMENT, in violation of PENAL CODE SECTION 504, a Felony, was committed by DUSTIN BRIAN CISNEROS and ADAM NG, who was an officer, director, trustee, clerk, servant, or agent of an association, society, or corporation, specifically, Sales Representative for QUADRANET ENTERPRISES, and, who fraudulently appropriated to a use or purpose not in the due and lawful execution of that trust, property in their possession and/or under their control by virtue of that trust, and/or secreted it with a fraudulent intent to appropriate it. That property had a value exceeding nine hundred fifty dollars (\$950).

NOTICE: Conviction of this offense will require the defendant to provide DNA samples and print impressions pursuant to Penal Code sections 296 and 296.1. Willful refusal to provide the samples and impressions is a crime.

NOTICE: The People of the State of California intend to present evidence and seek jury findings regarding all applicable circumstances in aggravation, pursuant to Penal Code section 1170(b) and *Cunningham v. California* (2007) 549 U.S. 270.

NOTICE: A Suspected Child Abuse Report (SCAR) may have been generated within the meaning of Penal Code §§ 11166 and 11168 involving the charges alleged in this complaint. Dissemination of a SCAR is limited by Penal Code §§ 11167 and 11167.5 and a court order is required for full disclosure of the contents of a SCAR.

NOTICE: Any allegation making a defendant ineligible to serve a state prison sentence in the county jail shall not be subject to dismissal pursuant to Penal Code § 1385.

NOTICE: Conviction of this offense prohibits you from owning, purchasing, receiving, possessing, or having under your custody and control any firearms, and effective January 1, 2018, will require you to complete a Prohibited Persons Relinquishment Form (“PPR”) pursuant to Penal Code § 29810.


