


- 1. The institution is a separate legal entity active in the territory of the Federation, and under federal jurisdiction as an Institution Headquarters in the federation.
- 2. The institution is established for the purpose of the global unification of all corporate entities by category of its kind, thus enabling the growth of the capabilities of centralizing and exercising members of world origin as a single independent unit of the entity representing the world network created by its own members.
- 3. Institution is the legal form of a legal entity based on its performance as a logistics and representation of the composition of all entities of the world network category of the same kind representing the interests and issues of the global activity of the field of its kind and also for the creation of a common logistics for the development and modernization of the global network of industry Category of its type of institution.
- 4. Everyone from all over the world has the right to add independently to their categorical kind of institution and to use their membership as a cooperative partnership between two entities of an independent status.
- 5. Institution is a legal form active as a joint venture jointly establishing its function for the purpose of joint representation of all members, as an independent branch between all the world members of the institution and their origin, and under the democratic governance of the institutional members.
- 6. Each member of the institution shall have the right to use one's own vote for the function of the joint democracy of the member bodies and to jointly influence the institution's active interest according to the vision and purpose of all members of the institution as a global network of unified entities.
- 7. A member of an institution may be any legal or legally active entity designated for the categorical composition of the institution by institutional purpose and established by the first document.
- 8. The institution is therefore based on a breakdown by category of category;

## A. Political institution, composed of a worldwide network of legal entities.

 The category is further divided as the Institute of World Unification of Political Parties, Consulates and Ambassadors, Governments of the Countries, General Secretaries or Political Research Centers, as distinct institutions.

#### B. Business institutions, composed of a worldwide network of legal entities.

I. The category is further divided as, the Institute of World Unification of Business Associations, Bank, Business Organizations, and Trading Companies looking at their different commercial categories according to the active type of market as different institutions.

# C. Civil and Social Institutions, composed of a worldwide network of legal entities.

- I. The category is further divided into such as the Institute of World Unification of Cultural Movements, Religious Churches and Sects, Social Communities and Associations, the Protestant Movement, Sports Centers and Clubs, people of racial unity and multitudes of cultures, educational centers and universities. distinct as institutions.
- 9. The institution has the right and is legally established for the purpose;
  - a. Establish the Common Headquarters of the institution as a branch with an address in the Federation.
  - b. Establish representative and active branches and offices abroad, according to the jurisdiction of the foreign legal state.
  - c. Being one of the legal Institutions, internationally and federally.
  - d. Conference together of all members of the institution, and cooperation with a public or international society.

- e. Representation of all members of the institution in the joint use of the seat and logistics of the institution.
- f. The right to media activities intended to cooperate in a company based on actual facts justifying the issuance of a public report on behalf of the institution, thereby enabling the public company, its members, and community centers.
- g. Joint Planning of Growth Global networks and activities in the nature of logistics and the available legal resources of the institution's categorization according to its own members.
- h. To base their own decisions on the objectives of the democracy of all members of the institution and thereby to determine the joint development of the institution according to legally permissible objectives.
- To develop joint business projects on behalf of the institution, on behalf of the individual institutional members commitments, and their planning, performance and organization.
- Managing the administration of own bills, Financial account in Banks, owning the finances and the yault.
- k. Trade on behalf of the institution.
- To select regular contributions from its own members, if established by the democracies of the members of the institution.
- m. Establish the institution's own assets and the production of business and representation goods under the name of the institution.
- n. The institution has a duty to manage its own assets for the purpose of securing the risk-free function of Institutional Activities.
- o. Expand equity capital from profits and invest in general projects.
- p. Issuing and regulatory limitation of stock papers for investment co-operation.

- q. Sharing information for the purpose of institution growth as a joint venture partner, thereby utilizing the common intelligence and logistics of all members of the institution.
- r. To use the partnership institution as a member body and institution, open to all members of the institution.
- s. Promote a joint growth of partnerships between members of the institution and the acquisition of new members of the institution among the same categorical subject matter of the institution.
- t. Establish own records of office employees and workers' structures. Provide the organization's own official logistics for institutional purposes and management cooperation.
- u. Establish its own logistics offices and archives.
- v. Use an active global network of partnerships of all their own members, depending on their dependence on their own consent and the contractual obligation.
- w. Each member of the institution may use its own foreign assets for the purpose of the business or development of a joint Institution group.
- x. Establish agreements and performance with other non-institutional bodies and are not related to the institutional category.
- 10. Institution is an entity that is composed of management performance as the General Council composed of members of the institution, administration teams as well as staff who are composed of hired agencies or in the form of their own staff.
- 11. The General Council The Institution is a powerful bond of a common democracy that determines the institution's development and activities, meaning the growth of the common name of the institution, and the decision-making about strategic activities.
- 12. Each member of the General Council thus establishes its own team which

- functions as the Office of company member, in order to communicate with the institution and ensure the joint development of legal and strategic development issues.
- 13. The General Council, like any member, has the right to vote for one vote on democratic issues.
- 14. The General Council is made up of all the members of the Institution and represented by officials of the Federal offices, thus ensuring the synchronization of institutional functions and the direct registration of institutional strategies prior to the administration of jurisdiction and the cadastre by federal authorities and the exercise of such legal responsibility.
- 15. Federal Authorities have the right, in the event of stabilization or legal needs, to limit, modify, administer, develop or block the Institutions' interests and certain activities if this is necessary.
- 16. An institution's administrative team may be composed of its own staff or, in the case of the hire of certified federation service agencies.
- 17. An institution, such as an Administrative Team, consists of an observer who records all the functions and activities of the institution for the purpose of storing logistics in an institution archive allowing the administration of all legal and certification documents.
- 18. The Notariate is the Institution's Office, which creates a register of all documents of the Institutions that are decisive for the development strategy and plan, joint agreements and legal moves, as well as the principles of the duties of the notarial registry under the principles of Federal Jurisdiction.
- 19. The Internal Office of the Notary merely processes documents and declarations for the purpose of registration with an independent notary who is not a member of the institution.
- 20. The Law Office, observes the activities of the General Council and develops the interests of the institution's strategies to synchronize with the federal law and the jurisdiction principle, and to enable the use of the principles of the Federal Jurisdiction for the purpose of institution development.
- 21. The Accounting Office processes the economic movement of the institution and ensures the registration of accounts, receivables and expenses and profits for

- the purpose of its own autonomous administration of the function of the Institution, maintenance and communication with the Federal Authorities.
- 22. The Treasury Authority may be created if the Institution regularly manages valuable and valuable raw materials and high finance at the level of which a safe and special service report is required.
- 23. The Organizing Team of the Institution handles activities approved by the General Council of the Institution and thus ensures the establishment of cooperation with business or political and community entities for the purpose of implementing the plans created and for organizing cooperation between the Institutional Members.
- 24. The General Council is formed, in the act of any entity establishing its membership of the Institution ID's Federation, according to its or its designated categorical foundations. The entity becomes a member of the institution or the first founder.
- 25. Establishment An institution may be initiated by any person and a person abroad or within the Federation. The act of founding an institution will be registered with the Federal Authorities and designed for development. The Federal Authorities will designate the Institution category and issue permission to jointly organize members of the Institution under the law.
- 26. An entity which has commenced its own declaration of membership of an Institution will also create its own executive authority from persons who will therefore represent the entity in communicating with the Institution and thus with other members of the Institution for the purpose of joint synchronization in the performance of the institution.
- 27. Institutions originate in the use of legal systems recognized by the Federations and international law principles of mobilization of the world market;

#### Like, Business Growth of Parties of the Force of the Federation

1. Entities based in the territory of the Federation have the right to a joint declaration on the establishment of an institution and thereby to register an act of declaration before the Notarial Authorities and the Office of the

- Cadastral Administration, the Magistrates' Department.
- 2. As a joint agreement on the establishment of a joint center of its own affiliates determining the joint performance of the institution's headquarters and a common capacity determining the capacity for joint performance.
- 3. The entities of the Federation have the right to use or lend their own assets and mobilizing forces for the purpose of the investment as the founding property of an institution capable of responsible autonomy of institution building with a common name as an institution of legal status.
- 4. Federation entities are also entitled to use logistics of the organized market between trade and productive subjects of the federation and abroad, according to deficit management as the founding property of the institution, capable of responsible autonomy of institution building with a common name as an institution of legal status.

### **Like, Logistics Growth of Foreign States Parties**

- 1. As a joint treaty establishing a joint center of representative offices of independent status, determining the joint performance of the institution's headquarters and a common capacity determining the capacity for joint performance.
- 2. Logistic support of the organized market using the autonomy of the legal name of the Institution.
- 28. The institution also establishes its own cooperation with the Federal Authorities, which therefore supports the growth of joint logistics for the purpose of creating investment and subsidy based on programs the government's own resources investment co-operation of the central bank and other banks active in the federation.
