

# Ministerial Order 981/2020

of the 26th of October, by which the Ministry of Defence of the Unified Eothasi Socialist Realm submits a purchase order to Royal Marquesan Exports for diversified military equipment.

**BE IT ENACTED** by Her Imperial Majesty, Empress Cordelia of Eothasia, by and with the advice and consent of the Lords and Ladies of this present College and Conclave assembled, and by the authority of the same, as follows:

On this date, the 26th of October of the year 2020, the Ministry of Defence is officially authorised, by the powers vested in the Federal College of Ministries, to submit a purchase order to Royal Marquesan Exports, an internationally recognised foreign corporation based in Gholgoth. It is the intention of the Ministry of Defence —as the institution of the Republic tasked with ensuring the capability of the Eothasi Defence Forces to protect both the territorial boundaries as well as the interests, foreign and domestic, of the Republic— to take advantage of a unique opportunity to diversify the military equipment in use by the Eothasi Defence Forces' branches and services.

It is, then, with this intention, that the Ministry of Defence presents the following text to the Federal Conclave for approval, in consensus with all ministries and the superior order of hierarchy of the Republic, as well as with the necessary governmental debate required to achieve this consensus and the grace of Her Imperial Majesty, Empress Cordelia III, as Imperial Arbiter of the Eothasi Republic.

## Article 1. *Recognition of relations*

The Ministry of Defence of the Eothasi Republic, in its competence as the coordinator of the services of the Defence Forces of the Republic, recognises the institution of Royal Marquesan Exports as an international

arms manufacturing corporation of interest, hereby referred to as the 'Corporation'.

### Article 2. *Purchase submission order*

1. The Ministry of Defence submits alongside this Ministerial Order an official procurement order in order to begin processing of all the detailed equipment in this order as per the necessary procedures established by the Corporation.
2. The Ministry of Defence unlocks for this process a total of twenty six billion universal standard dollars (\$26,000,000,000.00), guaranteeing in this manner the necessary funds are available for this expansion of the military capabilities of the Republic.

### Article 3. *Delivery.*

1. Delivery of all purchased materials are to take place to **Grozzo Harbour** in the Unified Eothasi Socialist Realm, a military port in the south of the nation corresponding to the Popular Community of Aterni. Additional information shall be provided at request of the Corporation.
2. Expected time for the completion of the first delivery of the purchased equipment is three months. Further deliveries until the completion of the contract shall be negotiated between representatives of the Corporation and the Ministry of Defence of the Republic, maintaining a maximum elapsed time between deliveries of three months.
3. Contractual obligations extend to deliveries of the equipment to Grozzo Harbour and not beyond the boundaries of the port installations.

#### Article 4. *Payment*

1. An initial payment of 10% the total agreed-upon price shall be paid upon approval of the purchase order in the form of a deposit to ensure the continued cooperation between the Corporation and the Ministry.
2. The remaining 90% shall be divided in negotiation with the Corporation and the Ministry as per the delivery of equipment is made in an equitable manner with respect to the value of the equipment provided by the Corporation.
3. Payments will be made only upon the delivery of equipment and not before. Delays in delivery will result in an equivalent delay in the payment of the equipment being delivered.

#### Article 5. *Escort*

1. In coordination with the Corporation, the Ministry and the Defence Forces of the Republic shall negotiate the allocation of an escort element to the delivery vessels in order to ensure their transit to the Unified Eothasi Socialist Realm.
2. The Eothasi Government, Ministry of Defence and military shall not be responsible for the loss of any military equipment in transit, and will demand the delivery of all pieces of purchase equipment without exception.

#### Provision 1. *Habilitation*

The Unified Eothasi Socialist Realm and its subservient departments and ministries may order any modifications to this deal in accordance with prior coordination with the Corporation.

#### Provision 2. *Entry into force*

This shall enter into force upon the official publication of this Bulletin.
