Atty. Atty. William Gilmour was a Toronto PD narcotics officer and a RCMP officer prior to becoming a lawyer and at both jobs he was asked to resign or be fired because of his dubious conduct including an unarmed teenager in the back and having an affair with the wife of a colleague he was assigned to investigate.
