- **Seth Cordell** (Libertarian Party) is running for election for [Governor of Kansas](#). He is on the ballot in the general election on [November 8, 2022](#). He advanced from the Libertarian Party convention on [April 23, 2022](#).

- **What do you think should be done to help Kansans dealing with high costs?**
- A large factor in the high price of goods is the lack of local competition for those goods. Easing the tax and regulations on small businesses will allow people to supply those goods at a lower cost and without dependency on a supply chain that is growing increasingly fragile. Easing the tax burden on consumers will also increase their spending power and offset the increase in costs.
- **Share your thoughts on abortion rights and restrictions.**
- I voted no to the Amendment and would not vote to increase restrictions on abortion. I believe the government should not be involved with an individuals healthcare choices. My personal views regarding abortion align fairly well with the current standards and would not actively seek to change them.
- **Do you think KanCare should be expanded? Why or why not?**
- No. I believe the driving force behind the destruction of our healthcare system is government interference. I will not seek to cancel KanCare, but will strive to build an economy where it is no longer needed.
- **What is your stance on the legalization of medical marijuana?**
- **Recreational marijuana?**
- I support the full legalization of marijuana. For one, in study after study it is shown to be much safer than other currently legal recreational drugs. Secondly, the economic impact to the state would be incredible. Not only from the moderate taxation of the sale of recreational cannabis, but also full legalization would eliminate many of the regulations on the hemp industry which are preventing it from being a viable crop.
- **Share your thoughts about transgender athletes in sports.**
- I think the issue of transgender athletes in sports is not the business of the government. It should be up to the school who they allow on a team, and it should be up to the sanctioning body if they want to allow it in their contests. For Kansas high school sports, it would be KSHSAA that should be making that decision. The government arguing about this is yet another example of overreach and inefficiency.
- **What are your thoughts on election integrity in Kansas? Across the United States? Would you change the election process and how?**
- It doesn't matter if every vote in Kansas is properly accounted for, if it is perceived as inaccurate or corrupt, there will always be doubt. We need to find a way that ensures not only the integrity of the elections, but also the perception of them. I don't know exactly what that looks like on election

day, but would find a non-partisan solution. Prior to the election a great start would be the Republicans and the Democrats being willing to step on stage with everyone that is on the ballot to ensure a properly informed voting base.

- **What are the issues you would address for farmers and ranchers?**
- Easing regulation in the food industries would allow more small processing facilities to open and give farmers and ranchers a more diverse market to sell their products to. Over time this will lead to more dependable and diverse business opportunities that will also shorten the supply chain and prevent shortages.
- **What are the key education issues in Kansas for K-12? For universities?**
- We need to eliminate standardized testing as a metric for success. They are not an accurate predictor of future success and take way too much class time to prepare for. K-12 needs to adapt to the new demands of a modern workforce and focus more on technical and vocational programs.
- **What do you think needs to be done to promote social and racial justice?**
- Accountability for all in authority. Ending qualified immunity for police officers and police unions. Also limit the power in the state capitol and give more authority to cities and counties that know how to solve the unique problems they face.

- Cullene Lang
 - Libertarian
 - A FEW STANCES:
 - **Abortion:** I am pro-choice and believe the right of a woman to control her own body is inalienable. However, I do not support state funding of abortions or state-mandated abortions.
 - **Agriculture:** Farmers, ranchers and all other purveyors of goods and services in the agricultural free market should operate unhindered by government regulation, while being policed by private sector consumer protection agencies for quality, and held strictly liable by government only against fraud and deception.
 - **Crime:** The only justified function of government is the protection of the lives, rights and property of its citizens. The appropriate way to suppress crime is through consistent and impartial enforcement of laws that protect individual rights. I support the trend toward private protection services and voluntary community crime control groups.
 - **Drugs:** I support the decriminalization of drugs. I support the right of physicians to prescribe marijuana (or any other currently illegal substance) felt to benefit the patient. I believe law enforcement officers who are paid by the state or local governments should not be providing information to DEA or any other agency. If other agencies wish to employ them, let those other agencies foot the bill. The War on Drugs is in reality a war on the American people, our Constitution, and the Bill of Rights.
 - **Economy and Budget:** I support implementation of the following policies:
 - a. Dramatic reductions in both taxes and government spending;
 - b. An end to deficit budgets;
 - c. A halt to inflationary monetary policies;
 - d. The

elimination of all government impediments to free trade; and e. The repeal of all controls on wages, prices, rents, profits, production and interest rates.

- **Education:** I advocate the complete separation of education and the state. Government schools lead to the indoctrination of children and interfere with the free choice of individuals. Government ownership, operation, regulation, and subsidy of schools and colleges should be ended. As an interim measure to encourage the growth of private schools and variety in education, including home schooling, I support tax credits for tuition and other expenditures related to an individual's education.
- **Guns:** I believe the Constitution does and should protect the right of honest citizens to possess and use firearms to defend their life, liberty, property and safety. I would eliminate all requirements to pay fees and register gun owners. I would allow any law-abiding citizen to carry firearms openly or concealed for any reason except the commission of a crime.
- **Health Care:** I favor restoring and reviving a free market health care system, and advocate a complete separation of medicine from the state. I support an end to government-provided health insurance and health care. Both of these functions can be more effectively provided in the private sector. I support freedom of research, including human cloning and stem cell research by private industry and universities. I do not support government restriction or funding of medical or scientific research.

 - “Kobach was a member of [Donald Trump](#)'s presidential transition team. The transition team was a group of around 100 aides, policy experts, government affairs officials, and former government officials who were tasked with vetting, interviewing, and recommending individuals for top cabinet and staff roles in Trump's administration. He was appointed as immigration advisor for the transition team, according to *Politico*.^[11]”
 - DATA LEAKS: The technology website [Gizmodo](#) discovered that Kobach's office had made the last four digits of the [Social Security](#) (SS) numbers of thousands of state employees and legislators available to anyone doing an Internet search. It informed Kobach's office of the problem and was

informed it would be remedied. Gizmodo analyzed [conflict of interest](#) forms filed by the current 125 state House members, and those of 40 senators, and found the partial SS numbers for 117 of the Kansas House members, and those of 34 senators, as well as the numbers of former legislators.^[169] In a separate instance, the state of Florida, which had received Social Security numbers of hundreds of Kansas voters from Kobach in 2013 via participation in the Crosscheck program, made them publicly available in 2017^[170] leading to the federally mandated suspension of the program after a lawsuit accused Kobach of violating voters' privacy rights.

- Kobach has made a political career out of two main issues — illegal immigration and his unsubstantiated claims that voter fraud is a widespread problem.
 - But those issues are no longer just Kobach's politics. Former President Donald Trump helped make them mainstream Republican talking points.
 - If elected, Kobach will be able to pursue those issues as the state's lawyer. But his laser focus on them appears to have waned, and his new target is stopping national Democrats to protect Kansans from federal laws they hate. He's already sued Biden's administration twice as a private attorney on behalf of groups challenging COVID-19 vaccine mandates.

 - **Discarding of provisional ballots**[\[edit\]](#)
 - In January 2017, Kansas election officials tossed thousands of uncounted provisional ballots cast in November 2016, saying that there was no record that those residents were registered voters.^[180] Kobach's office did not compile a count of how many ballots were tossed, but an assessment by the *Associated Press* and the League of Women Voters of the state's 11 largest counties out of a total of [105 counties](#), show that at least 8,864 ballots cast were discarded without being counted, slightly more than 1 percent of total votes in those counties.^[180]
