COME NOW the respondent(s), (**Deric Lostutter**), to provide the Court further proof as to why the Temporary Restraining Order should be dismissed, and that the Court accepts this addendum to the Response to Petition on the grounds that I was served the petition November 10th 2015 by the Forsyth County Sheriff's Office, just 2 days before the hearing was set.

1. SECTION A of petition for Restraining order, PETIONER states that I have reached out to my followers, but fails to mention that she previously reached out to those same followers and friends, spreading defamatory or damaging content. Petitioner therefore exhibits behavior that would indicate she does not fear my supporters, nor myself, but only seeks to harm me.

2. SECTION A of Petition for restraining order, PETIONER states that I threatened to call CPS and make false reports, and the Ohio Board of Nursing, but provided no proof of those claims in her Petition.
3. SECTION A of Petition for Restraining order, PETIONER states that I distributed private nudes of her given to myself by a "jaded ex". PETIONER provided only a screenshot of a repost of a Twitter post that doesn't exist on my timeline. Furthermore, the person who originally posted the photo on Twitter, is a young female, who she has repeatedly harassed. PETIONER provided no proof as to myself in actual possession of any photos of her.

4. That in section G PETITIONER expresses that she wishes I cease all contact with people surrounding her personal life. PETITIONER has provided other Twitter accounts, some to be assumed to be under her control, the original Petition, signed and stamped, in an effort to drive 3rd party harassment towards my online presence and followers. **(EXHIBIT AA, : PRO SE RESPONSE TO PETITION FOR CIVIL STALKING PROTECTION ORDER OR CIVIL SEXUALLY ORIENTED PROTECTION ORDER (R.C. 2903.214))** and continues to provide documents and information to those accounts.
5. That PETITIONER has a live in boyfriend, named on PETITION, Robert Ashdown III, who has continued to harass me to this day. **(EXHIBIT 1: ADDENDUM TO PRO SE RESPONSE TO PETITION)**
6. That PETITIONER originally called Jefferson County Sheriff's office, who found that PETITIONER could not provide proof of threats, and PETITIONER refused to make a written police report. **(EXHIBIT 2: ADDENDUM TO PRO SE RESPONSE TO PETITION)**
7. That the court recognizes my position with online news syndicate "TruthVoice.Com" and dismisses the claim that I threatened Petitioner's life by saying "I will make you famous" dated 10-18-2015 filed in Petition. I was simply referring to the fact I could write a Cyber-Bullying article and include her antics.
8. That the court recognizes Sheriff Abdalla's support of my claims, and dismisses Petitioner's claims that I threatened her with physical Violence on 10-4-15. I was simply referring to having her arrested in response to her death threats against myself.
9. That the court recognizes that stating I would drive to Mingo Junction, where the Petitioner doesn't even live, does not constitute a threat to life, Petitioner was not named in that statement posted on 10-18-15 and that I am free to travel where I wish.
10. That the court recognize that wishing the Chiefs good luck on their next game on 10-27-15 does not constitute intimidation, and is a positive statement.

11. That the court recognizes that stating "I can take you to waffle house to breakfast tomorrow for \$10 in gas" does not constitute a threat of physical violence, and that I have repeatedly tried to discuss with Petitioner, her problems with me, and continued harassment of myself, my family, and my business.

12. That the court recognizes that PETITIONER has a history of stalking, and previously had an RO placed against her, but later dismissed after mutual agreement between the two parties.

13. That the court recognizes that PETITIONER, herself, continues to passively aggressively discuss myself, my political views, and my activities with other people who take part in her repeated harassment. This would demonstrate that PETITIONER does not "live in fear" of me and is only using the court as a weapon for her stalking/harassment. **(EXHIBIT 4: ADDENDUM TO PRO SE**

On 10-28-15 at approximately 9:30am, a male who identified himself as Deric Lostutter called to inquire if any reports had been made against him. He stated that he has been having ongoing problems with Samantha Jo Cook/Samantha Jo Thompson from Wintersville. He stated that Samantha has been stalking and harassing him and that he has been in contact with his attorney over the matter. I advised Lostutter that while I was unaware of any complaints on file, his attorney may fax a request to this department at 283-8598 to further look into the matter.

On 10-11-15, Samantha Cook did call the station to report ongoing problems with Lostutter, AKA "KY Anonymous," with whom she had developed an online friendship due to his involvement with the Steubenville rape case. She stated that he was making vague threats to make false reports against her and to cause problems in general. Samantha provided limited information and could not detail specific threats. Nor did she advise that she was in fear of him as he does not live locally and their relationship/friendship was primarily online. She did not choose to respond to speak with a deputy at that time. I did advise her that she could pursue a protection order but would likely have to obtain more information about the suspect in order to do so. She stated she would follow up if necessary. The call was logged in the log book on 10-11-15 at 4:00pm.
