

ZEDE ORQUÍDEA NORMATIVE 2
BUSINESS ENTITY REGISTRATION WITHIN ZEDE ORQUÍDEA

COMES NOW Guillermo Felipe Peña Panting, on this the 18th day of March 2021, acting by and through my authority as the duly appointed Technical Secretary of ZEDE Orquídea, and hereby enacts the following ZEDE Orquídea Normative 2 (“Normative 2”), stating as follow:

1. Title. Normative 2 may be cited as the “Normative on Business Entity Registration in ZEDE Orquídea.”
2. Legal Authority. Normative 2 is made by the Technical Secretary of ZEDE Orquídea.
3. Application of Normative 2. Normative 2 applies in the jurisdiction of ZEDE Orquídea and all districts thereof.
4. Date of Enactment and Commencement. Normative 2 shall be enacted upon the first to occur, namely, either: (1) the response of no objection transmitted by the Standing Committee for the Committee for the Adoption of Best Practice; or (2) at the conclusion of fourteen (14) days from the Technical Secretary’s submission of Normative 2 to the Standing Committee for the Adoption of Best Practices.
5. Business Entity Registration System for ZEDE Orquídea.

ZEDE Orquídea shall enact internal regulations establishing a business entity registration system generally based upon the registration system used in the State of Delaware in the United States of America, with modification as necessary. In enacting this system, ZEDE Orquídea shall be guided by:

- a. Ease of use;
- b. Access;
- c. Transparency; and
- d. To the extent possible, interaction with and incorporation into Honduran systems, institutions and the local economy.

ZEDE Orquídea shall provide forms for business entity registration and filing similar to those provided by the state of Delaware, with modification as necessary. These forms shall also include instructions regarding the information required therein.


Upon completion, the ZEDE Orquídea business entity registration system shall be accomplished via on-line portal and electronic submission. Until such system is established, the Technical Secretary may accept business entity filings in a manner set by him so long as it otherwise complies with the provisions contained herein.

The Technical Secretary shall be the custodian of all business entity filings and shall establish a numerical system for compiling and organizing such filings.

The Technical Secretary shall establish fees for business entity filings in ZEDE Orquídea.
